The following examples illustrate how the total returns set forth in the table on the previous page are calculated.

Example 1: A Knock-Out Event has not occurred, and the level of the Basket increases from the Starting Basket Level of 100 to an Ending Basket Level of 120. Because a Knock-Out Event has not occurred and the Basket Return of 20% is less than the Contingent Minimum Return of 26%, the investor receives a payment at maturity of \$1,260 per \$1,000 principal amount note.

Example 2: A Knock-Out Event has not occurred, and the level of the Basket decreases from the Starting Basket Level of 100 to an Ending Basket Level of 80. Because a Knock-Out Event has not occurred and the Basket Return of -20% is less than the Contingent Minimum Return of 26%, the investor receives a payment at maturity of \$1,260 per \$1,000 principal amount note.

Example 3: A Knock-Out Event has not occurred, and the level of the Basket increases from the Starting Basket Level of 100 to an Ending Basket Level of 130. Because a Knock-Out Event has not occurred and the Basket Return of 30% is greater than the Contingent Minimum Return of 26%, the investor receives a payment at maturity of \$1,300 per \$1,000 principal amount note, calculated as follows:

$$$1,000 + ($1,000 \times 30\%) = $1,300$$

Example 4: A Knock-Out Event has occurred, and the level of the Basket decreases from the Starting Basket Level of 100 to an Ending Basket Level of 80. Because a Knock-Out Event has occurred and the Basket Return is -20%, the investor receives a payment at maturity of \$800 per \$1,000 principal amount note, calculated as follows:

$$1,000 + (1,000 \times -20\%) = 800$$

Example 5: A Knock-Out Event has occurred, and the level of the Basket increases from the Starting Basket Level of 100 to an Ending Basket Level of 120. Because a Knock-Out Event has occurred and the Basket Return is 20%, the investor receives a payment at maturity of \$1,200 per \$1,000 principal amount note, calculated as follows:

$$1,000 + (1,000 \times 20\%) = 1,200$$


