### JPMorgan Chase & Co. \$7,866,000 Notes Linked to a Weighted Basket of Three Buffered Return Enhanced Components, Consisting of the Dow Jones EURO STOXX 50® Index, the FTSE™ 100 Index and the TOPIX® Index due April 14, 2009

#### General

- The notes are designed for investors who seek a return of twice the appreciation of each underlying in a weighted diversified basket of three international buffered return enhanced components, consisting of the Dow Jones EURO STOXX 50® Index, the FTSE™ 100 Index and the TOPIX® Index, each of which is subject to a different maximum return as described below, at maturity. Investors should be willing to forgo interest and dividend payments and, if any Component Underlying declines by more than 10%, be willing to lose some or all of their principal.
- Senior unsecured obligations of JPMorgan Chase & Co. maturing April 14, 2009†.
- Minimum denominations of \$20,000 and integral multiples of \$1,000 in excess thereof.
- The notes priced on March 28, 2008 and are expected to settle on or about April 2, 2008.

#### Key Terms

**Basket/Basket Components:** The notes are linked to a weighted basket consisting of three buffered return enhanced components (each a "Basket Component," and together, the "Basket Components", each linked to an international index (each a "Component Underlying," and together, the "Component Underlyings") as set forth below:

\* The maximum payment at maturity is \$1,164.10 per \$1,000 principal amount note.

**Payment at Maturity:** The amount you will receive at maturity is based on the Basket Return, which in turn is based on the performance of the Basket Components. At maturity, your payment per \$1,000 principal amount note will be calculated as follows:  

$$\$1,000 + (\$1,000 \times \text{Basket Return})$$

**Basket Return:** The sum of the products of (a) the Component Return of each Basket Component and (b) the Component Weighting of such Basket Component.

**Component Return:** With respect to each Basket Component, the Component Return will be calculated as follows:

For each Basket Component, if the Ending Underlying Level for the applicable Component Underlying declines from the Starting Underlying Level for such Component Underlying by more than 10%, your return on the notes at maturity may be adversely affected and you may lose some or all of your investment at maturity.	

**Maximum Return:** 16.60%, 14.40%, and 18.40% for the Dow Jones EURO STOXX 50® Index, the FTSE™ 100 Index and the TOPIX® Index, respectively. For example, if the Underlying Return for the Dow Jones EURO STOXX 50® Index is more than 8.30%, the applicable Component Return will be equal to the applicable Maximum Return, or 16.60%.

**Underlying Return:** With respect to each Component Underlying, the performance of the Component Underlying from the Starting Underlying Level to the Ending Underlying Level, calculated as follows:

$$\frac{\text{Ending Underlying Level} - \text{Starting Underlying Level}}{\text{Starting Underlying Level}}$$

**Starting Underlying Level:** With respect to each Component Underlying, the Index closing level on the pricing date, which was 3641.05 for the Dow Jones EURO STOXX 50® Index, 5692.90 for the FTSE™ 100 Index and 1243.81 for the TOPIX® Index.

**Ending Underlying Level:** With respect to each Component Underlying, the arithmetic average of the Index closing levels on each of the Ending Averaging Dates.

**Ending Averaging Dates†:** April 2, 2009, April 3, 2009, April 6, 2009, April 7, 2009 and April 8, 2009

**Maturity Date†:** April 14, 2009

### What Is the Underlying Return for Each Component Underlying and the Corresponding Component Return for Each Basket Component Assuming a Range of Performance for Each Component Underlying?

The following table illustrates the hypothetical Underlying Return for each Component Underlying and the corresponding Component Return for each Basket Component. The hypothetical Underlying Returns and Component Returns set forth below assume a Starting Underlying Level of 3500, 5500 and 1200 for the Dow Jones EURO STOXX 50<sup>®</sup> Index, the FTSE<sup>™</sup> 100 Index and the TOPIX<sup>®</sup> Index, respectively, and reflect the Maximum Return of 16.60%, 14.40% and 18.40% for the Basket Components linked to the Dow Jones EURO STOXX 50<sup>®</sup> Index, the FTSE<sup>™</sup> 100 Index and the TOPIX<sup>®</sup> Index, respectively. The hypothetical Underlying Returns and Component Returns set forth below are for illustrative purposes only and may not be the actual Underlying Returns and Component Returns applicable to a purchaser of the notes. ### Hypothetical Examples of Amounts Payable at Maturity

The following examples illustrate how the payment at maturity is calculated under various hypothetical circumstances. You should review the following examples in conjunction with the hypothetical table set forth on the previous page, including the underlying assumptions described on the previous page. The hypothetical payments at maturity set forth below are for illustrative purposes only and may not be the actual payment at maturity applicable to a purchaser of the notes. The numbers appearing in the following examples have been rounded for ease of analysis.

**Example 1: The level of the Dow Jones EURO STOXX 50® Index increases from a Starting Underlying Level of 3500 to an Ending Underlying Level of 3710, the FTSE™ 100 Index increases from a Starting Underlying Level of 5500 to an Ending Underlying Level of 5775, and the level of the TOPIX® Index increases from a Starting Underlying Level of 1200 to an Ending Underlying Level of 1284.**

Because the Ending Underlying Level of each Component Underlying is greater than its Starting Underlying Level, and each of the Underlying Return of 6.00% for the Dow Jones EURO STOXX 50® Index, 5.00% for the FTSE™ 100 Index and 7.00% for the TOPIX® Index, each multiplied by 2, does not exceed the applicable Maximum Return of 16.60%, 14.40% and 18.40%, respectively, the Basket Return is calculated as follows:

$$[(6\% \times 2) \times 55\%] + [(5\% \times 2) \times 25\%] + [(7\% \times 2) \times 20\%] = 11.90\%$$

Accordingly, the investor receives a payment at maturity of \$1,119.00 per \$1,000 principal amount note, calculated as follows:

$$\$1,000 + (\$1,000 \times 11.90\%) = \$1,119.00$$

**Example 2: The level of the Dow Jones EURO STOXX 50® Index increases from a Starting Underlying Level of 3500 to an Ending Underlying Level of 4200, the FTSE™ 100 Index increases from a Starting Underlying Level of 5500 to an Ending Underlying Level of 7150, and the level of the TOPIX® Index increases from a Starting Underlying Level of 1200 to an Ending Underlying Level of 1680.**

Because the Ending Underlying Level of each Component Underlying is greater than its Starting Underlying Level, and each of the Underlying Return of 20.00% for the Dow Jones EURO STOXX 50® Index, 30.00% for the FTSE™ 100 Index and 40.00% for the TOPIX® Index, each multiplied by 2, exceeds the applicable Maximum Return of 16.60%, 14.40% and 18.40%, respectively, the Basket Return is calculated as follows:

$$(16.60\% \times 55\%) + (14.40\% \times 25\%) + (18.40\% \times 20\%) = 16.41\%$$

Accordingly, the investor receives a payment at maturity of \$1,164.10 per \$1,000 principal amount note, which reflects the maximum payment at maturity, calculated as follows:

$$\$1,000 + (\$1,000 \times 16.41\%) = \$1,164.10$$

**Example 3: The level of the Dow Jones EURO STOXX 50® Index increases from a Starting Underlying Level of 3500 to an Ending Underlying Level of 3850, the FTSE™ 100 Index increases from a Starting Underlying Level of 5500 to an Ending Underlying Level of 5830, and the level of the TOPIX® Index increases from a Starting Underlying Level of 1200 to an Ending Underlying Level of 1284.**

Because the Ending Underlying Level of each Component Underlying is greater than its Starting Underlying Level, and the Underlying Return of 10.00% for the Dow Jones EURO STOXX 50® Index multiplied by 2 exceeds the applicable Maximum Return of 16.60%, while each of the Underlying Return of 6.00% for the FTSE™ 100 Index and 7.00% for the TOPIX® Index, each multiplied by 2, does not exceed the applicable Maximum Return of 14.40% and 18.40%, respectively, the Basket Return is calculated as follows:

$$(16.60\% \times 55\%) + [(6\% \times 2) \times 25\%] + [(7\% \times 2) \times 20\%] = 14.93\%$$

Accordingly, the investor receives a payment at maturity of \$1,149.30 per \$1,000 principal amount note, calculated as follows:

$$\$1,000 + (\$1,000 \times 14.93\%) = \$1,149.30$$

**Example 4: The level of the Dow Jones EURO STOXX 50® Index decreases from a Starting Underlying Level of 3500 to an Ending Underlying Level of 3150, the FTSE™ 100 Index decreases from a Starting Underlying Level of 5500 to an Ending Underlying Level of 4950, and the level of the TOPIX® Index decreases from a Starting Underlying Level of 1200 to an Ending Underlying Level of 1080.**

Because the Ending Underlying Level of each Component Underlying is less than its Starting Underlying Level by not more than 10%, the investor receives a payment at maturity of \$1,000 per \$1,000 principal amount note.

**Example 5: The level of the Dow Jones EURO STOXX 50® Index decreases from a Starting Underlying Level of 3500 to an Ending Underlying Level of 2450, the FTSE™ 100 Index decreases from a Starting Underlying Level of 5500 to an Ending Underlying Level of 4400, and the level of the TOPIX® Index decreases from a Starting Underlying Level of 1200 to an Ending Underlying Level of 720.**

Because the Ending Underlying Level of each Component Underlying is less than its Starting Underlying Level by more than 10%, the Basket Return is calculated as follows:

$$\{[(-30\% + 10\%) \times 1.1111] \times 55\%\} + \{[(-20\% + 10\%) \times 1.1111] \times 25\%\} + \{[(-40\% + 10\%) \times 1.1111] \times 20\%\} = -21.666\%$$

Accordingly, the investor receives a payment at maturity of \$783.34 per \$1,000 principal amount note, calculated as follows:

$$\$1,000 + (\$1,000 \times -21.666\%) = \$783.34$$

**Example 6: The level of the Dow Jones EURO STOXX 50® Index decreases from a Starting Underlying Level of 3500 to an Ending Underlying Level of 2450, the FTSE™ 100 Index decreases from a Starting Underlying Level of 5500 to an Ending Underlying Level of 4950, and the level of the TOPIX® Index decreases from a Starting Underlying Level of 1200 to an Ending Underlying Level of 720.**

Because the Ending Underlying Level of the FTSE™ 100 Index is less than its Starting Underlying Level by not more than 10% and the Ending Underlying Level of each of the other Component Underlyings is less than its Starting Underlying Level by more than 10%, the Basket Return is calculated as follows:

$$\{[(-30\% + 10\%) \times 1.1111] \times 55\%\} + 0\% + \{[(-40\% + 10\%) \times 1.1111] \times 20\%\} = -18.889\%$$

Accordingly, the investor receives a payment at maturity of \$811.11 per \$1,000 principal amount note, calculated as follows:

$$\$1,000 + (\$1,000 \times -18.889\%) = \$811.11$$

**Example 7: The level of the Dow Jones EURO STOXX 50® Index increases from a Starting Underlying Level of 3500 to an Ending Underlying Level of 3710, the FTSE™ 100 Index decreases from a Starting Underlying Level of 5500 to an Ending Underlying Level of 4400, and the level of the TOPIX® Index decreases from a Starting Underlying Level of 1200 to an Ending Underlying Level of 840.**

Because the Ending Underlying Level of the Dow Jones EURO STOXX 50® Index is greater than its Starting Underlying Level, and the Underlying Return of 6.00% multiplied by 2 does not exceed the applicable Maximum Return of 16.60%, and the Ending Underlying Level of each of the other Component Underlyings is less than its Starting Underlying Level by more than 10%, the Basket Return is calculated as follows:

$$[(6\% \times 2) \times 55\%] + \{[(-20\% + 10\%) \times 1.1111] \times 25\%\} + \{[(-30\% + 10\%) \times 1.1111] \times 20\%\} = -0.62\%$$

Accordingly, the investor receives a payment at maturity of \$993.78 per \$1,000 principal amount note, calculated as follows:

$$\$1,000 + (\$1,000 \times -0.62\%) = \$993.78$$



## Selected Purchase Considerations

- **APPRECIATION POTENTIAL** — The notes provide the opportunity to enhance equity returns by multiplying a positive Underlying Return for each Component Underlying by two, up to the Maximum Return of 16.60% for the Dow Jones EURO STOXX 50® Index, 14.40% for the FTSE™ 100 Index and 18.40% for the TOPIX® Index. Accordingly, the maximum payment at maturity is \$1,164.10 for every \$1,000 principal amount note. Because the notes are our senior unsecured obligations, payment of any amount at maturity is subject to our ability to pay our obligations as they become due.
- **LIMITED PROTECTION AGAINST LOSS** — Payment at maturity of the principal amount of the notes is protected against a decline in the Ending Underlying Level of each Component Underlying, as compared to the applicable Starting Underlying Level, of up to 10%. If the Ending Underlying Level of a Component Underlying declines by more than 10%, for every 1% decline of the Component Underlying beyond 10%, the Component Return for the Basket Component linked to such Component Underlying will be reduced by 1.1111%.
- **DIVERSIFICATION AMONG THE COMPONENT UNDERLYINGS** — Because the Basket Component linked to the Dow Jones EURO STOXX 50® Index makes up 55% of the Basket, we expect that generally the market value of your notes and your payment at maturity will depend significantly on the performance of the Dow Jones EURO STOXX 50® Index.  
The return on the notes is linked to a weighted basket consisting of three buffered return enhanced components, each linked to the Dow Jones EURO STOXX 50® Index, the FTSE™ 100 Index and the TOPIX® Index, respectively. The Dow Jones EURO STOXX 50® Index consists of 50 component stocks of market sector leaders from within the Eurozone. The Dow Jones EURO STOXX 50® Index and STOXX® are the intellectual property (including registered trademarks) of STOXX Limited, Zurich, Switzerland, and/or Dow Jones & Company, Inc., a Delaware corporation, New York, USA (the “Licensors”), which are used under license. The notes are in no way sponsored, endorsed, sold or promoted by the Licensors and neither of the Licensors shall have any liability with respect thereto. The FTSE™ 100 Index measures the composite price performance of stocks of the largest 100 companies (determined on the basis of market capitalization) traded on the London Stock Exchange. The TOPIX® Index consists of all common stocks listed on the First Section of the Tokyo Stock Exchange (the “TSE”) that have an accumulative length of listing of at least six months. The TOPIX® Index is a weighted index, the component stocks of which are reviewed and selected every six months, with the market price of each component stock multiplied by the number of shares listed. For additional information about each Component Underlying, see the information set forth under “The Dow Jones EURO STOXX 50® Index,” “The FTSE™ 100 Index” and “The TOPIX® Index” of the accompanying product supplement no. 103-I.
- **CAPITAL GAINS TAX TREATMENT** — You should review carefully the section entitled “Certain U.S. Federal Income Tax Consequences” in the accompanying product supplement no. 103-I. Subject to the limitations described therein, and based on certain factual representations received from us, in the opinion of our special tax counsel, Davis Polk & Wardwell, it is reasonable to treat your purchase and ownership of the notes as an “open transaction” for U.S. federal income tax purposes. Assuming this characterization is respected, your gain or loss on the notes should be treated as long-term capital gain or loss if you hold the notes for more than a year, whether or not you are an initial purchaser of notes at the issue price. However, the Internal Revenue Service (the “IRS”) or a court may not respect this characterization or treatment of the notes, in which case the timing and character of any income or loss on the notes could be significantly and adversely affected. In addition, on December 7, 2007, Treasury and the IRS released a notice requesting comments on the U.S. federal income tax treatment of “prepaid forward contracts” and similar instruments, such as the notes. The notice focuses in particular on whether to require holders of these instruments to accrue income over the term of their investment. It also asks for comments on a number of related topics, including the character of income or loss with respect to these instruments; the relevance of factors such as the nature of the underlying property to which the instruments are linked; the degree, if any, to which income (including any mandated accruals) realized by Non-U.S. Holders should be subject to withholding tax; and whether these instruments are or should be subject to the “constructive ownership” regime, which very generally can operate to recharacterize certain long-term capital gain as ordinary income that is subject to an interest charge. While the notice requests comments on appropriate transition rules and effective dates, any Treasury regulations or other guidance promulgated after consideration of these issues could materially and adversely affect the tax consequences of an investment in the notes, possibly with retroactive effect. Both U.S. and Non-U.S. Holders should consult their tax advisers regarding the U.S. federal income tax consequences of an investment in the notes, including possible alternative treatments and the issues presented by this notice.

## Selected Risk Considerations

An investment in the notes involves significant risks. Investing in the notes is not equivalent to investing directly in the Basket, the Basket Components, the Component Underlyings or any of the component stocks of the Component Underlyings. These risks are explained in more detail in the “Risk Factors” section of the accompanying product supplement no. 103-I dated October 19, 2007.

- **YOUR INVESTMENT IN THE NOTES MAY RESULT IN A LOSS** — The notes do not guarantee any return of principal. The return on the notes at maturity is linked to the performance of the Component Underlyings and will depend on whether, and the extent to which, the Underlying Return is positive or negative. Your investment will be exposed on a leveraged basis to any decline in the Ending Underlying Level for any Component Underlying beyond the 10% buffer as compared to the Starting Underlying Level.
- **THE COMPONENT RETURN FOR EACH BASKET COMPONENT IS LIMITED TO THE APPLICABLE MAXIMUM RETURN** — If the Ending Underlying Level of a Component Underlying is greater than its Starting Underlying Level, the Component Return for the Basket Component linked to such Component Underlying will not exceed the Maximum Return of 16.60%, 14.40% and 18.40% for the Dow Jones EURO STOXX 50® Index, the FTSE™ 100 Index and the TOPIX® Index, respectively, regardless of the appreciation in the Component Underlyings, which may be significant. Accordingly, your payment at maturity will not exceed \$1,164.10 for each \$1,000 principal amount note.

- **CHANGES IN THE VALUES OF THE COMPONENT UNDERLYINGS MAY OFFSET EACH OTHER** — Price movements in the Component Underlyings may not correlate with each other. - **CERTAIN BUILT-IN COSTS ARE LIKELY TO ADVERSELY AFFECT THE VALUE OF THE NOTES PRIOR TO MATURITY** — While the payment at maturity described in this pricing supplement is based on the full principal amount of your notes, the original issue price of the notes includes the agent's commission and the cost of hedging our obligations under the notes through one or more of our affiliates. As a result, the price, if any, at which JPMSI will be willing to purchase notes from you in secondary market transactions, if at all, will likely be lower than the original issue price, and any sale prior to the maturity date could result in a substantial loss to you. The notes are not designed to be short-term trading instruments. Accordingly, you should be able and willing to hold your notes to maturity.
- **NO PERIODIC INTEREST OR DIVIDEND PAYMENTS OR VOTING RIGHTS** — As a holder of the notes, you will not receive periodic interest payments, and you will not have voting rights or rights to receive cash dividends or other distributions or other rights that holders of securities composing any of the Component Underlyings would have.
- **NO DIRECT EXPOSURE TO FLUCTUATIONS IN FOREIGN EXCHANGE RATES** — The value of your notes will not be adjusted for exchange rate fluctuations between the U.S. dollar and the currencies upon which the stocks underlying each Component Underlying are based, although any currency fluctuations could affect the performance of the Basket. Therefore, if the applicable currencies appreciate or depreciate relative to the U.S. dollar over the term of the notes, you will not receive any additional payment or incur any reduction in your payment at maturity.
- **LACK OF LIQUIDITY** — The notes will not be listed on any securities exchange. JPMSI intends to offer to purchase the notes in the secondary market but is not required to do so. Even if there is a secondary market, it may not provide enough liquidity to allow you to trade or sell the notes easily. Because other dealers are not likely to make a secondary market for the notes, the price at which you may be able to trade your notes is likely to depend on the price, if any, at which JPMSI is willing to buy the notes.

  - the time to maturity of the notes;
  - the dividend rate on the common stocks underlying the Component Underlyings;
  - interest and yield rates in the market generally;
  - a variety of economic, financial, political, regulatory or judicial events;
  - the exchange rate and volatility of the exchange rate between the U.S. dollar, the European Union euro, the British pound and the Japanese yen; and
  - our creditworthiness, including actual or anticipated downgrades in our credit ratings.
