

What is the Total Return on the Notes at Maturity Assuming a Range of Performance for the Index?

The following table and graph illustrate the hypothetical total return at maturity on the notes. The "total return" as used in this term sheet is the number, expressed as a percentage, that results from comparing the payment at maturity per \$1,000 principal amount note to \$1,000. The hypothetical total returns set forth below assume an Initial Index Level of 850 and a Maximum Total Return on the notes of 26.00%. Hypothetical Examples of Amounts Payable at Maturity

The following examples illustrate how the total returns set forth in the table and graph above are calculated.

Example 1: The level of the Index increases from the Initial Index Level of 850 to an Ending Index Level of 892.50. Because the Ending Index Level of 892.50 is greater than the Initial Index Level of 850 and the Index Return of 5% multiplied by 2 does not exceed the hypothetical Maximum Total Return of 26.00%, the investor receives a payment at maturity of \$1,100 per \$1,000 principal amount note, calculated as follows:

\$1,000 + [\$1,000 x (5% x 2)] = \$1,100

Example 2: The level of the Index decreases from the Initial Index Level of 850 to an Ending Index Level of 765. Although the Index Return is negative, because the Ending Index Level of 765 is less than the Initial Index Level of 850 by not more than the Buffer Amount of 10%, the investor receives a payment at maturity of \$1,000 per \$1,000 principal amount note.

Example 3: The level of the Index increases from the Initial Index Level of 850 to an Ending Index Level of 1020. Because the Ending Index Level of 1020 is greater than the Initial Index Level of 850 and the Index Return of 20% multiplied by 2 exceeds the hypothetical Maximum Total Return of 26.00%, the investor receives a payment at maturity of \$1,260 per \$1,000 principal amount note, the maximum payment on the notes.

Example 4: The level of the Index decreases from the Initial Index Level of 850 to an Ending Index Level of 680. Because the Index Return is negative and the Ending Index Level of 680 is less than the Initial Index Level of 850 by more than the Buffer Amount of 10%, the investor receives a payment at maturity of \$888.89 per \$1,000 principal amount note, calculated as follows:

\$1,000 + [\$1,000 x (-20% + 10%) x 1.1111] = \$888.89

Selected Purchase Considerations

- APPRECIATION POTENTIAL The notes provide the opportunity to enhance equity returns by multiplying a positive Index Return by two, up to the Maximum Total Return on the notes of 26.00%, or a maximum payment at maturity of \$1,260 for every \$1,000 principal amount note. The actual Maximum Total Return on the notes and the actual maximum payment at maturity will be set on the pricing date and will not be less than 26.00% and \$1,260 per \$1,000 principal amount note, respectively. Because the notes are our senior unsecured obligations, payment of any amount at maturity is subject to our ability to pay our obligations as they become due.
- LIMITED PROTECTION AGAINST LOSS Payment at maturity of the principal amount of the notes is protected against a decline in the Ending Index Level, as compared to the Initial Index Level, of up to 10%. If the Ending Index Level declines by more than 10%, for every 1% decline of the Index beyond 10%, you will lose an amount equal to 1.1111% of the principal amount of your notes.
- DIVERSIFICATION OF THE S&P 500[®] INDEX The return on the notes is linked to the S&P 500[®] Index. The S&P 500[®] Index consists of 500 component stocks selected to provide a performance benchmark for the U.S. equity markets. - CAPITAL GAINS TAX TREATMENT You should review carefully the section entitled "Certain U.S. Federal Income Tax Consequences" in the accompanying product supplement no. 18-A-I. 

- YOUR INVESTMENT IN THE NOTES MAY RESULT IN A LOSS The notes do not guarantee any return of principal.
