#### General

This supplemental term sheet relates to one (1) note offering. The notes are linked to one, and only one, Reference Stock. The notes are designed for investors who seek an interest rate that is higher than the current dividend yield on the Reference Stock or the yield on a conventional debt security with the same maturity issued by us or an issuer with a comparable credit rating. Investors should be willing to forgo the potential to participate in the appreciation of the Reference Stock, be willing to accept the risks of owning the common stock of the Reference Stock issuer, and be willing to lose some or all of their principal at maturity. Investing in the notes is not equivalent to investing in the shares of the Reference Stock issuer.

The notes will pay interest monthly at the fixed rate specified below. However, the notes do not guarantee any return of principal at maturity. - THE NOTES OFFER A HIGHER INTEREST RATE THAN THE YIELD ON DEBT SECURITIES OF COMPARABLE MATURITY ISSUED BY US OR AN ISSUER WITH A COMPARABLE CREDIT RATING The notes will pay interest at the Interest Rate indicated on the cover of this supplemental term sheet. We believe that the Interest Rate is higher than the yield received on debt securities of comparable maturity issued by us or an issuer with a comparable credit rating. Because the notes are our senior unsecured obligations, any interest payment or any payment at maturity is subject to our ability to pay our obligations as they become due.
- MONTHLY INTEREST PAYMENTS The notes offer monthly interest payments at the Interest Rate set forth on the cover of this supplemental term sheet. Interest will be payable monthly in arrears on the 30th calendar day of each month, except for the first interest payment, which will be payable on February 28, 2009 (each such date, an "Interest Payment Date"), commencing February 28, 2009, to and including the Maturity Date, to the holders of record at the close of business on the date 15 calendar days prior to the applicable Interest Payment Date. Assuming this characterization is respected, amounts treated as interest on the Deposit will be taxed as ordinary income while the Put Premium will not be taken into account prior to maturity or sale. However, there are other reasonable treatments that the Internal Revenue Service (the "RS") or a court may adopt, in which case the timing and character of any income or loss on the notes could be significantly and adversely affected. In addition, on December 7, 2007, Treasury and the IRS released a notice requesting comments on the U.S. federal income tax treatment of "prepaid forward contracts" and similar instruments. While it is not clear whether the notes would be viewed as similar to the typical prepaid forward contract described in the notice, it is possible that any Treasury regulations or other guidance promulgated after consideration of these issues could materially and adversely affect the tax con



The following examples illustrate how the total value of payments received at maturity set forth in the table above are calculated.

Example 1: The lowest closing price of the Reference Stock during the Monitoring Period was \$5.52 but the Final Share Price is \$14.49. Because the Final Share Price of \$14.49 is greater than the Initial Share Price of \$13.80, you will receive a payment at maturity of \$1,000 per \$1,000 principal amount note.

Example 2: The lowest closing price of the Reference Stock during the Monitoring Period was \$5.52 and the Final Share Price is \$13.11. Because the Final Share Price of \$13.11 is less than the Initial Share Price of \$13.80 and the closing price of the Reference Stock declined by more than the Protection Amount on at least one day during the Monitoring Period, you will receive the Physical Delivery Amount, or at our election, the Cash Value thereof, at maturity. Because the Final Share Price of the Reference Stock is \$13.11, the total value of your final payment at maturity, whether in cash or shares of the Reference Stock, is \$950.00.

Example 3: The closing price of the Reference Stock does not decline, as compared with the Initial Share Price, by more than the Protection Amount on any day during the Monitoring Period prior to the Observation Date. However, the closing price of the Reference Stock on the Observation Date is \$5.52, a decline of more than the Protection Amount. Because the Final Share Price of \$5.52 is less than the Initial Share Price of \$13.80 and the Final Share Price has declined by more than the Protection Amount, you will receive the Physical Delivery Amount, or at our election, the Cash Value thereof, at maturity. Because the Final Share Price of the Reference Stock is \$5.52, the total value of your final payment at maturity, whether in cash or shares of the Reference Stock, is \$400.00.

Example 4: The Final Share Price of \$6.90 is less than the Initial Share Price of \$13.80 but does not decline by more than the Protection Amount and the closing price of the Reference Stock does not decline by more than the Protection Amount on any day during the Monitoring Period. Because the closing price of the Reference Stock has not declined by more than the Protection Amount, you will receive a payment at maturity of \$1,000 per \$1,000 principal amount note, even though the Final Share Price of \$6.90 is less than the Initial Share Price of \$13.80.

Regardless of the performance of the Reference Stock or the payment you receive at maturity, you will receive interest payments, for each \$1,000 principal amount note, in the aggregate amount of approximately \$80.00 over the term of the notes. If we had priced the notes on January 15, 2009, you would have received 72 shares of the Reference Stock or, at our election, the Cash Value thereof, at maturity, provided the Final Share Price declined from the Initial Share Price and the closing price of the Reference Stock declined by more than the Protection Amount from the Initial Share Price on at least one day during the Monitoring Period. The actual number of shares of the Reference Stock, or the Cash Value thereof, you may receive at maturity and the actual Protection Amount applicable to your notes may be more or less than the amounts displayed in this hypothetical and will depend in part on the closing price of the Reference Stock on the Pricing Date.

# **Supplemental Plan of Distribution Information**

If the notes linked to the common stock of GE priced on January 16, 2009, JPMSI, acting as agent for JPMorgan Chase & Co., would receive a commission of approximately \$57.80 per \$1,000 principal amount note and would use a portion of that commission to allow selling concessions to other dealers of approximately \$36.40 per \$1,000 principal amount note. This commission will include the projected profits that our affiliates expect to realize in consideration for assuming risks inherent in hedging our obligations under the notes. The concessions of approximately \$36.40 include concessions to be allowed to selling dealers and concessions to be allowed to any arranging dealer. The actual commission received by JPMSI may be more or less than \$57.80 and will depend on market conditions on the Pricing Date. In no event will the commission received by JPMSI exceed \$60.00 per \$1,000 principal amount note.

The total aggregate principal amount of the notes being offered by this supplemental term sheet may not be purchased by investors in this offering.
