



Barrier Optimization Securities with Partial Protection

Tactical Market Exposure to Complement Traditional Investments

JPMorgan Chase & Co. Notes linked to the Russell 2000® Index due on or about October 29, 2010

Investment Description

Barrier Optimization Securities with Partial Protection are securities issued by JPMorgan Chase & Co. with returns linked to the performance of the Russell 2000® Index (the "Index") (each, a "Note" and collectively, the "Notes"). The Notes are designed to provide exposure to the potential positive performance of the Index, subject to the Return Barrier (which will be determined on the Trade Date). If the Index Return is positive and the closing level of the Index is never greater than the Index Barrier (which will be determined on the Trade Date) on any trading day during the Observation Period, at maturity of the Notes you will receive an amount equal to the sum of (a) the principal amount of your Notes plus (b) the product of (i) the principal amount of your Notes multiplied by (ii) the Index Return multiplied by (iii) the Participation Rate, subject to the Return Barrier. If the Index Return is between 0% and -15% inclusive and the closing level of the Index is never greater than the Index Barrier on any trading day during the Observation Period, you will receive the principal amount of your Notes. If the Index Return is less than -15% and the closing level of the Index is never greater than the Index Barrier on any trading day during the Observation Period, at maturity you will lose 1% of your principal for every 1% decline in the Index beyond -15% and may lose up to 85% of your principal at maturity. If the closing level of the Index is greater than the Index Barrier on any trading day during the Observation Period, you will receive (a) the principal amount of your Notes plus (b) the product of (i) the principal amount of your Notes multiplied by (ii) a Conditional Coupon equal to 8.00%. **The partial principal protection feature applies only if you hold the Notes to maturity. Any payment on the Notes, including any principal protection, is subject to the creditworthiness of the JPMorgan Chase & Co. Investing in the Notes involves significant risks, including potential loss of up to 85% of your principal and a capped appreciation at maturity.**

Features

- ☐ **Tactical Investment Opportunity**—If you believe the Index will never close above the Index Barrier on any trading day during the Observation Period, the Notes provide an opportunity for exposure to positive Index Returns with reduced exposure to negative Index Returns at maturity. If the Index closes above the Index Barrier on any trading day during the Observation Period, you will receive only a return equal to the contingent payment of 8.00% at maturity and will have no exposure to positive or negative Index Returns.
- ☐ **Partial Protection Feature**—If you hold the Notes to maturity and the Index never closes above the Index Barrier on any trading day during the Observation Period, your investment will be protected from the first 15% decline in the Index, subject to the creditworthiness of JPMorgan Chase & Co., and will have 1-for-1 downside exposure to any negative index returns below -15%. If the Index closes above the Index Barrier on any trading day during the Observation Period, your investment will be fully principal protected, subject to the creditworthiness of JPMorgan Chase & Co.

As used in this free writing prospectus, the "Company," "we," "us" or "our" refers to JPMorgan Chase & Co.

The phrase "closing level of the Index" as used in this free writing prospectus shall have the meaning set forth under "Index Closing Level" as that term is defined in the accompanying product supplement no. UBS-10-A-I.

The Notes may be suitable for you if, among other considerations:

- ◆ You seek a 15-month investment with a return linked to the Index and you believe that the Index will appreciate during the Observation Period and that any appreciation in the Index is unlikely to exceed the Index Barrier on any trading day during the Observation Period.
- ◆ You seek an investment that offers partial (15%) principal protection on the Notes when held to maturity.
- ◆ You are willing and able to lose 1% of your principal amount of the Notes for every 1% that the Index Return is less than -15% if the Index never closes above the Index Barrier on any trading day during the Observation Period.
- ◆ You are willing and able to hold the Notes to maturity.
- ◆ You are willing to invest in securities the potential return of which is subject to a cap that is equal to the Return Barrier.
- ◆ You are willing to invest in securities for which there may be little or no secondary market and you accept that the secondary market will depend in large part on the price, if any, at which J.P. Morgan Securities Inc. is willing to trade the Notes.
- ◆ You are willing to forgo dividends paid on the equity securities underlying the Index.
- ◆ You do not seek current income from this investment.
- ◆ You are comfortable with the creditworthiness of JPMorgan Chase & Co., as Issuer of the Notes.

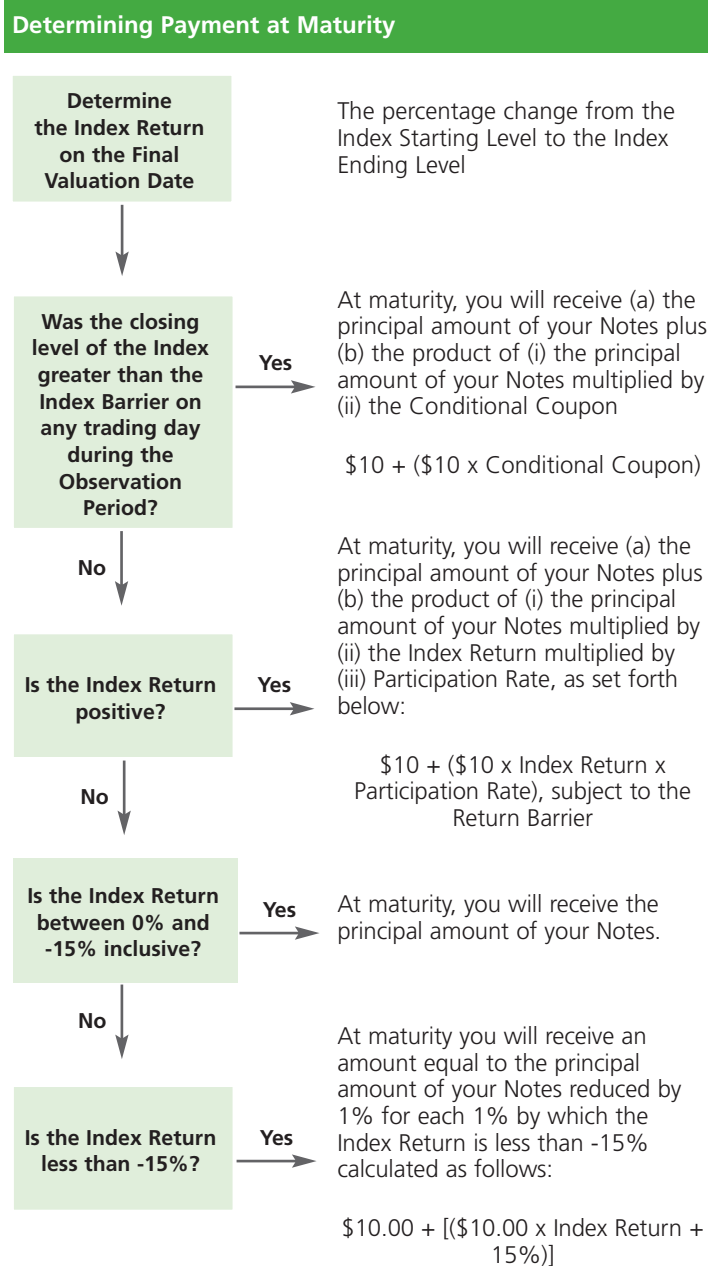
The Notes may not be suitable for you if, among other considerations:

- ◆ You do not believe the Index will appreciate during the Observation Period, or you believe the Index will appreciate during the Observation Period in an amount that exceeds the Index Barrier.
- ◆ You seek an investment that is 100% principal protected.
- ◆ You seek an investment the potential return of which is greater than a cap equal to the Return Barrier.
- ◆ You are unable or unwilling to hold the Notes to maturity.
- ◆ You prefer to receive dividends paid on the equity securities underlying the Index.
- ◆ You prefer the lower risk, and therefore accept the potentially lower returns, of fixed income investments with comparable maturities and credit ratings.
- ◆ You seek current income from this investment.
- ◆ You are not willing or unable to assume the credit risk associated with JPMorgan Chase & Co., as Issuer of the Notes.
- ◆ You seek an investment for which there will be an active secondary market.

Accordingly, if the Index Return is less than -15% and the closing level of the Index never exceeded the Index Barrier on any trading day during the Observation Period, you could lose up to 85% of the principal amount of your Notes depending on the percentage by which the Index Return is less than -15%.

Hypothetical Examples and Return Table of the Notes at Maturity

The following examples and table illustrate the payment at maturity for a \$10 principal amount Note on a hypothetical offering of the Note, on the following assumptions*:

Observation Period:	The period starting on, and including, the Trade Date and ending on, and including, the Final Valuation Date

* The actual Index Starting Level, Return Barrier and Index Barrier for the Notes will be set on the Trade Date. If the actual Return Barrier as determined on the Trade Date is less than 42.50%, your maximum payment at maturity will be lower than the hypothetical maximum payment at maturity shown below

Example 1 — The Index Ending Level is 650 and the closing level of the Index never exceeded the Index Barrier on any trading day during the Observation Period.

The Index Return is 30%, as set forth below:

$$\begin{aligned} & \frac{\text{Index Ending Level} - \text{Index Starting Level}}{\text{Index Starting Level}} \\ &= \frac{650 - 500}{500} \\ &= 30\% \end{aligned}$$

Since the Index Return is positive and the closing level of the Index never exceeded the Index Barrier on any trading day during the Observation Period, investors would receive at maturity the principal amount of each Note plus a payment equal to 100% of the Index Return, as set forth below:

$$\begin{aligned} \text{Payment at maturity per \$10.00 principal amount Note} &= \$10.00 + (\$10.00 \times \text{Index Return} \times \text{Participation Rate}) \\ &= \$10.00 + (\$10.00 \times 30\% \times 100\%) \\ &= \$10.00 + \$3.00 \\ &= \$13.00 \end{aligned}$$

Example 2 — The Index Ending Level is 450 and the closing level of the Index never exceeded the Index Barrier on any trading day during the Observation Period.

The Index Return is -10%, as set forth below:

$$\begin{aligned} & \frac{\text{Index Ending Level} - \text{Index Starting Level}}{\text{Index Starting Level}} \\ &= \frac{450 - 500}{500} \\ &= -10\% \end{aligned}$$

Since the Index Return is between 0% and -15% inclusive and the closing level of the Index never exceeded the Index Barrier on any trading day during the Observation Period, investors would receive at maturity the principal amount of each Note:

$$\text{Payment at maturity per \$10.00 principal amount Note} = \$10.00$$

Example 3 — The Index Ending Level is 300 and the closing level of the Index never exceeded the Index Barrier on any trading day during the Observation Period.

The Index Return is -40%, as set forth below:

$$\begin{aligned} & \frac{\text{Index Ending Level} - \text{Index Starting Level}}{\text{Index Starting Level}} \\ &= \frac{300 - 500}{500} \\ &= -40\% \end{aligned}$$

Since the Index Return is less than -15% and the closing level of the Index never exceeded the Index Barrier on any trading day during the Observation Period, investors would receive at maturity the principal amount of each Note reduced by 1% (or a fraction thereof) for each 1% (or a fraction thereof) by which the Index Return is less than -15%, as set forth below:

$$\begin{aligned} \text{Payment at maturity per \$10.00 principal amount Note} &= \$10.00 + [\$10.00 \times (\text{Index Return} + 15\%)] \\ &= \$10.00 + [\$10.00 \times (-40\% + 15\%)] \\ &= \$10.00 + (\$10.00 \times -25\%) \\ &= \$10.00 - \$2.50 \\ &= \$7.50 \end{aligned}$$

Example 4 — The Index Ending Level is 775 and the closing level of the Index exceeded the Index Barrier on at least one trading day during the Observation Period.

The Index Return is 55%, as set forth below:

$$\begin{aligned} & \frac{\text{Index Ending Level} - \text{Index Starting Level}}{\text{Index Starting Level}} \\ &= \frac{775 - 500}{500} \\ &= 55\% \end{aligned}$$

Since the closing level of the Index exceeded the Index Barrier on at least one trading day during the Observation Period, investors would receive at maturity (a) the principal amount of each Note plus (b) the product of (i) the principal amount of each Note multiplied by (ii) the Conditional Coupon, as set forth below:

$$\begin{aligned} \text{Payment at maturity per \$10.00 principal amount Note} &= \$10.00 + [(\$10.00 \times \text{Conditional Coupon})] \\ &= \$10.00 + [(\$10.00 \times 8.00\%)] \\ &= \$10.00 + \$0.80 \\ &= \$10.80 \end{aligned}$$

Example 5 — The Index Ending Level is 225 and the closing level of the Index exceeded the Index Barrier on at least one trading day during the Observation Period.

The Index Return is -55%, as set forth below:

$$\begin{aligned} & \frac{\text{Index Ending Level} - \text{Index Starting Level}}{\text{Index Starting Level}} \\ &= \frac{225 - 500}{500} \\ &= -55\% \end{aligned}$$

Since the closing level of the Index exceeded the Index Barrier on at least one trading day during the Observation Period, investors would receive at maturity (a) the principal amount of each Note plus (b) the product of (i) the principal amount of each Note multiplied by (ii) the Conditional Coupon, regardless of the Index Return, as set forth below:

$$\begin{aligned} \text{Payment at maturity per \$10.00 principal amount Note} &= \$10.00 + (\$10.00 \times \text{Conditional Coupon}) \\ &= \$10.00 + (\$10.00 \times 8.00\%) \\ &= \$10.00 + \$0.80 \\ &= \$10.80 \end{aligned}$$

What Are the Tax Consequences of an Investment in the Notes?

You should review carefully the section entitled “Certain U.S. Federal Income Tax Consequences” in the accompanying product supplement no. UBS-10-A-I. Subject to the limitations described therein, and based on certain factual representations received from us, in the opinion of our special tax counsel, Davis Polk & Wardwell LLP, your Notes should be treated as “open transactions” for U.S. federal income tax purposes. Assuming this characterization is respected, the gain or loss on your Notes should be treated as long-term capital gain or loss if you hold your Notes for more than a year, whether or not you are an initial purchaser of Notes at the issue price. However, the Internal Revenue Service (the “IRS”) or a court may not respect this characterization or treatment of the Notes, in which case the timing and character of any income or loss on the Notes could be significantly and adversely affected. For example, the IRS could assert that a “deemed” taxable exchange has occurred on the date on which a Barrier Event (as described in “Risk Factors — Risks Relating to the Notes Generally — The tax consequences of an investment in the notes are unclear” in the accompanying product supplement no. UBS-10-A-I) occurs, if any. If the IRS were successful in asserting that a taxable exchange has occurred, any gain on the deemed exchange would likely be capital gain. In this event, aspects of the tax treatment of the Note following the Barrier Event would be uncertain. In addition, in December 2007, Treasury and the IRS released a notice requesting comments on the U.S. federal income tax treatment of “prepaid forward contracts” and similar instruments, such as the Notes. The notice focuses in particular on whether to require holders of these instruments to accrue income over the term of their investment. It also asks for comments on a number of related topics, including the character of income or loss with respect to these instruments; the relevance of factors such as the nature of the underlying property to which the instruments are linked; the degree, if any, to which income (including any mandated accruals) realized by Non-U.S. Holders should be subject to withholding tax; and whether these instruments are or should be subject to the “constructive ownership” regime, which very generally can operate to recharacterize certain long-term capital gain as ordinary income that is subject to an interest charge. While the notice requests comments on appropriate transition rules and effective dates, any Treasury regulations or other guidance promulgated after consideration of these issues could materially and adversely affect the tax consequences of an investment in the Notes, possibly with retroactive effect. Both U.S. and Non-U.S. Holders should consult their tax advisers regarding the U.S. federal income tax consequences of an investment in the Notes, including possible alternative treatments and the issues presented by this notice. Non-U.S. Holders should also note that they may be withheld upon at a rate of up to 30% unless they have submitted a properly completed IRS Form W-8BEN or otherwise satisfied the applicable documentation requirements.

Subject to certain assumptions and representations received from us, the discussion in the preceding paragraph, when read in combination with the section entitled “Certain U.S. Federal Income Tax Consequences” in the accompanying product supplement, constitutes the full opinion of Davis Polk & Wardwell LLP regarding the material U.S. federal income tax consequences of owning and disposing of Notes.

Key Risks

An investment in the Notes involves significant risks. Investing in the Notes is not equivalent to investing directly in any of the component securities of the Index. These risks are explained in more detail in the “Risk Factors” section of the accompanying product supplement no. UBS-10-A-I.

Risks Relating to the Notes Generally

- ◆ **Your Investment in the Notes May Result in a Loss:** The Notes do not guarantee any return of principal in excess of \$1.50 per \$10.00 principal amount Note, subject to the credit risk of JPMorgan Chase & Co. Any such research, opinions or recommendations could affect the value of the Index or the equity securities included in the Index, and therefore the market value of the Notes.
- ◆ **Tax Treatment:** Significant aspects of the tax treatment of the Notes are uncertain. You should consult your tax adviser about your tax situation.
- ◆ **Potential JPMorgan Chase & Co. 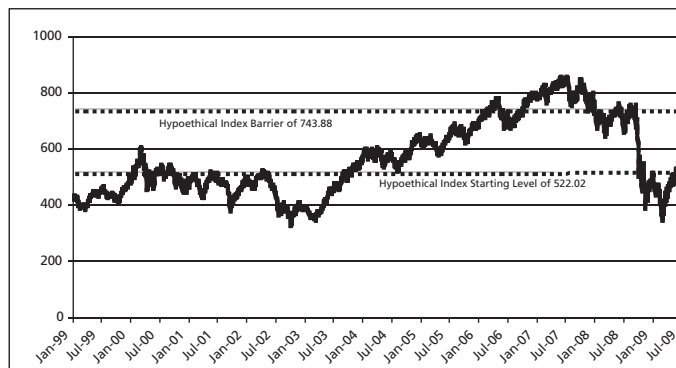
- ◆ **Risks Associated with Small Capitalization Stocks:** The stocks that constitute the Index are issued by companies with relatively small market capitalization. The stock prices of smaller companies may be more volatile than stock prices of large capitalization companies. Small capitalization companies may be less able to withstand adverse economic, market, trade and competitive conditions relative to larger companies. These companies tend to be less well-established than large market capitalization companies. Small capitalization companies are less likely to pay dividends on their stocks, and the presence of a dividend payment could be a factor that limits downward stock price pressure under adverse market conditions.

Russell 2000® Index

The Russell 2000® Index was developed by Russell Investment Group and is calculated, maintained and published by Russell Investments, a subsidiary of Russell Investment Group. As discussed more fully in the accompanying product supplement no. UBS-10-A-I under the heading "The Russell 2000® Index," the Russell 2000® Index is intended to track the performance of the small capitalization segment of the U.S. equity market and consists of the middle 2,000 companies included in the Russell 3000ETM Index. The Russell 3000ETM Index is composed of the 4,000 largest U.S. companies as determined by market capitalization and represents approximately 99% of the U.S. equity market. As a capitalization-weighted index, the Russell 2000® Index is calculated by adding the market values of its 2,000 components stocks, which are derived by multiplying the price of each stock by the number of available shares, to arrive at the total market capitalization of the 2,000 stocks. The total market capitalization is then divided by a divisor, which represents the "adjusted" capitalization of the Russell 2000® Index on the base date of December 31, 1986.

The graph below illustrates the daily performance of the Russell 2000® Index from January 4, 1999 to July 16, 2009 as well as a hypothetical Index Barrier, based on a hypothetical Index Starting Level of 522.02, which was the Russell 2000® Index closing level on July 16, 2009 and a hypothetical Return Barrier of 42.50%. (The actual Index Starting Level, Index Barrier and Return Barrier will be determined on the Trade Date. The actual Return Barrier will be between 40.00% and 45.00%).
