Selected Purchase Considerations

- UNLEVERAGED APPRECIATION POTENTIAL The notes provide the opportunity to earn an unleveraged return equal to the appreciation of the Index Return, without upside return enhancement, up to the Maximum Total Return on the notes of 29.00%. Accordingly, the maximum payment at maturity will be \$1,290 for every \$1,000 principal amount note. Because the notes are our senior unsecured obligations, payment of any amount at maturity is subject to our ability to pay our obligations as they become due.
- LIMITED PROTECTION AGAINST LOSS Payment at maturity of the principal amount of the notes is protected against a decline in the Ending Index Level, as compared to the Initial Index Level, of up to and including 20%. If the Ending Index Level declines by more than 20% as compared to the Initial Index Level, for every 1% decline of the Index beyond 20%, you will lose an amount equal to 1% of the principal amount of your notes. Accordingly, at maturity you will receive a payment equal to at least \$200 for each \$1,000 principal amount note.
- DIVERSIFICATION OF THE S&P MIDCAP 400[®] INDEX The return on the notes is linked to the S&P MidCap 400[®] Index. The S&P MidCap 400[®] Index consists of 400 component stocks selected to provide a performance benchmark for the medium market capitalization segment (between approximately \$1 billion to \$4 billion) of the U.S. equity markets. - CAPITAL GAINS TAX TREATMENT You should review carefully the section entitled "Certain U.S. Federal Income Tax Consequences" in the accompanying product supplement no. 39-A-II. As described therein, we and you will agree to characterize and treat the notes for U.S. federal income tax purposes as "open transactions". Subject to the limitations described therein, and based on certain factual representations received from us, in the opinion of our special tax counsel, Sidley Austin LLP, it is reasonable to treat your purchase and ownership of the notes as "open transactions" for U.S. federal income tax purposes. Assuming this characterization is respected, your gain or loss on the notes should be treated as long-term capital gain or loss if you hold the notes for more than a year, whether or not you are an initial purchaser of notes at the issue price. However, the Internal Revenue Service (the "IRS") or a court may not respect this characterization or treatment of the notes, in which case the timing and character of any income or loss on the notes could be significantly and adversely affected. For example, the notes could be treated as "contingent payment debt instruments", as discussed in the section entitled "Certain U.S. Federal Income Tax Consequences" in the accompanying product supplement no. 39-A-II.

Moreover, on December 7, 2007, the Treasury Department and the IRS released a notice requesting comments on the U.S. federal income tax treatment of "prepaid forward contracts" and similar instruments, such as the notes. The notice focuses in particular on whether to require holders of these instruments to accrue income over the term of their investment. It also asks for comments on a number of related topics, including the character of income or loss with respect to these instruments; the relevance of factors such as the nature of the underlying property to which the instruments are linked; the degree, if any, to which income (including any mandated accruals) realized by Non-U.S. Holders should be subject to withholding tax; and whether these instruments are or should be subject to the "constructive ownership" regime, which very generally can operate to recharacterize certain long-term capital gain as ordinary income that is subject to an interest charge. Your investment will be exposed to any decline in the Ending Index Level, as compared to the Initial Index Level, beyond the 20% buffer. Accordingly, you could lose up to \$800 for each \$1,000 principal amount note that you invest in.
- YOUR MAXIMUM GAIN ON THE NOTES IS LIMITED TO THE MAXIMUM TOTAL RETURN If the Ending Index Level is greater than the Initial Index Level, for each \$1,000 principal amount note, you will receive at maturity \$1,000 plus an additional amount that will not exceed the Maximum Total Return of 29.00% of the principal amount, regardless of the appreciation in the Index, which may be significant.

As a result, and as a general matter, the price, if any, at which JPMSI will be willing to purchase notes from you in secondary market transactions, if at all, will likely be lower than the original issue price and any sale prior to the maturity date could result in a substantial loss to you. This secondary market price will also be affected by a number of factors aside from the agent's commission and hedging costs, including those set forth under "Many Economic and Market Factors Will Impact the Value of the Notes" below. The notes are not designed to be short-term trading instruments. Accordingly, you should be able and willing to hold your notes to maturity.
- NO INTEREST OR DIVIDEND PAYMENTS OR VOTING RIGHTS As a holder of the notes, you will not receive interest payments, and you will not have voting rights or rights to receive cash dividends or other distributions or other rights that holders of equity securities composing the Index would have.
- LACK OF LIQUIDITY The notes will not be listed on any securities exchange. JPMSI intends to offer to purchase the notes in the secondary market but is not required to do so. Even if there is a secondary market, it may not provide enough liquidity to allow you to trade or sell the notes easily. Because other dealers are not likely to make a secondary market for the notes, the price at which you may be able to trade your notes is likely to depend on the price, if any, at which JPMSI is willing to buy the notes.
- **POTENTIAL CONFLICTS** We and our affiliates play a variety of roles in connection with the issuance of the notes, including acting as calculation agent and hedging our obligations under the notes. What Is the Total Return on the Notes at Maturity Assuming a Range of Performance for the Index?

The following table illustrates the hypothetical total return at maturity on the notes. The "total return" as used in this pricing supplement is the number, expressed as a percentage, that results from comparing the payment at maturity per \$1,000 principal amount note to \$1,000. The hypothetical total returns set forth below assume an Initial Index Level of 620.00 and reflect the Maximum Total Return on the notes of 29.00%. The hypothetical total returns set forth below are for illustrative purposes only and may not be the actual total returns applicable to a purchaser of the notes. Hypothetical Examples of Amounts Payable at Maturity

The following examples illustrate how the total returns set forth in the table above are calculated.

Example 1: The level of the Index increases from the Initial Index Level of 620 to an Ending Index Level of 775. Because the Ending Index Level of 775 is greater than the Initial Index Level of 620 and the Index Return of 25.00% does not exceed the Maximum Total Return of 29.00%, the investor receives a payment at maturity of \$1,250 per \$1,000 principal amount note, calculated as follows:

\$1,000 + (\$1,000 × 25%) = \$1,250

Example 2: The level of the Index decreases from the Initial Index Level of 620 to an Ending Index Level of 527. Because the Ending Index Level of 527 is less than the Initial Index Level of 620 by not more than the Buffer Amount of 20.00%, the investor receives a payment at maturity of \$1,000 per \$1,000 principal amount note.

Example 3: The level of the Index decreases from the Initial Index Level of 620 to an Ending Index Level of 310. Because the Ending Index Level of 310 is less than the Initial Index Level of 620 by more than the Buffer Amount of 20.00%, the investor receives a payment at maturity of \$700 per \$1,000 principal amount note, calculated as follows:

\$1,000 + [\$1,000 × (-50% + 20%)] = \$700

Example 4: The level of the Index increases from the Initial Index Level of 620 to an Ending Index Level of 868. Because the Ending Index Level of 868 is greater than the Initial Index Level of 620 and the Index Return of 40.00% exceeds the Maximum Total Return of 29.00%, the investor receives a payment at maturity of \$1,290 per \$1,000 principal amount note, the maximum payment on the notes. **Example 5: The level of the Index decreases from the Initial Index Level of 620 to an Ending Index Level of 0.** Because the Ending Index Level of 0 is less than the Initial Index Level of 620 by more than the Buffer Amount of 20.00%, the investor receives a payment at maturity of \$200 per \$1,000 principal amount note, which reflects the principal protection provided by the Buffer Amount of 20.00%, calculated as follows:
