Supplemental Information About the EURO STOXX 50® Index

The EURO STOXX 50® Index is calculated, maintained and published by STOXX Limited. STOXX Limited was formerly a joint venture between Deutsche Börse AG, Dow Jones & Company and SWX Swiss Exchange. Following a change in the shareholders of STOXX Limited, the joint venture now comprises Deutsche Börse AG and SIX Group AG. In addition, on March 1, 2010, STOXX Limited announced the removal of the "Dow Jones" prefix from all of its indices, including the EURO STOXX 50® Index.

Accordingly, all references in the accompanying product supplement no. 168-A-I to the "Dow Jones EURO STOXX 50® Index." will be deemed to refer to the "EURO STOXX 50® Index." We have entered into a non-exclusive license with STOXX Limited (including its affiliates) for the right to use the EURO STOXX 50® Index in connection with the offering of securities, including the notes.

Supplemental Terms of the Notes

For purposes of the notes offered by this term sheet, notwithstanding anything to the contrary set forth under "General Terms of the Notes — Calculation Agent" in the accompanying product supplement 168-A-I, all calculations with respect to the Exchange Rate on any trading day will be rounded to five significant figures, with fives rounded up (*e.g.*, 123.456 will be rounded to 123.46).

What Is the Index Return for Each Component Index and the Corresponding Component Return for Each Basket Component Assuming a Range of Performances for Each Component Index?

The following table illustrates the hypothetical Index Return for each Component Index and the corresponding Component Return for each Basket Component. Hypothetical Examples of Amount Payable at Maturity

The following examples illustrate how the payment at maturity is calculated under various hypothetical circumstances. You should review the following examples in conjunction with the hypothetical table set forth above, including the underlying assumptions described above. The hypothetical payments at maturity set forth below are for illustrative purposes only and may not be the actual payment at maturity applicable to a purchaser of the notes. The numbers appearing in the following examples have been rounded for ease of analysis.

Example 1: The level of the EURO STOXX 50® Index increases from an Initial Index Level of 4050 to an Ending Index Level of 4151.25, the FTSE™ 100 Index increases from an Initial Index Level of 9600 to an Ending Index Level of 9696 and the level of the TOPIX® Index increases from an Initial Index Level of 11.4 to an Ending Index Level of 11.514. Because the Ending Index Level of each Component Index is greater than its Initial Index Level, and the Underlying Returns of 2.50% for the EURO STOXX 50® Index, 1.00% for the FTSE™ 100 Index and 1.00% for the TOPIX® Index, each multiplied by 2, do not exceed the applicable Maximum Returns of 16.00%, 13.25% and 13.08%, respectively, the Basket Return is calculated as follows:

$$[(2.5\% \times 2) \times 51\%] + [(1\% \times 2) \times 25\%] + [(1\% \times 2) \times 24\%] = 3.530\%$$

Accordingly, the investor receives a payment at maturity of 1,035.30 per 1,000 principal amount note, calculated as follows: $1,000 \times 3.530\%$ = 1,035.30

Example 2: The level of the EURO STOXX 50[®] Index increases from an Initial Index Level of 4050 to an Ending Index Level of 4860, the FTSETM 100 Index increases from an Initial Index Level of 9600 to an Ending Index Level of 12480 and the level of the TOPIX[®] Index

increases from an Initial Index Level of 11.4 to an Ending Index Level of 15.96. Because the Ending Index Level of each Component Index is greater than its Initial Index Level, and the Underlying Returns of 20.00% for the EURO STOXX 50® Index, 30.00% for the FTSETM 100 Index and 40.00% for the TOPIX® Index, each multiplied by 2, exceed the applicable Maximum Returns of 16.00%, 13.25% and 13.08%, respectively, the Basket Return is calculated as follows:

$$(16.00\% \times 51\%) + (13.25\% \times 25\%) + (13.08\% \times 24\%) = 14.612\%$$

Accordingly, the investor receives a payment at maturity of \$1,146.12 per \$1,000 principal amount note, which reflects the maximum payment at maturity, calculated as follows:

$$1,000 + (1,000 \times 14.612\%) = 1,146.12$$

Example 3: The level of the EURO STOXX 50® Index increases from an Initial Index Level of 4050 to an Ending Index Level of 4860, the FTSETM 100 Index increases from an Initial Index Level of 9600 to an Ending Index Level of 9696 and the level of the TOPIX® Index increases from an Initial Index Level of 11.4 to an Ending Index Level of 11.514. Because the Ending Index Level of each Component Index is greater than its Initial Index Level, and the Underlying Return of 20.00% for the EURO STOXX 50® Index multiplied by 2 exceeds the applicable Maximum Return of 16.00%, while the Underlying Returns of 1% for the FTSETM 100 Index and 1% for the TOPIX® Index, each multiplied by 2, do not exceed the applicable Maximum Returns of 13.25% and 13.08%, respectively, the Basket Return is calculated as follows:

$$(16.00\% \times 51\%) + [(1\% \times 2) \times 25\%] + [(1\% \times 2) \times 24\%] = 9.140\%$$

Accordingly, the investor receives a payment at maturity of \$1091.40 per \$1,000 principal amount note, calculated as follows:

$$$1,000 + ($1,000 \times 9.140\%) = $1,091.40$$

Example 4: The level of the EURO STOXX 50® Index decreases from an Initial Index Level of 4050 to an Ending Index Level of 3847.50, the FTSETM 100 Index decreases from an Initial Index Level of 9600 to an Ending Index Level of 9120 and the level of the TOPIX® Index decreases from an Initial Index Level of 11.4 to an Ending Index Level of 10.83. Because the Ending Index Level of each Component Index is less than its Initial Index Level by not more than 10%, the investor receives a payment at maturity of \$1,000 per \$1,000 principal amount note.

Example 5: The level of the EURO STOXX 50® Index decreases from an Initial Index Level of 4050 to an Ending Index Level of 2835, the FTSETM 100 Index decreases from an Initial Index Level of 9600 to an Ending Index Level of 7680 and the level of the TOPIX® Index decreases from an Initial Index Level of 11.4 to an Ending Index Level of 6.84. Because the Ending Index Level of each Component Index is less than its Initial Index Level by more than 10%, the Basket Return is calculated as follows:

$$([(-30\% + 10\%) \times 1.1111] \times 51\%) + ([(-20\% + 10\%) \times 1.1111] \times 25\%) + ([(-40\% + 10\%) \times 1.1111] \times 24\%) = -22.111\%$$

Accordingly, the investor receives a payment at maturity of \$778.89 per \$1,000 principal amount note, calculated as follows:

$$1,000 + (1,000 \times -22.111\%) = 778.89$$

Example 6: The level of the EURO STOXX 50® Index decreases from an Initial Index Level of 4050 to an Ending Index Level of 2835, the FTSETM 100 Index decreases from an Initial Index Level of 9600 to an Ending Index Level of 9120 and the level of the TOPIX® Index decreases from an Initial Index Level of 11.4 to an Ending Index Level of 6.84. Because the Ending Index Level of the FTSETM 100 Index is less than its Initial Index Level by not more than 10% and the Ending Index Level of each of the other Component Indices is less than its Initial Index Level by more than 10%, the Basket Return is calculated as follows:

$$([(-30\% + 10\%) \times 1.1111] \times 51\%) + 0\% + ([(-40\% + 10\%) \times 1.1111] \times 24\%) = -19.333\%$$

Accordingly, the investor receives a payment at maturity of \$806.67 per \$1,000 principal amount note, calculated as follows:

$$1,000 + (1,000 \times -19.333\%) = 806.67$$

Example 7: The level of the EURO STOXX 50® Index increases from an Initial Index Level of 4050 to an Ending Index Level of 4252.50, the FTSETM 100 Index decreases from an Initial Index Level of 9600 to an Ending Index Level of 7680 and the level of the TOPIX® Index decreases from an Initial Index Level of 11.4 to an Ending Index Level of 6.84. Because the Ending Index Level of the EURO STOXX 50® Index is greater than its Initial Index Level, and the Underlying Return of 5% multiplied by 2 does not exceed the applicable Maximum Return of 16.00%, and the Ending Index Level of each of the other Component Indices is less than its Initial Index Level by more than 10%, the Basket Return is calculated as follows:

$$[(5\% \times 2) \times 51\%] + ([(-20\% + 10\%) \times 1.1111] \times 25\%) + ([(-40\% + 10\%) \times 1.1111] \times 24\%) = -5.678\%$$

Accordingly, the investor receives a payment at maturity of \$943.22 per \$1,000 principal amount note, calculated as follows:

$$$1,000 + ($1,000 \times -5.678\%) = $943.22$$

Hypothetical Examples of Index Return Calculations

The following examples illustrate how the Index Return for a Component Index is calculated in different hypothetical scenarios based on a range of performances of the closing level of the EURO STOXX 50® Index and the Exchange Rate for the EURO STOXX 50® Index. The examples below use the EURO STOXX 50® Index as the Component Index and assume that the hypothetical closing level of the EURO STOXX 50® Index on the pricing date is 3000, the hypothetical Exchange Rate for the EURO STOXX 50® Index on the pricing date is 1.35 and, therefore, the hypothetical Initial Index Level for EURO STOXX 50® Index is 4050. The examples below also assume that the Ending Index Level for the EURO STOXX 50® Index on a single date, which we refer to as the final Ending Averaging Date. The hypothetical Index Returns set forth below are for illustrative purposes only and may not be the actual Index Returns for the EURO STOXX 50® Index or for any other Component Index. The numbers appearing in the following examples have been rounded for ease of analysis.

Example 1: The closing level of the EURO STOXX 50[®] Index increases from 3000 on the pricing date to 3300 on the final Ending Averaging Date, and the Exchange Rate of the EURO STOXX 50[®] Index remains flat at 1.35 from the pricing date to the final Ending Averaging Date. The Ending Index Level is equal to:

3300 X 1.35 = 4455

Because the Ending Index Level of 4455 is greater than the Initial Index Level of 4050, the Index Return is positive and is equal to 10%.

Example 2: The closing level of the EURO STOXX 50[®] Index remains flat at 3000 from the pricing date to the final Ending Averaging Date, and the Exchange Rate of the EURO STOXX 50[®] Index increases from 1.35 on the pricing date to 1.62 on the final Ending Averaging Date. The Ending Index Level is equal to:

 $3000 \times 1.62 = 4860$

Because the Ending Index Level of 4860 is greater than the Initial Index Level of 4050, the Index Return is positive and is equal to 20%.

Example 3: The closing level of the EURO STOXX 50[®] Index increases from 3000 on the pricing date to 3300 on the final Ending Averaging Date, and the Exchange Rate of the EURO STOXX 50[®] Index increases from 1.35 on the pricing date to 1.62 on the final Ending Averaging Date. The Ending Index Level is equal to:

3300 x 1.62 = 5346

Because the Ending Index Level of 5346 is greater than the Initial Index Level of 4050, the Index Return is positive and is equal to 32%, which is greater than the Maximum Return for the Basket Component linked to the EURO STOXX 50[®] Index and therefore the Component Return for this Basket Component will be limited to the Maximum Return for such Basket Component.

Example 4: The closing level of the EURO STOXX 50[®] Index increases from 3000 on the pricing date to 3300 on the final Ending Averaging Date, but the Exchange Rate of the EURO STOXX 50[®] Index decreases from 1.35 on the pricing date to 1.08 on the final Ending Averaging Date.

The Ending Index Level of the EURO STOXX 50[®] Index is equal to:

3300 x 1.08 = 3564

Even though the closing level of the EURO STOXX 50[®] Index has increased by 10%, because the Exchange Rate of the EURO STOXX 50[®] Index has decreased by 20%, the Ending Index Level of 3564 is less than the Initial Index Level of 4050, and the Index Return is negative and is equal to -12%.

Example 5: The closing level of the EURO STOXX 50® Index decreases from 3000 on the pricing date to 2700 on the final Ending Averaging Date, but the Exchange Rate of the EURO STOXX 50® Index increases from 1.35 on the pricing date to 1.62 on the final Ending Averaging Date. The Ending Index Level is equal to:

2700 X 1.62 = 4374

Even though the closing level of the EURO STOXX 50[®] Index has decreased by 10%, because the Exchange Rate of the EURO STOXX 50[®] Index has increased by 20%, the Ending Index Level of 4374 is greater than the Initial Index Level of 4050, and the Index Return is positive and is equal to 8%.

Example 6: The closing level of the EURO STOXX 50[®] Index decreases from 3000 on the pricing date to 2700 on the final Ending Averaging Date, and the Exchange Rate of the EURO STOXX 50[®] Index decreases from 1.35 on the pricing date to 1.08 on the final Ending Averaging Date. The Ending Index Level is equal to:

2700 x 1.08 = 2916

Because the Ending Index Level of 2916 is less than the Initial Index Level of 4050, the Index Return is negative and is equal to -28%.

Example 7: The closing level of the EURO STOXX 50[®] Index remains flat at 3000 from the pricing date to the final Ending Averaging Date, and the Exchange Rate of the EURO STOXX 50[®] Index decreases from 1.35 on the pricing date to 1.08 on the final Ending Averaging Date. The Ending Index Level is equal to:

3000 x 1.08 = 3240

Because the Ending Index Level of 3240 is less than the Initial Index Level of 4050, the Index Return is negative and is equal to -20%.

Example 8: The closing level of the EURO STOXX 50[®] Index decreases from 3000 on the pricing date to 2700 on the final Ending Averaging Date, and the Exchange Rate of the EURO STOXX 50[®] Index remains flat at 1.35 from the pricing date to the final Ending Averaging Date.

The Ending Index Level is equal to:

2700 X 1.35 = 3645

Because the Ending Index Level of 3645 is less than the Initial Index Level of 4050, the Index Return is negative and is equal to -10%.

- APPRECIATION POTENTIAL The notes provide the opportunity to enhance equity returns by multiplying a positive Index Return for each Component Index by two, including any positive return caused by a change in the applicable Exchange Rate, up to the Maximum Return of 16.00% for the EURO STOXX 50® Index, 13.25% for the FTSE™ 100 Index and 13.08% for the TOPIX® Index. The TOPIX® Index is a weighted index, the component stocks of which are reviewed and selected every six months, with the market price of each component stock multiplied by the number of shares listed. - POTENTIAL EXCHANGE RATE GAINS Appreciation of the applicable Component Currency against the U.S. dollar may increase the Ending Index Level for the applicable Component Index, which is used to calculate the Index Return of such Component Index. Because the Basket Return is based on the Component Return of each Component Index, the Basket Return, and therefore the payment at maturity, is linked to the Ending Index Level for each Component Index, and you will benefit from any such appreciation, unless offset by a decrease in the closing level of one or more of the Component Indices or depreciation of one or more of the other Component Currencies against the U.S. dollar.


- EVEN THOUGH THE COMPONENT CURRENCIES TRADE AROUND-THE-CLOCK, THE NOTES WILL NOT Because the inter-bank market in foreign currencies is a global, around-the-clock market, the hours of trading for the notes, if any, will not conform to the hours during which the Component Currencies are traded. Consequently, significant price and rate movements may take place in the underlying foreign exchange markets that will not be reflected immediately in the price of the notes. Additionally, there is no systematic reporting of last-sale information for foreign currencies which, combined with the limited availability of quotations to individual investors, may make it difficult for many investors to obtain timely and accurate data regarding the state of the underlying foreign exchange markets.
- THE NOTES ARE SUBJECT TO CURRENCY EXCHANGE RISK Foreign currency exchange rates vary over time, and may vary
 considerably during the term of the notes. The value of each Component Currency and the U.S. dollar is at any moment a result of
 the supply and demand for that currency. Changes in foreign currency exchange rates result over time from the interaction of
 many factors directly or indirectly affecting economic and political conditions in the Component Currencies' countries, the United
 States, and economic and political developments in other relevant countries.
 Of particular importance to potential currency exchange risk are:
 - existing and expected rates of inflation;
 - existing and expected interest rate levels;
 - the balance of payments in the members nations of the European Union (including the United Kingdom), Japan and the United States and between each country and its major trading partners; and
 - the extent of governmental surplus or deficit in the members nations of the European Union (including the United Kingdom), Japan and the United States.


All of these factors are, in turn, sensitive to the monetary, fiscal and trade policies pursued by the European Union (including the United Kingdom and other members countries), Japan, the United States and those of other countries important to international trade and finance.


- THE RECENT GLOBAL FINANCIAL CRISIS CAN BE EXPECTED TO HEIGHTEN CURRENCY EXCHANGE RISKS In periods of financial turmoil, capital can move quickly out of regions that are perceived to be more vulnerable to the effects of the crisis than others with sudden and severely adverse consequences to the currencies of those regions. In addition, governments around the world, including the United States government and governments of other major world currencies, have recently made, and may be expected to continue to make, very significant interventions in their economies, and sometimes directly in their currencies. Such interventions affect currency exchange rates globally and, in particular, the value of the Component Currencies relative to the U.S. dollar. Further interventions, other government actions or suspensions of actions, as well as other changes in government economic policy or other financial or economic events affecting the currency markets, may cause currency exchange rates to fluctuate sharply in the future, which could have a material adverse effect on the value of the notes and your return on your investment in the notes at maturity.







The exchange rates set forth above and displayed in the graphs below are for illustrative purposes only and do not form part of the calculation of the Basket Return. 



