

Hypothetical Examples of Amounts Payable at Maturity

The following examples illustrate how the total returns set forth in the table above are calculated.

Example 1: The level of the Index increases from the Initial Index Level of 760.00 to an Ending Index Level of 767.60. Because the Ending Index Level of 767.60 is greater than the Initial Index Level of 760.00 and the Index Return of 1% multiplied by 2 does not exceed the Maximum Return of 17.70%, the investor receives a payment at maturity of \$1,020 per \$1,000 principal amount note. calculated as follows:

 $1,000 + [1,000 \times (1\% \times 2)] = 1,020$

Example 2: The level of the Index decreases from the Initial Index Level of 760.00 to an Ending Index Level of 684.00. Although the Index Return is negative, because the Ending Index Level of 684.00 is less than the Initial Index Level of 760.00 by not more than the Buffer Amount of 10%, the investor receives a payment at maturity of \$1,000 per \$1,000 principal amount note.

Example 3: The level of the Index increases from the Initial Index Level of 760.00 to an Ending Index Level of 988.00. Because the Ending Index Level of 988.00 is greater than the Initial Index Level of 760.00 and the Index Return of 30% multiplied by 2 exceeds the Maximum Return of 17.70%, the investor receives a payment at maturity of \$1,177.00 per \$1,000 principal amount note, the maximum payment on the notes.

Example 4: The level of the Index decreases from the Initial Index Level of 760.00 to an Ending Index Level of 532.00. 
