
Return Profile



Hypothetical Examples of Amounts Payable at Maturity

The following examples illustrate how the total returns set forth in the table above are calculated.

Example 1: The level of the Index increases from the Initial Index Level of 900.00 to an Ending Index Level of 945.00. Because the Ending Index Level of 945.00 is greater than the Initial Index Level of 900.00 and the Index Return of 5% multiplied by 1.5 does not exceed the hypothetical Maximum Return of 15%, the investor receives a payment at maturity of \$1,075 per \$1,000 principal amount note, calculated as follows:

\$1,000 + [\$1,000 x (5% x 1.5)] = \$1,075 Example 2: The level of the Index decreases from the Initial Index Level of 900.00 to an Ending Index Level of 810.00. Although the Index Return is negative, because the Ending Index Level of 810.00 is less than the Initial Index Level of 900.00 by not more than the Buffer Amount of 10%, the investor receives a payment at maturity of \$1,000 per \$1,000 principal amount note.

Example 3: The level of the Index increases from the Initial Index Level of 900.00 to an Ending Index Level of 1,170.00. Because the Ending Index Level of 1,170.00 is greater than the Initial Index Level of 900.00 and the Index Return of 30% multiplied by 1.5 exceeds the hypothetical Maximum Return of 15%, the investor receives a payment at maturity of \$1,150 per \$1,000 principal amount note, the maximum payment on the notes.

Example 4: The level of the Index decreases from the Initial Index Level of 900,00 to an Ending Index Level of 630.00. Because the Index Return is negative and the Ending Index Level of 630.00 is less than the Initial Index Level of 900.00 by more than the Buffer Amount of 10%, the investor receives a payment at maturity of \$800 per \$1,000 principal amount note, calculated as follows:

 $1,000 + [1,000 \times (-30\% + 10\%)] = 800$

Example 5: The level of the Index decreases from the Initial Index Level of 900.00 to an Ending Index Level of o.oo. Because the Index Return is negative and the Ending Index Level of o.oo is less than the Initial Index Level of 900.00 by more than the Buffer Amount of 10%, the investor receives a payment at maturity of \$100 per \$1,000 principal amount note, calculated as follows:

 $1,000 + [1,000 \times (-100\% + 10\%)] = 100$
