We operate in a highly competitive market cybersecurity, and the size and resources of some of our larger competitors may allow them to compete more effectively than we can.

Enterprise sales cycle tend to be long (3 to 6+ months) and can impact our short term cashflow position.

We are actively addressing this challenge by adding a 'starter' SaaS offering for the enterprises that tend to have a much short (~ 30 days) sales cycle.

Current adverse macro economic trends might impact enterprise IT's short term budgets and make it hard for them to adopt a new solution like ours.

Hiring specialized and highly skilled technical resources (software programmers, cyber threat analysts, etc.) continues to be very challenging in this tight job market.

Scaling Go-To-Market for a new SaaS company requires significant marketing budgets and can negatively impact the cashflow position.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

Management's Discussion and Analysis of Financial Condition and Results of Operations

2023 was a year of great learning for the TruKno team in terms of what we need to do to improve our product offerings and revenue. In this financial report, I have have outline our detail plan to improve our traction and revenue in 2024.

OverviewWhat does your Company do? We provide highly curated cyber threat intelligence & detections for the emerging cyber threat to mid to large enterprises and managed service providers.

At the end of 2023, we had a total of \$233,800 in cash and equivalents.

Milestones At this moment we have close to \$800K worth of enterprise deals in trial. Out of this pipeline, about \$400K are in contract discussions/negotiations. In order to increase our sales funnel, we are in the process of launch a 'premium' version of our cyber threat dashboards that will allow us to gain significantly highly enterprise user base that we can target for upselling. Over the last 9 months we have built a unique capability to threat hunt/detect latest cyber attack with our pre-correlated detection rules called 'Detection Chain'. We are planning a major marketing push this summer to get the word out about this differentiated capability. This new capability has allowed us to double our price point to the enterprise.

Historical Results of Operations

- *Revenues & Gross Margin.* For the period ended December 31, 2023, the Company had revenues of \$99,600 compared to the year ended December 31, 2022.
- *Assets.* As of December 31, 2023, the Company had total assets of \$187,450, including \$149,914 in cash. As of December 31, 2022, the Company had \$158,301 in total assets, including \$64,352 in cash.
- *Net Loss.* The Company has had net losses of \$94,107 and net losses of \$74,122 for the fiscal years ended December 31, 2023 and December 31, 2022, respectively.
- *Liabilities.* The Company's liabilities totaled \$75,071 for the fiscal year ended December 31, 2023 and \$26,171 for the fiscal year ended December 31, 2022. These liabilities are related to unearned revenue related to annual SaaS contracts with our enterprises.

Liquidity & Capital Resources

To-date, the company has been financed with \$233,800 original owner's equity investment and \$190,206 WeFunder SAFE Agreement. We are actively taking to venture capital investors to raise a SEED round to scale our startup.

Runway & Short/Mid Term Expenses

TruKno, LLC cash in hand is \$149,914, as of December 2023. Over the last three months, revenues have averaged \$10,250/month, cost of goods sold has averaged \$0/month, and operational expenses have averaged \$15,594/month, for an average burn rate of \$5,344 per month. At this moment we have close to \$800K worth of enterprise deals in trial. Out of this pipeline, about \$400K are in contract discussions/negotiations. Our number one priority right now is to push these deals to close to improve our cashflow.

The Lead Investor. As described above, each Investor that has entered into the Investor Agreement will grant a power of attorney to make voting decisions on

behalf of that Investor to the Lead Investor (the "Proxy"). The Proxy is irrevocable unless and until a Successor Lead Investor takes the place of the Lead Investor, in which case, the Investor has a five (5) calendar day period to revoke the Proxy. Pursuant to the Proxy, the Lead Investor or his or her successor will make voting decisions and take any other actions in connection with the voting on Investors' behalf.

The Lead Investor is an experienced investor that is chosen to act in the role of Lead Investor on behalf of investors that have a Proxy in effect. The Lead Investor will be chosen by the Company and approved by Wefunder Inc. and the identity of the initial Lead Investor will be disclosed to Investors before Investors make a final investment decision to purchase the securities related to the Company.

The Lead Investor can quit at any time or can be removed by Wefunder Inc. for cause or pursuant to a vote of investors as detailed in the Lead Investor Agreement. In the event the Lead Investor quits or is removed, the Company will choose a Successor Lead Investor who must be approved by Wefunder Inc. The identity of the Successor Lead Investor will be disclosed to Investors, and those that have a Proxy in effect can choose to either leave such Proxy in place or revoke such Proxy during a 5-day period beginning with notice of the replacement of the Lead Investor.

The Lead Investor will not receive any compensation for his or her services to the SPV. The Lead Investor may receive compensation if, in the future, Wefunder Advisors LLC forms a fund ("Fund") for accredited investors for the purpose of investing in a non-Regulation Crowdfunding offering of the Company. In such as circumstance, the Lead Investor may act as a portfolio manager for that Fund (and as a supervised person of Wefunder Advisors) and may be compensated through that role.

Although the Lead Investor may act in multiple roles with respect to the Company's offerings and may potentially be compensated for some of its services, the Lead Investor's goal is to maximize the value of the Company and therefore maximize the value of securities issued by or related to the Company. As a result, the Lead Investor's interests should always be aligned with those of Investors. It is, however, possible that in some limited circumstances the Lead Investor's interests could diverge from the interests of Investors, as discussed in section 8 above.
