Company may not successfully develop, market and launch all products. Company is seeking to develop and market new business models, new game products, and new technologies. While it has a history of successfully developing and marketing gaming products, much of Company's business plan involves new products that have not yet been fully designed, developed and/or been proven and will require ongoing capital funding, the expertise of Company's employees, and significant time and effort to develop and realize meaningful returns from this investment. It is possible that Company's products may never be fully developed or launched, and there may never be liquidity

financed, and there may never be liquidity.

Company has limited assets and operating revenues. Delays in financing, negative market conditions, delays completing intended plans, additional expenses, and other unforeseen complications often encountered by small business ventures may cause Company to encounter difficulties that prevent it from operating its business as intended.

Expenses may be higher than anticipated. Company utilizes contract resources in many cost-advantageous countries such as Argentina, Uruguay, and Romania. Changes in laws or enforcement or civil unrest could impact our ability to operate. Company may not have, or may not be able to obtain, or may not be able to obtain at a reasonable cost, the resources needed to successfully develop, launch and operate Company's products.

Company may require more capital. If Company seeks to raise additional capital for any number of legitimate reasons, there is no guarantee that Company will be able to raise such capital. If Company is unable to raise such additional capital, Company may be unable to successfully achieve the Company's goals and objectives as anticipated. Additionally, the terms, conditions and dilutive effects of such future capital may cause Company to be unable to fulfill its intended goals and objectives despite good faith efforts to develop and launch Company's products.

The SAFE offering is being conducted on a best-efforts basis. Earlier investors assume greater risks than later investors. The value of companies such as ours increases in relation to increases in our capital, users, revenues, and later in relation to our profits. As Company develops a trajectory of success and growth, it becomes easier to raise additional capital, perhaps even with non-dilutive capital such as debt financing. We are offering increasing valuation tranches to catalyze a positive feedback loop and honor earlier investors with lower valuation caps. No guarantee can be given that sufficient proceeds will be available to fully develop, launch, and market our products.

The tax treatment of the SAFE is uncertain, and there may be adverse tax consequences for the Investors upon certain future events. The tax characterization of the SAFE, although generally characterized as equity, is uncertain. The purchase of a SAFE may result in adverse tax consequences to Investors, including withholding taxes, income taxes and tax reporting requirements. Investors should consult with and must rely upon the advice of their own professional tax advisors with respect to the tax treatment of a purchase of the SAFE and its anticipated conversion.

Statements Regarding Forward-Looking Information. Our materials contain "forward-looking statements" that involve risks and uncertainties, as well as assumptions that, if they never materialize or prove incorrect, could cause the results of the Company to differ materially from those expressed or implied by such forward-looking statements. All statements, other than the statements of historical fact, are statements that may be deemed forward-looking statements, including any projections of earnings, revenues, or other financial matters; any statements of the plans, strategies, and objectives of management for future operations; any statements concerning the future development and market acceptance of proposed products; any statements regarding future economic conditions or performance; statements of

belief and any statement or assumptions underlying any of the foregoing.

Company's Products may not be widely adopted and may have limited users. It is possible that Company's games and in-app purchases will not be widely adopted. The team has developed hit products before, at Company and at previous employers, and believes follow-on products to Eternium will be well-received. However, past accomplishments are not a guarantee of future performance. Such a lack of use or interest would negatively impact Company's revenue and viability.

Alternative products will compete with Company's games. The gaming market being so large, it is almost certain that alternative products have been or will be established that are materially similar or superior to Company's games. Competition with these alternative products could negatively impact interest in or use of Company's games. Moreover, many of the features and functions of Company's games may not be protectable and may be copied by competitors.

Company may be the target of malicious cyberattacks or launch exploitable flaws in its underlying code, which may result in security breaches and the ability of Company to carry on its business. If Company's security is compromised or subjected to attacks that frustrate or thwart our users' ability to access Company's games, users may cut back on or stop using Company's games altogether, which could have seriously negative impacts on Company's ability to survive. There can be no assurances that Company's games will be uninterrupted or fully secure, which may result in an unwillingness of users to access, adopt and utilize Company's games. Further, Company's games may also be the target of malicious attacks seeking to identify and exploit weaknesses in the software, which may result in the loss of use and adoption. In any such event, if the launch of the Company's games does not occur, if Company's games are not widely adopted, or if Company's games are susceptible to malicious cyberattacks, Investors may lose all of their investment. Company intends to use responsible software engineering practices to mitigate this risk.

If Company's games are unable to satisfy data protection, security, privacy, and other government and industry-specific requirements, its growth could be harmed. There are a number of data, security, privacy and other government and industry-specific protections and requirements, including those that require companies to notify individuals of data security incidents involving certain types of personal data. Security compromises could harm Company's reputation, erode user confidence in the effectiveness of its security measures, negatively impact its ability to attract new users, or cause existing users to stop using Company's Products.

Company may not be able to protect its proprietary rights. Company develops proprietary software, creative works, and technologies. We attempt to protect our software, creative works, and production techniques under copyright, trademark, patent and trade secret laws, as well as through contractual restrictions on disclosure, copying and distribution. Software and services are susceptible to unauthorized copying. Unauthorized third parties may be able to copy or reverse engineer our software to obtain and use programming or production techniques that we regard as proprietary. In addition, our competitors could independently

proprietary. In addition, our competitors could independently develop products or technologies substantially equivalent or superior to our own.

Company may be subject to intellectual property claims. As the number of software and technology products increases and the features of these products continue to overlap, software and technology developers may increasingly become subject to infringement claims. Company's software products may inadvertently infringe upon the intellectual property rights of others. Our software products could become subject to the intellectual property rights of others. Although we believe that we are making reasonable efforts to ensure that our products do not violate the intellectual property rights of others, it is possible that third parties may still claim infringement. Existing or future infringement claims against us, whether valid or not, may be time-consuming and expensive to defend. Intellectual property litigation or claims could force us to do one or more of the following: cease selling, incorporating, or using products or services that incorporate the challenged intellectual property; obtain a license from the holder of the infringed intellectual property, which, if available at all, may not be available on commercially favorable terms; or redesign the effected software products, which could cause us to incur additional costs, delay introduction and possibly reduce the appeal of our products. Any of these actions may cause material harm to our business and financial results.

There is a heightened degree of risk because the Company may utilize artificial intelligence (AI) and/or blockchain technologies, including the potential issuance of fungible tokens (currencies) and non-fungible tokens ("NFTs"). Companies seeking to develop new products and services using new and disruptive technologies often experience unexpected problems in the areas of product development, marketing, financing, legal, and general management, among others, which frequently cannot be solved. In addition, developing new products and services requires substantial amounts of financing, which may not be available in whole or part through institutional private placements, the public markets or otherwise. There is heightened risk when utilizing technologies subject to an unclear and shifting regulatory environment, where jurisdictions have yet to provide clear guidance. Failure by the Company or certain users of Company's games to comply with any laws, rules and regulations, some of which may not exist yet or are subject to interpretation and may be subject to change, could result in a variety of adverse consequences, including civil penalties and fines. Changes in the regulatory regime that restrict, prohibit, or create complexities and expenses could cause significant damage to Company's games. As a result, we may be unable to have an Equity Financing and/or repay the SAFE.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the

Company or its actions.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

USE OF FUNDS

9. What is the purpose of this offering?

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from this Offering. Accordingly, the Company will have broad discretion in using these proceeds.

10. How does the issuer intend to use the proceeds of this offering?

If we raise: **\$150,000**

Use of Proceeds: 93.5% of capital raised shall pay employee salaries and contractor expenses directly related to the development of Project Artemis and the new Eternium game. 6.5% of the raise will go towards the Wefunder intermediary fee.

If we raise: **\$1,235,000**

Use of Proceeds: 80% paying for staffing expenses directly related to the development of Project Artemis and the new Eternium game + 20% towards operational expenses (including 6.5% Wefunder fee) and player acquisition marketing.

Book Entry and Investment in the Co-Issuer. Investors will make their investments by investing in interests issued by one or more co-issuers, each of which is a special purpose vehicle (“SPV”). The SPV will invest all amounts it receives from investors in securities issued by the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors’ interests in the investments will be recorded in each investor’s “Portfolio” page on the Wefunder platform. All references in this Form C to an Investor’s investment in the Company (or similar phrases) should be interpreted to include investments in a SPV.

12. How can an investor cancel an investment commitment?

NOTE: Investors may cancel an investment commitment until 48 hours prior to the deadline identified in these offering materials.

The intermediary will notify investors when the target offering amount has been met. Ownership and Capital Structure

THE OFFERING

The main terms of the SAFEs are provided below.

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides Investors the right to **preferred stock** in the Company ("**Preferred Stock**"), when and if the Company sponsors an equity offering that involves **Preferred Stock**, on the standard terms offered to other Investors.

Conversion to Preferred Equity. Based on our SAFEs, when we engage in an offering of equity interests involving **preferred stock**, **Investors will receive a number of shares of preferred stock** calculated using the method that results in the greater number of **preferred stock**:

the total value of the Investor's investment, divided by the price of **preferred stock** issued to new Investors, or if the valuation for the company is more than **\$13,000,000.00** (the "Valuation Cap"), the amount invested by the Investor divided by the quotient of

(i) the Valuation Cap divided by

(ii) the total amount of the Company's capitalization at that time.

For investors up to the first **\$300,000.00** of the securities, investors will receive a valuation cap of **\$10,000,000.00**

Additional Terms of the Valuation Cap. For purposes of option (ii)

above, the Company's capitalization calculated as or immediately prior to the Equity Financing and (without double-counting, in each case calculated on an as-converted to Common Stock basis):

- Includes all shares of Capital Stock issued and outstanding;
- Includes all Converting Securities;
- Includes all (i) issued and outstanding Options and (ii) Promised Options; and
- Includes the Unissued Option Pool, except that any increase to the Unissued Option Pool in connection with the Equity Financing shall only be included to the extent that the number of Promised Options exceeds the Unissued Option Pool prior to such increase.

Liquidity Events. If the Company has an initial public offering or is acquired by, merged with, or otherwise taken over by another company or new owners prior to Investors in the SAFEs receiving **preferred stock**, Investors will receive

- proceeds equal to the greater of (i) the Purchase Amount (the "Cash-Out Amount") or (ii) the amount payable on the number of shares of Common Stock equal to the Purchase Amount divided by the Liquidity Price (the "Conversion Amount")

Liquidity Priority. In a Liquidity Event or Dissolution Event, this Safe is intended to operate like standard nonparticipating Preferred Stock. The Investor's right to receive its Cash-Out Amount is:

1. Junior to payment of outstanding indebtedness and creditor claims, including contractual claims for payment and convertible promissory notes (to the extent such convertible promissory notes are not actually or notionally converted into Capital Stock);
2. On par with payments for other Safes and/or Preferred Stock, and if the applicable Proceeds are insufficient to permit full payments to the Investor and such other Safes and/or Preferred Stock, the applicable Proceeds will be distributed pro rata to the Investor and such other Safes and/or Preferred Stock in proportion to the full payments that would otherwise be due; and
3. Senior to payments for Common Stock.

Securities Issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV is formed concurrently with the filing of the Form C. Given this, the SPV does not have any financials to report. The SPV is managed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. Making Fun earns revenue from players of games it develops and publishes both directly and via partners like Apple, Google, Valve (Steam), and Microsoft (Windows Store). The Company's headquarters are in Oakland, CA. The Company's customers are global.

Milestones

Making Fun, Inc. was incorporated in the State of Delaware in December 2009.

Since then, we have:

- Eternium: 37mm downloads, 7mm email subscribers, 4.8 star rating, \$20mm lifetime revenue
- Experienced global team, \$100K/mo. revenue, high output with low cash burn
- Rebuilding Eternium: more characters & story, new engine w/ better graphics, mobile & PC launch 2024
- Project Artemis next-gen action RPG: co-op multiplayer, Unreal Engine 5, mobile & PC launch 2024
- Significant progress: New games are playable and FUN, past risk points in development
- Perfect time to invest: Products launch in 12 months; raising funds for completion & marketing

Historical Results of Operations

- *Revenues & Gross Margin.* For the period ended June 30, 2022, the Company had revenues of \$2,622,054 compared to the year ended June 30, 2021, when the Company had revenues of \$2,850,098. Our gross margin was 87.84% in fiscal year 2023, compared to 87.8% in 2022.
- *Assets.* As of June 30, 2022, the Company had total assets of \$1,760,491, including \$403,171 in cash. As of June 30, 2021, the Company had \$1,972,019 in total assets, including \$132,703 in cash.
- *Net Income.* The Company has had net income of \$188,761 and net income of \$180,238 for the fiscal years ended June 30, 2022 and June 30, 2021, respectively.
- *Liabilities.* The Company's liabilities totaled \$273,455 for the fiscal year ended June 30, 2022 and \$589,327 for the fiscal year ended June 30, 2021.

Liquidity & Capital Resources

To-date, the company has been financed with \$328,213 in debt, \$53,639 in equity, and \$450,000 in SAFEs.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 8 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 6 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Making Fun, Inc. cash in hand is \$554,737, as of July 2023. Over the last three months, revenues have averaged \$158,307/month, cost of goods sold has averaged \$18,814/month, and operational expenses have averaged \$198,780/month, for an average burn rate of \$59,287 per month. Our intent is to be profitable in 14 months.

In April, we received a check from the class action settlement Donald R. Cameron, et al. v. Apple Inc. in the amount of \$120,973.23.

In the next 3 - 6 months, we expect a similar level of \$100-125K per month in product revenues + one-time amounts of \$100K (net of commission) for our Employee Retention Tax Credit + \$200K in contracted development milestones with a partner. During the same period, we expect our expenses to remain relatively flat at about \$200k per month.

We are not profitable. Based on our recent results and future projections, we expect that existing cash + receivables will not quite fund us to the launch of our two next-generation products in mid-2024, at which point revenues should rise substantially. Hence the raise on Wefunder to provide completion capital, a buffer, and some growth capital. We wish to raise more than our Wefunder minimum, either on Wefunder and/or via a subsequent private raise, to support additional marketing and growth of staff.

With cash in the bank we have runway to take us through the Wefunder campaign. Additionally, we expect \$100K from an ERC refund from the U.S. government, \$200K in development milestone payments later in the year, we shall apply for grant funding of \$50K+, and we shall execute Kickstarter campaigns for Project Artemis and the new Eternium, each of which could bring in six digits or more of revenue based on the large number of fans of Eternium.

As described above, each Investor that has entered into the Investor Agreement will grant a power of attorney to make voting decisions on behalf of that Investor to the Lead Investor (the “Proxy”). The Proxy is irrevocable unless and until a Successor Lead Investor takes the place of the Lead Investor, in which case, the Investor has a five (5) calendar day period to revoke the Proxy. Pursuant to the Proxy, the Lead Investor or his or her successor will make voting decisions and take any other actions in connection with the voting on Investors’ behalf.

The Lead Investor is an experienced investor that is chosen to act in the role of Lead Investor on behalf of Investors that have a Proxy in effect. The Lead Investor will be chosen by the Company and approved by Wefunder Inc. and the identity of the initial Lead Investor will be disclosed to Investors before Investors make a final investment decision to purchase the securities related to the Company.

The Lead Investor can quit at any time or can be removed by

The Lead Investor can quit at any time or can be removed by Wefunder Inc. for cause or pursuant to a vote of investors as detailed in the Lead Investor Agreement. In the event the Lead Investor quits or is removed, the Company will choose a Successor Lead Investor who must be approved by Wefunder Inc. The identity of the Successor Lead Investor will be disclosed to Investors, and those that have a Proxy in effect can choose to either leave such Proxy in place or revoke such Proxy during a 5-day period beginning with notice of the replacement of the Lead Investor.

The Lead Investor will not receive any compensation for his or her services to the SPV. The Lead Investor may receive compensation if, in the future, Wefunder Advisors LLC forms a fund ("Fund") for accredited investors for the purpose of investing in a non-Regulation Crowdfunding offering of the Company. In such a circumstance, the Lead Investor may act as a portfolio manager for that Fund (and as a supervised person of Wefunder Advisors) and may be compensated through that role.

Although the Lead Investor may act in multiple roles with respect to the Company's offerings and may potentially be compensated for some of its services, the Lead Investor's goal is to maximize the value of the Company and therefore maximize the value of securities issued by or related to the Company. As a result, the Lead Investor's interests should always be aligned with those of Investors.
