It is important to acknowledge the potential risk that the recent growth rate in golf could change. This risk is rooted in the possibility that external factors, such as changes in consumer preferences, and economic conditions, could negatively impact the demand for golf-related products and services. As such, it is essential

for the company to consider the long-term sustainability of its growth strategy and to remain vigilant in monitoring external trends and factors that could potentially impact the demand for its offerings.

The company's lack of intellectual property on its golf bag designs increases the risk of competitors entering the market and taking market share. To compete, the company must continue to secure and enforce trademarks; however, trademark approval is not guaranteed and could be invalidated by conduct or third-party challenges. Enforcement of intellectual property rights may involve costly legal proceedings that may not be successful.

Manufacturing overseas can lead to quality control challenges. Defects can result in returns, claims, delayed shipments, and reduced orders, leading to additional costs, loss of business, and damage to reputation. Moreover, an increase in raw material or energy costs may negatively impact profitability due to unexpected price changes, shortages, and higher operating costs. The inability to raise prices to offset these costs may lead to reduced volume, sales, and operating profit, thereby negatively affecting your investment.

Investors face the risk of no return until a strategic acquisition, IPO, or other exit opportunities. Dividends are not guaranteed as investments are long-term. The company will prioritize pursuing growth and increasing its market share.

The Preferred Stock has no voting rights except as required by law, with all voting rights reserved for Common Stockholders. Holders of Preferred Stock are required to vote in favor of certain transactions and amendments approved by the board and Common Stockholders. Therefore, investors must rely on Common Stockholders to make strategic decisions, including the election of qualified directors, to ensure the success of the Company.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. ### USE OF FUNDS

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from this Offering. Accordingly, the Company will have broad discretion in using these proceeds.

Use of Proceeds: 93.5% towards a key sales hire and 6.5% towards Wefunder fees.

Use of Proceeds: Over the next 18 months, the allocation of the funds is projected to be used 47% towards key sales and marketing hires, 31% towards marketing, 15.5% towards Inventory and Product Development, and 6.5% towards Wefunder fees.

Book Entry and Investment in the Co-Issuer. Investors will make their investments by investing in interests issued by one or more co-issuers, each of which is a special purpose vehicle ("SPV"). The SPV will invest all amounts it receives from investors in securities issued by the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. GALVIN AND MATHEWS FBA INC. is offering up to 962,616 shares of Class C Preferred Stock, at a price per share of \$1.50.

Investors in the first \$835,700.40 of the offering will receive stock at a price per share of \$1.20, and a pre-money valuation of \$12,000,000.00.

The campaign maximum is \$1,234,998.90 and the campaign minimum is \$50,000.40.

#### Securities Issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV has been formed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

#### Voting Rights

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her

voting rights, these voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the “Investor”), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor’s true and lawful proxy and attorney (the “Proxy”) with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor (“Replacement Lead Investor”) takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

Restriction on Transferability

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

To the extent applicable, in cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. As holders of a majority-in-interest of voting rights in the Company, **the shareholders** may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, **the shareholders** may change the terms of the Articles of Incorporation for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. **The shareholders** may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. They may also vote to engage in new offerings and/or to register certain of the Company's securities in a way that negatively affects the value of the securities the Investor owns. GALVIN AND MATHEWS FBA INC. was originally formed as an LLC in May 2019. In January 2021, the Company converted to a California C-Corporation.

Since then, we have:

- Sold in major retailers like Dicks Sporting Goods, Golf Galaxy, PGA Tour Superstore, Scheels.

- 38,000+ Followers on TikTok and Instagram.
- Sold in 600+ golf courses nationwide.

#### Historical Results of Operations

Our company was organized in May 2019 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended December 31, 2022, the Company had revenues of \$4,577,492.12 compared to the year ended December 31, 2021, when the Company had revenues of \$2,687,047.64.
- *Assets.* As of December 31, 2022, the Company had total assets of \$1,670,288.03, including \$206,499.78 in cash. As of December 31, 2021, the Company had \$1,061,589.44 in total assets, including \$379,577.59 in cash.
- *Net Income.* The Company has had net income of \$83,218.78 and net income of \$93,733.75 for the fiscal years ended December 31, 2022 and December 31, 2021, respectively.
- *Liabilities.* The Company's liabilities totaled \$1,316,508.30 for the fiscal year ended December 31, 2022 and \$791,174.49 for the fiscal year ended December 31, 2021.

#### Liquidity & Capital Resources

To-date, the company has been financed with \$958,167 in debt.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 24 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

#### Runway & Short/Mid Term Expenses

GALVIN AND MATHEWS FBA INC. cash in hand is \$568,531, as of May 2023. Over the last three months, revenues have averaged \$457,071/month, cost of goods sold has averaged \$133,273/month, and operational expenses have averaged \$292,647/month, for an average net margin of \$31,151 per month. We are currently hovering around break-even. We are currently profitable.

Since the date of the financial statements, the Company has secured an additional \$250,00 line of credit from Chase Bank, with the opportunity to increase the line of credit after the 2022 Tax Return is filed.

Sunday Golf experienced a significant increase in its wholesale and promotional

sales opportunities as a result of its successful participation in the PPAI and PGA Trade Shows. The Company was able to leverage these events to showcase our products to potential customers and as a result, we added 67 new accounts and received a total of 108 orders. In addition to increased revenue, the new accounts that we acquired as a result of the trade shows provide Sunday Golf with a great opportunity to establish long-term relationships and recurring revenue streams.

As the Company has grown, the average monthly recurring software subscription costs have increased for the Company's CRM, Email Marketing, Customer Support, Website, Project Manager, and Inventory Management software.

The Company is currently holding \$1.35 million in inventory to ensure sales forecasts can be met, which is \$150,000 more than it held at the end of 2022.

Sunday Golf expects over \$4 million in revenue over the next 6 months and around \$3.85 million in COGS and Operating Expenses.

Sunday Golf's business operations are seasonal and revenues are partially tied to the golf season, which generally runs from March to October. During the historically low revenue months of January and February, the company typically experiences a net loss. These months also have the highest cash flow demands due to the need to stock up on inventory for the previous holiday selling season and ensure enough inventory is available to sell at the beginning of the upcoming golf season. On the other hand, November and December are still strong sales months due to Black Friday and holiday gifting.

The company is already profitable and doesn't need additional funding to achieve profitability. The company had an EBITDA of \$177,687.91 in 2022 and \$190,113.20 in 2021 and a Net Income of \$83,218.78 in 2022 and \$93,733.75 in 2021.

Additional sources of capital outside of this offering include:

- \$250,000 line of credit from Chase Bank that can be increased as the company continues to grow.
- \$100,000 of American Express Credit Card limit for shorter-term needs.
- \$300,000 of Inventory Financing is currently available from a previous debt provider.
- \$200,000 of additional personal savings from the company founders if needed.

It is important to note that while these sources of capital are available, the company will carefully consider the terms, interest rates, and repayment schedules of each option before accessing them. Additionally, the company will explore other funding options to diversify its sources of capital and minimize risk.

In such as circumstance, the Lead Investor may act as a portfolio manager for that Fund (and as a supervised person of Wefunder Advisors) and may be compensated through that role.

Although the Lead Investor may act in multiple roles with respect to the Company's offerings and may potentially be compensated for some of its services, the Lead Investor's goal is to maximize the value of the Company and therefore maximize the value of securities issued by or related to the Company. As a result, the Lead Investor's interests should always be aligned with those of Investors. It is, however, possible that in some limited circumstances the Lead Investor's interests could diverge from the interests of Investors, as discussed in section 8 above.

Investors that wish to purchase securities related to the Company through Wefunder Portal must agree to give the Proxy described above to the Lead Investor, provided that if the Lead Investor is replaced, the Investor will have a 5-day period during which he or she may revoke the Proxy. If the Proxy is not revoked during this 5-day period, it will remain in effect.

Tax Filings. In order to complete necessary tax filings, the SPV is required to include information about each investor who holds an interest in the SPV, including each investor's taxpayer identification number ("TIN") (e.g., social security number or employer identification number). To the extent they have not already done so, each investor will be required to provide their TIN within the earlier of (i) two (2) years of making their investment or (ii) twenty (20) days prior to the date of any distribution from the SPV. If an investor does not provide their TIN within this time, the SPV reserves the right to withhold from any proceeds otherwise payable to the Investor an amount necessary for the SPV to satisfy its tax withholding obligations as well as the SPV's reasonable estimation of any penalties that may be charged by the IRS or other relevant authority as a result of the investor's failure to provide their TIN. Investors should carefully review the terms of the SPV Subscription Agreement for additional information about tax filings.

*INSTRUCTIONS TO QUESTION 30: If information is presented to investors in a format, media or other means not able to be reflected in text or portable document format, the issuer should include:*

- (a) a description of the material content of such information;*
- (b) a description of the format in which such disclosure is presented; and*
- (c) in the case of disclosure in video, audio or other dynamic media or format, a transcript or description of such disclosure.*

## ONGOING REPORTING

32. The issuer will file a report electronically with the Securities & Exchange Commission annually and post the report on its website, no later than:

**120 days after the end of each fiscal year covered by the report.**

The issuer must continue to comply with the ongoing reporting requirements until:

1. the issuer is required to file reports under Exchange Act Sections 13(a) or 15(d);
2. the issuer has filed at least one annual report and has fewer than 300 holders of record;
3. the issuer has filed at least three annual reports and has total assets that do not exceed \$10 million;
4. the issuer or another party purchases or repurchases all of the securities issued pursuant to Section 4(a)(6), including any payment in full of debt securities or any complete redemption of redeemable securities; or the issuer liquidates or dissolves in accordance with state law.
