The possibility of issues or delays in our FDA and CE mark certification process would require us to extend our runway to get to the next fund raise

The venture capital market could be in a difficult situation when we go raise our series A, which would be a challenge to get to the next steps

Supply chain issues could delay our first shipment of devices to the market, as long lead time components can sometimes be hard to find

A large company could come up with a competing product, which would reduce the market share we can address.

Regulations could change in the future, which would require Norbert to change some of its approaches in its regulatory pathway and delay go to market

Some long lead time components could be harder to source than we are planning now, which would delay our go to market date.

We have protected our IP efficiently, but the cost of defending it could be high and endanger the company.

The market could become highly competitive. New technologies by unknown or known competitors may damage the company.

There is a potential risk of security breaches - should the company get hacked. The company could unwittingly violate privacy of users which could prevent business operations and create damages to brand.

There is a potential risk of litigation against company or IP disputes or litigation from dissatisfied customers or violation of laws.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. Milestones

Norbert Health Inc was incorporated in the State of Delaware in July 2019.

Since then, we have:

- Repeat tech entrepreneur built a device and AI to measure all vitals signs in 30s, medical accuracy.
- Combination of radar, infrared and advanced camera make it possible to measure all vitals accurately
- Clinical trials for certification in progress - target FDA approval date is Q4 2023 (not guaranteed)
- Ongoing pilots with major healthcare players like Northwell, NYU, Duke, Vivalto, SOS, Weill-Cornell
- Saeju Jeong, founder of Noom, invested and is a board member. \$8M raised from top tier VCs, angels
- \$265Bn worth of Medicare costs are moving to home care - and need automated vitals scanning devices!
- Manufacturing devices with major contract manufacturer in Q4 2023 in Europe

The Company is subject to risks and uncertainties common to early-stage companies. Given the Company's limited operating history, the Company cannot reliably estimate how much revenue it will receive in the future.

Historical Results of Operations

- *Revenues & Gross Margin.* For the period ended December 31, 2023, the Company had revenues of \$0 compared to the year ended December 31, 2022, when the Company had revenues of \$0. Our gross margin was % in fiscal year 2023, compared to % in 2022.
- *Assets.* As of December 31, 2023, the Company had total assets of \$2,091,609, including \$1,636,144 in cash. As of December 31, 2022, the Company had \$4,054,990 in total assets, including \$3,226,871 in cash.
- *Net Loss.* The Company has had net losses of \$3,746,137 and net losses of \$2,885,111 for the fiscal years ended December 31, 2023 and December 31, 2022, respectively.
- *Liabilities.* The Company's liabilities totaled \$3,048,475 for the fiscal year ended December 31, 2023 and \$1,237,701 for the fiscal year ended December 31, 2022.

Liquidity & Capital Resources

To-date, the company has been financed with \$1,105,890 in debt, \$8,000,000 in equity, \$2,400,000 in convertibles, and \$3,479,898 in SAFEs.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 15 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 9 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Norbert Health Inc cash in hand is \$825,000, as of May 2023. Over the last three months, revenues have averaged \$0/month, cost of goods sold has averaged \$0/month, and operational expenses have averaged \$280,000/month, for an average burn rate of \$280,000 per month. Our intent is to be profitable in 18 months. Things have been going as planned since our financial cover, there is not material change to report at this time.

Our revenue will stay close to zero until we get FDA clearance in the fall, six months from now.

At this point we will manufacture and sell 5000 Norbert devices that will generate 2.5m ARR towards early 2023.

We are not profitable yet and the funding we are raising on this 4m SAFE note will get us to the point where we are generating our first sales. Profitability will depend on how much investment we make in developing more vital signs and capabilities for our device - we can develop more software to run on our hardware platform so as to deliver more value to our customers, in increase revenue per device.

We will receive non dilutive funding from the French government to finance our R&D operations in France - this will positively impact our 2023 runway in the same magnitude as in 2022.

Our current 4m fundraise will help us finance the manufacturing of our first 5000 units.

All projections in the above narrative are forward-looking and not guaranteed.

The Proxy is irrevocable unless and until a Successor Lead Investor takes the place of the Lead Investor, in which case, the Investor has a five (5) calendar day period to revoke the Proxy. Pursuant to the Proxy, the Lead Investor or his or her successor will make voting decisions and take any other actions in connection with the voting on Investors'

behalf.

The Lead Investor is an experienced investor that is chosen to act in the role of Lead Investor on behalf of Investors that have a Proxy in effect. The Lead Investor will be chosen by the Company and approved by Wefunder Inc. and the identity of the initial Lead Investor will be disclosed to Investors before Investors make a final investment decision to purchase the securities related to the Company.

The Lead Investor can quit at any time or can be removed by Wefunder Inc. for cause or pursuant to a vote of investors as detailed in the Lead Investor Agreement. In the event the Lead Investor quits or is removed, the Company will choose a Successor Lead Investor who must be approved by Wefunder Inc. The identity of the Successor Lead Investor will be disclosed to Investors, and those that have a Proxy in effect can choose to either leave such Proxy in place or revoke such Proxy during a 5-day period beginning with notice of the replacement of the Lead Investor.

The Lead Investor will not receive any compensation for his or her services to the SPV. The Lead Investor may receive compensation if, in the future, Wefunder Advisors LLC forms a fund ("Fund") for accredited investors for the purpose of investing in a non-Regulation Crowdfunding offering of the Company. In such a circumstance, the Lead Investor may act as a portfolio manager for that Fund (and as a supervised person of Wefunder Advisors) and may be compensated through that role.
