Market competition: The online organic market is becoming increasingly competitive, which may affect the ability of online organic stores to attract and retain customers.

Business model risks: Online organic stores may have a high cost structure due to factors such as marketing expenses and shipping costs, which may impact their profitability and ability to scale.

We operate in a highly regulated industry, where changes in laws, regulations, or government policies related to agriculture and food safety can significantly impact our business operations. Amendments to existing regulations or the introduction of new ones could increase our operational costs, impose additional compliance requirements, or restrict our ability to source and sell produce. Such changes could adversely affect our profitability and the ability to conduct our business as planned.

As a distributor of fresh produce, we face inherent risks associated with food safety. Despite our strict quality control measures, there is always a possibility that our products could become contaminated with pathogens, leading to foodborne illnesses. An occurrence of such an event could lead to liability claims, damage our reputation, and result in a loss of customer trust, significantly impacting our financial condition and operations.

Our business model heavily relies on maintaining strong relationships with independent farmers. Any disruption in these relationships, whether due to disputes, farmers' inability to meet our quality standards, or other reasons, could lead to a shortage in supply and affect our ability to offer a diverse range of produce. This could adversely impact our sales, customer satisfaction, and overall business performance.

Climate change poses a significant risk to our agricultural supply chain. Changes in weather patterns, increased frequency of extreme weather events, and other environmental shifts could affect the yield and quality of produce from our partner farmers. This uncertainty could lead to inconsistent supply, increased costs, and potential challenges in meeting customer demand, thereby impacting our operational efficiency and profitability.

Our operations are reliant on third-party software for critical functions such as payment processing and communication (e.g., WhatsApp). Any disruptions, malfunctions, or breaches in these third-party services could lead to operational challenges, data security issues, and damage to our reputation. Furthermore, changes in terms or costs of these services could adversely impact our business efficiency and financial results.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. Hideki Seki is a part-time officer. As such, it is likely that the company will not make the same progress as it would if that were not the case.

The main terms of the SAFEs are provided below.

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"),

which provides Investors the right to **preferred stock** in the Company ("**Preferred Stock**"),

when and if the Company sponsors an equity offering that involves **Preferred Stock**, on the standard terms offered to other investors.

Conversion to Preferred Equity. Based on our SAFEs, when we engage in an offering of equity interests involving preferred stock.

Investors will receive a number of shares of preferred stock calculated using the method that results in the greater number of **preferred stock**:

i. the total value of the Investor's investment, divided by the price of ${\bf preferred}$ stock issued to new Investors, or

ii. if the valuation for the company is more than \$35,000,000.00 (the "Valuation Cap"), the amount invested by the Investor divided by the quotient of

- a. the Valuation Cap divided by
- b. the total amount of the Company's capitalization at that time.

Additional Terms of the Valuation Cap. For purposes of option (ii) above, the Company's capitalization calculated as of immediately prior to the Equity Financing and (without double-counting, in each case calculated on an as-converted to Common Stock basis):

- Includes all shares of Capital Stock issued and outstanding;
- Includes all Converting Securities;
- Includes all (i) issued and outstanding Options and (ii) Promised Options; and
- Includes the Unissued Option Pool, except that any increase to the Unissued Option Pool in connection with the Equity Financing shall only be included to the extent that the number of Promised Options exceeds the Unissued Option Pool prior to such increase.

Liquidity Events. If the Company has an initial public offering or is acquired by, merged with, or otherwise taken over by another company or new owners prior to Investors in the SAFEs receiving **preferred stock**, Investors will receive

- proceeds equal to the greater of (i) the Purchase Amount (the "Cash-Out Amount") or (ii) the amount payable on the number of shares of Common Stock equal to the Purchase Amount divided by the Liquidity Price (the "Conversion Amount")

Liquidity Priority. In a Liquidity Event or Dissolution Event, this Safe is intended to operate like standard nonparticipating Preferred Stock. The Investor's right to receive its Cash-Out Amount is:

- Junior to payment of outstanding indebtedness and creditor claims, including contractual claims for payment and convertible promissory notes (to the extent such convertible promissory notes are not actually or notionally converted into Capital Stock);
- 2. On par with payments for other Safes and/or Preferred Stock, and if the applicable Proceeds are insufficient to permit full payments to the Investor and such other Safes and/or Preferred Stock, the applicable Proceeds will be distributed pro rata to the Investor and such other Safes and/or Preferred Stock in proportion to the full payments that would otherwise be due; and
- 3. Senior to payments for Common Stock.

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV is formed concurrently with the filing of the Form C. Given this, the SPV does not have any financials to report. The SPV is managed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

Voting Rights

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

Restriction on Transferability

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

Overview

Orgfarm makes Organic affordable. A leader in South India with 1142+ farmers, 50K+U and 1M+ orders.

Milestones

Orgfarm, Inc. ("Orgfarm" or the "Company"), Delaware corporation, was incorporated on October 11, 2019, for

the purpose to hold shares issued by Orgfarm Supplies Private Limited ("Orgfarm India"). The Company is also

selling produces provided by Orgfarm India to the US market or outside US. Orgfarm India, Indian corporation, was incorporated on October 31, 2018, as 99.9% owned by Mr. R.

Thirumalai Kumaran Ramamoothy Mukundu, and 0.1% by Mr. R Vijayakumar. In 2019, Orgfarm India issued

approximately 97% shares to Orgfarm, Inc., and became its subsidiary. Orgfarm India is engaged in the

business of selling all kinds of fresh fruits and vegetables, organic produce, groceries, and other home needs

through the Company's website, third party's website or mobile app in India. Orgfarm India is also providing

technical services and product development.

Since then, we have:

- Orgfarm's founders are serial entrepreneurs and have built successful businesses from the ground up
- Organic is the future and Orgfarm is already a leader in South India. Gokul Rajaram has invested!
- Orgfarm has 1142+ farmers, 1M+ orders and 50k+ customers. Its has unique B2B & B2C integrated model,
- Orgfarm provides optimized supply & delivery and end-to-end traceability guarantees quality

Historical Results of Operations

Our company was organized in October 2019 and has limited operations upon which prospective investors may base an evaluation of its performance.

- Revenues & Gross Margin. For the period ended December 31, 2022, the Company had revenues of \$1,467,000 compared to the year ended December 31, 2021, when the Company had revenues of \$1,339,000. Our gross margin was -0.95% in fiscal year 2022, compared to 24.35% in 2021.
- Assets. As of December 31, 2022, the Company had total assets of \$1,196,000, including \$47,000 in cash. As of December 31, 2021, the Company had \$1,153,000 in total assets, including \$419,000 in cash.
- Net Loss. The Company has had net losses of \$771,000 and net losses of \$881,000 for the fiscal years ended December 31, 2022 and December 31, 2021, respectively.
- *Liabilities*. The Company's liabilities totaled \$2,991,000 for the fiscal year ended December 31, 2022 and \$2,258,000 for the fiscal year ended December 31, 2021.

Liquidity & Capital Resources

To-date, the company has been financed with \$2,185,000 in convertibles and \$576,000 in debt.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 36 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 24 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

ORGFARM INC cash in hand is \$25,000, as of September 2023. Over the last three months, revenues have averaged \$75,000/month, cost of goods sold has averaged \$65,000/month, and operational expenses have averaged \$25,000/month, for an average burn rate of \$15,000 per month. Our intent is to be profitable in 12 months.

Since the date of our financials, we will start express delivery from our store to online customer instead of delivering from our warehouse which will make the unit economics much better. We are starting to promote across all apartment towers around each of our store to push online orders.

Revenue is expected to hit \$100K in three months once fund raising is complete while expenses are expected to be around \$80K. We aim to become profitable in 12 months after fund raise.

We are not profitable now but working on unit economics to become profitable sooner. We expect to become profitable in 12 months once fund raise is done. Based on our plan we need \$3M fund to become profitable in 12 months and continue to grow the business.

Aside from Wefunder, we are talking to direct investors in the US and Japan for fund raise at the same valuation. If we are not able to fund raise then we will grow slowly by keeping the operating cost low.

All projections in the above narrative are forward-looking and not guaranteed.

Although the Lead Investor may act in multiple roles with respect to the Company's offerings and may potentially be compensated for some of its services, the Lead Investor's goal is to maximize the value of the Company and therefore maximize the value of securities issued by or related to the Company. As a result, the Lead Investor's interests should always be aligned with those of Investors. It is, however, possiblethat in some limited circumstances the Lead Investor's interests could diverge from the interests of Investors, as discussed in section 8 above.

Investors that wish to purchase securities related to the Company through Wefunder Portal must agree to give the Proxy described above to the Lead Investor, provided that if the Lead Investor is replaced, the Investor will have a 5-day period during which he or she may revoke the Proxy. If the Proxy is not revoked during this 5-day period, it will remain in effect.

Tax Filings. In order to complete necessary tax filings, the SPV is required to include information about each investor who holds an interest in the SPV, including each investor's taxpayer identification number ("TIN") (e.g., social security number or employer identification number). To the extent they have not already done so, each investor will be required to provide their TIN within the earlier of (i) two (2) years of making their investment or (ii) twenty (20) days prior to the date of any distribution from the SPV. If an investor does not provide their TIN within this time, the SPV reserves the right to withhold from any proceeds otherwise payable to the Investor an amount necessary for the SPV to satisfy its tax withholding obligations as well as the SPV's reasonable estimation of any penalties that may be charged by the IRS or other relevant authority as a result of the investor's failure to provide their TIN. Investors should carefully review the terms of the SPV Subscription Agreement for additional information about tax filings.

INSTRUCTIONS TO QUESTION 30: If information is presented to investors in a format, media or other means not able to be reflected in text or portable document format, the issuer should include:

(a) a description of the material content of such information,

(b) a description of the format in which such disclosure is presented; and

(c) in the case of disclosure in video, audio or other dynamic media or format, a transcript or description of such disclosure.

ONGOING REPORTING

32. The issuer will file a report electronically with the Securities & Exchange Commission annually and post the report on its website, no later than:

120 days after the end of each fiscal year covered by the report.

- 1. the issuer is required to file reports under Exchange Act Sections 13(a) or 15(d);

- 3. the issuer has filed at least three annual reports and has total assets that do not exceed \$10 million:
- 4. the issuer or another party purchases or repurchases all of the securities issued pursuant to Section 4(a)(6), including any payment in full of debt securities or any complete redemption of redeemable securities; or the issuer liquidates or dissolves in accordance with state law.
