Uncertain Risk.

An investment in Nascend PBC (also referred to as “we”, “us”, “our”, or “Company”) involves a high degree of risk and should only be considered by those who can afford the loss of their entire investment. Furthermore, the purchase of any of the securities should only be undertaken by persons whose financial resources are sufficient to enable them to indefinitely retain an illiquid investment. Each investor in the Company should consider all of the information provided to such potential investor regarding the Company as well as the following risk factors, in addition to the other information listed in the Company's Form C. The following risk factors are not intended, and shall not be deemed to be, a complete description of the commercial and other risks inherent in the investment in the Company.

Our business projections are only projections.

There can be no assurance that the Company will meet our projections. There can be no assurance that the Company will be able to find sufficient demand for our product, that people think it's a better option than a competing product, or that we will be able to provide the service at a level that allows the Company to make a profit and still attract business.

Any valuation at this stage is difficult to assess.

The valuation for the offering was established by the Company. Unlike listed companies that are valued publicly through market-driven stock prices, the valuation of private companies, especially startups, is difficult to assess and you may risk overpaying for your investment.

If the Company cannot raise sufficient funds it will not succeed.

The Company is offering securities in the amount of up to \$1,235,000 in this offering, and may close on any investments that are made. Even if the maximum amount is raised, the Company is likely to need additional funds in the future in order to grow, and if it cannot raise those funds for whatever reason, including reasons relating to the Company itself or the broader economy, it may not survive. If the Company manages to raise only the minimum amount of funds, sought, it will have to find other sources of funding for some of the plans outlined in “Use of Proceeds.”

We may not have enough capital as needed and may be required to raise more capital.

We anticipate needing access to credit in order to support our working capital requirements as we grow. It is still a difficult environment for obtaining credit on favorable terms. If we cannot obtain credit when we need it, we could be forced to raise additional equity capital, modify our growth plans, or take some other action. Issuing more equity may require bringing on additional investors. Securing these additional investors could require pricing our equity below its current price. If so, your investment could lose value as a result of this additional dilution. In addition, even if the equity is not priced lower, your ownership percentage would be decreased with the addition of more investors. If we are unable to find additional investors willing to provide capital, then it is possible that we will choose to cease our sales activity. In that case, the only asset remaining to generate a return on your investment could be our intellectual property. Even if we are not forced to cease our sales activity, the unavailability of credit could result in the Company performing below expectations, which could adversely impact the value of your investment.

Management Discretion as to Use of Proceeds.

Our success will be substantially dependent upon the discretion and judgment of our management team with respect to the application and allocation of the proceeds of this Offering. The use of proceeds described below is an estimate based on our current business plan. We, however, may find it necessary or advisable to re-allocate portions of the net proceeds reserved for one category to another, and we will have broad discretion in doing so.

Projections: Forward Looking Information.

Any projections or forward looking statements regarding our anticipated financial or operational performance are hypothetical and are based on management's best estimate of the probable results of our operations and will not have been reviewed by our independent accountants. These projections will be based on assumptions which management believes are reasonable. Some assumptions invariably will not materialize due to unanticipated events and circumstances beyond management's control. Therefore, actual results of operations will vary from such projections, and such variances may be material. Any projected results cannot be guaranteed.

The amount raised in this offering may include investments from company insiders or immediate family members (required).

We are reliant on one main type of service/product.

All of our current services and products are variants on one type of service/product. providing a platform for training and certification of healthcare

systems and providers. Our revenues are therefore dependent upon the market for training and certification.

Minority Holder; Securities with No Voting Rights.

The securities that an investor is buying has no voting rights attached to them. This means that you will have no rights in dictating on how the Company will be run. You are trusting in management discretion in making good business decisions that will grow your investments. Furthermore, in the event of a liquidation of our company, you will only be paid out if there is any cash remaining after all of the creditors of our company have been paid out and the preferred shareholders have received the amounts on which they have a preference.

You are trusting that management will make the best decision for the Company.

You are trusting in management discretion. You are buying securities as a minority holder, and therefore must trust the management of the Company to make good business decisions that grow your investment.

Our products could fail to achieve the sales projections we expected.

Our growth projections are based on an assumption that with an increased advertising and marketing budget our products will be able to gain traction in the marketplace at a faster rate than our current products have. It is possible that our products will fail to gain market acceptance for any number of reasons. If our products fail to achieve significant sales and acceptance in the marketplace, this could materially and adversely impact the value of your investment.

We are an early growth company and have limited revenue and operating history.

The Company has a limited operating history beyond our development phase with few customers upon which to evaluate its performance, and has not generated sustained profits. The likelihood of its creation of a viable business must be considered in light of the problems, expenses, difficulties, complications, and delays frequently encountered in connection with the growth of a business, operation in a competitive industry, and the continued development of its technology and products. The Company anticipates that its operating expenses will increase for the near future, and there is no assurance that it will be profitable in the near future. If you are investing in this Company, it's because you think that Nascend PBC, a Certified B-Corporation is a good idea, that the team will be able to successfully market, and sell the products and services, that we can price them right and sell them to enough people so that the Company will succeed. Further, the Company will only be able to pay dividends on any shares once its directors determine that it is financially able to do so. Nascend has incurred a net loss and has had limited revenues generated since inception. You should consider the business, operations and prospects in light of the risks, expenses and challenges faced as an emerging growth company.

We have pending patent and copyright approvals that might be vulnerable.

One of the Company's most valuable assets is its intellectual property. The Company's intellectual property such as patents, trademarks, copyrights, Internet domain names, algorithms, and trade secrets may not be fully registered with the proper authorities. Due to the value, competitors may misappropriate or violate the rights owned by the Company. The Company intends to continue to protect its intellectual property portfolio from such violations. It is important to note that unforeseeable costs associated with such practices may invade the capital of the Company before and after the approvals are finalized.

Our trademarks, copyrights and other intellectual property could be unenforceable or ineffective.

Intellectual property is a complex field of law in which few things are certain. It is possible that competitors will be able to design around our intellectual property, find prior art to invalidate it, or render the patents unenforceable through some other mechanism. If competitors are able to bypass our trademark and copyright protection without obtaining a sublicense, it is likely that the Company's value will be materially and adversely impacted. This could also impair the Company's ability to compete in the marketplace. Moreover, if our trademarks and copyrights are deemed unenforceable, the Company will almost certainly lose any potential revenue it might be able to raise by entering into sublicenses. This would cut off a significant potential revenue stream for the Company.

The Company is vulnerable to hackers and cyber-attacks.

As an internet-based business, we may be vulnerable to hackers who may access the data of our investors and the issuer companies that utilize our platform. Further, any significant disruption in service on its computer systems could reduce the attractiveness of the platform and result in a loss of investors and companies interested in using our platform. Further, we rely on a third-party technology provider to provide some of our back-up technology. Any disruptions of services or cyber-attacks either on our technology provider or on us could harm our reputation and materially negatively impact our financial condition and business.

The loss of one or more of our key personnel, or our failure to attract and retain other highly qualified personnel in the future, could harm our business.

To be successful, the Company requires capable people to run its day to day operations. As the Company grows, it will need to attract and hire additional employees in sales, marketing, design, development, operations, finance, legal, human resources and other areas. Depending on the economic environment and the Company's performance, we may not be able to locate or attract qualified individuals for such positions when we need them. We may also make hiring mistakes, which can be costly in terms of resources spent in recruiting, hiring and investing in the incorrect individual and in the time delay in locating the right employee fit. If we are unable to attract, hire and retain the right talent or make too many hiring mistakes, it is likely our business will suffer from not having the right employees in the right positions at the right time. This would likely adversely impact the value of your investment.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

Raising our maximum target allows us to implement optimization of our current product line with exploration of new development in our pipeline. Only raising our minimum would force us to use our current product line in our GTM strategy.

Book Entry and Investment in the Co-Issuer. Investors will make their investments by investing in interests issued by one or more co-issuers, each of which is a special purpose vehicle ("SPV"). The SPV will invest all amounts it receives from investors in securities issued by the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. THE OFFERING

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides Investors the right to **preferred stock** in the Company ("Preferred Stock"), when and if the Company sponsors an equity offering that involves **Preferred Stock**, on the standard terms offered to other Investors.

Conversion to Preferred Equity. Based on our SAFEs, when we engage in an offering of equity interests involving **preferred stock**, **Investors will receive a number of**

shares or preferred stock calculated using the method that results in the greater number of **preferred stock**:

- i. the total value of the Investor's investment, divided by
 - a. the price of **preferred stock** issued to new investors multiplied by
 - b. the **discount rate** (90%), or
- ii. if the valuation for the company is more than **\$6,000,000.00** (the "Valuation Cap"), the amount invested by the Investor divided by the quotient of
 - a. the Valuation Cap divided by
 - b. the total amount of the Company's capitalization at that time.
- iii. for investors up to the first **\$175,000.00** of the securities, investors will receive a valuation cap of **\$5,400,000.00** and a discount rate of 90.0%. Wefunder VIP investors will be entitled to these terms for the entire duration of the offering, even if the threshold limit noted above is met.

Additional Terms of the Valuation Cap. For purposes of option (ii) above, the Company's capitalization calculated as of immediately prior to the Equity Financing and (without double-counting, in each case calculated on an as-converted to Common Stock basis):

- Includes all shares of Capital Stock issued and outstanding;

Overview

Transformative Tech for Brighter Beginnings: Elevating Outcomes for Opioid Exposed Newborns.

NASCEND is an innovative clinical solution, education and certification company, enhanced by technology, that is dedicated to transforming the quality of care and medical outcomes of opioid-exposed infants (OEI). We train and certify hospitals and individual providers who provide care for women and infants affected by maternal substance use disorder (SUD). Through nurse-driven, infant-focused, and comfort-first care modalities combined with integrated apps for assessment, treatment, and advanced comfort we standardize and improve care for any nursery or NICU.

Milestones

NASCEND PBC was incorporated in the State of Delaware in March 2022 as a result of a merger from NASCEND LLC originally founded in 2016.

Since then, we have:

1. Trained 7,000 providers across 38 states, enhancing care and outcomes for approximately 1.6 million infants.
2. Successfully developed and launched two apps, introduced a national certification program, and established a 16-credit online learning platform.
3. Rolled out four lines of training and education in collaboration with a national partner, that features continuing education and consistently earns 5/5 ratings from over 98% of participants.
4. Certified three early adopter healthcare systems, with five hospitals in advanced contract negotiations and eight hospitals in preliminary talks.

5. Secured 24-month outcomes for our certification program, that notably outperforms our initial quality improvement data.
6. Achieved and maintained Certified B-Corp status for the past four years and earned KY Canopy Certification, demonstrating our commitment to using business as a force for good.
7. Received the prestigious Canopy Top Social Impact Award and recognized as a Healthcare Business Review Top 10 Health Education Service Provider, both in 2023.
8. Dr. Forbes was honored as one of Forbes' 1000 Entrepreneurs to Watch in 2021, a testament to her impactful leadership and innovation.

Historical Results of Operations

Our company was organized in March 2022 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended December 31, 2022, the Company had revenues of \$83,183 compared to the year ended December 31, 2021, when the Company had revenues of \$145,783.
- *Assets.* As of December 31, 2022 the Company had total assets of \$140,958, including \$125,245 in cash. As of December 31, 2021, the Company had \$424,025 in total assets, including \$408,032 in cash.
- *Net Loss.* The Company has had net losses of \$288,758 and net losses of \$191,024 for the fiscal years ended December 31, 2022 and December 31, 2021, respectively.
- *Liabilities.* The Company's liabilities totaled \$627,887 for the fiscal year ended December 31, 2022 and \$700,116 for the fiscal year ended December 31, 2021.

Liquidity & Capital Resources

To-date, the company has been financed with \$700,062 in debt and revenues the company has generated.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 18 months before we either achieve consistent revenue to sustain the company or we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future outside of what is described in this Form C.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We do not plan on raising capital again in the immediate future. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

NASCEND PBC cash in hand is \$159,798, as of January 2024. Over the last three months, revenues have averaged \$95,037/month, cost of goods sold has averaged \$0/month, and operational expenses have averaged \$33,926/month, for an average net margin of \$61,111 per month. We are currently cash flow positive.

Since our financial review in 2022, we've achieved a consistent positive cash flow and anticipate generating revenue in the first quarter of 2024. Noteworthy developments include securing a 3-year grant of \$750K distributed between 2023-2025, obtaining a significant multi-site hospital contract exceeding \$500K, and resuming pre-covid educational events with our national partner, Mead Johnson, in Q2 of 2023. As we approach 2024, these events continue to grow, alongside the establishment of two new national partnerships. Operationally, we successfully launched V2 of our commercial LULLABY app, initiated the development of a web-based, electronic health record (EHR)-integratable version of AssessPro, and completed the discovery phase for a platform supporting operations and our NNCP with a data lake. Our team expanded with the hiring of 2 full-time and 2 fractional executive-level employees and we increased our marketing and PR presence. Finally, we commenced the repayment of our EIDL loan.

In the upcoming six months, we have a committed revenue of \$640,000, coupled with a projected revenue of \$518,000, resulting in a total of \$1,158,000. Concurrently, we plan to strategically increase our operations by expanding our

sales and marketing team to boost the sales pipeline and to pursue Electronic Health Record (EHR) integration for our main app product. This expansion will lead to a proportional rise in average monthly expenses, expected to increase from the current \$22,780 to approximately \$76,600 within the next six months.

We are currently cash flow positive and are projecting to continue to be cash flow positive based on client contracts, committed and pending grants and projects in our pipeline.

Aside from this Wefunder offering, we can rely on a secured \$500k grant with an additional 4 grants in the pipeline that total \$1M. We are also a finalist for a competitive 5 year, 0% interest loan for \$100k.

All projections in the above narrative are forward-looking and not guaranteed.
