This offering is being conducted on an expedited basis due to circumstances relating to COVID-19 and pursuant to the Commission's temporary regulatory COVID-19 relief.

Dining for Charities is still in the early stages of growth, which inherently carries higher investment risks. Early-stage ventures may face uncertainties regarding their business model, scalability, and long-term sustainability. Dining for Charities is scalable on every level. The question becomes how fast we are able to expand our markets to maximize our revenue potential.

The risk is making sure we hire the right people in all key positions. We need to hire the right management team and key regional sales managers to push our market expansion. The risk is making sure we get it right. We do have a succession plan in place to replace any key management positions.

Dining for Charities operates in the competitive deal space, and its success depends on its ability to attract customers and maintain its market position. Economic downturns or shifts in consumer preferences could impact the demand for dining vouchers and gift certificates, affecting the company's revenue.

As with any growing business, there might be operational challenges. Dining for Charities needs to efficiently manage its partnerships with restaurants, businesses, and charities to ensure smooth operations and timely distribution of funds. Any operational inefficiencies could lead to financial strain or reputation damage.

The company's operations might be subject to various local and national

regulations related to fundraising, charitable contributions, and business practices. Changes in these regulations or failure to comply with them could have legal and financial consequences.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. USE OF FUNDS

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from this Offering. Accordingly, the Company will have broad discretion in using these proceeds.

10. How does the issuer intend to use the proceeds of this offering?

If we raise: **\$50,006**

Use of Proceeds: 42.5% marketing / 50% software development / 7.5% towards Wefunder fees.

If we raise: **\$1,229,120**

Use of Proceeds: 15% towards marketing / 34.5% to hiring key personnel / 3% towards software development / 7.5% towards Wefunder fees/ 40% operating expenses towards market expansion.

Achieving the capital raise of \$1.23MM will allow Dining for Charities to escalate our full expansion across the U.S. allowing us to hire key personnel, provide the marketing needed for expansion, and increase our ability to be profitable for our stockholders in a shorter time period.

Book Entry and Investment in the Co-Issuer. Investors will make their investments by investing in interests issued by one or more co-issuers, each of which is a special purpose vehicle ("SPV"). The SPV will invest all amounts it receives from investors in securities issued by the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. All references in this Form C to an Investor's investment in the Company (or similar phrases) should be interpreted to include investments in a SPV.

The Company is offering to both accredited and non-accredited investors up to 184,000 shares of Class "B" Preferred Nonvoting Stock at a price per share of \$6.68. The minimum amount of Class "B" Preferred Nonvoting Stock for this capital raise will be 7,486 shares at a price per share of \$6.68. The maximum amount of shares sold in this capital raise will be 184,000 shares at a price per share of \$6.68

The campaign maximum is \$1,229,120 and the campaign minimum is \$50,006.48.

Securities Issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV is formed concurrently with the filing of the Form C. Given this, the SPV does not have any financials to report. The SPV is managed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

Voting Rights

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

Restriction on Transferability

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

To the extent applicable, in cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. As holders of a majority-in-interest of voting rights in the Company, **the shareholders** may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, **the shareholders** may change the terms of the Articles of Incorporation for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. **The shareholders** may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. They may also vote to engage in new offerings and/or to register certain of the Company's securities in a way that negatively affects the value of the securities the Investor owns. The offering price for the securities offered pursuant to this Form C has been determined arbitrarily by the Company, and does not necessarily bear any relationship to the Company's book value, assets, earnings or other generally accepted valuation criteria. Accordingly, the offering price should not be considered to be indicative of the actual value of the securities offered hereby.

In the future, we will perform valuations of our common stock that take into account factors such as the following:

- \$1.1M cumulative revenue, bootstrapped. 47.28% Returning Customer Rate from 2021 thru July 2023.
- 5/10/23 "Dining for Charities Day" declared in Columbus, GA recognizing 100K+ raised for charities.
- Named "The Next Big Deal" by the National Association of Broadcasters Small Market in October, 2019.
- Over 8,000 customers.
- 15% of each deal sold is donated monthly to a local charity partner in the markets we operate in.

Historical Results of Operations

Our company was organized in October 2019 and has limited operations upon which prospective investors may base an evaluation of its performance. On June 28th, 2023, the Company converted into a Georgia C-corporation called Dining for Charities, Inc.

- *Revenues & Gross Margin.* For the period ended December 31, 2022, the Company had revenues of \$231,037 compared to the year ended December 31, 2021, when the Company had revenues of \$249,111. Our gross margin was 92.25% in fiscal year 2022, compared to 84.5% in 2021.
- *Assets.* As of December 31, 2022, the Company had total assets of \$0, including \$0 in cash. As of December 31, 2021, the Company had \$0 in total assets, including \$0 in cash.
- *Net Loss.* The Company has had net losses of \$12,561 and net losses of \$45,619 for the fiscal years ended December 31, 2022 and December 31, 2021, respectively.
- *Liabilities.* The Company's liabilities totaled \$154,075 for the fiscal year ended December 31, 2022 and \$113,500 for the fiscal year ended December 31, 2021.

Liquidity & Capital Resources

To date, the company has been funded with \$116,009 of debt and a \$45,600 line of credit.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 12 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 8 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from

the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Dining for Charities cash in hand is \$11,188.70, as of September 2023. Over the last three months, revenues have averaged \$18,168.33/month, cost of goods sold has averaged \$1,075/month, and operational expenses have averaged \$19,662.18/month, for an average burn rate of \$2,568.85 per month. Our intent is to be profitable in 15 months.

Dining for Charities has made significant changes to how we expand markets and optimize our business operations. These changes have significantly improved our ability for faster growth and a lot more profitability.

Since the date our financials cover, here are the key material changes and trends in our finances and operations:

Market Expansion: We are currently on-boarding 5 new markets that include Atlanta, (the 6th largest city in the U.S.), Las Vegas, (the 40th largest city--- but one of the top entertainment destinations in the world and a great "deal" location), Mobile, AL., Birmingham, AL., and Auburn, AL. All these cities have a very active rich foodie and restaurant culture.

In additional 8 more markets are planned by the end of the year.

This expansion of actively growing and increasing our market presence increases our customer base, revenues, and overall revenues.

Revised Market Structure: Dining for Charities has been able to revise our market structure over the past 3 months to where when we open new markets we can deliver a 35-50% profit margin. This is a significant change indicating a significant shift in our operations aimed at improving profitability and sustainability.

Profitability Projections: Our new market structure allows us to project profitability as early as 15 months from the time of receiving \$1.2M of funding. Our ability to now expand into markets faster, plus the new revenue structure creates this opportunity.

Business Expansion Plan: Our goal is to be in 100 U.S. markets by the end of 2024 and in 200 markets by end of 2025 with a look to go global at that point. All of this points to increased revenues, larger customer base and brand exposure.

Dining for Charities has been revenue-generating since its inception in 2018. We are seeking capital primarily for market expansion and marketing efforts. Here is a summary of our revenue and expense expectations once we receive the capital infusion.

Dining for Charities already has monthly revenues of \$18K - \$20K a month. Fourth quarter will increase our revenues due to the holidays. These projections include the market expansions that are already underway.

Revenues:

First Month: \$40,000
Months 2 & 3: \$60,000 per month
Months 4 - 6: \$100,000 per month

Expenses:

First Month: \$40,000
Months 2 & 3: \$55,000 per month
Months 4 - 6: \$75,000 per month

Our revenue projections show a steady increase over the next six months, which aligns with our expansion plans. Our expenses are expected to increase, mainly driven by hiring key personnel and expanding into new markets.

The capital we are seeking will support our growth initiatives and help cover the increased expenses associated with our expansion and marketing. The additional capital will enable us to continue to operate and expand our operations as planned.

We understand that it is critical that we continue to monitor our financial performance closely to ensure that our expenses remain in line with our revenue growth. That will insure our business will remain sustainable and profitable as we move forward.

We are not yet profitable. Dining for Charities is on the verge of profitability. We've demonstrated the viability of our business model. While we may not be profitable yet, that is due to continuing to increase our market growth, attorney and accounting fees associated with our restructuring our company to a C-Corp, and continuing to build on what we started.

The funding will play a crucial role in helping us achieve profitability much faster. The funding will support key initiatives, including hiring essential personnel and marketing, which are essential steps to expand into new markets, increase revenues, and build brand awareness.

The key for us is to manage expenses and revenue effectively to reach that tipping point where revenues exceed expenses, leading to profitability.

We have a strong plan and the key will be for us to execute that plan, utilizing the right resources and the effectiveness of our marketing efforts. We have Dining for Charities positioned to become profitable in the very near future. Our plan is to regularly perform financial monitoring and adjustments as needed to reach our goal.

We have been able to take steps to ensure the financial stability of Dining for Charities during our start-up, growth and expansion phase because I have a primary source of income from running media companies. I have access to a line of credit, and short-term loans as needed. These have been valuable resources that have helped me cover any short-term financial needs, including operational expenses during our fundraising campaigns.

Our profitability is so close, which indicates that our strategic planning and financial management are on the right track.

Our ability to cover expenses and access additional funding sources provide a strong foundation for navigating the challenges that often come with scaling nonprofit organizations.

One of my key responsibilities to Dining for Charities will be to continually monitor our financial performance closely and make informed decisions to achieve our goals so we can maximize our profits for our investors.
