- 1. Market Saturation and Competition. The social media landscape is highly competitive, with numerous established platforms and new entrants continuously emerging. Needworking.com may struggle to attract and retain a significant user base due to strong competition, leading to potential difficulties in generating revenue and achieving profitability.it the risk description
- 2. User Adoption and Engagement. The success of a social media platform heavily relies on user adoption and engagement. There is a risk that Needworking.com may not gain sufficient traction or fail to engage users effectively, which could result in limited user growth, decreased user activity, and reduced monetization opportunities.
- 3. Economic and Market Volatility. Economic downturns, fluctuations in market conditions, or unforeseen events, such as a global recession or a pandemic, may adversely impact the investment climate, investor sentiment, and consumer spending, potentially affecting the availability of funding, user adoption, and revenue generation for Needworking.com.
- 4. This may temporarily reduce our market size. Furthermore, a global crisis might make it harder to diversify.
- 8. The Company has the right to extend the Offering deadline. The Company may extend the Offering deadline beyond what is currently stated herein. This means that your investment may continue to be held in escrow while the Company attempts to raise the maximum offering amount even after the Offering deadline stated herein is reached. - 12. The failure to attract and retain key employees could hurt our business, and our management does not have extensive experience in the operation of businesses such as ours. Our success also depends upon our ability to attract and retain numerous highly qualified employees. Our failure to attract and retain skilled management and employees may prevent or delay us from pursuing certain opportunities. If we fail to successfully fill many management roles, fail to fully integrate new members of our management team, lose the services of key personnel, or fail to attract additional qualified personnel, it will be significantly more difficult for us to achieve our growth strategies and success.
- 13. We are highly dependent on the services of our founder. Our future business and results of operations depend in significant part upon the continued contributions of our CEO and founder. If we lose those services or if they fail to perform in their current position, or if we are not able to attract and retain skilled employees in addition to our CEO and the current team, this could adversely affect the development of our business plan and harm our business. In addition, the loss of any other member of the board of directors or executive officers could harm the Company's business, financial condition, cash flow and results of operations.
- 14. Our management may not be able to control costs in an effective or timely manner. The Company's management anticipates it can use reasonable efforts to assess, predict and control costs and expenses. However, implementing our business plan may require more employees, capital equipment, supplies or other expenditure items than management has predicted. Likewise, the cost of compensating employees and consultants or other operating costs may be higher than management's estimates, which could lead to sustained losses.
- 15. Start-up investing is risky. Investing in early-stage companies is very risky, highly speculative, and should not be made by anyone who cannot afford to lose their entire investment. - 20. We may conduct future offerings of our common stock and pay debt obligations with our common stock which may diminish our investors' pro rata ownership and depress our stock price. We reserve the right to make future offers and sales, either public or private, of our securities, including shares of our common stock or securities convertible into common stock at prices differing from the price of the common stock previously issued. In the event that any such future sales of securities are affected or we use our common stock to pay principal or interest on our debt obligations, an investor's pro rata ownership interest may be reduced to the extent of any such future sales.
- 21. Inability to protect our proprietary technology would disrupt our business. We rely, in part, on trademark, copyright, and trade secret law to protect our intellectual property in the United States and abroad. We seek to protect our software, documentation, and other written materials under trade secret and copyright law, which afford only limited protection. We have additional United States and foreign patent applications pending. We cannot predict whether such pending patent applications will result in issued patents, and if they do, whether such patents will effectively protect our intellectual property. The intellectual property rights we obtain may not be sufficient to provide us with a competitive advantage, and could be challenged, invalidated, infringed or misappropriated. We may not be able to protect our proprietary rights in the United States or internationally (where effective intellectual property protection may be unavailable or limited), and competitors may independently develop technologies that are similar or superior to our technology, duplicate our technology or design around any patent of ours. We attempt to further protect our proprietary technology and content by requiring our employees and consultants to enter into confidentiality and assignment of inventions agreements and third parties to enter into nondisclosure agreements. These agreements may not effectively prevent unauthorized use or disclosure of our confidential information, intellectual property or technology and may not provide an adequate remedy in the event of unauthorized use or disclosure of our confidential information, intellectual property or technology. Litigation may be necessary in the future to enforce our intellectual property rights, to determine the validity and scope of our proprietary rights or the rights of others, or to defend against claims of infringement or invalidity. Such litigation could result in substantial costs and diversion of management time and resources and could have a material adverse effect on our business, financial condition, and operating results. - 22. Third parties might infringe upon our technology. We cannot assure you that the steps we have taken to protect our property rights will prevent misappropriation of our technology. To protect our rights to our intellectual property, we plan to rely on a combination of trade secrets, confidentiality agreements and other contractual arrangements with our employees, affiliates, strategic partners and others. We may be unable to detect inappropriate use of our technology. Failure to adequately protect our intellectual property could materially harm our brand, devalue our proprietary content and affect our ability to compete effectively. Further, defending any technology rights could result in significant financial expenses and managerial resources.
- 23. The U.S. Securities and Exchange Commission does not pass upon the merits of any securities offered or the terms of the offering, nor does it pass upon the accuracy or completeness of any offering document or literature.

Similar reliance has been placed on apparently available exemptions from securities registration or qualification requirements under applicable state securities laws. No assurance can be given that any offering currently qualifies or will continue to qualify under one or more of such exemptive provisions due to, among other things, the

adequacy of disclosure and the manner of distribution, the existence of similar offerings in the past or in the future, or a change of any securities law or regulation that has retroactive effect. 27. The Securities issued by the Company will not be freely tradable until one year from the initial purchase date. Although the Securities may be tradable under federal securities law, state securities regulations may apply, and each Investor should consult with his or her attorney.

The Company has sustained operating losses during the years ended December 31, 2022 and 2021. Management believes this situation is typical for prerevenue software developers and intends to monetize the application through advertising and subscriptions. Additionally, management notes that the majority of the Company's expenses are discretionary, including advertising and marketing and general and administrative expenses which comprise a significant portion of expenses during the years ended December 31, 2022 and 2021. Management intends to manage expenses on an as needed basis until additional capital is secured or the application is monetized. Results of Operations: The Company is currently in its pre-revenue stage. During the year ended December 31, 2022, the Company had operating expenses of \$15,617, resulting in a net loss for the year of \$15,617. During the year ended December 31, 2021, the Company had operating expenses of \$8,975, resulting in a net loss for the year of \$8,975. Liquidity & Capital Resources: On December 31, 2022, the Company had cash and cash equivalents of \$1,935 and negative working capital of \$7,617 as compared to cash and cash equivalents of \$10,905 and working capital of \$10,017 on December 31, 2021. During periods of 2021 and 2022, the Company raised gross proceeds of \$139,492 and \$72,983, respectively, from the issuance of common stock to our sole shareholder that were primarily used to fund the Company's software development costs.
