Business and Anticipated Business Plan

6. Describe in detail the business of the issuer and the anticipated business plan of the issuer.

Company Summary: WOOW is a new revolutionary social media platform for short videos, that aims to disrupt the 200 billion dollars advertising industry and aims to change how ads are run in social networks. Woow's mission is: To have advertising without tracking and data collection. WOOW stands a beacon of change, in the new era where privacy defines our path forward. Problem: Social media users often grapple with privacy concerns like: Invasive Tracking: Many consumers feel that online tracking, especially by third-party companies, is invasive and unsettling. Privacy Violations: The collection and sale of personal data are often perceived as a breach of privacy. Unwanted Targeted Advertising: Consumers are frustrated by the constant monitoring of their online activities, which results in the bombardment of targeted ads. Data Profiling and Discrimination: Concerns exist that collected data can lead to discriminatory practices in various aspects of life. Data Brokerage: The sale of personal data to unknown data brokers raises questions about data security. Cross-Device Tracking: The tracking of users across multiple devices has raised worries about maintaining online privacy. In an age when privacy is paramount, people are increasingly averse to being tracked and having their data collected, aggregated, profiled, and sold to the highest bidder. Advertisers are facing escalating ad prices coupled with lackluster user engagement. In today's rapidly evolving advertising landscape, businesses face a growing challenge: how to connect with consumers who are increasingly ignoring and avoiding traditional marketing messages. "Ad blindness" has become a widespread phenomenon, with consumers describing ads as annoying and intrusive. Additionally, general click-through-rates (CTR) on social media may look no better than 0.006 %- 2%. For many companies while cost-per-click (CPC) ranges between \$1.20- \$5.27. This low CTR often requires massive marketing budgets to have any real customer impact, which makes marketing very difficult for small companies with limited budgets. The Product & Solutions: Woow is a new social media app that incorporates a number of unique features that we believe are not available on any other platform. Over the past two years, the WOOW team has made tremendous efforts to develop an AI-driven marketing approach that addresses these privacy concerns. WOOW's approach is two-fold: it prioritizes the customer's experience while ensuring that users are not tracked and their data is not collected. Woow is currently available on the Google Play App Store under Woow Social and the Apple App Store iOS version is in development. Competitive Analysis/Advantage: We believe Woow's greatest starting differentiation is in incentive based advertising, which aims to allow companies to interact a lot more closely with their customers. Users get to choose what ads they want to watch and interact with, specifically suggested for them based on interest and content suggestion. Users aim to then be paid for watching and interacting with an ad, effectively capturing the attention of a potential customer and increasing interaction between brands and users. These incentive based ads plan to get people to watch content more and potentially spend more time on the platform by choice. It aims to also increase ROI through more effective customer targeting, something that the more populated social media platforms struggle with due to ad volume and generally low interest in most ads. Target Market: Woow's target audience includes all social media users. A sample, initial profile would be any person with access to a smart phone between the ages of 18 and 45, and access to internet connections, whether cellular or wifi. Generation Z and younger millennial crowds are typically the best early adopter market for apps.

1. Third parties might infringe upon our technology, trademark, or other proprietary rights, or think we are infringing upon their rights: We cannot assure you that the steps we have taken to protect our property rights will prevent misappropriation of our technology. To protect our rights to our intellectual property, we plan to rely on a combination of patents, trade secrets, confidentiality agreements and other contractual arrangements with our employees, affiliates, strategic partners, and others. We may be unable to detect inappropriate use of our technology. Failure to adequately protect our intellectual property could materially harm our brand, devalue our proprietary content and affect our ability to compete effectively. Further, defending any intellectual property rights could result in significant financial expenses and managerial resources. If we were to initiate legal proceedings against a third party to enforce a patent claiming one of our technologies, the defendant may assert that our patent is invalid and/or unenforceable or does not cover its processes, components or future products. Proving patent infringement can be difficult. Any loss of patent protection or difficulty in enforcing intellectual property rights would have a material adverse impact on our business.
2. Inability to protect our proprietary technology would disrupt our business: We rely, in part, on trademark, copyright, and trade secret law to protect our intellectual property in the United States and abroad. We seek to protect our software, documentation, and other written materials under trade secret and copyright law, which afford only limited protection. The intellectual property rights we obtain may not be sufficient to provide us with a competitive advantage, and could be challenged, invalidated, infringed or misappropriated. We may not be able to protect our proprietary rights in the United States or internationally (where effective intellectual property protection may be unavailable or limited), and competitors may independently develop technologies that are similar or superior to our technology, duplicate our technology or design around any patent of ours. Litigation may be necessary in the future to enforce our intellectual property rights, to determine the validity and scope of our proprietary rights or the rights of others, or to defend against claims of infringement or invalidity. Such litigation could result in substantial costs and diversion of management time and resources and could have a material adverse effect on our business, financial condition, and operating results. Any settlement or adverse determination in such litigation would also subject us to significant liability.
3. Start-up investing is risky: Investing in early-stage companies is very risky, highly speculative, and should not be made by anyone who cannot afford to lose their entire investment. Unlike an investment in a mature business where there is a track record of revenue and income, the success of a startup or early-stage venture often relies on the development of a new product or service that may or may not find a market. 6. Our management may not be able to control costs in an effective or timely manner: The Company's management anticipates it can use reasonable efforts to assess, predict and control costs and expenses. However, implementing our business plan may require more employees, capital equipment, supplies or other expenditure items than management has predicted.
7. Our future growth depends on our ability to develop and retain customers: Our future growth depends to a large extent on our ability to effectively anticipate and adapt to customer requirements and offer

services that meet customer demands. If we are unable to attract customers and/or retain customers, our business, results of operations and financial condition may be materially adversely affected.

8. Our ability to succeed depends on how successful we will be in our fundraising efforts: We rely on investment funds in order to use resources to build the necessary tech and business infrastructure to be successful in the long-term. Current and future competitors may be able to draw on substantially greater financial resources than those available to the Company to develop products that are easier to commercialize or become more popular with the potential consumers of our products.
9. We face risks related to health epidemics and other outbreaks, which could significantly disrupt the Company's operations and could have a material adverse impact on us: The outbreak of pandemics and epidemics could materially and adversely affect the Company's business, financial condition, and results of operations. If a pandemic occurs in areas in which we have material operations or sales, the Company's business activities originating from affected areas, including sales, materials, and supply chain related activities, could be adversely affected. Disruptive activities could include the temporary closure of facilities used in the Company's supply chain processes, restrictions on the export or shipment of products necessary to run the Company's business, business closures in impacted areas, and restrictions on the Company's employees' or consultants' ability to travel and to meet with customers, vendors or other business relationships. The extent to which a pandemic or other health outbreak impacts the Company's results will depend on future developments, which are highly uncertain and cannot be predicted, including new information which may emerge concerning the severity of a virus and the actions to contain it or treat its impact, among others. Pandemics can also result in social, economic, and labor instability which may adversely impact the Company's business. If the Company's employees or employees of any of the Company's vendors, suppliers or customers become ill or are quarantined and in either or both events are therefore unable to work, the Company's operations could be subject to disruption. The extent to which a pandemic affects the Company's results will depend on future developments that are highly uncertain and cannot be predicted.
10. Your shares are not easily transferable: You should not plan on being able to readily transfer and/or resell your security. Currently there is no market or liquidity for these shares and the Company does not have any plans to list these shares on an exchange or other secondary market. At some point the Company may choose to do so, but until then you should plan to hold your investment for a significant period of time before a liquidation event occurs, if ever.
11. The Company likely will not pay dividends for the foreseeable future: Unless otherwise specified in the offering documents and subject to state law, you are not entitled to receive any dividends on your interest in the Company. Accordingly, any potential investor who anticipates the need for current dividends or income from an investment should not purchase Securities in the Offering.
12. You may only receive limited ongoing disclosure: While the Company must disclose certain information, since the Company is at an early stage, it is only able to provide limited information about its business plan and operations because it does not have fully developed operations or a long history. The Company may also only be obligated to file information periodically regarding its business, including financial statements. A publicly listed company, in contrast, is required to file annual and quarterly reports and promptly disclose certain events — through continuing disclosure that you can use to evaluate the status of your investment.
13. The Company may never receive a future equity financing or undergo a liquidity event such as a sale of the Company or an initial public offering (IPO): If a liquidity event does not occur, such as a sale of the Company or an IPO, the purchasers could be left holding Company securities in perpetuity. The Company's securities have numerous transfer restrictions and will likely be highly illiquid, with potentially no secondary market on which to sell them. The securities have only a minority of voting rights and do not provide the ability to direct the Company or its actions.
14. Future fundraising may affect the rights of investors: The Company is raising funds to finance its expansion plans, and may raise additional funds in the future, either through offerings of securities or borrowing from banks or other lending sources. The terms of future capital raises or loan agreements may include covenants that give security holders or creditors greater control over the Company's ability to raise additional funds and use of its assets.

15. Any valuation at this stage is difficult to assess: Unlike listed companies that are valued publicly through market-driven stock prices, the valuation of private companies, especially startups, is difficult to assess and you may risk overpaying for your investment. In addition, there may be additional classes of equity with rights that are superior to the class of equity being sold.
16. 18. *Neither the Offering nor the Securities have been registered under federal or state securities laws, leading to an absence of certain regulation applicable to the Company.*

The securities being offered have not been registered under the Securities Act of 1933 (the "Securities Act"), in reliance on exemptive provisions of the Securities Act. Similar reliance has been placed on apparently available exemptions from securities registration or qualification requirements under applicable state securities laws. No assurance can be given that any offering currently qualifies or will continue to qualify under one or more of such exemptive provisions due to, among other things, the adequacy of disclosure and the manner of distribution, the existence of similar offerings in the past or in the future, or a change of any securities law or regulation that has retroactive effect. If, and to the extent that, claims or suits for rescission are brought and successfully concluded for failure to register any offering or other offerings or for acts or omissions constituting offenses under the Securities Act, the Securities Exchange Act of 1934, or applicable state securities laws, the Company could be materially adversely affected, jeopardizing the Company's ability to operate successfully. 19. *The Company has the right to extend the Offering Deadline, conduct multiple closings, or end the Offering early.*

The Company may extend the Offering Deadline beyond what is currently stated herein. This means that your investment may continue to be held in escrow while the Company attempts to raise the Minimum Amount even after the Offering Deadline stated herein is reached. While you have the right to cancel your investment up to 48 hours before an Offering Deadline, if you choose to not cancel your investment, your investment will not be accruing interest during this time and will simply be held until such time as the new Offering Deadline is reached without the Company receiving the Minimum Amount, at which time it will be returned to you without interest or deduction, or the Company receives the Minimum Amount, at which time it will be released to the Company to be used as set forth herein. 20. *The Company's management may have broad discretion in how the Company uses the net proceeds of the Offering.*

Despite that the Company has agreed to a specific use of the proceeds from the Offering, the Company's management will have considerable discretion over the allocation of proceeds from the Offering. You may not have the opportunity, as part of your investment decision, to assess whether the proceeds are being used appropriately.

21. *The Securities issued by the Company will not be freely tradable until one year from the initial purchase date. Although the Securities may be tradable under federal securities law, state securities regulations may apply, and each Investor should consult with his or her attorney.*

You should be aware of the long-term nature of this investment. There is not now and likely will not be a public market for the Securities. Because the Securities offered in this Offering have not been registered under the Securities Act or under the securities laws of any state or non-United States jurisdiction, the Securities have transfer restrictions and cannot be resold in the United States except pursuant to Rule 501 of Regulation CF. 23. *The shares of Securities acquired upon the Offering may be significantly diluted as a consequence of subsequent financings.*

Company equity securities will be subject to dilution. Company intends to issue additional equity to future employees and third-party financing sources in amounts that are uncertain at this time, and as a consequence, holders of Securities will be subject to dilution in an unpredictable amount. Such dilution may reduce the purchaser's economic interests in the Company.

24. The amount of additional financing needed by Company will depend upon several contingencies not foreseen at the time of this Offering. Each such round of financing (whether from the Company or other investors) is typically intended to provide the Company with enough capital to reach the next major corporate milestone. WOOW INC. was originally organized as a limited liability company in New York on May 18, 2020. The limited liability company was merged into the Company on July 11, 2023. The Company operates a social media platform with mobile interface. Since Inception, the Company has relied on securing funding from its members. As of December 31, 2022, the Company had negative retained earnings and will likely incur additional losses prior to generating positive working capital. During the next twelve months, the Company intends to fund its operations with funding from a fundraising campaign and the receipt of funds from revenue producing activities, if and when such can be realized. If the Company cannot secure additional capital, it may cease operations. On July 28, 2023, the Company had 100 shares issued and outstanding. In December 2023, the Company did a 50,000 to 1 stock split, to bring the total number of issued shares to 5,000,000. Results of Operations: During 2023, the Company began earning revenue through its mobile app. Through September 2023, the Company earned approximately \$25,000 in revenue. Revenue for the year ended December 31, 2022 decreased by \$200 to \$0, as compared to \$200 reported for the year ended December 31, 2021. Operating expenses for the year ended December 31, 2022 increased by \$54,200 to \$324,500, as compared to \$270,300 reported for the year ended December 31, 2021. Liquidity & Capital Resources: During 2023, the Company received \$96,000 in cash contributions to support the operations of the business. No equity securities were sold for the \$96,000 in cash. On December 31, 2022 and December 31, 2021 the Company had cash and cash equivalents of \$0 and working capital of \$0. During 2022, the Company had contributions of \$324,500 to support the operations of the business. Out of the \$324,500, \$51,000 was received as an investment in the Company at a \$15 million valuation. No equity securities were sold for the remaining \$273,500 in contributions, which came from existing members. During 2022, the Company averaged a monthly burn rate of approximately \$27,000 compared to an average monthly burn rate of approximately \$22,500 in 2021.
