# **Business and Anticipated Business Plan**

6. Describe in detail the business of the issuer and the anticipated business plan of the issuer.

Our Mission: At MISAA, LLC, our mission is to use our knowledge and experience to improve the health and well-being of the transplant community around the world. The scientists are driven to succeed by their shared passion for knowledge and growth, and the desire to apply that knowledge to remedy real-world problems, from healthcare to environmental sustainability. Our Expertise: Our team of scientists and researchers are leaders in the field of in Vitro diagnostics. We have extensive experience in developing cutting-edge diagnostic products and we are constantly exploring new ways to improve patient outcomes. Our Products: We have developed a range of in Vitro diagnostic tests that address a variety of healthcare needs. These tests include quantifying biomarkers and pharmaceuticals, all of which are designed to improve patient care and outcomes. MISAA's parent company IOS received over \$4 million of Research & Development money to develop its launch product, the TacAssay in vitro diagnostic kit. MISAA is the developer of this first-of-its kind fast, simple, inexpensive test of the blood level of the best selling immunosuppressive drug Tacrolimus which is employed in the majority of kidney transplants in the world (liver and heart transplants as well). MISAA believes the total accessible market for its product is in the multiple billions. MISAA's TacAssay product is proprietary and the Company has filed for international patents with broad claims to the intellectual property. MISAA has begun the FDA approval process with a pre-submittal of a 510K. Approval is expected in the 12–18-month timeframe as a Class II non-invasive diagnostic system. The FDA has accepted MISAA's proposition that the complex, time delay and expensive LC-MS based test currently used is the predicate for clinical testing the TacAssay. The TacAssay will employ already an FDA-approved hardware, further speeding the process. Once approved, we believe that TacAssay will provide doctors an important new tool to monitor Tacrolimus levels in transplant patients. Our goal is to improve care and outcomes for millions of people.

### **Risk Factors**

1. Inability to protect our proprietary technology would disrupt our business. We rely, in part, on trademark, copyright, and trade secret law to protect our intellectual property in the United States and abroad. We seek to protect our software, documentation, and other written materials under trade secret and copyright law, which afford only limited protection. We have additional United States and foreign patent applications pending. We cannot predict whether such pending patent applications will result in issued patents, and if they do, whether such patents will effectively protect our intellectual property. The intellectual property rights we obtain may not be sufficient to provide us with a competitive advantage, and could be challenged, invalidated, infringed or misappropriated. We may not be able to protect our proprietary rights in the United States or internationally (where effective intellectual property protection may be unavailable or limited), and competitors may independently develop technologies that are similar or superior to our technology, duplicate our technology or design around any patent of ours. We attempt to further protect our proprietary technology and content by requiring

our employees and consultants to enter into confidentiality and assignment of inventions agreements and third parties to enter into nondisclosure agreements. These agreements may not effectively prevent unauthorized use or disclosure of our confidential information, intellectual property or technology and may not provide an adequate remedy in the event of unauthorized use or disclosure of our confidential information, intellectual property or technology. Litigation may be necessary in the future to enforce our intellectual property rights, to determine the validity and scope of our proprietary rights or the rights of others, or to defend against claims of infringement or invalidity. Such litigation could result in substantial costs and diversion of management time and resources and could have a material adverse effect on our business, financial condition, and operating results. Any settlement or adverse determination in such litigation would also subject us to significant liability.

- 2. Third parties might infringe upon our technology, trademark, or other proprietary rights, or think we are infringing upon their rights. We cannot assure you that the steps we have taken to protect our property rights will prevent misappropriation of our technology. To protect our rights to our intellectual property, we plan to rely on a combination of trade secrets, confidentiality agreements and other contractual arrangements with our employees, affiliates, strategic partners and others. We may be unable to detect inappropriate use of our technology. Failure to adequately protect our intellectual property could materially harm our brand, devalue our proprietary content and affect our ability to compete effectively. Further, defending any technology rights could result in significant financial expenses and managerial resources.
- 3. Regulatory Risk The regulations to which we are subject are complex and have tended to become more stringent over time. Regulatory changes could result in restrictions on our ability to carry on or expand our operations, higher than anticipated costs or lower than anticipated revenues. Failure to comply with applicable regulations could jeopardize our ability to sell our products and result in enforcement actions such as fines, civil penalties, injunctions, warning letters, recalls of products, delays in the introduction of products into the market, refusal of the regulatory agency or other regulators to grant future clearances and approvals, and the suspension or withdrawal of existing approvals by such regulatory agencies. Any of these sanctions could result in higher than anticipated costs or lower than anticipated sales and harm our reputation, business, financial condition and operating results.
- 4. Valuation Risk: Any valuation at this stage is difficult to assess. Unlike listed companies that are valued publicly through market-driven stock prices, the valuation of private companies, especially startups, is difficult to assess and you may risk overpaying for your investment. In addition, there may be additional classes of equity with rights that are superior to the class of equity being sold.
- 5. Limited Operating History Risk: We have a limited operating history upon which investors may base an evaluation of our potential future performance. In particular, we have not proven that we can develop and maintain relationships with key vendors and strategic partners to extract value from our intellectual property, raise sufficient capital in the public and/or private markets, or respond effectively to competitive pressures. As a result, there can be no assurance that we will be able to develop or maintain consistent revenue sources, or that our operations will be profitable and/or generate positive cash flow.
- 6. Key Employee Risk: We are highly dependent on the services of our senior scientists. Our future business and results of operations depend in significant part upon their continued contributions. If we lose those services or if they fail to perform in their current position, or if we are not able to attract and retain skilled employees in addition to the current team, this could adversely affect the development of our business plan and harm our business. In addition, the loss of any other executive officers could harm the Company's business, financial condition, cash flow and results of operations.
- 7. Start-up investing is risky: Investing in startups is very risky, highly speculative, and should not be made by anyone who cannot afford to lose their entire investment. Similar reliance has been placed on apparently available exemptions from securities registration or qualification requirements under

applicable state securities laws. No assurance can be given that any offering currently qualifies or will continue to qualify under one or more of such exemptive provisions due to, among other things, the adequacy of disclosure and the manner of distribution, the existence of similar offerings in the past or in the future, or a change of any securities law or regulation that has retroactive effect. You may not have the opportunity, as part of your investment decision, to assess whether the proceeds are being used appropriately.

19. The Securities issued by the Company will not be freely tradable until one year from the initial purchase date. Although the Securities may be tradable under federal securities law, state securities regulations may apply, and each Investor should consult with his or her attorney.

You should be aware of the long-term nature of this investment. There is not now and likely will not be a public market for the Securities. We cannot assure you that the Securities could be resold by you at the Offering price or at any other price.

- 24. In addition to the risks listed above, businesses are often subject to risks not foreseen or fully appreciated by the management. It is not possible to foresee all risks that may affect us. Moreover, the Company cannot predict whether the Company will successfully effectuate the Company's current business plan. MISAA, LLC (the "Company") is presently a vessel with newly assigned assets and operations to be created in 2024. Staff and support and all other resources are currently in Intelligent Optical Systems and will be moved into the Company as funds are raised and as the Department of Army Small Business Innovation Research ("SBIR") is approved. IOS expects further SBIR-type funding for the resources necessary to support further testing and FDA approval. The relationship between IOS and the Company is as follows: IOS, Inc., is a company more than two decades old, devoted to fulfilling SBIR/STTR (Small Business Innovation Research SBIR and Small Business Technology Transfer STTR programs) contracts for government and business customers and commercializing the results. The Company has been created by IOS. Inc to commercialize one of IOS's most successful products, an In Vitro Diagnostic (IVD), the TacAssay. IOS has assigned all patent rights and patent application rights all inventions, innovations, technology, trade secrets, know-how and other intellectual property, and all other intellectual property rights related to TacAssay to MISAA. The assignment document is Exhibit E to our operating agreement, which is uploaded as a separate document, along with this Offering Statement. IOS has received 10 million Class A Units of the Company in exchange for the assignment of this intellectual property and intellectual property rights. IOS is the initial member of the Company, and the Company now seeks financing under Regulation CF and is selling Class B Units. The entire staff which has done all TacAssay product development, and which has managed the FDA approval process, all the laboratory facilities, and all the support facilities supporting the staff and involved in the product's development, and the management thereof, is with IOS at the moment. We anticipate that the next stage of TacAssay product testing and development will be paid for under a \$1.3 million SBIR contract being finalized now with the Department of Defense. The contract is expected to be signed early in Q2 of 2024 and is expected to pay for the majority of the work to be done for the FDA approval process. As staff and facilities are released from the Department of Defense contract, they will be transferred to the Company. The Company has access to a fully functioning accounting, human resources, and operational capability operated by IOS, all of which will be transferred to the Company as it is needed. The Company has an independent Board of Directors and will have its own independent operational management as its operations are set in motion. Reuben Sandler CEO and board member, converted a \$300,000 loan into equity of the parent company, IOS, and Henry Lichstein, the CFO of IOS, made a short-term Loan to IOS \$196,000 with no maturity date and no interest rate.
