Our business expansion goals are focused on selling to large regional and national outlets.

Sonic Power, Inc. is offering up to 1,200,000 shares of Series Seed Preferred stock, at a **price per share of \$1.00**.

The campaign maximum \$1,200,000.00 is and the campaign minimum is \$50,000.00.

Securities Issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV is formed concurrently with the filing of the Form C. Given this, the SPV does not have any financials to report. The SPV is managed by Wefunder Admin. LLC and is a co-issuer with the

Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

Voting Rights

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

Restriction on Transferability

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

Series Seed Preferred Stock Designation

Voting. The holders Series Seed Preferred Stock vote with holders of Common Stock together as a single class. Each share of Series Seed Preferred Stock is entitled to a number of votes equal to the number of shares of Class A Common Stock into which the share is convertible.

Protective Provisions. As long as any of the Preferred Stock

shall be outstanding, the Corporation shall not, without first obtaining the approval (whether at a meeting of stockholders of the Corporation, by written action of stockholders in lieu of a meeting or otherwise) of the holders of more than 50% of the outstanding shares of the Preferred Stock:

(a) amend, alter or repeal any provision of the Series Seed Preferred Stock designation;

(b) increase or decrease the authorized number of shares of Series Seed Preferred Stock; or

(c) enter into any liquidation, dissolution or winding up of the Corporation unless a sum equal to the Redemption Price

for all outstanding shares of Series Seed Preferred Stock is set aside for payment, in which case, the holders of shares

of Series Seed Preferred Stock shall have no right to vote on any such transaction.

Dividends. Until such time as the Corporation has paid aggregate dividends or made other distribution of assets to the holders of shares Series Seed Preferred Stock equal to the Original Issue Price (\$1) for each share of Series Seed Preferred Stock, the Corporation shall not declare or pay any cash dividends or make any other distribution of assets on the class of Common Stock, including any distribution in shares of Common Stock.

Liquidation. In the event of any voluntary or involuntary liquidation, dissolution or winding up of the Corporation, subject to the rights of any Senior Securities, the holders of shares Series Seed Preferred Stock shall receive, before any payment is made to the holders of Common Stock, an amount in cash or other assets equal to the Original Issue Price Deemed Liquidation. Each of the following shall be deemed to be a liquidation, dissolution or winding up of the Corporation: (i) the acquisition of the Corporation by another entity, except one in which the holders of stock outstanding immediately prior to such transaction retain at least a majority of the total voting power in the surviving or resulting entity; (ii) a sale, lease or other disposition of all or substantially all of the assets of the Corporation; or (iii) any liquidation, dissolution or winding up of the Corporation, whether voluntary or involuntary.

Conversion.

Right to Convert. A holder of Series Seed Preferred Stock has the right his shares of Series Seed Preferred Stock into a number of shares of Class A Common Stock as is determined by (x) multiplying the number of shares to be converted by the Original Issue Price thereof, and then (y) dividing the result by the Conversion Price in effect immediately prior to such conversion. The initial conversion price per share (the "Conversion Price") shall be the Original Issue Price, subject to adjustment.

Automatic Conversion. Upon (i) the payment to holders of Series Seed Preferred Stock of a sum equal to the Original Issue Price or (ii) in connection with, and on the closing of, a Qualified Public Offering (\$10 million), all of the outstanding shares of Series Seed Preferred Stock automatically convert into an aggregate number of shares of Class A Common Stock as is determined by (x) multiplying the number of shares to be converted by the Original Issue Price, and then (y) dividing the result by the applicable Conversion Price then in effect. Adjustments to Conversion Price and/or Number of shares

Issuable upon Conversion. Proportionate adjustment upon forward or reverse stock split. If the Class A Common Stock issuable upon conversion of the Series Seed Preferred Stock is changed into the same or a different number of shares of any other class of stock, whether by capital reorganization, reclassification or otherwise, in lieu of the number of shares of Class A Common Stock which the holders would otherwise have received, each holder of Series Seed Preferred Stock shall have the right thereafter to convert shares of Series Seed Preferred Stock into a number of shares of such other class or classes of stock which a holder of the number of shares of Class A Common Stock deliverable upon conversion of the Series Seed Preferred Stock immediately before that change.

Redemption. At any time issuance, the Corporation has the right to redeem all (but not less than all) of the outstanding shares of Series Seed Preferred Stock by (i) paying to the holders of Series Seed Preferred Stock a sum equal to the Series Seed Liquidation Price (which is equal to the Original Issue Price less the aggregate of all amounts previously paid or of the Fair Market Value of amounts distributed to the holders of Series Seed Preferred Stock) multiplied by the number of shares held and (ii) issuing to the holder a number of fully-paid, nonassessable shares of Class A Common Stock calculated by (x) multiplying the number of shares of Series Seed Preferred Stock by (y) the Original Issue Price, and then, (z) dividing the product of (x) and (y) by the applicable Conversion Price.

Milestones

Sonic Power, LLC. was organized in the State of FL in September, 2022. The Company converted to a Nevada C Corp in January 2024.

Since then, we have:

- 10,000+ customers in all 50 US states
- \$571,714 in gross sales since Jan 2023 launch
- 40M+ unique social media interactions (views, comments, likes, & shares)
- Target.com launching Q1 2024
- Products sold on Good Morning America and CBS Mornings digital platforms
- Launched 17 unique products in 2023 across various categories
- First retail "Pop-Up" concepts generated \$20k in 2 months (Nov-Dec 2023)

Historical Results of Operations

Our company was organized in September 2022 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended December 31, 2022, the Company had revenues of \$2,664. Our gross margin was 71.47% in fiscal year 2022.
- *Assets.* As of December 31, 2022, the Company had total assets of \$579,771, including \$344,859 in cash
- *Net Loss.* The Company has had net losses of \$23,878 for the fiscal year ending December 31, 2022.
- *Liabilities.* The Company's liabilities totaled \$101,602 for the fiscal year ended December 31, 2022.

To-date, the company has been financed with \$100,000 in debt and \$850,000 in equity.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 24 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 24 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses Sonic Power, Inc. cash in hand is \$18,111, as of January 2024. Over the last three months, revenues have averaged \$71,683/month, cost of goods sold has averaged \$17,900/month, and operational expenses have averaged \$28,772/month, for an average net margin of \$25,011 per month. Our intent is to be profitable in 7 months.

Our 2022 financials cover the capitalization by the initial members shortly after official company formation. Shortly after we started ramping our inventory spend and officially went to market Q1 2023. We ended 2023 with gross sales of \$538,069 with approximately \$190,000 left in inventory.

Over the next 6 months we expect revenues of \$850,000 and \$450,000 in operating expenses.

Currently we are not profitable. According to our analysis, we need \$66,522 in funding to reach profitability by August 2024.

We are lucky enough to have current investors who have been willing to provide interest free access to capital on an as needed basis to cover short term burn during this Wefunder Offering.

Pursuant to the Proxy, the Lead Investor or his or her successor will make voting decisions and take any other actions in connection with the voting on Investors’ behalf.

The Lead Investor is an experienced investor that is chosen to act in the role of Lead Investor on behalf of Investors that have a Proxy in effect. The Lead Investor will be chosen by the Company and approved by Wefunder Inc. and the identity of the initial Lead Investor will be disclosed to Investors before Investors make a final investment decision to purchase the securities related to the Company.

The Lead Investor can quit at any time or can be removed by Wefunder Inc. for cause or pursuant to a vote of investors as detailed in the Lead Investor Agreement. In the event the Lead Investor quits or is removed, the Company will choose a Successor Lead Investor who must be approved by Wefunder Inc. The identity of the Successor Lead Investor will be disclosed to Investors, and those that have a Proxy in effect can choose to either leave such Proxy in place or revoke such Proxy during a 5-day period beginning with notice of the replacement of the Lead Investor.

The Lead Investor will not receive any compensation for his or

her services to the SPV. The Lead Investor may receive compensation if, in the future, Wefunder Advisors LLC forms a fund ("Fund") for accredited investors for the purpose of investing in a non-Regulation Crowdfunding offering of the Company. In such as circumstance, the Lead Investor may act as a portfolio manager for that Fund (and as a supervised person of Wefunder Advisors) and may be compensated through that role.

Although the Lead Investor may act in multiple roles with respect to the Company's offerings and may potentially be compensated for some of its services, the Lead Investor's goal is to maximize the value of the Company and therefore maximize the value of securities issued by or related to the Company. As a result, the Lead Investor's interests should always be aligned with those of Investors. It is, however, possible that in some limited circumstances the Lead Investor's interests could diverge from the interests of Investors, as discussed in section 8 above.

Investors that wish to purchase securities related to the Company through Wefunder Portal must agree to give the Proxy described above to the Lead Investor, provided that if the Lead Investor is replaced, the Investor will have a 5-day period during which he or she may revoke the Proxy. If the Proxy is not revoked during this 5-day period, it will remain in effect.

Tax Filings. In order to complete necessary tax filings, the SPV is required to include information about each investor who holds an interest in the SPV, including each investor's taxpayer identification number ("TIN") (e.g., social security number or employer identification number). To the extent they have not already done so, each investor will be required to provide their TIN within the earlier of (i) two (2) years of making their investment or (ii) twenty (20) days prior to the date of any distribution from the SPV. If an investor does not provide their TIN within this time, the SPV reserves the right to withhold from any proceeds otherwise payable to the Investor an amount necessary for the SPV to satisfy its tax withholding obligations as well as the SPV's reasonable estimation of any penalties that may be charged by the IRS or other relevant authority as a result of the investor's failure to provide their TIN. Investors should carefully review the terms of the SPV Subscription Agreement for additional information about tax filings.

INSTRUCTIONS TO QUESTION 30: If information is presented to investors in a format, media or other means not able to be reflected in text or portable document format, the issuer should include:

ONGOING REPORTING

32. The issuer will file a report electronically with the Securities & Exchange Commission annually and post the report on its website, no later than:

120 days after the end of each fiscal year covered by the report.

3. the issuer has filed at least three annual reports and has total assets that do not exceed \$10 million;
4. the issuer or another party purchases or repurchases all of the securities issued pursuant to Section 4(a)(6), including any payment in full of debt securities or any complete redemption of redeemable securities; or the issuer liquidates or dissolves in accordance with state law.
