Competitors entering the market with higher marketing budgets. This could slow our growth as we keep a limited budget to enter a competitor dispute.

Little Rebels is a small team executing the company's mission and tasks at the moment. All processes and company growth heavily rely on the company's founder for the moment.

Increasing shipping and transportation costs are driving retail prices up while also lowering gross profit margins.

International Trade Regulations, customs duty changes, and tariffs are factors in international trade. Although plush toys have been excluded in the past from duties and tariffs, changes in governments can always affect supply chain costs.

This round won't secure the success of the company for the next year. We will be launching a new round, for seed investment in order to keep growing in a healthy way, but there are no guarantees on when would that happen.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from this Offering. Accordingly, the Company will have broad discretion in using these proceeds.

If we raise: **\$25,000**

Use of Proceeds: 7.5% towards WeFunder fees, 35% marketing, 25% inventory, 32.5% sales. We could do more marketing if we raised a larger amount, however, we are only planning on accepting a small, \$25k community allocation at this time.

If we reach our target offering amount prior to the deadline, we may conduct an initial closing of the offering early if we provide notice about the new offering deadline at least five business days prior to the new offering deadline (absent a material change that would require an extension of the offering and reconfirmation of the investment commitment). Wefunder will notify investors if we conduct an initial closing. Thereafter, we may conduct additional closings from time to time at our and Wefunder's discretion until the deadline date.

The following describes the process to invest in the Company, including how the Company will complete an Investor's transaction and deliver securities to the investor.

1. Investor Commitment. The Investor will submit, through Wefunder Portal, a requested investment amount. When doing so, the Investor will also execute an investment contract with the Company ("Investment Agreement"), using the Investor's electronic signature.
2. Acceptance of the Investment. If the Investor Agreement is complete, the Investor's commitment will typically be recorded within a few minutes. 3. Investor Transfer of Funds. The company is issuing promissory notes to investors. The principal amount of each note is the amount invested by the investor. The company will use 5% of its net revenues to pay back principal on the notes. Each note will be paid back based on its pro rata share of all notes issued in this offering. The company will make interest payments to the investor quarterly. The company may prepay principal and interest at any time. The company will continue payments until investors have received 2.0x their principal investment (the repayment amount), provided however that at any time the company may defer up to 1 such payments upon notice to the Lender.

Investors in the **first \$10,000.00 of the fundraiser will receive 2.5x their principal.**

**Upon the occurrence of an event of default (as defined in each note), all unpaid principal, accrued interest and other amounts owing will automatically be immediately due, payable and collectible by the company pursuant to applicable law.**

18. How may the rights of the securities being offered be materially limited, diluted or qualified by the rights of any other class of security identified above?

Because the Investor holds no voting rights in the company, the holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering). These decisions could affect net revenues and diminish payments made to Investors.

Based on the risk that the company may never realize revenues or face a Default Event, the Investor may never see any returns.

Additional risks related to the rights of other security holders are discussed below, in Question 20.

20. How could the exercise of rights held by the principal shareholders identified in Question 6 above affect the purchasers of the securities being offered?

As holders of a majority-in-interest of voting rights in the Company, the shareholders may make decisions with which the Investor disagrees, or that negatively affect the net revenues of the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, the shareholders may change the terms of the Operating Agreement for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. The shareholders may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. Other holders of securities of the Company may also have access to more information than the Investor, leaving the Investor at a disadvantage with respect to any decisions regarding the securities he or she owns.

The shareholders have the right to redeem their securities at any time. shareholders could decide to force the Company to redeem their securities at a time that is not favorable to the Investor and is damaging to the Company. Investors' exit may affect the value of the Company and/or its viability.

In cases where the rights of holders of convertible debt, SAFEs, or other outstanding options or warrants are exercised, or if new awards are granted under

our equity compensation plans, an Investor's interests in the Company may be negatively affected.

Based on the risks described above, the Investor could lose all or part of his or her investment in the securities in this offering, and may never see positive returns.

21. How are the securities being offered being valued? Include examples of methods for how such securities may be valued by the issuer in the future, including during subsequent corporate actions.

The offering price for the securities offered pursuant to this Form C has been determined arbitrarily by the Company, and does not necessarily bear any relationship to the Company's book value, assets, earnings or other generally accepted valuation criteria. In determining the offering price, the Company did not employ investment banking firms or other outside organizations to make an independent appraisal or evaluation. Accordingly, the offering price should not be considered to be indicative of the actual value of the securities offered hereby.

The value of the promissory notes will be determined by the Company's senior management in accordance with U.S. generally accepted accounting principles. For example, the notes may be valued based on principal plus anticipated interest payments over the course of the term of the note.

22. What are the risks to purchasers of the securities relating to minority ownership in the issuer?

An Investor in the promissory notes holds no position in the Company and will have no voting rights in the Company, and thus will be limited as to its ability to control or influence the governance and operations of the Company.

The marketability and value of the Investor's interest in the Company will depend upon many factors outside the control of the Investor. The Company will be managed by its officers and be governed in accordance with the strategic direction and decision-making of its board of directors, and the Investor will have no independent right to name or remove an officer or member of the board of directors of the Company.

23. What are the risks to purchasers associated with corporate actions, including additional issuances of securities, issuer repurchases of securities, a sale of the issuer or of assets of the issuer or transactions with related parties?

Additional issuances of securities. Following the Investor's investment in the Company, the Company may sell interests to additional investors, which will dilute the percentage interest of the Investor in the Company. The Investor may have the opportunity to increase its investment in the Company in such a transaction, but such opportunity cannot be assured. The amount of additional financing needed by the Company, if any, will depend upon the maturity and objectives of the Company. The declining of an opportunity or the inability of the Investor to make a follow-on investment, or the lack of an opportunity to make such a follow-on investment, may result in substantial dilution of the Investor's interest in the Company.

Issuer repurchases of securities. The Company may have authority to repurchase its securities from shareholders, which may serve to decrease any liquidity in the market for such securities, decrease the percentage interests held by other similarly situated investors to the Investor, and create pressure on the Investor to sell its securities to the Company concurrently.

A sale of the issuer or of assets of the issuer. As a minority owner of the Company, the Investor will have limited or no ability to influence a potential sale of the Company or a substantial portion of its assets. Thus, the Investor will rely upon the executive management of the Company and the Board of Directors of the Company to manage the Company so as to maximize value for shareholders. Accordingly, the success of the Investor's investment in the Company will depend in large part upon the skill and expertise of the executive management of the Company and the Board of Directors of the Company. If the Board Of Directors of the Company authorizes a sale of all or a part of the Company, or a disposition of a substantial portion of the Company's assets, there can be no guarantee that the value received by the Investor, together with the fair market estimate of the value remaining in the Company, will be equal to or exceed the value of the Investor's initial investment in the Company.

Transactions with related parties. The Investor should be aware that there will be occasions when the Company may encounter potential conflicts of interest in its operations. On any issue involving conflicts of interest, the executive management and Board of Directors of the Company will be guided by their good faith judgement as to the Company's best interests. The Company may engage in transactions with affiliates, subsidiaries or other related parties, which may be on terms which are not arm's-length, but will be in all cases consistent with the duties of the management of the Company to its shareholders. By acquiring an interest in the Company, the Investor will be deemed to have acknowledged the existence of any such actual or potential conflicts of interest and to have waived any claim with respect to any liability arising from the existence of any such conflict of interest.

### Milestones

Little Rebels Inc. was incorporated in the State of Delaware in April 2019.

Since then, we have:

- TAGIE Awards winners
- Available nationwide at museums, toy stores, and major retailers like Macy's, Smithsonian, Airports
- Our founder was chosen as one of the 100 most influential people in the industry
- Partnership with The Malala Fund
- Offering investors a 2x return with projected repayment in 3 years (not guaranteed)

The Company is subject to risks and uncertainties common to early-stage companies. Given the Company's limited operating history, the Company cannot reliably estimate how much revenue it will receive in the future.

### Historical Results of Operations

- *Revenues & Gross Margin.* For the period ended December 31, 2022, the Company had revenues of \$5,614 compared to the year ended December 31, 2021, when the Company had revenues of \$7,247. Our gross margin was 63.36% in fiscal year 2022, compared to 61.39% in 2021.
- *Assets.* As of December 31, 2022, the Company had total assets of \$5,109, including \$10 in cash. As of December 31, 2021, the Company had \$757 in total assets, including \$147 in cash.
- *Net Loss.* The Company has had net losses of \$210 and net income of \$2,175 for the fiscal years ended December 31, 2022 and December 31, 2021, respectively.
- *Liabilities.* The Company's liabilities totaled \$5,000 for the fiscal year ended December 31, 2022 and \$438 for the fiscal year ended December 31, 2021.

### Liquidity & Capital Resources

To-date, the company has been financed with \$5,343 in debt.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 4 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 6 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

### Runway & Short/Mid Term Expenses

Little Rebels Inc. cash in hand is \$129, as of January 2024. Over the last three months, revenues have averaged \$1,200/month, cost of goods sold has averaged \$465/month, and operational expenses have averaged \$500/month, for an average net margin of \$235 per month. Our intent is to be profitable in 1 months.

Since the date our finances cover, we have launched our Wefunder page and are currently working to raise an additional \$10k outside of Wefunder. This funding will allow us to have more inventory, invest in toy shows and marketing, and boost our sales.

We are cashflow positive from Operations. Our goal with this campaign is to accelerate our Marketing and Sales efforts which require investment upfront (e.g., tradeshow, ads, PR, ...). Since this is a Revenue Funding campaign, we are offering a Revenue Share of our future sales that we are looking to secure through this \$25,000 sales acceleration. Over the next 3-6 months we are expecting to double our revenues while keeping our expenses as lean as they are today.

We are currently profitable despite global toy sales forecasts declining by over

20% for 2023 compared to the hypes of the COVID years in 2020 and 2021. The industry is currently going through a restructuring with larger companies such as Mattel and HASBRO laying off 1000s of workers. Our financials and forecasts are according to our projections. Not only have we shown at Little Rebels the importance of lean operations and scaling as we grow, but there also is a recent chain of M&A events with new innovative toy brands getting acquired by the mid-sized giants in the industry (e.g., Spin Master acquired Melissa and Doug).

Besides Wefunder, we are currently finalizing \$10K in financing from a Latin American accelerator, Sancor Seguros Impulsa, from Argentina. Besides that, our sales are raising and we are looking to keep the trend growing since we want our main source of capital to come from our sales.
