The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. Book Entry and Investment in the Co-Issuer. Investors will make their investments by investing in interests issued by one or more co-issuers, each of which is a special purpose vehicle ("SPV"). The SPV will invest all amounts it receives from investors in securities issued by the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. The main terms of the SAFEs are provided below.

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity (“SAFE”), which provides Investors the right to CF Shadow Series of the Capital Stock (whether Preferred Stock or another class issued by the Company) equal to the Purchase Amount divided by the Conversion Price

“CF Shadow Series” shall mean a series of Capital Stock that is identical in all respects to the shares of Capital Stock (whether Preferred Stock or another class issued by the Company) issued in the relevant Equity Financing (e.g., if the Company sells Series A Preferred Stock in an Equity Financing, the Shadow Series would be Series A-CF Preferred Stock), except that:

a. **CF Shadow Series shareholders shall have no voting rights** and shall not be entitled to vote on any matter that is submitted to a vote or for the consent of the stockholders of the Company;

b. **CF Shadow Series shareholders have no information or inspection rights**, except with respect to such rights deemed not waivable by laws.

Investors will receive a number of shares of stock calculated using the method that results in the greater number of **stock**:

1. the total value of the Investor’s investment, divided by
 1. the price of **stock** issued to new Investors multiplied by
 2. the **discount rate** (80%), or
2. if the valuation for the company is more than **\$22,000,000.00** (the “Valuation Cap”), the amount invested by the Investor divided by the quotient of
 1. the Valuation Cap divided by
 2. the total amount of the Company’s capitalization at that time.

Management's Discussion and Analysis of Financial Condition and Results of Operations

Overview

Journalism: accessible to all.

Zette is a software company that provides access to premium content through a pay-per-article business model, all while sharing revenue with content partners. Zette's technology allows readers to access, read and share content behind paywalls through a recurring subscription model that grants credit access to a bundle of paid content on a click-to-unlock basis every month.

Milestones

Off Topic Inc. was incorporated in the State of Delaware in July 2020.

Since then, we have:

- 50k beta readers signed up to the platform.
- Offering seamless integration with a wide variety of publishers through long-term partnerships.
- Won Fast Companies 2023 "World Changing Ideas" Award.
- 30-50% margins based on revenue share deals with publishers.

The Company is subject to risks and uncertainties common to early-stage companies. Given the Company's limited operating history, the Company cannot reliably estimate how much revenue it will receive in the future.

Historical Results of Operations

Our company was organized in July 2020 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended December 31, 2022, the Company had revenues of \$12,932 compared to the year ended December 31, 2021, when the Company had revenues of \$2.
- *Assets.* As of December 31, 2022, the Company had total assets of \$130,254, including \$130,254 in cash. As of December 31, 2021, the Company had \$1,197,784 in total assets, including \$1,197,784 in cash.
- *Net Loss.* The Company has had net losses of \$1,060,587 and net losses of \$664,076 for the fiscal years ended December 31, 2022 and December 31, 2021, respectively.
- *Liabilities.* The Company's liabilities totaled \$1,895,207 for the fiscal year ended December 31, 2022 and \$1,904,269 for the fiscal year ended December 31, 2021.

Liquidity & Capital Resources

To-date, the company has been financed with \$40,000 in convertibles and \$2,243,699 in SAFEs.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 8 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 3 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Off Topic Inc. cash in hand is \$36,000, as of January 2024. Over the last three months, revenues have averaged \$0/month, cost of goods sold has averaged \$0/month, and operational expenses have averaged \$9,200/month, for an average burn rate of \$9,200 per month. Our intent is to be profitable in 11 months.

profitable in 11 months.

In H1 2023, we focused the majority of our finances and operations on building and launching the MVP to the public. Due to challenges in the macroeconomic funding environment, we postponed further fundraising plans to Q1 2024. In H2 2023, we iterated on the product, grew our reader base 5x YoY, consolidated headcount of the team, and streamlined expenses to extend runway. We also spent time developing the AI component of the company.

In the next 3-6 months, we're planning to keep expenses low as we gear up for the full launch of our product, including monetization, AI features and the launch of major publisher deals. We expect to continue running lean on a \$10k - \$20k monthly burn rate for H1 2024. We're expecting revenue to quickly rise once monetization is open, thanks to (i) a strong user base, including both existing Zette readers and new readers from our acquisition of "Below the Fold" in Q4 2023; (ii) the addition of highly requested publishers and new AI features; and (iii) an extremely strong news cycle in 2024 due to the presidential election. As a result, we are expected to generate ~\$40k in monthly recurring revenues by the end of Q2 2024.

We are not yet profitable. We will need an estimated \$500k in additional funding to reach profitability, and we expect to reach this point between Q4 2024 and Q1 2025. Prior to net profitability, our revenue is expected to exceed operational costs after 2-3 quarters. After that, only content costs are expected to exceed revenue, but with advantageous payment terms.

We have enough capital to cover short-term burn throughout the campaign. Outside of Wefunder, we have an open fundraising vehicle (Angellist RUV) for accredited investors, which we aim to close in H1 2024. We also plan to open monetization in Q2 2024. We also plan to fundraise from VCs in H1 2024.

All projections in the above narrative are forward-looking and not guaranteed.

The Proxy is irrevocable unless and until a Successor Lead Investor takes the place of the Lead Investor, in which case, the Investor has a five (5) calendar day period to revoke the Proxy. Pursuant to the Proxy, the Lead Investor or his or her successor will make voting decisions and take any other actions in connection with the voting on Investors' behalf.

The Lead Investor is an experienced investor that is chosen to act in the role of Lead Investor on behalf of Investors that have a Proxy in effect. The Lead Investor will be chosen by the Company and approved by Wefunder Inc. and the identity of the initial Lead Investor will be disclosed to Investors before Investors make a final investment decision to purchase the securities related to the Company.
