The Company relies in significant part on the healthcare market's reimbursement models

A significant portion of the Company's business is generated by its ability to attract healthcare stakeholders willing to budget for select non-billable services via marketing and technology processes

The Company operates in a dynamic industry, and accordingly, can be affected by a variety of factors.

Management of the Company believes that changes in any of the following areas could have a significant negative impact on the Company in terms of its future financial position, results of operations, or cash flows:

- Ability to obtain additional financing;
- Advances and trends in new technologies and industry standards;
- Changes in certain strategic relationships or customer relationships;
- Changes in government policy;

Marketplace monetization model requires volume of engaged users and the right offerings. Should we be unable to grow the marketplace sufficiently, we may not be able to generate sufficient future profits.

The risks described above are not the only ones the Company faces. Additional risks that we currently do not know about or that we currently believe to be immaterial may also impair our operations and business results

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. If we raise: **\$124,000**

Use of Proceeds: 35% Operational and Staffing, 35% Product Design and Development, 15% Sales and Marketing, 7.5% R&D, 7.5% Wefunder fee. \$124K would afford Ella Es Health the ability to recruit both a coach and health navigator to fully test run the model.

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides Investors the right to **preferred stock** in the Company ("Preferred Stock"), when and if the Company sponsors an equity offering that involves **Preferred Stock**, on the standard terms offered to other Investors.

Conversion to Preferred Equity. Based on our SAFEs, when we engage in an offering of equity interests involving **preferred stock**, **Investors will receive a number of shares of preferred stock** calculated using the method that results in the greater number of **preferred stock**:

- i. the total value of the Investor's investment, divided by
 - a. the price of **preferred stock** issued to new Investors multiplied by

- ii. if the valuation for the company is more than **\$6,000,000.00** (the "Valuation Cap"), the amount invested by the Investor divided by the quotient of
 - a. the Valuation Cap divided by
 - b. the total amount of the Company's capitalization at that time.

Liquidity Priority. In a Liquidity Event or Dissolution Event, this Safe is intended to operate like standard nonparticipating Preferred Stock. The Investor's right to receive its Cash-Out Amount is:

- i. Junior to payment of outstanding indebtedness and creditor claims, including contractual claims for payment and convertible promissory notes (to the extent such convertible promissory notes are not actually or notionally converted into Capital Stock);
- ii. On par with payments for other Safes and/or Preferred Stock, and if the applicable Proceeds are insufficient to permit full payments to the Investor and such other Safes and/or Preferred Stock, the applicable Proceeds will be distributed pro rata to the Investor and such other Safes and/or

be distributed pro rata to the investor and such other sales and/or Preferred Stock in proportion to the full payments that would otherwise be due; and

iii. Senior to payments for Common Stock.

The company has authorized no Preferred Stock to date. Investors in the SAFE, if converted as part of an equity financing, will receive Preferred Stock. Preferred Stock has a liquidation preference over Common Stock.

18. How may the rights of the securities being offered be materially limited, diluted or qualified by the rights of any other class of security identified above?

The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

The Company is subject to risks and uncertainties common to early-stage companies. Given the Company's limited operating history, the Company cannot reliably estimate how much revenue it will receive in the future.

Historical Results of Operations

Our company was organized in January 2022 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenue.* For the period ended December 31, 2023, the Company had revenues of \$0 compared to the year ended December 31, 2022, when the Company had revenues of \$0.
- *Assets.* As of December 31, 2023, the Company had total assets of \$13,367, including \$13,367 in cash. As of December 31, 2022, the Company had \$7,231 in total assets, including \$7,231 in cash.
- *Net Loss.* The Company has had net losses of \$7,114 and net losses of \$7,769 for the fiscal years ended December 31, 2023 and December 31, 2022, respectively.
- *Liabilities.* The Company's liabilities totaled \$0 for the fiscal year ended December 31, 2023 and \$5,000 for the fiscal year ended December 31, 2022.

Liquidity & Capital Resources

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 18 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 6 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Ella Es Health, Inc. cash in hand is \$13,367.22, as of March 2024. Over the last three months, revenues have averaged \$0/month, cost of goods sold has averaged \$0/month, and operational expenses have averaged \$957/month, for an average burn rate of \$957 per month. Our intent is to be profitable in 12 months.

There are no material changes since the date our financials cover. Founders contribute \$250 each month to cover operational expenses. Legal, accounting fees are generally the monthly expenditures

Over the next 3-6 months, we expect no revenue until a partnership has been established, which may take over 6 months. In order to become revenue generating, we need staff and a product director, which we'd expect to be ~\$300K. We expect expenses to be \$900/month on average over the next 3-6 months.

We are not currently profitable. We will need at least \$300k to become profitable. Assuming we raise that, we expect profitability Q4 2024. Key infrastructure expenses include: Initial wireframe, staffing: 1 Lifestyle/health coach and product director, project manager and internal collaboration tool. The \$300K includes the \$124K from WeFunder. We plan to raise the rest from VCs and healthplan partnerships for example, that may agree to augment our funding to help build the model. We may also include later rounds through WeFunder.

Besides funds raised through Wefunder, other sources of capital include individual founder monthly contributions that will cover short-term burn rate. We're exploring private VCs and PE firms as well.

All projections in the above narrative are forward-looking and not guaranteed.
