8. Discuss the material factors that make an investment in the issuer speculative or risky:

We have had a 50% increase in wool yarn cost due to the closure of our original wool yarn supplier, National Spinning, Inc. We've found an alternative wool spinning company that is actually higher quality but in order to match the same yarn specs we've had, it will need to be a custom order which is approximately 50.6% more expensive than our previous supplier. We've already raised prices in anticipation of this price change and customers are still buying our socks.

There is only 1 wool top maker in the USA, called Chargeurs. It is highly unlikely they go out of business due to major partnerships and lobbying from large groups of American sheep farmers, but their closure would interfere with our operations since we would have spin wool by hand.

Outsourcing to China and Asia is a risk. The outsourcing of textile jobs is one of the main reasons we got into this business. The reason our wool supplier closed after over 100 years is due to outsourcing. We will continue to fight to bring textile jobs back to America, but it takes everyone making their apparel purchases statements of patriotism. Yes, it costs more, but it should. We believe American labor is the best labor, and Americans should be compensated well for their hard work. If the market does agree with our view of compensating American labor fairly for American-made goods, this would impede our cash flows.

Growing may be challenging as we face hiring decisions. We have a very niche goal and target market, so finding someone who fits well within our company will

be challenging no doubt. Veterans will be a great place to start when the time comes to being looking for talent.

We have a small management team. Although our management team is small, we do have a work ethic like no other. It's why none of us have taken a dime since the inception of this company. It takes sacrifices to be successful and we are fully prepared. And loss to our small team could be a significant burden.

Economic uncertainty. Given the Fed's position on driving inflation down to 2%, they may force us into a recession instead of achieving a soft landing as intended. If this is the case, we may see a decrease in sales due to recession.

Megan Compton is a part-time officer. As such, it is likely that the company will not make the same progress as it would if that were not the case.

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from this Offering. Accordingly, the Company will have broad discretion in using these proceeds.

10. How does the issuer intend to use the proceeds of this offering?

If we raise: **\$50,000**

Use of Proceeds: 30% towards marketing and content creation to better engage our audience of 87k followers on Instagram. 7.9% towards Wefunder fees. 33% for wool yarn purchases. 9.1% for yarn dying. 20% for knitting 1/3 of the yarn purchased.

If we raise: **\$124,000**

Use of Proceeds: 16% towards marketing and content creation to better engage our audience of 87k followers on Instagram. 7.9% towards Wefunder fees. 15% for wool yarn purchases. 4.1% for yarn dying. 22% for knitting all of the yarn purchased. 6% to purchase packaging for the socks. 10% all in cost to attend SHOT Show 2025. 4% to attend 2025 Bataan Memorial Death March. 13% pay for employees. 2% cash reserves.

The company is issuing promissory notes to investors. The principal amount of each note is the amount invested by the investor. The company will use **9% of its gross revenues** to pay back principal on the notes. Each note will be paid back based on its pro rata share of all notes issued in this offering. The company will make interest payments to the investor quarterly. The company may prepay principal and interest at any time. The company will continue payments until investors have received **2.0x their principal investment** (the repayment amount) , provided however that at any time the company may defer up to 1 such payments upon notice to the Lender.

Investors in the **first \$15,000.00 of the fundraise will receive 2.2x their principal**. Wefunder VIP investors will be entitled to these terms for the entire duration of the offering, even if the threshold limit noted above is met. Therefore, the company could potentially offer all \$124,000.00 at 2.2x their principal.

Upon the occurrence of an event of default (as defined in each note), all unpaid principal, accrued interest and other amounts owing will automatically be immediately due, payable and collectible by the company pursuant to applicable law.

The notes do not provide investors with any voting rights in the company.

18. How may the rights of the securities being offered be materially limited, diluted or qualified by the rights of any other class of security identified above?

Because the Investor holds no voting rights in the company, the holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering). These decisions could affect gross revenues and diminish payments made to Investors.

Based on the risk that the company may never realize revenues or face a Default Event, the Investor may never see any returns.

Additional risks related to the rights of other security holders are discussed below, in Question 20.

20. How could the exercise of rights held by the principal shareholders identified in Question 6 above affect the purchasers of the securities being offered?

As holders of a majority-in-interest of voting rights in the Company, the unitholders may make decisions with which the Investor disagrees, or that negatively affect the gross revenues of the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, the unitholders may change the terms of the Operating Agreement for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. The unitholders may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. Other holders of securities of the Company may also have access to more information than the Investor, leaving the Investor at a disadvantage with respect to any decisions regarding the securities he or she owns.

The unitholders have the right to redeem their securities at any time. unitholders could decide to force the Company to redeem their securities at a time that is not favorable to the Investor and is damaging to the Company. Investors' exit may affect the value of the Company and/or its viability.

In cases where the rights of holders of convertible debt, SAFEs, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be negatively affected.

Based on the risks described above, the Investor could lose all or part of his or her investment in the securities in this offering, and may never see positive returns.

The offering price for the securities offered pursuant to this Form C has been determined arbitrarily by the Company, and does not necessarily bear any relationship to the Company's book value, assets, earnings or other generally accepted valuation criteria. In determining the offering price, the Company did not employ investment banking firms or other outside organizations to make an independent appraisal or evaluation. Accordingly, the offering price should not be considered to be indicative of the actual value of the securities offered hereby.

The value of the promissory notes will be determined by the Company's senior management in accordance with U.S. generally accepted accounting principles. For example, the notes may be valued based on principal plus anticipated interest payments over the course of the term of the note.

22. What are the risks to purchasers of the securities relating to minority ownership in the issuer?

An Investor in the promissory notes holds no position in the Company and will have no voting rights in the Company, and thus will be limited as to its ability to control or influence the governance and operations of the Company.

The marketability and value of the Investor's interest in the Company will depend upon many factors outside the control of the Investor. The Company will be managed by its officers and be governed in accordance with the strategic direction and decision-making of its management, and the Investor will have no independent right to name or remove an officer or member of the management of the Company.

23. What are the risks to purchasers associated with corporate actions, including additional issuances of securities, issuer repurchases of securities, a sale of the issuer or of assets of the issuer or transactions with related parties?

Additional issuances of securities. Following the Investor's investment in the Company, the Company may sell interests to additional investors, which will dilute the percentage interest of the Investor in the Company. The Investor may have the opportunity to increase its investment in the Company in such a transaction, but such opportunity cannot be assured. The amount of additional financing needed by the Company, if any, will depend upon the maturity and objectives of the Company. Overview

The First Performance Rucking Sock. Made in the USA with 100% American Materials & Labor.

Ruck Sox is an American textile company owned by a disabled veteran that manufactures high-performance socks domestically to reduce blisters for first responders and service members while also working to revive the US textile industry. Using 100% American labor and materials, Ruck Sox aims to support American jobs and provide the highest quality socks to heroes who serve our country.

Milestones

Ruck Sox, LLC was incorporated in the State of North Carolina in March 2022.

Since then, we have:

- Special Operations Disabled Veteran-Owned Company.

- Social media following of over 86k.
- Total Addressable Market is \$23.39B globally, growing at 2.72% annually through 2027.
- \$19k in revenue through the first 8 months.
- 5 retailers outside of Ft. Bragg/Liberty carry our products. All have made several reorders.
- CEO is finishing the MBA program at UNC & plans to pursue a Master of Textiles at NC State.
- We use Shopify e-commerce & POS sales channels.

The Company is subject to risks and uncertainties common to early-stage companies. Given the Company's limited operating history, the Company cannot reliably estimate how much revenue it will receive in the future.

Historical Results of Operations

Our company was organized in March 2022 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended December 31, 2023, the Company had revenues of \$18,914.31 compared to the year ended December 31, 2022, when the Company had revenues of \$61.02. Our gross margin was 59.97% in fiscal year 2023, compared to -57.05% in 2022.
- *Assets.* As of December 31, 2023, the Company had total assets of \$27,605.70, including \$375.49 in cash. As of December 31, 2022, the Company had \$21,615.27 in total assets, including \$18,197.27 in cash.
- *Net Loss.* The Company has had net losses of \$8,240.82 and net losses of \$3,988.73 for the fiscal years ended December 31, 2023 and December 31, 2022, respectively.
- *Liabilities.* The Company's liabilities totaled \$0 for the fiscal year ended December 31, 2023 and \$0 for the fiscal year ended December 31, 2022.

Liquidity & Capital Resources

To-date, the Company has bootstrapped with approximately \$40,000 in capital. After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 36 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 24 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Ruck Sox, LLC cash in hand is \$6,737, as of January 2024. Over the last three months, revenues have averaged \$2,583/month, cost of goods sold has averaged \$1,104/month, and operational expenses have averaged \$3,609/month, for an average burn rate of \$2,130 per month. Our intent is to be profitable in 10 months.

The FY22 financials began April 1, 2022, just after the company was formed on 3/31/2022. Most of 2022 was dedicated to prototyping, hence the expenses. In FY23, socks were not available for sale until May. We will be switching wool suppliers moving forward which will increase yarn costs by approximately 50% and more than triple yarn MOQs, hence our need for funding. We recognize revenue for preorders at the time the order is placed. Since the date our financials cover, we changed our ecommerce and point of sale platform from Wix to Shopify. We've entered into negotiations with large companies that would order large quantities of socks. And we changed wool suppliers due to our original wool supplier going out of business.

We expect between \$12,000 and \$27,000 in revenue in the next 6 months, and potentially up to \$ 83,000 by year-end. There is a large range due to some exciting, large projects currently in motion but not finalized yet. Over the next 6 months, we expect operating expenses to be approximately \$42,000 if we raise the amount we would like to raise. This will be allocated almost exclusive to increasing inventory by over 200%.

We are not profitable yet as all profits have been reinvested into the company while operating very lean on cash. We're able to do this due to great expense projections. This strategy will continue for a little while longer as we build up inventory for projected demand, and incur upfront costs for marketing content that will then be able to be reused. We believe we reach profitability if we raise \$124k.

We have not raised any other funds outside of Wefunder, apart from startup equity investments made by the partners. For additional sources of capital outside of this offering, we could fall back on family and on founder-contributed capital if necessary.
