Business and Anticipated Business Plan

6. Describe in detail the business of the issuer and the anticipated business plan of the issuer.

Introduction: Well Water Finders, Inc. (“WWF” or the “Company”) is a groundwater location technology firm focusing on developing and manufacturing equipment to map the depth, location, and activity of groundwater. WWF's patented technology is intended to enable users to determine the presence of groundwater before making important business decisions in agriculture, real estate, and municipal development. Examples of such business decisions include determining the best depth and location to extract groundwater, and determining the best location to funnel harvested water down towards aquifers to replenish depleted aquifers. The Company owns US Patent 10830915, “Method of Determining Subsurface Properties Using Multifrequency Electromagnetic Depth Sounding”. Our technology identifies groundwater by sending multiple electromagnetic pulses into the ground and capturing returns. The system not only identifies zones that contain water but also the activity of the water in that zone. This activity is important in identifying areas that will support the volume required for a water well. In addition, the system identifies the hardness of geological layers. This functionality is important in identifying areas that have low permeability and could allow water to be funneled downward for recharging an aquifer. Business Model: WWF is pursuing a business model made up of four components: (1) Direct sales of the equipment; (2) Monthly recurring revenue from licensing advanced software features; (3) On-demand revenue from bringing in remote hydrogeologists to consult on projects (similar to telemedicine); (4) Rentals of the equipment (e.g., hardware stores, equipment rentals, feed stores); Company History: Our family has been involved in the development of groundwater location technology for more than 20 years. Our original focus was to identify groundwater so it could be extracted by water wells. However, with the recent increase in droughts and water shortages, our focus has shifted to a dual-function system that allows both identification

of water for extraction and the mapping of sub-terranean layers so aquifers can be recharged with harvested rainfall. Our journey began when Andrew and Franz Vandekop created the initial technology. Andrew is CEO of WWF and a robotics engineer. Franz Vandekop is Andrew's father and an electrical engineer. With this expertise, Franz and Andrew set out to create a system that could fit in the back of a truck and detect subterranean formations. After years of field tests and using the equipment on a variety of terrains, they were awarded two US patents. In 2021, Teisha Vandekop then led the creation of Well Water Finders, a firm dedicated to helping landowners determine the availability of groundwater under their properties. After a two-year pilot program, the Company is now working towards manufacturing units for business-to-business ("B2B"), business-to-government ("B2G"), and business-to-consumer ("B2C") distribution. Market: We believe that the WWF technology has the potential to serve multiple industries and sectors across the world. During our pilot program, we served new landowners, realtors, ranchers, corporate developers, farming operations, and businesses. In the United States alone, groundwater for the public supply has an estimated annual value of \$27.7 billion according to the National Groundwater Association. According to Ibis World, the US water well drilling industry is valued at \$9.3 billion. The output of America's farms are estimated at an annual value of \$164 billion according to the United States Department of Agriculture ("USDA"), and the land development industry has an estimated value of \$9.4 billion according to Ibis World.

Well Water Finders currently has 2 employees.

1. Our ability to succeed depends on how successful we will be in our fundraising efforts. We rely on investment funds in order to use resources to build the necessary tech and business infrastructure to be successful in the long-term. In the event of competitors being better capitalized than we are, that would give them a significant advantage in marketing and operations.
2. We are highly dependent on the services of our founder. Our future business and results of operations depend in significant part upon the continued contributions of our CEO and founder. If we lose those services or if they fail to perform in their current position, or if we are not able to attract and retain skilled employees in addition to our CEO and the current team, this could adversely affect the development of our business plan and harm our business. In addition, the loss of any other member of the board of directors or executive officers could harm the Company's business, financial condition, cash flow and results of operations.
3. Inability to protect our proprietary technology would disrupt our business. We rely, in part, on trademark, copyright, and trade secret law to protect our intellectual property in the United States and abroad. We seek to protect our software, documentation, and other written materials under trade secret

and copyright law, which afford only limited protection. We have additional United States and foreign patent applications pending. We cannot predict whether such pending patent applications will result in issued patents, and if they do, whether such patents will effectively protect our intellectual property. The intellectual property rights we obtain may not be sufficient to provide us with a competitive advantage, and could be challenged, invalidated, infringed or misappropriated. We may not be able to protect our proprietary rights in the United States or internationally (where effective intellectual property protection may be unavailable or limited), and competitors may independently develop technologies that are similar or superior to our technology, duplicate our technology or design around any patent of ours. We attempt to further protect our proprietary technology and content by requiring our employees and consultants to enter into confidentiality and assignment of inventions agreements and third parties to enter into nondisclosure agreements. These agreements may not effectively prevent unauthorized use or disclosure of our confidential information, intellectual property or technology and may not provide an adequate remedy in the event of unauthorized use or disclosure of our confidential information, intellectual property or technology. Litigation may be necessary in the future to enforce our intellectual property rights, to determine the validity and scope of our proprietary rights or the rights of others, or to defend against claims of infringement or invalidity. Such litigation could result in substantial costs and diversion of management time and resources and could have a material adverse effect on our business, financial condition, and operating results. Any settlement or adverse determination in such litigation would also subject us to significant liability.

4. Third parties might infringe upon our technology, trademark, or other proprietary rights, or think we are infringing upon their rights. We cannot assure you that the steps we have taken to protect our property rights will prevent misappropriation of our technology. To protect our rights to our intellectual property, we plan to rely on a combination of trade secrets, confidentiality agreements and other contractual arrangements with our employees, affiliates, strategic partners and others. We may be unable to detect inappropriate use of our technology. Failure to adequately protect our intellectual property could materially harm our brand, devalue our proprietary content and affect our ability to compete effectively. Further, defending any technology rights could result in significant financial expenses and managerial resources.
5. Emerging Market: We operate in an emerging market that is characterized by rapid changes in customer requirements, frequent introductions of new and enhanced products, and continuing and rapid technological advancement.
6. Start-up investing is risky: Investing in startups is very risky, highly speculative, and should not be made by anyone who cannot afford to lose their entire investment. 8. Maintaining, extending and expanding our reputation and brand image are essential to our business success. We seek to maintain, extend, and expand our brand image through marketing investments, including advertising and consumer promotions, and product innovation. Increasing attention on marketing could adversely affect our brand image. It could also lead to stricter regulations and greater scrutiny of marketing practices. Existing or increased legal or regulatory restrictions on our advertising, consumer promotions and marketing, or our response to those restrictions, could limit our efforts to maintain, extend and expand our brands. Moreover, adverse publicity about regulatory or legal action against us could damage our reputation and brand image, undermine our customers' confidence and reduce long-term demand for our products, even if the regulatory or legal action is unfounded or not material to our operations. 9. If we do not respond to technological changes or upgrade our site and technology systems, our growth prospects and results of operations could be adversely affected. To remain competitive, we must plan to enhance and improve the functionality and features of our website and technology infrastructure. As a result, we will need to continue to improve and expand our hosting and network infrastructure and related software capabilities. These improvements may require greater levels of spending than we have experienced in the past. Without such improvements, our operations might suffer from unanticipated system disruptions, slow application performance or unreliable service levels, any of which could negatively affect our reputation and ability to attract and retain customers and contributors. Furthermore, in order to continue to attract and retain new customers, we are likely to incur expenses in connection with continuously updating and improving our user interface and experience. We may face significant delays in introducing new services, products and enhancements. If competitors introduce new products and services using new technologies or if new industry standards and practices emerge, our existing websites and our proprietary technology and systems may become obsolete or less competitive, and our business may be harmed. In addition, the expansion and improvement of our systems and infrastructure may require us to commit substantial financial, operational and technical resources, with no assurance that our business will improve.

The securities being offered have not been registered under the Securities Act of 1933 (the "Securities Act"), in reliance on exemptive provisions of the Securities Act. Similar reliance has been placed on apparently available exemptions from securities registration or qualification requirements under applicable state securities laws. No assurance can be given that any offering currently qualifies or will continue to qualify under one or more of such exemptive provisions due to, among other things, the adequacy of disclosure and the manner of distribution, the existence of similar offerings in the past or in the future, or a change of any securities law or regulation that has retroactive effect. The Offering

Well Water Finders, Inc. ("Company") is offering securities under Regulation CF, through Netcapital Funding Portal Inc. ("Portal"). Portal is a FINRA/SEC registered funding portal and will receive cash compensation

equal to 4.9% of the value of the securities sold through Regulation CF. Investments made under Regulation CF involve a high degree of risk and those investors who cannot afford to lose their entire investment should not invest.

The Company plans to raise between \$10,000 and \$1,215,600 through an offering under Regulation CF. Specifically, if we reach the target offering amount of \$10,000, we may conduct the first of multiple or rolling closings of the offering early if we provide notice about the new offering deadline at least five business days prior to such new offering deadline (absent a material change that would require an extension of the offering and reconfirmation of the investment commitment). Financial Condition of the Issuer

Well Water Finders, Inc. was incorporated on September 11, 2023 in the state of Texas after being converted from Well Water Finders, LLC, a limited liability company formed in the state of Texas on October 30, 2020. The Company's headquarters are located in Meridian, Texas. Well Water Finders is a groundwater location technology company focusing on developing and manufacturing equipment to map the depth, location, and activity of groundwater. The patented WWF technology allows users to determine the presence of groundwater before making important business decisions in agriculture, real estate, and municipal development. These decisions include determining the best depth and location to extract groundwater; and also determining the best location to funnel harvested water down towards aquifers for a goal of replenishing depleted aquifers. Results of Operations: As part of its pilot program, the Company has been earning revenue by performing groundwater location surveys across Texas. Revenue for the year ended December 31, 2023 increased by \$39,178 to \$106,836, as compared to \$67,658 reported for the year ended December 31, 2022. Operating expenses for the year ended December 31, 2023 increased by \$9,051 to \$26,147, as compared to \$17,096 reported for the year ended December 31, 2022. Liquidity & Capital Resources: On December 31, 2023, the Company had cash and cash equivalents of \$115,377 and working capital of \$139,177, as compared to cash and cash equivalents of \$39,007 and working capital of \$59,962 on December 31, 2022. The Company had outstanding balances due from its stockholders totaling \$25,769 and \$23,274 as of December 31, 2023 and December 31, 2022, respectively. These amounts did not bear interest and were repaid in full as of February 14, 2024. For the years ended December 31, 2023 and 2022, net cash provided by operating activities amounted to \$80,365 and \$52,707, respectively. A significant

portion of the funds raised in this Offering are planned to be used to assist with manufacturing and field verification.
