Food Costs, which can change often and quickly. Given we are trying to deal mostly with local purveyors we should hedge most of those costs

Economical Collapse due to war or unforeseen global challenges that cajoled contribute to collapse of incomes

Hurricane and storms are always a threat to the east coast. We have chosen a location we feel will be safe from those catastrophes.

BOARDS Charcuterie Plus, Inc. relies heavily on a consistent and reliable supply of locally-sourced ingredients for its artisanal charcuterie, crudités, and baked goods products. Adverse weather conditions, natural disasters, or issues with suppliers may disrupt the availability and quality of these ingredients, impacting product availability and quality. Additionally, contamination or disease outbreaks affecting livestock or crops used in the Company's products could lead to supply shortages or safety concerns. Furthermore, transportation or logistical challenges may impact the timely delivery of perishable products to customers or retail locations, affecting customer satisfaction and revenue streams.

Staffing can be challenging in the NY market as good work is hard to find. Labor can be challenging.

Global Pandemic or Public Health Crisis Risks: A global pandemic or public health emergency could disrupt the Company's operations, supply chains, or consumer demand, impacting its ability to produce and distribute products. Potential restrictions on gatherings or dining experiences may impact the Company's business model and revenue streams. Additionally, workforce challenges due to illness, quarantines, or safety concerns could affect the Company's ability to maintain operations and meet customer demand.

Food Safety and Product Quality Risks: As a producer of food products, BOARDS Charcuterie Plus, Inc. faces potential food safety incidents resulting from improper handling, storage, or preparation of its products, posing health risks to consumers. The Company may also be exposed to recalls or product liability issues due to contamination or foodborne illnesses associated



with its products, leading to financial losses and reputational damage. Failure to meet applicable regulatory requirements or food safety standards could result in potential legal liabilities or operational disruptions.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

Dana Minuta is a part-time officer. As such, it is likely that the company will not make the same progress as it would if that were not the case.

### USE OF FUNDS

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from this Offering. Accordingly, the Company will have broad discretion in using these proceeds.

10. How does the Issuer intend to use the proceeds of this offering?

If we raise: **\$50,000**

Use of Proceeds: 60% towards kitchen build out and development, 10% for website development and branding, 12.1% for inventory, 10% for advertising, 7.9% Wefunder fee.

If we raise: **\$124,000**

Use of Proceeds: 35% for kitchen build out, 15% for retail buildout, 20% for advertising, 10.1% for website buildout and branding, 12% for inventory, 7.9% Wefunder fee.

Raising the maximum would allow us to enhance interiors, equipment quality, packaging, marketing and quality of employees. The more we raise, the more we can invest in higher quality everything which pays off by adding longevity to each component.

Because the Investor holds no voting rights in the company, the holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering). These decisions could affect gross revenues and diminish payments made to Investors.

Based on the risk that the company may never realize revenues or face a Default Event, the Investor may never see any returns.

As holders of a majority-in-interest of voting rights in the Company, the principal shareholder(s) may make decisions with which the Investor disagrees, or that negatively affect the value of

the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of the principal shareholder(s), and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, the principal shareholder(s) may change the terms of the articles of incorporation for the Company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. The principal shareholder(s) also may force the Company to prepay the promissory notes before their maturity date. The principal shareholder(s) may make changes that affect the tax treatment of the Company in ways that are unfavorable to the Investor but favorable to them. The principal shareholder(s) may also vote to engage in new offerings and/or to register certain of the Company's securities in a way that negatively affects the value of the securities the Investor owns. The principal shareholder(s) may also have access to more information than the Investor, leaving the Investor at a disadvantage with respect to any decisions regarding the securities he or she owns.

Based on the factors described above, the Investor could lose all or part of his or her investment in the securities in this offering, and may never see positive returns.

The offering price for the securities offered pursuant to this Form C has been determined arbitrarily by the Company, and does not necessarily bear any relationship to the Company's book value, assets, earnings or other generally accepted valuation criteria. In determining the offering price, the Company did not employ investment banking firms or other outside organizations to make an independent appraisal or evaluation. Accordingly, the offering price should not be considered to be indicative of the actual value of the securities offered hereby.

The value of the promissory notes will be determined by the Company's senior management in accordance with U.S. generally accepted accounting principles. For example, the notes may be valued based on principal plus anticipated interest payments over the course of the term of the note.

22. What are the risks to purchasers of the securities relating to minority ownership in the Issuer?

An Investor in the promissory notes will likely hold a minority position in the Company and will have no voting rights in the Company, and thus will be limited as to its ability to control or influence the governance and operations of the Company.

The marketability and value of the Investor's interest in the Company will depend upon many factors outside the control of the Investor. The Company will be managed by its officers and be governed in accordance with the strategic direction and decision-making of its board of directors, and the Investor will have no independent right to name or remove an officer or member of the board of directors of the Company.

Issuer Repurchase of Securities/Prepayment of Notes. The Company has the right to repay principal and interest on the promissory notes at any time prior to the maturity date.
