Business and Anticipated Business Plan

Describe in detail the business of the issuer and the anticipated business plan of the issuer.

Avalon.AI is a value-based, healthcare data analytics company. We integrate claims data with other datasets to pinpoint the top percentile of physicians and connect them with employees at self-insured companies. Our AI model delivers optimal care outcomes, lowers costs, and enhances access to high-quality healthcare for people across all socioeconomic levels.

Our platform, Healthcare GPS, is the first of its kind to allow employees to quickly access physicians by specialties within a specific geographical area considered to be top tier and best in class. Moreover, Healthcare GPS distinguishes itself with its capability to pinpoint and address prescription drug usage trends among the employee population.

By streamlining services, employees gain access to the cost savings and enhanced care quality sought by employers in their medical programs. A pivotal feature is the holistic insight into employees' treatment plans. Healthcare GPS stands as a groundbreaking product, equipped with capabilities tailored for the current landscape and future-proofed with additional functionalities. To date, there are a few competitors who purport to deploy a similar business model, but it usually involves benefiting financially from referrals and limited in scope and ability. Avalon.AI is the first unbiased company to identify best performing physicians for all working Americans. **We work for them!**

The Company was incorporated in Florida in March of 2020 in the midst of the Global Pandemic with the goal being the first AI company to effectively reduce Opioid prescribing habits at the point of care at hospital systems and Ambulatory Surgery Centers (ASCs) throughout the country. We accomplished this and continue to work with many of the country's largest hospital systems in supporting their overall Opioid Reduction Programs. It was in this role where we realized that Avalon.AI was quite astute at identifying best performing physicians based on prescribing habits. In January of 2023, we pivoted and dedicated all our resources to building a new technology platform targeting self-insured companies in identifying best performing physicians for all employees at these companies. Virtually all Americans. Since then, we are very far along with our tech build-out and sales efforts and should reach our sales and revenue forecast post our Reg C raise at \$25,000,000.

The Self-Insured Market is a \$7.3 Billion-dollar sector. Our Business Model is SaaS-based with price points at \$6/employee/month. In our experience, we did not want cost to be a barrier to entry as the value prop ROI is \$1500/employee/year YOY. For a company with 100K employees that's a \$150,000,000 savings YOY in medical costs like multiple visits, unnecessary imaging and tests, ER visits, etc. We have already teed up several mid-size and large clients including a one client with 185,000 employees that will close this year. We will be at \$100mm in revenue in 12 months post injection.

We have a limited operating history upon which you can evaluate our performance, and accordingly, our prospects must be considered in light of the risks that any new company encounters. The Company is still in an early phase and we are just beginning to implement our business plan. There can be no assurance that we will ever operate profitably. The likelihood of our success should be considered in light of the problems, expenses, difficulties, complications and delays usually encountered by early-stage companies. The Company may not be successful in attaining the objectives necessary for it to overcome these risks and uncertainties.

Global crises such as COVID-19 can have a significant effect on our business operations and revenue projections.

There is an ongoing outbreak of a novel and highly contagious form of coronavirus ("COVID-19"), which the World Health Organization declared a global pandemic on March 11, 2020. The outbreak of COVID-19 has caused a worldwide public health emergency with a substantial number of hospitalizations and deaths and has significantly adversely impacted global commercial activity and contributed to both volatility and material declines in equity and debt markets. The global impact of the outbreak is rapidly evolving, and many national, state, and local governments have reacted by instituting mandatory or voluntary quarantines, travel prohibitions and restrictions, closures or reductions of offices, businesses, schools, retail stores, restaurants, and other public venues and/or cancellations, suspensions and/or postponements of certain events and activities, including certain non-essential government and regulatory activities. Businesses are also implementing their own precautionary measures, such as voluntary closures, temporary or permanent reductions in work force, remote working arrangements and emergency contingency plans.

Such measures, as well as the general uncertainty surrounding the dangers, duration, and impact of COVID-19, are creating significant disruption to supply chains and economic activity, impacting consumer confidence and contributing to significant market losses, including by having particularly adverse impacts on transportation, hospitality, healthcare, tourism, sports, entertainment and other industries dependent upon physical presence. Technological infrastructure has, and will likely continue to be, strained for so long as mandatory or voluntary quarantines are instituted, which will change, and potentially disrupt, the operations of the Company. As COVID-19 continues to spread, potential additional adverse impacts, including a global, regional or other economic recession of indeterminate duration, are increasingly likely and difficult to assess and, if the spread of COVID-19 is prolonged, it could adversely affect many economies, global financial markets and the Company even after COVID-19 is contained.

The extent of the impact of COVID-19 on the Company's operational and financial performance will depend on many factors, all of which are highly uncertain and cannot be predicted. Those factors include the duration and scope of the resulting public health emergency; the extent of any related restrictions implemented; the impact of such public health emergency on overall supply and demand, goods and services, investor liquidity, consumer confidence and levels of economic activity; and the extent of its disruption to important global, regional and local supply chains and economic markets. As policy changes are made by regulators, there is no guarantee that the company will be able to provide services in its current form, which may place a substantial hardship on operations, causing an Investor to lose all or a portion of their investment.

We may have difficulty raising needed capital in the future as a result of, among other factors, our lack of revenue, as well as the inherent business risks associated with our Company and present and future market conditions.

The Company's success depends on the experience and skill of its manager and other key personnel.

In particular, we are dependent on our managers. The loss of the Managers, the Principals or any other key personnel could harm the Company's business, financial condition, cash flow and performance. Although dependent on certain key personnel, the Company does not have any key person life insurance policies on any such people

We are dependent on certain key personnel in order to conduct our operations and execute our business plan, however, the Company has not purchased any insurance policies with respect to those individuals in the event of their death or disability. Therefore, if any of these personnel die or become disabled, the Company will not receive any compensation to assist with such person's absence. The loss of such person could negatively affect the Company and our operations. We have no way to guarantee key personnel will stay with the Company, as many states do not enforce non-competition agreements, and therefore acquiring key man insurance will not ameliorate all of the risk of relying on key personnel.

Damage to our reputation could negatively impact our business, financial condition and results of operations.

Our reputation and the quality of our brand are critical to our business and success and will be critical to our success as we form and advise new markets. Any incident that erodes confidence in our brand could significantly reduce the Company's value and damage our business. We may be adversely affected by any negative publicity, regardless of its accuracy. Also, there has been a marked increase in the use of social media platforms and similar devices, including blogs, social media websites and other forms of internet-based communications that provide individuals with access to a broad audience. The availability of information on social media platforms is virtually immediate as is its impact. Information posted may be adverse to our interests or may be inaccurate, each of which may harm our performance, prospects or business. The harm may be immediate and may disseminate rapidly and broadly, without affording us an opportunity for redress or correct.

Risks Related to the Offering

The U.S. Securities and exchange Commission does not pass upon the merits of the Securities or the terms of the Offering, nor does it pass upon the accuracy or completeness of any Offering document or literature.

You should not rely on the fact that our Form C is accessible through the U.S. Securities and Exchange Commission's EDGAR filing system as an approval, endorsement or guarantee of compliance as it relates to this Offering. The U.S. Securities and Exchange Commission has not reviewed this Form C, nor any document or literature related to this Offering.

Neither the Offering nor the Securities have been registered under federal or state securities laws.

No governmental agency has reviewed or passed upon this Offering or the Securities. Neither the Offering nor the Securities have been registered under federal or state securities laws. Investors will not receive any of the benefits available in registered Offerings, which may include access to quarterly and annual financial statements that have been audited by an independent accounting firm. Investors must therefore assess the adequacy of disclosure and the fairness of the terms of this Offering based on the information provided in this Form C and the accompanying exhibits.

The Company's management may have broad discretion in how the Company uses the net proceeds of the Offering.

Unless the Company has agreed to a specific use of the proceeds from the Offering, the Company's management will have considerable discretion over the use of proceeds from the Offering. You may not have the opportunity, as part of your investment decision, to assess whether the proceeds are being used appropriately.

The Company has the right to limit individual Investor commitment amounts based on the Company's determination of an Investor's sophistication.

The Company may prevent any Investor from committing more than a certain amount in this Offering based on the Company's determination of the Investor's sophistication and ability to assume the risk of the investment. This means that your desired investment amount may be limited or lowered based solely on the Company's determination and not in line with relevant investment limits set forth by the Regulation CF rules. 9. How will the issuer complete the transaction and deliver securities to the investors?

Options, Warrants and Other Rights

17. How may the rights of the securities being offered be materially limited, diluted or qualified by the rights of any other class of securities?

Investors should understand the potential for dilution. The investor's stake in a company could be diluted due to the company issuing additional Capital Units. In other words, when the company issues more Capital Units, the percentage of the company that you own will go down, even though the value of the company may go up. You will own a smaller piece of a larger company. This increase in number of Capital Units outstanding could result from a stock offering (such as an initial public offering, another crowdfunding round, a venture capital round, angel investment), employees exercising options, or by conversion of certain instruments (e.g., convertible bonds, preferred shares or warrants) into Capital Units. If the company decides to issue more Capital Units, an investor could experience value dilution, with each Capital Unit being worth less than before, and control dilution, with the total percentage an investor owns being less than before. There may also be earnings dilution, with a reduction in the amount earned per Capital Unit (though this typically occurs only if the company offers dividends, and most early-stage companies are unlikely to offer dividends, preferring to invest any earnings into the company)

18. Are there any differences not reflected above between the securities being offered and each other class of security of the issuer?

Yes. The issuer has authorized both Class A Voting Capital Units and Class B Non-Voting Capital Units. The securities being sold in this Regulation Crowdfunding offering are only Class B Non-Voting Capital Units. The differences are described below:

Class A Voting Capital Units:

Class A Voting Members shall have the right to vote upon all matters upon which Members have the right to vote under the Act or the Operating Agreement. The percentage Voting Interest of a Class A Voting Member shall be the percentage that is derived when the Member's Class A Voting Capital Units account is divided by the total of all Class A Voting Capital Unit accounts.

Class B Non-Voting Capital Units:

Class B Non-Voting Capital Units shall have no right to vote on any matters.

19. How could the exercise of rights held by the principal owners identified in Question 5 above affect the purchasers of Securities being offered?

The holder of a majority of the voting rights in the company may make decisions with which you disagree, or that negatively affect the value of your investment in the company, and you will have no recourse to change those decisions. Your interests may conflict with the interests of other investors, and there is no guarantee that the company will develop in a way that is advantageous to you. For example, the majority Member may decide to issue additional Capital Units to new investors, sell convertible debt instruments with beneficial conversion features, or make decisions that affect the tax treatment of the company in ways that may be unfavorable to you. Based on the risks described above, you may lose all or part of your investment in the securities that you purchase, and you may never see positive returns.

20. How are the securities being offered valued? Include examples of methods for how such securities may be valued by the issuer in the future, including during subsequent corporate actions.

The Company is issuing securities in this Regulation Crowdfunding offering at a pre-money valuation of \$27,072,756.

The securities being offered are valued at the issuer's discretion. An early-stage company typically sells its Capital Units (or grants options over its shares) to its founders and early employees at a very low cash cost, because they are, in effect, putting their "sweat equity" into the company. When the company seeks cash investments from outside investors, like you, the new investors typically pay a much larger sum for their Capital Units than the founders or earlier investors, which means that the cash value of your stake is immediately diluted because each Capital Unit of the same type is worth the same amount, and you paid more for your Capital Units than earlier investors did for theirs.

There are several ways to value a company, and none of them is perfect and all of them involve a certain degree of guesswork. Any of these methods, plus others, may be used to determine valuation in the future:

Liquidation Value - The amount for which the assets of the company can be sold, minus the liabilities owed, e.g., the assets of a bakery include the cake mixers, ingredients, baking tins, etc. The liabilities of a bakery include the cost of rent or mortgage on the bakery. However, this value does not reflect the potential value of a business, e.g., the value of the secret recipe. The value for most startups lies in their potential, as many early stage companies do not have many assets.

Book Value - This is based on analysis of the company's financial statements, usually looking at the company's balance sheet as prepared by its accountants. However, the balance sheet only looks at costs (i.e., what was paid for the asset), and does not consider whether the asset has increased in value over time. In addition, some intangible assets, such as patents, trademarks or trade names, are very valuable but are not usually represented at their market value on the balance sheet.

Earnings Approach - This is based on what the investor will pay (the present value) for what the investor expects to obtain in the future (the future return), taking into account inflation, the lost opportunity to participate in other investments, the risk of not receiving the return. However, predictions of the future are uncertain and valuation of future returns is a best guess.

Different methods of valuation produce a different answer as to what your investment is worth. Typically, liquidation value and book value will produce a lower valuation than the earnings approach. However, the earnings approach is also most likely to be risky as it is based on many assumptions about the future, while liquidation value and book value are much more conservative.

Future investors (including people seeking to acquire the company) may value the company differently. They may use a different valuation method, or different assumptions about the company's business and its market. Different valuations may mean that the value assigned to your investment changes. It frequently happens that when a large institutional investor such as a venture capitalist makes an investment in a company, it values the company at a lower price than the initial investors did. If this happens, the value of the investment would go down.

21. What are the risks to purchasers of the securities relating to minority ownership in the issuer?

The company's Certificate of Incorporation or Operating Agreement can be amended by the holders of a majority of the issued and outstanding Capital Units of the Company. As minority owners, the crowdfunding investors are subject to the decisions made by the majority owners. The issued and outstanding Capital Units give management voting control of the company. As a minority owner, you may be outvoted on issues that impact your investment, such as, among other things: (a) the liquidation, dissolution or winding up of the company, or effecting any merger or consolidation; (b) amendment of any provision of the Certificate of Incorporation or

Operating Agreement; (c) creation and issuance of other securities having rights, preferences or privileges senior to the Capital Units sold to the crowdfunding investors, or increasing the authorized number of Capital Units of the company; or (d) creation of any debt security.

22. What are the risks to purchasers associated with corporate actions including:

- 1. Additional issuances of securities**
- 2. Issuer repurchases of securities**
- 3. A sale of the issuer or of assets of the issuer**
- 4. Transactions with related parties**

The authorization and issuance of additional Capital Units will dilute the ownership of the crowdfunding investors. As a result, if the company achieves profitable operations in the future, its net income per share will be reduced because of dilution, and the market price of the company's Capital Units, if there is a market price, could decline as a result of the additional issuances of securities. If the company repurchases securities, so that the above risk is mitigated, and there are fewer Capital Units, the company may not have enough cash available for marketing expenses, growth, or operating expenses to reach our goals. If we do not have enough cash to operate and grow, we anticipate the market price of our securities would decline. A sale of the company or of all of the assets of the company may result in an entire loss of your investment. We cannot predict the market value of the company or its assets, and the proceeds of a sale may not be cash, but instead, unmarketable securities, or an assumption of liabilities. Financial Condition of the Issuer

26. Does the issuer have an operating history?

The Company was incorporated in Florida in March of 2020 in the midst of the Global Pandemic with the goal being the first AI company to effectively reduce Opioid prescribing habits at the point of care at hospital systems and Ambulatory Surgery Centers (ASCs) throughout the country. We accomplished this and continue to work with many of the country's largest hospital systems in supporting their overall Opioid Reduction Programs. It was in this role where we realized that Avalon.AI was quite astute at identifying best performing physicians based on prescribing habits. In

January of 2023, we pivoted and dedicated all our resources to building a new technology platform targeting self-insured companies in identifying best performing physicians for all employees at these companies. Virtually all Americans. Since then, we are very far along with our tech build-out and sales efforts and should reach our sales and revenue forecast post our Reg C raise at \$25,000,000.

To date, the company has limited operating history, however has increased revenue from \$52,063 in 2022 to \$220,400 in 2023. In addition, operating expenses only increased from \$169,527 in 2022 to \$195,065 in 2023, resulting in positive net income in 2023 of \$25,335.

Revenue

Revenue for 2023 was \$220,400, compared to \$52,063 in 2022.

Expenses

The Company's expenses consist of, among other things, advertising and marketing, bank charges and fees, consulting fees, contractors, insurance, legal and professional services, office supplies and software, repairs and maintenance, and other business expenses. Total operating expenses in 2023 increased \$25,538 from 2022, from \$169,527 in 2022 to \$195,065 in 2023. The increase was mostly attributable to an increase in amortization and consulting fees.

Historical results and cash flows:

The Company is currently in the initial production stage and is revenue-generating. We are of the opinion the historical cash flows will not be indicative of the revenue and cash flows expected for the future because the company's products and systems are in place to allow revenue and cash flow, to begin to increase.

Cash flow increased from \$77 to \$12,206 from 2022 to 2023. Cash was primarily generated through equity investments in 2022 and with sales in 2023. The net income in 2023 increased from -\$117,464 in 2022 to \$25,335 in 2023. The issuer raised \$1,409,00 in 2022 versus \$1,400 in 2023.

Liquidity and Capital Resources

The company had approximately \$12,206 cash on hand as of December 31, 2023.

healthcare system. In this way, we wanted to offer CF investors a chance to be a part of this much needed technology. The funds will help the expansion of the company's operations, reach, and product offerings. The company has other funds and capital resources available.

Funds from this campaign are not necessary for the viability of the company but will greatly improve its financial standing and support in scaling its technology, marketing and management. We should close on the state of NC with 185,000 lives in the next 60 days. This will help us hit 80% of our forecasted goal in the first year. We plan to surpass this goal in six months. So, the raise and projected mark of \$5mm will support a more rapid scale to hit key metrics in the overall growth of Avalon.AI

The CF raise will have very little impact on the overall solvency of Avalon.AI as we have already commenced with sales and revenue. Based on current cash flow and revenue, our runway of \$25mm in the next 12 months will lead us 24-36 months in operations and burn.
