The most obvious risk is that the film may not perform well at the box office. Many factors, including poor marketing, bad reviews, audience disinterest, or strong competition from other films released at the same time, can lead to lower-than-expected ticket sales.

Securing effective distribution is critical for a film's success. Even if the film is well-made, difficulties in securing a good distribution deal, or inefficiencies in the distribution process, can limit its availability to audiences, adversely affecting revenues.

Broader economic factors can influence the entertainment spending habits of the public. Economic downturns or recessions can reduce audience willingness to spend money on entertainment like cinema, impacting the potential revenue of the film.

Filmmaking involves navigating complex copyright, distribution rights, and contracts. Legal challenges could arise, for example, from disputes over intellectual property rights or contractual

from disputes over intellectual property rights or contractual disagreements with cast and crew, leading to costly litigation or settlement expenses.

The rapid pace of technological change in media consumption can alter the traditional revenue streams from box office to digital platforms. A film traditionally released in theaters might miss out on revenue opportunities or fail to meet changing consumer preferences.

Content that is deeply rooted in Christian themes may face challenges in reaching a broader audience beyond the Christian community due to the adversity of modern culture to the Christian faith.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

Jennifer Huff and Andrew Huff are part-time officers. As such, it is likely that the company will not make the same progress as it would if that were not the case.

The Offering

USE OF FUNDS

9. What is the purpose of this offering?

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from this Offering. Accordingly, the Company will have broad discretion in using these proceeds.

10. How does the issuer intend to use the proceeds of this offering?

If we raise: **\$50,000**

Use of Proceeds: This would help us with all up front costs prior to the beginning of production including development, casting, location fees, etc. 7.9% of the funds will also go to pay WeFunder's fees.

If we raise: **\$550,000**

Use of Proceeds: This will allow us to pay all production costs (cast, crew, supplies, etc.) for a 20 day shoot. 16% would go toward talent, 32% would go toward production crew, 15% would go toward production equipment, and 30% would go toward the remaining production expenses. 7.9% of the funds will also go to pay WeFunder's fees.

If we raise: **\$850,000**

Use of Proceeds: This would pay for the production, provide us with the necessary funds to complete post-production, and allow us to hire a marketing company to help us spread the word about the film. 60% would go toward production/post-production and 32% would go toward marketing. 7.9% of the funds will also go to pay WeFunder's fees.

If we raise: **\$1,235,000**

Use of Proceeds: This would give us the funds needed to produce and market the movie as well as facilitate theatrical distribution. 50% would go toward production/post-production, 16% toward marketing, and 34% toward distribution. 7.9% of the funds will also go to pay WeFunder's fees.

Provided that Investment Company has completed the Offering, and Investor is not in breach of this Agreement, Producer agrees to **repay to investor the Financing Amount, also referred to as Investor's Capital Contribution, together with a twenty percent (20%) premium thereon (a fifty percent (50%) premium thereon for Early Bird Investors)** ("Investor Recoupment"), solely from Gross Receipts (if any) in accordance with this Paragraph 5. First, to the payment of any actual third party, out-of-pocket sales fees and sales expenses payable to the sales agents engaged to sell the Picture and other third party distribution fees and expenses (including but not limited to reasonable outside attorney fees) actually incurred and not otherwise recouped by Investment Company relating directly to the Picture, and ongoing third party, out-of-pocket accounting costs

and expenses incurred by Investment Company in connection with the processing of payments to profit participants on the Picture;

5.1 All other costs, expenses and charges actually incurred and paid by the Investment Company (or any affiliated or related entities) in connection with the production, post-production of the Picture or any rights therein, including, but not limited to, actual, out of pocket third party delivery costs and expenses (exclusive of the budgeted delivery costs), actual, out of pocket third party reasonable festival expenses (e.g., publicist, accommodations for producers, etc.), guild royalties, residuals, the gross amount (net of any insurance proceeds in connection therewith) paid for the settlement of any claims or lawsuits, including all expenses, court costs and attorneys' fees in connection with any such claim or litigation; but only to the extent any of the foregoing have not previously been paid or assumed by the Picture's distributor; and

Because the Investor holds no voting rights in the company, the holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering). These decisions could affect net revenues and diminish payments made to Investors.

Based on the risk that the company may never realize revenues or face a Default Event, the Investor may never see any returns. Additional risks related to the rights of other security holders are discussed below, in Question 20.

20. How could the exercise of rights held by the principal shareholders identified in Question 6 above affect the purchasers of the securities being offered?

As holders of a majority-in-interest of voting rights in the Company, **the unitholders** may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, **the unitholders** may change the terms of the operating agreement for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. **The unitholders** may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. They may also vote to engage in new offerings and/or to register certain of the Company's securities in a way that negatively affects the value of the securities the Investor owns. Other holders of securities of the Company may also have access to more information than the Investor, leaving the Investor at a disadvantage with respect to any decisions regarding the securities he or she owns.

The unitholders have the right to redeem their securities at any time. **Unitholders** could decide to force the Company to redeem their **securities** at a time that is not favorable to the Investor and is damaging to the Company. Our intent is to be profitable in 12 months. There have been no material changes or trends in our finances or operations since the date that our financials cover.

In the next 3-6 months we expect to spend \$500,000 on the movie with the following breakdown: \$72,000 on cast, \$160,000 on crew, \$75,000 on equipment, \$100,000 on additional production expenses such as hair and makeup supplies, wardrobe, props, and location fees, \$25,000 on production travel, \$50,000 on a musical score, and the remaining \$18,000 on administrative needs such as production insurance and legal assistance.

We are not currently profitable. We anticipate the film will be profitable within 12 months, following the planned release date of 3/21/2025. With connections to Regal Cinemas, Malco Theaters, and potential additions like Cinemark and AMC, we project box office revenues between \$5 million and \$15 million. These projections consider market demand, marketing effectiveness, and distribution reach. We believe our strategic partnerships, targeted marketing, and favorable market conditions will position our film for significant success. The revenue is currently expected to be solely generated by box office receipts.

Huff Media Productions, the company that will provide production support for the film, has the business capital to both invest in the film and cover short-term burn throughout the campaign.
