The Company depends on a functional global supply chain to manufacture and ship our products. Issues within the global supply chain could interrupt our operations and impact our ability to fulfill orders.

While we have worked with co-manufacturers, we currently manufacture all products in-house at a Company-owned production facility. Unforeseen incidents at the facility (including flood, fire, etc) could interrupt our operations and impact our ability to fulfill orders.

As a food and beverage business, we are regulated at a State and Federal level. Extensive changes to manufacturing or distribution requirements could impact our ability to manufacture and fulfill orders.

Should the Company enter high-growth periods, we risk selling out too quickly and not having sufficient working capital to restock our inventory.

Should a better-funded competitor launch with a comparable product at a lower price, we could lose sufficient marketshare.

Should a substantive recall occur of any (or multiple) of our raw materials or finished products, this could reduce or eliminate our ability to generate revenue.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the

Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from this Offering. Accordingly, the Company will have broad discretion in using these proceeds.

Use of Proceeds: 73.1% for Marketing including PR, Paid + Organic Social, Email + SMS, Sampling, and Trade Shows. 20% for R&D. 6.9% Wefunder fee.

If we raise: **\$124,000**

Use of Proceeds: 73.1% for Marketing including PR, Paid + Organic Social, Email + SMS, Sampling, and Trade Shows. 20% for R&D, Working Capital, and Inventory. 6.9% Wefunder fee. Raising the full \$124K would allow us to dedicate more budget to marketing, including dollars intended for experimental initiatives, ensuring that we have a diversified plan for acquiring customers.

Book Entry and Investment in the Co-Issuer. Investors will make their investments by investing in interests issued by one or more co-issuers, each of which is a special purpose vehicle ("SPV"). The SPV will invest all amounts it receives from investors in securities issued by the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. All references in this Form C to an Investor's investment in the Company (or similar phrases) should be interpreted to include investments in a SPV.

## Ownership and Capital Structure

The main terms of the SAFEs are provided below.

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides Investors the right to **preferred units** in the Company ("**Preferred Units**"), when and if the Company sponsors an equity offering that involves **Preferred Units**, on the standard terms offered to other Investors.

*Conversion to Preferred Equity.* Based on our SAFEs, when we engage in an offering of equity interests involving **preferred units**,

**Investors will receive a number of shares of preferred units** calculated using the method that results in the greater number of **preferred units**:

1. the total value of the Investor's investment, divided by
  1. the price of **preferred units** issued to new Investors multiplied by
  2. the **discount rate** (85%), or



2. if the valuation for the company is more than **\$7,000,000.00** (the "Valuation Cap"), the amount invested by the Investor divided by the quotient of
  1. the Valuation Cap divided by
  2. the total amount of the Company's capitalization at that time.
3. for investors up to the first **\$50,000.00** of the securities, investors will receive a valuation cap of **\$6,000,000.00** and a discount rate of 85%. Wefunder VIP investors will be entitled to these terms for the entire duration of the offering, even if the threshold limit noted above is met.

*Additional Terms of the Valuation Cap.* For purposes of option (ii) above, the Company's capitalization calculated as of immediately prior to the Equity Financing and (without double-counting, in each case calculated on an as-converted to Common Units basis):

- Includes all shares of Capital Units issued and outstanding;
- Includes all Converting Securities;
- Includes all (i) issued and outstanding Options and (ii) Promised Options; and
- Includes the Unissued Option Pool, except that any increase to the Unissued Option Pool in connection with the Equity Financing shall only be included to the extent that the number of Promised Options exceeds the Unissued Option Pool prior to such increase.

*Liquidity Events.* If the Company has an initial public offering or is acquired by, merged with, or otherwise taken over by another company or new owners prior to Investors in the SAFEs receiving **preferred units**, Investors will receive

- proceeds equal to the greater of (i) the Purchase Amount (the "Cash-Out Amount") or (ii) the amount payable on the number of shares of Common Units equal to the Purchase Amount divided by the Liquidity Price (the "Conversion Amount")

*Liquidity Priority.* In a Liquidity Event or Dissolution Event, this Safe is intended to operate like standard nonparticipating Preferred Units. The Investor's right to receive its Cash-Out Amount is:

1. Junior to payment of outstanding indebtedness and creditor claims, including contractual claims for payment and convertible promissory notes (to the extent such convertible promissory notes are not actually or notionally converted into Capital Units);

2. On par with payments for other Safes and/or Preferred Units, and if the applicable Proceeds are insufficient to permit full payments to the Investor and such other Safes and/or Preferred Units, the applicable Proceeds will be distributed pro rata to the Investor and such other Safes and/or Preferred Units in proportion to the full payments that would otherwise be due; and
3. Senior to payments for Common Units.

### **VIP Bonus**

Cheeky Cocktails will offer a discount to the normal terms listed in this Form C for all investments that are committed by investors who are part of Wefunder, Inc's VIP program. This means eligible Wefunder investors will receive a discount for any securities they purchased in this offering. For more specific details on the company's discount, please review the description of the terms above.

The discount is only valid until the offering closes. Investors eligible for the bonus will also receive priority if they are on a waitlist to invest and the company exceeds its maximum funding goal. They will be given the first opportunity to invest if space in the offering becomes available due to the cancellation or failure of previous investments.

### **Securities Issued by the SPV**

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV is formed concurrently with the filing of the Form C. Given this, the SPV does not have any financials to report. The SPV is managed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of the securities to be sold to the investors.

the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

### **Voting Rights**

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

### **Proxy to the Lead Investor**

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

### **Restriction on Transferability**

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

- ii. the majority-in-interest of all then-outstanding Safes with the same "Post-Money Valuation Cap" and "Discount Rate" as this Safe (and Safes lacking one or both of such terms will be considered to be the same with respect to such term(s)), provided that with respect to clause (ii):
  - A. the Purchase Amount may not be amended, waived or modified in this manner,
  - B. the consent of the Investor and each holder of such Safes must be solicited (even if not obtained), and

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

To the extent applicable, in cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. This means that the pro-rata portion of the Company represented by the Investor's securities will decrease, which could also diminish the Investor's voting and/or economic rights. - the price at which we sell other securities in light of the relative rights, preferences and privileges of those securities;
- our results of operations, financial position and capital resources;
- current business conditions and projections;
- the marketability or lack thereof of the securities;
- the hiring of key personnel and the experience of our management;
- the introduction of new products;
- the risk inherent in the development and expansion of our products;
- our stage of development and material risks related to our business;

- the likelihood of achieving a liquidity event, such as an initial public offering or a sale of our company given the prevailing market conditions and the nature and history of our business;
- industry trends and competitive environment;

We will analyze factors such as those described above using a combination of financial and market-based methodologies to determine our business enterprise value. For example, we may use methodologies that assume that businesses operating in the same industry will share similar characteristics and that the Company's value will correlate to those characteristics, and/or methodologies that compare transactions in similar securities issued by us that were conducted in the market.

Issuer repurchases of securities. A sale of the issuer or of assets of the issuer. As a minority owner of the Company, the Investor will have limited or no ability to influence a potential sale of the Company or a substantial portion of its assets. ### **Overview**

Professional Cocktail Ingredients for the Home & Bar

Cheeky Cocktails is a company that produces premium syrups and juices for cocktails, catering to both professional bartenders and home enthusiasts. Founded by bartenders, the Company focuses on creating high-quality, natural ingredients for craft cocktails without using artificial flavors, colors, or preservatives. The company’s products are used in various establishments, from five-star hotels to stadiums and resorts. and are also available for retail

purchase, allowing customers to create bar-quality drinks at home.

### **Milestones**

Cheeky Cocktails LLC was incorporated in the State of New York in July 2018.

Since then, we have:

- \$1.2M in revenue on \$20K in paid ads
- Sold in 1200 stores in 44 states + International including Anthropologie, HomeGoods, and more
- First order profitable/\$117 AOV for repeat customers
- Carried at Four and Five-star hotels and resorts (The Standard Highline, Bellagio, Aria, etc)

### **Historical Results of Operations**

- *Revenues & Gross Margin.* For the period ended December 31, 2023, the Company had revenues of \$265,309 compared to the year ended December 31, 2022, when the Company had revenues of \$221,248. Our gross margin was 37.33% in fiscal year 2023, compared to 34.88% in 2022.
- *Assets.* As of December 31, 2023, the Company had total assets of \$104,063, including \$22,621 in cash. As of December 31, 2022, the Company had \$177,625 in total assets, including \$70,354 in cash.
- *Net Loss.* The Company has had net losses of \$338,062 and net losses of \$234,872 for the fiscal years ended December 31, 2023 and December 31, 2022, respectively.
- *Liabilities.* The Company's liabilities totaled \$1,040,222 for the fiscal year ended December 31, 2023 and \$760,632 for the fiscal year ended December 31, 2022.

### **Liquidity & Capital Resources**

To-date, the company has been financed with \$447,800 in debt, \$160,000 in convertibles, and \$240,000 in SAFEs.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 6 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 3 months. Except as otherwise



plan to raise capital in 6 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

### **Runway & Short/Mid Term Expenses**

Cheeky Cocktails LLC cash in hand is \$20,000, as of August 2024. Over the last three months, revenues have averaged \$33,920/month, cost of goods sold has averaged \$10,835/month, and operational expenses have averaged \$27,226/month, for an average burn rate of \$4,141 per month. Our intent is to be profitable in 6 months.

Since the date our financials cover, our baseline monthly sales increased, we launched into 700 additional stores, and we closed an additional \$115K in investment. We launched into the first month of the pandemic in 2020, and corporate sales skyrocketed immediately, as consumers were searching for products like ours for the first couple of years of the pandemic. We sold “wholesale quantities” at full retail prices during this time, so while our business grew over time and we sold more actual product each year from 2022 to now, we’re selling at a lower margin to wholesale customers.

We expect to be cash flow positive (\$50K+ in monthly revenue) for one or more months during Q3 of 2024 and more consistently during Q4. If we are successful raising the maximum investment on Wefunder we will invest the additional funds in marketing, with the goal of exceeding \$100K in monthly revenue by Q1 of 2025. We expect we will be profitable for the 2025 calendar year. We are forecasting expenses to be \$174k for the next 6 months, or \$29K/month

As noted above, while we have been and will continue to be cash flow positive for several months in 2024, we plan to reach profitability in 2025. We have three forecasted scenarios. In the worst case scenario (in which we land no additional wholesale customers, our two national accounts do not reorder, and we stick to our rough 1.5x growth from last year), we need an additional \$40K on top of the \$50K minimum from Wefunder to bridge us through March of 2025, at which point we’re profitable for the remainder of the year. In the forecasted scenario in which several of our initiatives move the needle

in which several of our initiatives drove the increase (ie, new tradeshow customers, the social commerce gifting, etc), we withdraw our \$50K from the Wefunder in August, and we're cashflow positive every month thereafter.

Besides Wefunder, we are currently raising capital and have soft circled commitments from several angels. We have access to additional debt should we need it.

All projections in the above narrative are forward-looking and not guaranteed.

The Lead Investor may receive compensation if, in the future, Wefunder Advisors LLC forms a fund ("Fund") for accredited investors for the purpose of investing in a non-Regulation Crowdfunding offering of the Company. In such as circumstance, the Lead Investor may act as a portfolio manager for that Fund (and as a supervised person of Wefunder Advisors) and may be compensated through that role.

Although the Lead Investor may act in multiple roles with respect to the Company's offerings and may potentially be compensated for some of its services, the Lead Investor's goal is to maximize the value of the Company and therefore maximize the value of securities issued by or related to the Company. As a

result, the Lead Investor's interests should always be aligned with those of Investors. It is, however, possible that in some limited circumstances the Lead Investor's interests could diverge from the interests of Investors, as discussed in section 8 above.

Investors that wish to purchase securities related to the Company through Wefunder Portal must agree to give the Proxy described above to the Lead Investor, provided that if the Lead Investor is replaced, the Investor will have a 5-day period during which he or she may revoke the Proxy. If the Proxy is not revoked during this 5-day period, it will remain in effect.

**Tax Filings.** In order to complete necessary tax filings, the SPV is required to include information about each investor who holds an interest in the SPV, including each investor's taxpayer identification number ("TIN") (e.g., social security number or employer identification number). To the extent they have not already done so, each investor will be required to provide their TIN within the earlier of (i) two (2) years of making their investment or (ii) twenty (20) days prior to the date of any distribution from the SPV. If an investor does not provide their TIN within this time, the SPV reserves the right to withhold from any proceeds otherwise payable to the Investor an amount necessary for the SPV to satisfy its tax withholding obligations as well as the SPV's reasonable estimation of any penalties that may be charged by the IRS or other relevant authority as a result of the investor's failure to provide their TIN. Investors should carefully review the terms of the SPV Subscription Agreement for additional information about tax filings.

4. the issuer or another party purchases or repurchases all of the securities issued pursuant to Section 4(a)(6), including any payment in full of debt securities or any complete redemption of redeemable securities; or the issuer liquidates or dissolves in accordance with state law.
