The film industry is volatile. As such, a return on investment is not guaranteed. Investors should be aware that film productions can have little to no success based on market trends.

The original creator of the series, Manuel Godoy, is critical to the continuity of the series. Any personal tragedy or accident that would make him unavailable can seriously jeopardize the production.

The sink cost for film production is very high and may require additional funding sources which can effect the rate of return for investors.

Securing enough screens for profitability can be a hurdle that our company may not be able to reach. It is important that we reach a wide enough audience to recoup our sink cost and pay back our financiers.

The presence of AI in the industry has caused acting unions to be unpredictable . This can cause delays, cancellations, recasting, and other problems that will drastically effect the production cost. This is something we may not be able to avoid.

Social media platforms consistently change their algorithms which can sometimes prove unfavorable to the marketing strategies of film releases. This could be a potential problem for us in the future.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

USE OF FUNDS

This offering is for the purpose of raising funds to produce the film "The Godfather Part II".

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from this Offering. Accordingly, the Company will have broad discretion in using these proceeds.

This Agreement (the "Agreement") constitutes the understanding and agreement between Black Sands First Act Co, and its assignee, if any ("Producer") and the investor executing this Agreement on the signature page hereto ("Financier"), in connection with certain investment financing undertaken by Financier regarding the animated series project tentatively entitled "Black Sands: Episodes 1-3" (the "Project") being produced by Producer.

WHEREAS, the Securities are being offered through the Portal in minimum increments of Two Hundred and Fifty Dollars (\$250) for a **target offering amount of Seven Hundred and Fifty Thousand Dollars (\$750,000)** (the "Target Amount") and a **maximum offering amount of Two Million Two Hundred and Fifty Thousand Dollars (\$2,250,000)** (the "Maximum Amount").

WHEREAS, if the Financier has invested in the first \$750,000 raised by the Producer, Financier will receive a higher profit share in the Gross Receipts as set forth under Section 5 of the Agreement ("Early Bird Incentive").

RECOUPMENT AND PROFIT PARTICIPATION:

Provided that Producer has completed the Offering, and Financier is not in breach of this Agreement, **Producer agrees to repay to Financier the Financing Amount, together with a 10% premium thereon ("Financier Recoupment"), solely from Gross Receipts** (if any) in accordance with this Paragraph 5 and the waterfall structure outlined below.

"Gross Receipts" as used herein shall mean all non-returnable, non-forfeitable sums derived by, or credited to, Producer or any of its affiliated or related parties from the distribution, exhibition, and other exploitation of the Project (excluding any sequel or derivative, any merchandising, publishing, soundtrack and other allied and/or ancillary rights relating thereto) and any other funds received by or credited to Producer or any of its affiliated or related parties from the exploitation of the Project.

Gross Receipts, if any, of the Project shall be allocated in the following order:

a. First, to the payment of the following:

i. Any actual third party, out-of-pocket sales fees and sales expenses payable to the sales agents engaged to sell the Project and

other third party distribution fees and expenses (including but not limited to reasonable outside attorney fees) actually incurred and not otherwise recouped by Producer relating directly to the Project, ongoing third party, out-of-pocket accounting costs and expenses incurred by Producer in connection with the processing of payments to profit participants on the Project;

ii. All other costs, expenses and charges actually incurred and paid by the Producer (or any affiliated or related entities) in connection with the production, post-production of the Project or any rights therein, including, but not limited to, actual, out of pocket third party delivery costs and expenses (exclusive of the budgeted delivery costs), actual, out of pocket third party reasonable festival expenses (e.g., publicist, accommodations for producers, etc.), guild royalties, residuals, the gross amount (net of any insurance proceeds in connection therewith) paid for the settlement of any claims or lawsuits, including all expenses, court costs and attorneys' fees in connection with any such claim or litigation; but only to the extent any of the foregoing have not previously been paid or assumed by the Project's distributor;

iii. Third party, out-of-pocket expenses incurred by Producer in connection with the ongoing ownership of the Project, including but not limited to (e.g., insurance premiums, the preservation and storage of negatives and master prints of the Project, and copyrighting of the Project) and maintenance and filing fees required to maintain Producer in good standing; taxes and other fees; and any amounts required to be withheld by law, if any;

iv. Any compensation or deferred compensation and bonuses (e.g., box office bonuses, award bonuses) payable to parties rendering services in connection with the Project (to the extent not assumed by the distributor(s) of the Project); market rate compensation payable to the Producer or its affiliates for services rendered in connection with the production, completion and delivery of the Project; any amounts paid to the completion guarantor of the Project (if any) in repayment of sums advanced by such completion guarantor; any reasonable reserve amount, as determined by Producer in its good faith business judgment, required to cover anticipated future costs or liabilities, provided that such reserve amounts shall be liquidated every twelve (12) months.

b. Second, to recoup P&A Costs;

c. Third, to pay Distribution Fees & Expenses;

d. Fourth, to pay Sales Agent Costs;

e. Fifth, to Debt Service;

f. Sixth, to Repay Investors (including Financier Recoupment);

g. Seventh, for the payment of any actual Deferments, which deferments shall not exceed 20% of the final budget of the Project. As used herein, "Deferments" shall mean arrangements for the deferral of some or all of the costs of goods and/or services in the Production Budget provided by the supplier of such goods and/or services;

h. Eighth, to Profit Share to 3rd Parties;

i. **Finally, the remaining amount shall be considered Production Company Net Receipts, to be split as follows:**

- 67 - 70% to Producer

- 30 - 33% to be divided among all Financiers participating in the Reg CF and A round.

"Net Receipts," as used herein, shall mean One Hundred Percent (100%) of all Gross Receipts remaining after the payments of all amounts set forth in subparagraphs 5(a) through (h) above. Producer shall receive 67% to 70% of Net Receipts ("Producer's Net Receipts")

and the other 30% to 33% of Net Receipts shall be "Financier's Net Receipts", where i) Financier which do not qualify for Early Bird Incentive shall receive 30% and ii) the Financier who do qualify for the **Early Bird Incentive shall receive 33%**. Financier shall receive such percentage of Financier's Net Receipts equal to the percentage that the Financing Amount advanced to Producer represents to the actual Production Budget, which may exceed the estimated Production Budget as set forth herein.

Because the Investor holds no voting rights in the company, the holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering). These decisions could affect gross revenues and diminish payments made to Investors. As holders of a majority-in-interest of voting rights in the Company, **the shareholders** may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, **the shareholders** may change the terms of the articles of incorporation for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. **The shareholders** may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. Black Sands Anime Co. is 50% owned by Black Sands Entertainment Inc. Black Sands Entertainment Inc. is the original creator of all source IP and the licensor of the content. A copy of the licensor agreement is attached to the Form C.

The company operates within the dynamic and ever-evolving entertainment industry, specializing in the production and distribution of animated content and literary works.

Milestones

Black Sands First Act Co was incorporated in the State of Delaware in June 2024.

Since then, we have:

- Anime based off the most popular black indie comic series in the nation.
- Produced by the former President of Lion Forge Animation
- Millions in revenue generated from the source material already.
- Strong industry connections, attracting high level talent.

The Company is subject to risks and uncertainties common to early-stage companies. Given the Company's limited operating history, the Company cannot reliably estimate how much revenue it will receive in the future.

Our company was organized in June 2024 and has limited operations upon which prospective investors may base an evaluation of its performance.

Our intent is to be profitable in 24 months.

We have shown no material changes in our finances since inception. We are currently stable and expected to operate at full capacity once funded with our campaign maximum.

Our expenses will be north of a million dollars in the next 6 months if we fully fund the project, as we expect to hire hundreds of animators.

As this is a film project, our profitability comes at a significant cost. We expect profitability to occur after the theatrical release, set for the summer of 2025. The production budget will be covered by the \$2.25m raised through Wefunder, but there is also front end and backend unavoidable costs that are usually recovered by grants, presales, distributors etc. The full projected budget is over 4 million. We have partnering companies that help seed the initial development of the project. This comes from Black Sands Entertainment, Inc., and Composition Media, LLC.
