8. Discuss the material factors that make an investment in the issuer speculative or risky:

**Delayed Scaling Projections:** Our business growth relies heavily on our ability to scale operations efficiently. If our scaling projections take longer than anticipated, it could lead to delays in reaching key milestones, reduced revenue growth, and increased operational costs. These delays could also limit our ability to capitalize on market opportunities and strain our resources, impacting our overall business objectives and investor returns.

**Uncertain Duration of Key Retail Partnership:** Our contract with Michaels, a significant retail partner, is not guaranteed beyond one year. There is a potential risk that this partnership could be short-lived. The loss of this key retail outlet could reduce our visibility and sales, making it crucial that we continue to aggressively expand our B2B sales channel to diversify our revenue streams and mitigate the impact of any potential contract termination.

**Improper Execution on Large-Scale Deals:** The successful execution of large-scale deals is critical to our growth; however, any failure, whether due to personnel challenges or supply chain disruptions, could result in the loss of current and future business opportunities. Such failures could damage our reputation, lead to financial losses, and hinder our ability to secure similar deals in the future. Ensuring reliable execution is essential to maintaining the trust of our partners and sustaining our business growth.

**Regulatory Compliance and Recall Risk:** As a ready-to-eat food product, our sprinkles are subject to FDA recall regulations. Although sprinkles are considered a low-risk product in terms of food safety, the possibility of a recall cannot be completely eliminated. A large-scale recall could have a substantial financial impact on our company, not only in direct costs but also in terms of lost production time and the opportunity cost associated with remanufacturing the affected product. This could hinder our ability to meet market demand and affect our overall business performance.

**Dependence on a Single Production Facility:** Our operations currently rely on a single production facility. Any disruption, whether due to natural disasters, equipment failure, or other unforeseen events, could significantly impact our ability to manufacture and deliver products. There can be no assurance that we will be able to quickly or effectively resume operations or secure alternative facilities in the event of such disruptions.

**Debt Servicing:** A significant risk in this investment is the current debt service, particularly high-interest short term loans and credit card obligations. This debt has been critical in funding Sprinkle Pop's initial growth but now presents a substantial cash flow burden. To mitigate this risk, a portion of the investment will be allocated to paying down this high-interest debt, which will immediately reduce financial strain. This reduction will allow us to refocus resources on building efficiencies, increasing inventory, and making strategic equipment purchases, ultimately positioning us for more sustainable growth.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

### USE OF FUNDS

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from this Offering. Accordingly, the Company will have broad discretion in using these proceeds.

Book Entry and Investment in the Co-Issuer. Investors will make their investments by investing in interests issued by one or more co-issuers, each of which is a special purpose vehicle ("SPV"). The SPV will invest all amounts it receives from investors in securities issued by the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. All references in this Form C to an investor's investment in the Company (or similar phrases) should be

**Type of Security:** Convertible Promissory Notes ("Notes").

**Amount to be Offered:** The goal of the raise is \$124,000.00

**Valuation Cap:** \$5,000,000.00

**Discount Rate:** 100%

**Maturity Date:** 60 months from the Effective Date.

**Interest Rate:** 10.0%. Interest shall commence with the date of the convertible note and shall continue on the outstanding principal amount until paid in full or converted. Interest shall be computed on the basis of a year of 365 days for the actual number of days elapsed. All unpaid interest and principal shall be due and payable upon request of the Majority Holders on or after the Maturity Date.

**Early-Bird & VIP Investors:** Investors investing in the first \$100,000.00, will receive a valuation cap of \$4,500,000.00. Wefunder VIP investors will be entitled to these terms for the entire duration of the offering, even if the threshold limit noted above is met.

**Conversion and Repayment**

**(a) Conversion Upon Qualified Financing** Conversion upon a Qualified Financing. In the event that the Company issues and sells its shares of equity securities to investors (the "Investors") while this Note remains outstanding in an equity financing with total proceeds to the Company of not less than \$10,000,000 (excluding the conversion of the Notes or other convertible securities issued for capital raising purposes (e.g., Simple Agreements for Future Equity)) (a "Qualified Financing"), then the outstanding principal amount of this Note and any unpaid accrued interest shall automatically convert in whole without any further action by the Holder into Equity Securities sold in the Qualified Financing at a conversion price equal to the lesser of (i) the price paid per unit for Equity Securities by the Investors in the Qualified Financing multiplied by 1.0, and (ii) the quotient resulting from dividing \$5,000,000 by the number of outstanding common units of the Company immediately prior to the Qualified Financing (assuming conversion of all securities convertible into common units and exercise of all outstanding options and warrants, but excluding the units of equity securities of the Company issuable upon the conversion of the Notes or other convertible securities issued for capital raising purposes (e.g., Simple Agreements for Future Equity)). The issuance of Equity Securities pursuant to the conversion of this Note shall be upon and subject to the same terms and conditions applicable to Equity Securities sold in the Qualified Financing. Notwithstanding this paragraph, if the conversion price of the Notes as determined pursuant to this paragraph (the "Conversion Price") is less than the price per unit at which Equity Securities are issued in the Qualified Financing, the Company may, solely at its option, elect to convert this Note into units of a newly created series of preferred unit having the identical rights, privileges, preferences and restrictions as Equity Securities issued in the Qualified Financing, and otherwise on the same terms and conditions, other than with respect to (if applicable): (i) the per unit liquidation preference and the conversion price for purposes of price-based anti-dilution protection, which will equal the Conversion Price; and (ii) the per unit dividend, which will be the same percentage of the Conversion Price as applied to determine the per unit dividends of the Investors in the Qualified Financing relative to the purchase price paid by the Investors.

**(b) Conversion upon a Change of Control.** If the Company consummates a Change of Control (as defined in the Convertible Note) while this Note remains outstanding, the Company shall repay the Holder in cash in an amount equal to the outstanding principal amount of this Note plus any unpaid accrued interest on the original principal. For purposes of this Note, a "Change of Control" means (i) a consolidation or merger of the Company with or into any other corporation or other entity or person, or any other corporate reorganization, other than any such consolidation, merger or reorganization in which the units of the Company immediately prior to such consolidation, merger or reorganization continue to represent a majority of the voting power of the surviving entity immediately after such consolidation, merger or reorganization; (ii) any transaction

or series of related transactions to which the Company is a party in which in excess of 50% of the Company's voting power is transferred; or (iii) the sale or transfer of all or substantially all of the Company's assets, or the exclusive license of all or substantially all of the Company's material intellectual property; provided that a Change of Control shall not include any transaction or series of transactions principally for bona fide equity financing purposes in which cash is received by the Company or any successor, indebtedness of the Company is cancelled or converted or a combination thereof. The Company shall give the Holder notice of a Change of Control not less than 10 days prior to the anticipated date of consummation of the Change of Control. Any repayment pursuant to this paragraph in connection with a Change of Control shall be subject to any required tax withholdings, and may be made by the Company (or any party to such Change of Control or its agent) following the Change of Control in connection with payment procedures established in connection with such Change of Control.

**(c) Procedure for Conversion.** Procedure for Conversion. In connection with any conversion of this Note into units, the Holder shall surrender this Note to the Company and deliver to the Company any documentation reasonably required by the Company (including, in the case of a Qualified Financing, all financing documents executed by the Investors in connection with such Qualified Financing). The Company shall not be required to issue or deliver the units into which this Note may convert until the Holder has surrendered this Note to the Company and delivered to the Company any such documentation. Upon the conversion of this Note into units pursuant to the terms hereof, in lieu of any fractional units to which the Holder would otherwise be entitled, the Company shall pay the Holder cash equal to such fraction multiplied by the price at which this Note converts.

**(d) Interest Accrual.** If a Change of Control or Qualified Financing is consummated, all interest on this Note shall be deemed to have stopped accruing as of a date selected by the Company that is up to 10 days prior to the signing of the definitive agreement for the Change of Control or Qualified Financing.

#### **Senior Indebtedness**

The indebtedness evidenced by this Note is subordinated in right of payment to the prior payment in full of any Senior Indebtedness in existence on the date of this Note or hereafter incurred. "Senior Indebtedness" shall mean, unless expressly subordinated to or made on a parity with the amounts due under this Note, all amounts due in connection with (i) indebtedness of the Company to banks or other lending institutions regularly engaged in the business of lending money (excluding venture capital, investment banking or similar institutions and their affiliates, which sometimes engage in lending activities but which are primarily engaged in investments in equity securities), and (ii) any such indebtedness or any debentures, notes or other evidence of indebtedness issued in exchange for such Senior Indebtedness, or any indebtedness arising from the satisfaction of such Senior Indebtedness by a guarantor.

#### **VIP Bonus**

Sprinkle Pop will offer a discount to the normal terms listed in this Form C for all investments that are committed by investors who are part of Wefunder, Inc's VIP program. This means eligible Wefunder investors will receive a discount for any securities they purchased in this offering. For more specific details on the company's discount, please review the description of the terms above.

The discount is only valid until the offering closes. Investors eligible for the bonus will also receive priority if they are on a waitlist to invest and the company exceeds its maximum funding goal. They will be given the first opportunity to invest if space in the offering becomes available due to the cancellation or failure of previous investments.

#### **Securities Issued by the SPV**

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue



interests in the SPV to investors. The SPV is formed concurrently with the filing of the Form C. Given this, the SPV does not have any financials to report. The SPV is managed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

### **Voting Rights**

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

### **Proxy to the Lead Investor**

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

### **Restriction on Transferability**

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

- Substantial DTC e-commerce business on 50% website; 50% Amazon boasting over 350k customers!

### Historical Results of Operations

- *Revenues & Gross Margin.* For the period ended December 31, 2023, the Company had revenues of \$2,792,661.02 compared to the year ended December 31, 2022, when the Company had revenues of \$3,099,566.77. Our gross margin was 58.9% in fiscal year 2023, and 47.88% in 2022.
- *Assets.* As of December 31, 2023, the Company had total assets of \$372,716.83, including \$98,362 in cash. As of December 31, 2022, the Company had \$253,319.25 in total assets, including \$18,212 in cash.
- *Net Loss.* The Company has had net losses of \$294,224.20 and net losses of \$652,729.92 for the fiscal years ended December 31, 2023 and December 31, 2022, respectively.
- *Liabilities.* The Company's liabilities totaled \$1,730,252.54 for the fiscal year ended December 31, 2023 and \$1,316,222.73 for the fiscal year ended December 31, 2022.

### Liquidity & Capital Resources

To-date, the company has been financed with \$1,270,900 in debt and \$350,000 in convertibles.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 12 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

### Runway & Short/Mid Term Expenses

Liz Bakes Cakes LLC cash in hand is \$79,921.73, as of August 2024. Over the last three months, revenues have averaged \$175,000/month, cost of goods sold has averaged \$62,000/month, and operational expenses have averaged \$120,000/month, for an average burn rate of \$7,000 per month. Our intent is to be profitable in 8 months.

Our 2024 YTD loss is \$485K Of that \$250k is attributed to Cost of Goods and labor outlay for our Michaels PO account for over 50% of the loss.

Website sales are down approximately \$250K year-to-date due to our strategic decision to scale back Meta ads in order to better control

our marketing efficiency and position ourselves for moderate and profitable growth during the busier fall season. Despite this, overall advertising spend has increased by 25%, driven by a greater investment in Amazon advertising, which has resulted in a 38% increase in sales, helping to offset the decrease in Shopify sales. Overall, our current trajectory is similar to last year's. With the addition of the Michaels holiday business and the onboarding of several large B2B projects, we anticipate ending the year near break-even and reaching solid profitability by February 2025.

We expect August to November to be our our busiest sales periods for our direct-to-consumer business. During these months, we expect to generate between \$300,000 and \$350,000 per month across all sales channels. Expenses are projected to be approximately \$220,000 per month, in addition to \$50,000 in debt payments. In addition to our general operating expenses we will incur another \$250,000-\$300,000 in costs for goods and labor to fulfill three purchase orders from Michaels, which are scheduled for delivery before the end of the year. Payments for these purchase orders are expected to start arriving in January 2025.

We are not currently profitable, although during our first five years, the business experienced 3x year growth but operated at a loss. While COVID led to an increase in new customer acquisition it also drove up cost in the the supply chain and shipping. Additionally IOS privacy changes in recent year have significantly driven up the cost of advertising.

In the summer of 2023, we made a strategic shift to drive more profitable revenue by reorganizing our sales and marketing efforts towards more profitable B2B sales and Amazon which has less volatile customer acquisition costs. We are now seeing the results of those efforts with our purchase order from Michaels and growth on Amazon. We expect to achieve profitability starting January 2025 as we receive our first payment from Michaels.

We intend to generate the bulk of our profits from Amazon and B2B sales. Consistent, large-scale revenue with low acquisition cost from Michaels and other B2B contracts will allow us to pay down high-interest debt and align our balance sheet. Additionally we will responsibly scale our ecommerce business, leveraging the seasonality of our product with heavier more profitable ad-spend during peak seasons. If our goals are met, we anticipate a profit of over \$750,000 in 2025, potentially doubling that in 2026. Our goal is to grow the company to over \$10 million in revenue with a 15%-20% net profit margin within the next 3-5 years. We expect to need another \$600k to achieve profitability through our current business model.

We are actively seeking to raise funds beyond our current Wefunder campaign. In addition, we are exploring potential purchase order (PO) financing options to support our operations. Our short-term cash burn will be managed through a combination of debt financing and external fundraising efforts. By securing these additional funds, we aim to ensure sufficient liquidity to meet our operational needs and capitalize on growth opportunities. Our goal is to strengthen our financial position, reduce dependency on high-interest debt, and create a stable foundation for sustainable growth. These efforts will not only support our immediate operational requirements but also position us for long-term success. The Lead Investor. As described above, each Investor that has entered into the Investor Agreement will grant a power of attorney to make voting decisions on behalf of that Investor to the Lead Investor (the "Proxy"). The Proxy is irrevocable unless and until a Successor Lead Investor takes the place of the Lead Investor, in which case, the Investor has a five (5) calendar day period to revoke the Proxy. Pursuant to the Proxy, the Lead Investor or his or her successor will make voting decisions and take any other actions in connection with the voting on Investors' behalf.

The Lead Investor is an experienced investor that is chosen to act in the role of Lead Investor on behalf of Investors that have a Proxy in effect. The Lead Investor will be chosen by the Company and approved by Wefunder Inc. and the identity of the initial Lead Investor will be disclosed to Investors before Investors make a final investment decision to purchase the securities related to the Company.

The Lead Investor can quit at any time or can be removed by Wefunder Inc. for cause or pursuant to a vote of investors as detailed in the Lead Investor Agreement. In the event the Lead Investor quits or is removed, the Company will choose a Successor Lead Investor who must be approved by Wefunder Inc. The identity of the Successor Lead Investor will be disclosed to Investors, and those that have a Proxy in effect can choose to either leave such Proxy in place or revoke such Proxy during a 5-day period beginning with notice of the replacement of the Lead Investor.

The Lead Investor will not receive any compensation for his or her services to the SPV. The Lead Investor may receive compensation if, in the future, Wefunder Advisors LLC forms a fund ("Fund") for accredited investors for the purpose of investing in a non-Regulation Crowdfunding offering of the Company. In such a circumstance, the Lead Investor may act as a portfolio manager for that Fund (and as a supervised person of Wefunder Advisors) and may be compensated through that role.

Although the Lead Investor may act in multiple roles with respect to the Company's offerings and may potentially be compensated for some of its services, the Lead Investor's goal is to maximize the value of the Company and therefore maximize the value of securities issued by or related to the Company. As a result, the Lead Investor's interests should always be aligned with those of Investors. It is, however, possible that in some limited circumstances the Lead Investor's interests could diverge from the interests of Investors, as discussed in section 8 above.

Investors that wish to purchase securities related to the Company through Wefunder Portal must agree to give the Proxy described above to the Lead Investor, provided that if the Lead Investor is replaced, the Investor will have a 5-day period during which he or she may revoke the Proxy. If the Proxy is not revoked during this 5-day period, it will remain in effect.

Tax Filings. In order to complete necessary tax filings, the SPV is required to include information about each investor who holds an interest in the SPV, including each investor's taxpayer identification number ("TIN") (e.g., social security number or employer

identification number). To the extent they have not already done so, each investor will be required to provide their TIN within the earlier of (i) two (2) years of making their investment or (ii) twenty (20) days prior to the date of any distribution from the SPV. If an investor does not provide their TIN within this time, the SPV reserves the right to withhold from any proceeds otherwise payable to the Investor an amount necessary for the SPV to satisfy its tax withholding obligations as well as the SPV's reasonable estimation of any penalties that may be charged by the IRS or other relevant authority as a result of the investor's failure to provide their TIN. Investors should carefully review the terms of the SPV Subscription Agreement for additional information about tax filings.
