Manufacturing and Supply Chain RisksVertikka's business model heavily relies on acquiring and setting up a new manufacturing facility. Delays or complications in this process, such as zoning issues, regulatory approvals, or construction delays, could significantly impact our production timeline and cost structure. Additionally, our reliance on specific suppliers for sustainable materials a risk. Disruptions in the supply chain, whether due to material shortages, transportation delays, or supplier insolvency, could hinder our ability to meet production targets and deliver homes on time.

Market Adoption and Demand UncertaintyWhile the market for affordable and sustainable housing is growing, there is a risk that our innovative prefabricated and modular homes may not achieve the anticipated level of market adoption. This could be due to various factors, including consumer reluctance to adopt new construction technologies, competition from established traditional construction methods, or economic downturns affecting overall housing demand. If the market does not embrace our products as expected, it could result in lower sales and profitability, making it challenging to achieve the projected growth.

Regulatory and Compliance Challenges

Vertikka operates in a highly regulated industry, and compliance with various local, state, and federal regulations is crucial. Changes in building codes, environmental regulations, or housing policies could impose additional costs or limit our ability to operate as planned. Furthermore, as we expand into new markets, particularly with the establishment of a manufacturing site in New York, we may encounter unfamiliar regulatory landscapes that could delay our expansion efforts or increase operational complexity. Non-compliance or delays in meeting regulatory requirements could result in fines, legal challenges, or project delays, impacting our overall business performance.

Capital Intensity and Financing Risks

The expansion and scaling of Vertikka's operations, including the acquisition of a manufacturing facility, are capital-intensive endeavors. Securing the necessary funding through our current and future investment rounds is critical to our growth strategy. There is a risk that we may not raise sufficient capital, or that the terms of financing could be unfavorable, leading to dilution of existing equity or an inability to fully execute our business plan. Additionally, any economic downturns or changes in investor sentiment could reduce access to capital markets, further complicating our funding efforts.

Customer and Partnership Reliance

Vertikka's business model depends on establishing strong relationships with key customers and partners, including government entities, financial institutions, and home builders. If these partnerships do not materialize or if existing relationships deteriorate, it could negatively impact our sales channels, financing options, and overall business growth. Furthermore, our reliance on a limited number of large customers or partners could create revenue concentration risks, where the loss of a single key partner or customer could significantly affect our financial stability.

Technoloav Intearation and Innovation Risks

Vertikka's success is heavily dependent on the effective integration and continuous innovation of prefabrication and modular construction technologies. There is a risk that the technology may not perform as expected, or that unforeseen technical challenges could arise during implementation. Additionally, staying ahead of competitors in terms of technological innovation requires ongoing investment in R&D, which could strain resources. Failure to successfully integrate new technologies or maintain our innovative edge could diminish our competitive advantage and market position.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

Book Entry and Investment in the Co-Issuer. Investors will make their investments by investing in interests issued by one or more co-issuers, each of which is a special purpose vehicle ("SPV"). The SPV will invest all amounts it receives from investors in securities issued by the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. All references in this Form C to an Investor's investment in the Company (or similar phrases) should be interpreted to include investments in a SPV.

Ownership and Capital Structure

THE OFFERING

13. Describe the terms of the securities being offered.

To view a copy of the SAFE you will purchase, please see [Appendix B, Investor Contracts](#). The main terms of the SAFEs are provided below.

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides Investors the right to **Preferred Stock** in the Company ("Preferred Stock"), when and if the Company sponsors an equity offering that involves **Preferred Stock**, on the standard terms offered to other Investors.

Conversion to Preferred Equity. Based on our SAFEs, when we engage in an offering of equity interests involving **Preferred Stock**, Investors will receive a number of shares of **Preferred Stock** calculated using the method that results in the greater number of **Preferred Stock**:

- i. the total value of the Investor's investment, divided by
 - a. the price of **Preferred Stock** issued to new Investors multiplied by
 - b. the **discount rate** (85%), or
- ii. if the valuation for the company is more than **\$50,000,000.00** (the "Valuation Cap"), the amount invested by the Investor divided by the quotient of

- invested by the investor divided by the quotient of
- a. the Valuation Cap divided by
 - b. the total amount of the Company's capitalization at that time.
- iii. For investors up to the first **\$300,000.00** of the securities, investors will receive a valuation cap of **\$45,000,000.00** and a discount rate of 80.0%. Wefunder VIP investors will be entitled to these terms for the entire duration of the offering, even if the threshold limit noted above is met.

Additional Terms of the Valuation Cap. For purposes of option (ii) above, the Company's capitalization calculated as of immediately prior to the Equity Financing and (without double-counting, in each case calculated on an as-converted to Common Stock basis):

- Includes all shares of Capital Stock issued and outstanding;
- Includes all Converting Securities;
- Includes all (i) issued and outstanding Options and (ii) Promised Options; and
- Includes the Unissued Option Pool, except that any increase to the Unissued Option Pool in connection with the Equity Financing shall only be included to the extent that the number of Promised Options exceeds the Unissued Option Pool prior to such increase.

Liquidity Events. If the Company has an initial public offering or is acquired by, merged with, or otherwise taken over by another company or new owners prior to Investors in the SAFEs receiving **Preferred Stock**, Investors will receive

- proceeds equal to the greater of (i) the Purchase Amount (the "Cash-Out Amount") or (ii) the amount payable on the number of shares of Common Stock equal to the Purchase Amount divided by the Liquidity Price (the "Conversion Amount")

Liquidity Priority. In a Liquidity Event or Dissolution Event, this Safe is intended to operate like standard nonparticipating Preferred Stock. The Investor's right to receive its Cash-Out Amount is:

- i. Junior to payment of outstanding indebtedness and creditor claims, including contractual claims for payment and convertible promissory notes (to the extent such convertible promissory notes are not actually or notionally converted into Capital Stock);
- ii. On par with payments for other Safes and/or Preferred Stock, and if the applicable Proceeds are insufficient to permit full payments to the Investor and such other Safes and/or Preferred Stock, the applicable Proceeds will be distributed pro rata to the Investor and such other Safes and/or Preferred Stock in proportion to the full payments that would otherwise be due; and
- iii. Senior to payments for Common Stock.

VIP Bonus

VERTIKKA will offer a discount to the normal terms listed in this Form C for all investments that are committed by investors who are part of Wefunder, Inc's VIP program. This means eligible Wefunder investors will receive a discount for any securities they purchased in this offering. For more specific details on the company's discount, please review the description of the terms above.

The discount is only valid until the offering closes. Investors eligible for the bonus will also receive priority if they are on a waitlist to invest and the company exceeds its maximum funding goal. They will be given the first opportunity to invest if space in the offering becomes available due to the cancellation or failure of previous investments.

Securities Issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV is formed concurrently with the filing of the Form C. Given this, the SPV does not have any financials to report. The SPV is managed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

Voting Rights

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

Restriction on Transferability

RESTRICTIONS ON TRANSFERABILITY

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

- ii. the majority-in-interest of all then-outstanding Safes with the same "Post-Money Valuation Cap" and "Discount Rate" as this Safe (and Safes lacking one or both of such terms will be considered to be the same with respect to such term(s)), provided that with respect to clause (ii):
 - A. the Purchase Amount may not be amended, waived or modified in this manner,
 - B. the consent of the Investor and each holder of such Safes must be solicited (even if not obtained), and
 - C. such amendment, waiver or modification treats all such holders in the same manner. "Majority-in-interest" refers to the holders of the applicable group of Safes whose Safes have a total Purchase Amount greater than 50% of the total Purchase Amount of all of such applicable group of Safes.

Pursuant to authorization in the Investor Agreement between each Investor and Wefunder Portal, Wefunder Portal is authorized to take the following actions with respect to the investment contract between the Company and an investor:

VERTIKKA was incorporated in the State of Wyoming in May 2024.

Since then, we have:

- Secured 200 Modular Home contract in Berger, Texas to meet the city's urgent housing needs.
- \$650B Market Focus: Targeting the high-demand, eco-friendly housing segment within a \$3T industry
- Bringing patented, Passive House-certified, manufactured homes to market
- Building ZERO-Energy homes that cut costs and consumption to zero while ensuring unmatched quality
- EDP-Certified production process with 99% of housing construction completed in the factory
- 80+ energy-efficient homes built with Biobuilds, a separate entity leveraging the same patent
- Experienced leadership with extensive backgrounds in product manufacturing and housing technology

The Company is subject to risks and uncertainties common to early-stage companies. Given the Company's limited operating history, the Company cannot reliably estimate how much revenue it will receive in the future.

Historical Results of Operations

Our company was incorporated in May 2024 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended July 31, 2024, the Company had revenues of \$3.
- *Assets.* As of July 31, 2024, the Company had total assets of \$6, including \$6 in cash.
- *Net Loss.* The Company has had net losses of \$572 through July 31, 2024.
- *Liabilities.* The Company's liabilities totaled \$0 through July 31, 2024.

Liquidity & Capital Resources

To-date, the company has been funded through personal contributions from the Founder and CEO.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 6 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 6 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

VERTIKKA cash in hand is \$2.97, as of August 2024. Over the last three months, revenues have averaged \$0/month, cost of goods sold has averaged \$0/month, and operational expenses have averaged \$0/month, for an average burn rate of \$0 per month. Our intent is to be profitable in 24 months.

Since our last financials, the key material changes include securing initial commitments towards our initial fund raise and advancing negotiations to acquire our manufacturing facility in Scranton, PA. These steps are critical for scaling operations and moving towards revenue generation.

In the next 3-6 months, we expect no revenue as we focus on acquiring our Northeast manufacturing facility. We're raising \$5-10 Million to establish production. We anticipate being revenue-generating within 12-18 months once the facility is operational. Production line, machinery acquisition, and set up \$1.5M over the next 6 months as well as technicians to set up manufacturing which comes to \$375k over the next 6 months. The lease to the manufacturing facility would cost approximately \$283,500 over the next 6 months.

We are not yet profitable. To reach profitability, we hope to raise total of \$10M to establish our manufacturing facility and scale production. We expect to achieve profitability within 24-30 months of securing the funding, driven by strong demand for affordable, sustainable housing.

Besides Wefunder, we are in discussions with strategic investors and exploring partnerships with States and top U.S. home builders. To cover short-term burn, we plan to use a combination of initial Wefunder commitments, pre-sales funds, and founder capital.

All projections in the above narrative are forward-looking and not guaranteed.

Although the Lead Investor may act in multiple roles with respect to the Company's offerings and may potentially be compensated for some of its services, the Lead Investor's goal is to maximize the value of the Company and therefore maximize the value of securities issued by or related to the

Company. As a result, the Lead Investor's interests should always be aligned with those of Investors. It is, however, possible that in some limited circumstances the Lead Investor's interests could diverge from the interests of Investors, as discussed in section 8 above.

Investors that wish to purchase securities related to the Company through Wefunder Portal must agree to give the Proxy described above to the Lead Investor, provided that if the Lead Investor is replaced, the Investor will have a 5-day period during which he or she may revoke the Proxy. If the Proxy is not revoked during this 5-day period, it will remain in effect.

Tax Filings. In order to complete necessary tax filings, the SPV is required to include information about each investor who holds an interest in the SPV, including each investor's taxpayer identification number ("TIN") (e.g., social security number or employer identification number). To the extent they have not already done so, each investor will be required to provide their TIN within the earlier of (i) two (2) years of making their investment or (ii) twenty (20) days prior to the date of any distribution from the SPV. If an investor does not provide their TIN within this time, the SPV reserves the right to withhold from any proceeds otherwise payable to the Investor an amount necessary for the SPV to satisfy its tax withholding obligations as well as the SPV's reasonable estimation of any penalties that may be charged by the IRS or other relevant authority as a result of the investor's failure to provide their TIN. Investors should carefully review the terms of the SPV Subscription Agreement for additional information about tax filings.

INSTRUCTIONS TO QUESTION 30: If information is presented to investors in a format, media or other means not able to be reflected in text or portable document format, the issuer should include:

- (a) a description of the material content of such information;*
- (b) a description of the format in which such disclosure is presented; and*
- (c) in the case of disclosure in video, audio or other dynamic media or format, a transcript or description of such disclosure.*

ONGOING REPORTING

32. The issuer will file a report electronically with the Securities & Exchange Commission annually and post the report on its website, no later than:

120 days after the end of each fiscal year covered by the report.

1. the issuer is required to file reports under Exchange Act Sections 13(a) or 15(d);

3. the issuer has filed at least three annual reports and has total assets that do not exceed \$10 million;
4. the issuer or another party purchases or repurchases all of the securities issued pursuant to Section 4(a)(6), including any payment in full of debt securities or any complete redemption of redeemable securities; or the issuer liquidates or dissolves in accordance with state law.
