An increase in the cost of raw materials or energy could affect the Company's profitability. Our retail pricing is competitive, and we do not intend to raise prices for 24 months, therefore operating profit could reduce.

The spirits business is highly regulated at the federal, state and local levels. Our operations may be subject to more restrictive regulations and increased taxation than are those of non-alcohol related businesses.

We rely on distributors to facilitate our route to market. Although currently we have great relationships with our distributors, we need to ensure we maintain a great relationship in order maintain and grow our operations.

We manufacture in South Africa and although we do have agreements in place to facilitate production in the UK and US (if needed), we may experience currency fluctuations in South Africa, that may impact operating profit.

The alcohol industry is highly competitive, with many established brands and new entrants vying for market share. The company may face challenges in differentiating its products, which could impact sales and profitability.

Shifts in consumer preferences, such as increasing demand for low-alcohol or non-alcoholic beverages, could reduce demand for the company's products.

The success of the company is likely tied to the strength of its brand and reputation. Any negative publicity, product recalls, or adverse events could harm the brand and result in lost sales.

As an early-stage company, there may be limited financial resources and a need for additional capital to fund growth. The inability to raise sufficient capital or manage cash flow could threaten the company's viability.

The alcohol industry is sensitive to changes in economic conditions, such as recessions, inflation, or shifts in disposable income. Adverse economic conditions could reduce consumer spending on alcohol products.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from this Offering. Accordingly, the Company will have broad discretion in using these proceeds.

10. How does the issuer intend to use the proceeds of this offering?

If we raise: **\$50,000**

Use of Proceeds: 20% towards digital marketing. 10% for in store marketing. 30% for inventory. 33.1% for additional sales staff. 6.9% towards the Wefunder intermediary fee.

If we raise: **\$1,235,000**

Use of Proceeds: 25% towards digital marketing. 10% for in store marketing. 38% for inventory. 20.1% for additional sales staff. 6.9% towards the Wefunder intermediary fee. Raising an additional \$1M+ would enable us to significantly increase our sales and marketing efforts in both On Premise and Off Premise channels, as well as increasing our inventory to accommodate more fluctuations in customer demand.

Book Entry and Investment in the Co-Issuer. Investors will make their investments by investing in interests issued by one or more co-issuers, each of which is a special purpose vehicle ("SPV"). The SPV will invest all amounts it receives from investors in securities issued by the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. All references in this Form C to an Investor's investment in the Company (or similar phrases) should be interpreted to include investments in a SPV.

12. How can an investor cancel an investment commitment?

Ownership and Capital Structure

THE OFFERING

The main terms of the SAFEs are provided below.

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides Investors the right to **Preferred Stock** in the Company ("**Preferred Stock**"). when and if the Company

sponsors an equity offering that involves **Preferred Stock**, on the standard terms offered to other Investors.

Uncapped SAFE. The “**Discount Rate**” is **85%**.

Conversion to Preferred Equity. If there is an Equity Financing before the termination of this Safe, on the initial closing of such Equity Financing, this Safe will automatically convert into the number of shares of Safe Preferred Stock equal to the Purchase Amount divided by the Discount Price.

“Discount Price” means the lowest price per share of the Standard Preferred Stock sold in the Equity Financing multiplied by the Discount Rate.

For investors up to the first **\$500,000.00** of the securities, investors will receive a discount rate of **80.0%**. Wefunder VIP investors will be entitled to these terms for the entire duration of the offering, even if the threshold limit noted above is met.

Liquidity Events. If there is a Liquidity Event before the termination of this Safe, the Investor will automatically be entitled (subject to the liquidation priority set forth in Section 1(d) below) to receive a portion of Proceeds, due and payable to the Investor immediately prior to, or concurrent with, the consummation of such Liquidity Event, equal to the greater of (i) the Purchase Amount (the “Cash-Out Amount”) or (ii) the amount payable on the number of shares of Common Stock equal to the Purchase Amount divided by the Liquidity Price (the “Conversion Amount”). If any of the Company’s securityholders are given a choice as to the form and amount of Proceeds to be received in a Liquidity Event, the Investor will be given the same choice, provided that the Investor may not choose to receive a form of consideration that the Investor would be ineligible to receive as a result of the Investor’s failure to satisfy any requirement or limitation generally applicable to the Company’s securityholders, or under any applicable laws.

Liquidation Priority. In a Liquidity Event or Dissolution Event, this Safe is intended to operate like standard non-participating Preferred Stock. The Investor’s right to receive its Cash-Out Amount is:

(i) Junior to payment of outstanding indebtedness and creditor claims, including contractual claims for payment and convertible promissory notes (to the extent such convertible promissory notes are not actually or notionally converted into Capital Stock);

converted into capital stock;

(ii) On par with payments for other Safes and/or Preferred Stock, and if the applicable Proceeds are insufficient to permit full payments to the Investor and such other Safes and/or Preferred Stock, the applicable Proceeds will be distributed pro rata to the Investor and such other Safes and/or Preferred Stock in proportion to the full payments that would otherwise be due; and

(iii) Senior to payments for Common Stock.

VIP Bonus

Spearhead Spirits will offer a discount to the normal terms listed in this Form C for all investments that are committed by investors who are part of Wefunder, Inc's VIP program. This means eligible Wefunder investors will receive a discount for any securities they purchased in this offering. For more specific details on the company's discount, please review the description of the terms above.

The discount is only valid until the offering closes. Investors eligible for the bonus will also receive priority if they are on a waitlist to invest and the company exceeds its maximum funding goal. They will be given the first opportunity to invest if space in the offering becomes available due to the cancellation or failure of previous investments.

Securities Issued by the SPV Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV is formed concurrently with the filing of the Form C. Given this, the SPV does not have any financials to report. The SPV is managed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors. The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and

rights, as if the investor invested directly in the Company.

Voting Rights If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect. Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the “Investor”), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor’s true and lawful proxy and attorney (the “Proxy”) with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor (“Replacement Lead Investor”) takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

Restriction on Transferability The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

one or both of such terms will be considered to be the same with respect to such term(s)), provided that with respect to clause (ii): (A) the Purchase Amount may not be amended, waived or modified in this manner, (B) the consent of the Investor and each holder of such Safes must be solicited (even if not obtained), and (C) such amendment, waiver or modification treats all such holders in the same manner. "Majority-in-interest" refers to the holders of the applicable group of Safes whose Safes have a total Purchase Amount greater than 50% of the total Purchase Amount of all of such applicable group of Safes.

For example, those interest holders could vote to change the terms of the agreements governing the Company’s operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

To the extent applicable, in cases where the rights of holders of convertible debt, SAFES, or other outstanding

options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. This means that the pro-rata portion of the Company represented by the Investor's securities will decrease, which could also diminish the Investor's voting and/or economic rights. Management's Discussion and Analysis of Financial Condition and Results of Operations

Overview

Spearhead Spirits is a beverage company focused on producing premium, African-inspired spirits. Our flagship products, Bayab Gin and Vusa Vodka, are crafted using traditional African botanicals and ingredients, combined with modern distillation methods. Spearhead Spirits aims to bring the rich heritage and flavors of Africa to the global market, offering consumers distinctive, high-quality spirits that celebrate the continent's diversity. Through innovation and craftsmanship, we are expanding the reach of African spirits in the premium beverage industry worldwide.

Milestones

Spearhead Spirits, Inc. was incorporated on April 22, 2022, in the state of Delaware. The company has three wholly-owned subsidiaries: Spearhead Spirits (PTY) LTD (organized on June 7, 2022, in Cape Town, South Africa), Spearhead Spirits Trading Inc. (incorporated on September 2, 2022, in the state of Delaware), and Spearhead Spirits LTD (organized on June 22, 2022, in the United Kingdom). Since then, we have:

Historical Results of Operations

Our company was incorporated in April 2022 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended December 31, 2023, the Company had revenues of \$892,013 compared to the year ended December 31, 2022, when the Company had revenues of \$37,609. Our gross margin was 59.3% in fiscal year 2023
- *Assets.* As of December 31, 2023, the Company had total assets of \$1,270,564, including \$196,358 in cash. As of December 31, 2022, the Company had \$1,729,680 in total assets, including \$1,359,547 in cash.
- *Net Loss.* The Company has had net losses of \$1,762,257 and net losses of \$1,299,513 for the fiscal years ended December 31, 2023 and December 31, 2022, respectively.
- *Liabilities.* The Company's liabilities totaled \$4,320,563 for the fiscal year ended December 31, 2023 and \$3,029,458 for the fiscal year ended December 31, 2022.

Liquidity & Capital Resources

To-date, the company has been financed with \$4,250,000 in convertibles.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 12 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 12 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Spearhead Spirits Inc cash in hand is \$117,835, as of August 2024. Over the last three months, revenues have averaged

2024. Over the last three months, revenues have averaged \$95,685/month, cost of goods sold has averaged \$46,274/month, and operational expenses have averaged \$87,000/month, for an average burn rate of \$37,589 per month. (Although we do not expect to incur these \$46,274/month COGS (inventory) costs in the coming months, so we would expect our burn rate to be significantly less than \$37,589 in the coming months). Our intent is to be profitable in 24 months.

Since the date our financials cover, we have released a new product (Sango Agave) which yields much higher cash margin. Therefore we expect monthly run rate will increase significantly. We have also made significant investment in product development and inventory in order to establish our award-winning portfolio.

Our last month (July 2024) we generated \$150,000 revenue as we introduced Sango Agave into the US market. Once we build this brand in the US, at a similar growth cadence to our other brands, we expect our monthly revenue to exceed \$200,000 a month. In addition, we plan to start selling and marketing our Whisky in 2025 which we believe has huge upside. Over the coming months, we expect our monthly expenses to be around \$100,000 per month.

We are not profitable at the moment as we have made significant investments in operational costs, product development and working with consultants to establish our route to market and distribution. Now this is in place, our monthly operating costs have dropped by 25%. Our financial projections target us reaching profitability in 2026. And we are targeting raising \$4M in capital to reach that point — of which our Wefunder community round will be one component.

With increased revenue and margin, our burn rate gives us sufficient runway as we look to raise and close Series A. As we are in conversations with two strategic alcohol companies, our ambition is to close series A within 12 months.

All projections in the above narrative are forward-looking and not guaranteed.

have a Proxy in effect can choose to either leave such Proxy in place or revoke such Proxy during a 5-day period beginning with notice of the replacement of the Lead Investor.

The Lead Investor will not receive any compensation for his or her services to the SPV. The Lead Investor may receive compensation if, in the future, Wefunder Advisors LLC forms a fund ("Fund") for accredited investors for the purpose of investing in a non-Regulation Crowdfunding offering of the Company. In such as circumstance, the Lead Investor may act as a portfolio manager for that Fund (and as a supervised person of Wefunder Advisors) and may be compensated through that role.

Although the Lead Investor may act in multiple roles with respect to the Company's offerings and may potentially be compensated for some of its services, the Lead Investor's goal is to maximize the value of the Company and therefore maximize the value of securities issued by or related to the Company. As a result, the Lead Investor's interests should always be aligned with those of Investors. It is, however, possible that in some limited circumstances the Lead Investor's interests could diverge from the interests of Investors, as discussed in section 8 above.

Investors that wish to purchase securities related to the Company through Wefunder Portal must agree to give the Proxy described above to the Lead Investor, provided that if the Lead Investor is replaced, the Investor will have a 5-day period during which he or she may revoke the Proxy. If the Proxy is not revoked during this 5-day period, it will remain in effect.

Tax Filings. In order to complete necessary tax filings, the SPV is required to include information about each investor who holds an interest in the SPV, including each investor's taxpayer identification number ("TIN") (e.g., social security number or employer identification number). To the extent they have not already done so, each investor will be required to provide their TIN within the earlier of (i) two (2) years of making their investment or (ii) twenty (20) days prior to the date of any distribution from the SPV. If an investor does not provide their TIN within this time, the SPV reserves the right to withhold from any proceeds otherwise payable to the Investor an amount necessary for the SPV to satisfy its tax withholding obligations as well as the SPV's reasonable estimation of any penalties that may be charged by the IRS or other relevant authority as a result of the investor's failure to provide their TIN. Investors should carefully review the terms of the SPV Subscription

Agreement for additional information about tax filings.

4. the issuer or another party purchases or repurchases all of the securities issued pursuant to Section 4(a)(6), including any payment in full of debt securities or any complete redemption of redeemable securities; or the issuer liquidates or dissolves in accordance with state law.
