The bar is still in the early phases of construction, and delays in permitting, construction, or supply chain disruptions could result in cost overruns or push back the anticipated opening date. These delays could impact revenue projections and investor returns.

San Francisco is known for its vibrant bar and restaurant scene, with a significant number of established sports bars and restaurants. The bar will face competition from other venues, which could affect its ability to attract a stable customer base.

Focusing on a women-centered sports bar, while a unique and potentially strong selling point, may limit the target audience. There is always a risk that the niche focus might not attract a large enough customer base to sustain profitability.

Economic conditions, particularly in a high-cost area like San Francisco, may negatively impact consumer spending. Bars and restaurants are often considered discretionary spending, and an economic downturn could reduce patronage and overall revenue.

San Francisco is one of the most expensive cities in the U.S., with high rent, labor, and operational costs. Rising costs could squeeze profit margins, making it difficult to achieve profitability or maintain operations in the long term.

The sports bar will require multiple licenses to operate, including alcohol, health, and safety permits. Delays or difficulties in obtaining these licenses, or failure to comply with San Francisco's stringent regulatory requirements, could delay opening or result in penalties.

Hiring and retaining a reliable and experienced staff in San Francisco, where the cost of living is high, could be challenging. A shortage of qualified staff could negatively impact the customer experience and operational efficiency.

The lingering effects of the COVID-19 pandemic or future public health crises could negatively affect consumer behavior, leading to reduced foot traffic or government-imposed restrictions that limit business operations.

As a new business, there is uncertainty about the timing and method of receiving loan repayments for investors. Since the bar is not yet open, the risk of delayed or reduced returns for investors is high. With a revenue share loan contract, if revenue is lower than anticipated, then it will take investors longer than anticipated to realize their financial returns.

Control of the Company. Control of the Company and all of its operations rest solely with the management and the membership of the Company, upon whose judgment and skills investors must rely. The Company's managers, officers and members have management experience, but no experience managing a bar/restaurant. The Company's ability to operate successfully may depend on its ability to attract and retain qualified personnel.

Financial Statements Prepared by The Company. The Company prepared its financial projections and statements internally. The financials have been reviewed but only for the Company's short operating history. Although the Company based its assumptions upon research, and the Company endeavored to make financial statements and projections as accurate and clear as possible, the statements may contain errors or incorrect assumptions.

Revisions to Use of Proceeds. It is possible that the use of the proceeds will be revised by management. Management will have significant flexibility in applying the net proceeds of this offering within the scope of the business of the Company. The failure of management to apply such funds effectively could have a material adverse effect on the Company's business, prospects, financial condition, and results of operations.

Lack of Operating History. Because the Company has not initiated operations, there is no assurance that Company will ever produce a profit. As a new enterprise, the Company is likely to be subject to risks management has not anticipated.

Risks With Respect To Potential Leased Premises. The Company is currently in negotiations with property owners for a potential site. There is no guarantee that the negotiations will result in a lease. Additionally, even if a lease is negotiated for particular premises, as with many projects, there is a risk that the premises will not be as anticipated or will be ready for operations in the time frame anticipated.

Licensing Risk. The Company will require a license for the sale of alcoholic beverages to operate the bar. The Company does not currently have a license and will need to apply and be approved for such license prior to opening the bar/restaurant. The Company anticipates that it will be able to obtain a liquor license but there is no guarantee that the Company will be able to do so either at all or in a timely manner.

Regulatory compliance. Our failure to comply with government rules and regulations may harm our business. Our business must comply with local, state and federal rules and regulations including alcohol, environmental, safety, food processing regulations. We believe that we can comply with the applicable rules and regulations. However, if we fail to comply with a rule or regulation, we may be subject to fines, or other penalties, or our permits or licenses may be lost or suspended. We may have to stop operating and our investors may lose their entire investment.

The Company May Not Be Able to Compete Against Established Competitors. The Company will be competing with established businesses that have an operating history and greater financial resources, management experience and market share than we have. There can be no assurance that we will be able to compete or capture adequate market share. The Company will not be profitable if we cannot compete successfully with other similar businesses.

Competitors Entering the Market. There are other bars/restaurants that are in the same geographic marketplace and other competitors may open a bar/restaurant that caters to the same customer base identified by the Company. Such competition could impact the ability of the store to earn revenues.

Transfer Restrictions. An investment in the Company should be considered only as a long-term investment due to transfer restrictions imposed by Federal and state regulations. The notes are "restricted securities" in that the Company's sale of them has not been registered under the Securities Act. Investors should understand that there are significant limitations on transfer of the notes.

USE OF FUNDS

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from this Offering. Accordingly, the Company will have broad discretion in using these proceeds.

10. How does the issuer intend to use the proceeds of this offering?

If we raise: **\$50,000**

Use of Proceeds: 83.8% towards lease (first, last, security deposit), 9.3% towards legal expenses, 6.9% Wefunder fees.

If we raise: **\$425,000**

Use of Proceeds: 9.3% towards lease (first, last, security deposit, 37.2% liquor license, 18.7% construction & architect fees, 9.3% fixtures & equipment, 9.3% technology (POS, software, TV/sound system), 9.3% insurance/licenses/fees, 6.9% Wefunder fees.

Milestones

The following table sets forth a summary of the milestones of Rikki's from its inception to the date of this offering.

The Libra Project, LLC was organized in the State of California in March 2024.

Since then, we have raised \$200,000 in equity capital, and begun to lay the groundwork for our Wefunder community round. We have received significant expressions of support and enthusiasm from the country, and have started to receive some attention in the press, even months before we open our doors.

The Company is subject to risks and uncertainties common to early-stage companies. Given the Company's limited operating history, the Company cannot reliably estimate how much revenue it will receive in the future.

Historical Results of Operations

Our company was organized in March 2024 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended March 8, 2024, the Company had no revenue or net income.
- *Assets.* As of March 8, 2024 (at inception), the Company had no assets or cash.
- *Liabilities.* The Company's liabilities totaled \$0 through March 8, 2024.

Related Party Transaction

Liquidity & Capital Resources

To-date, the company has been financed with \$200,000 in equity.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 6 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

The Libra Project, LLC cash in hand is \$209,492.79, as of October 2024. Over the last three months, revenues have averaged \$1,139/month, cost of goods sold has averaged \$996.80/month, and operational expenses have averaged \$3,331.81/month, for an average burn rate of \$3,189.61 per month. Our intent is to be profitable in 7 months.

Since our reviewed financials, we have held events where sell merchandise and build our potential customer base. In addition, we have raised \$200,000 in equity investment from our network.

Revenues the next 3-6 months are expected to be minimal and limited to merchandise sales of an estimate of \$800/month. Expenses the next 3-6 months will be significant assuming we are in contract for a premises. Estimates include: attorney's fees (\$4,000), lease deposit and rent (\$28,000), permits (\$1,000), construction costs (\$45,000), FF&E purchases (\$36,000), opening inventory (\$8,000), staffing up (\$3,000), food/beverage consultants (\$20,000), and owner stipend (\$6,000).

No, the company is not profitable. \$280,578 is needed to execute all pre-opening tasks and pay for all expenses as well as keep cash on hand for the first months of operations. With that funding in-hand we expect to be profitable in 6 months.

The company has \$200,000 in equity investor contributions as well as founder startup contributions. Some revenue has been realized through merchandise sales. Short term costs are to be covered by cash from the equity investments and potential private debt investments (in addition to the Wefunder offering).

All projections in the above narrative are forward-looking and not guaranteed.
