Greene Nation LLC (“**Issuer**”) the “**Company**,” “**we**,” “**us**,” or “**our**”), is offering a minimum amount of \$79,900 (the “**Target Offering Amount**”) and up to a maximum amount of \$286,700 (the “**Maximum Offering Amount**”) of Class A Units (the “**Securities**”) on a contingency basis as described in this Form C (this “**Offering**”). We must raise an amount equal to or greater than the Target Offering Amount by September 1, 2025 (the “**Offering Deadline**”). Unless we raise at least the Target Offering Amount by the Offering Deadline, no Securities will be sold in this Offering, all investment commitments will be canceled, and all committed funds will be returned.

Potential purchasers of the Securities are referred to herein as “**Investors**” or “**you**”. ### The Company

Greene Nation LLC (the “**Company**”) is a limited liability company formed in the state of Delaware on September 18, 2024 and is managed by MG Golf, LLC a Delaware Limited Liability Company (the “**Manager**”). The Company’s purpose is to provide golf enthusiasts with the opportunity for greater involvement in the sport by enabling them to acquire equity interests in the Company, which will own an interest in certain future earnings (the “**Player Revenue Interest**”), generated by Mason Greene, a professional golf player (“**Player**”). The Company’s principal objective is to finance certain approved expenses of Player for the benefit of Player’s professional development and career prospects in consideration for an interest in that Player’s future earnings, using the proceeds of this offering of securities under Regulation Crowdfunding (the “**Offering**”). For more information, see the section titled ‘*BUSINESS—The Player Revenue Interest.*’ This business model provides Investors with the opportunities to potentially generate revenue, provide long and short-term capital appreciation, and ultimately distribute profits.

*Investing in the Securities involves a high degree of risk and may result in the loss of your entire investment. Before making an investment decision with respect to the Securities, we urge you to carefully consider the risks described in this section and other factors set forth in this Form C. In addition to the risks specified below, the Company is subject to the same risks that all companies in its business, and all companies in the economy, are exposed to. These include risks relating to economic downturns, political and economic events and technological developments (such as hacking and the ability to prevent hacking). Additionally, early-stage companies are inherently riskier than more developed companies. Prospective Investors should consult with their legal, tax and financial advisors prior to making an investment in the Securities. The Securities should only be purchased by persons who can afford to lose all of their investment.*

### **Risks Related to the Company's Business**

***Our Company has a limited prior operating history. Therefore, acquiring Class A Units is a speculative investment. We cannot assure you that you will realize your investment objectives.***

An investment in our Class A Units involves a high degree of risk, including the possibility that you may not realize a return on your investment, or that your investment could lose some or all its value. The Company has only a limited operating history upon which prospective Investors may evaluate its performance. There is no guarantee that the Company will generate a financial return or that the value of its Player Revenue Interest will increase. For these reasons, we urge you to read this Form C carefully, and consult with your legal and financial advisors before deciding to invest in these Class A Units.

The prospects of the Company must be considered in light of the risks, expenses, and difficulties encountered in establishing a new business in a highly competitive industry. The Company will be engaged in a highly speculative business. The future financial performance of the Company will depend on its ability to earn revenue from Player's golf tours and tournaments. We cannot assure you the Company can successfully carry out its investment and operational strategy.

***An investment made through this Offering constitutes only an investment in the Company and not in the underlying Player Revenue Interest.***

A purchase of Class A Units of the Company does not constitute an investment in the underlying Player Revenue Interest directly. This limits the voting rights of Investors solely to the Company, which are further limited by the Company's Operating Agreement, described further in this Form C and attached hereto as Exhibit C. Investors will have voting rights only with respect to certain matters, primarily relating to amendments to the Operating Agreement that would adversely change the rights of their Class A Units and removal of the Manager for "cause." The Manager thus retains significant control over the management of the Company. In addition, the economic interest of a holder of Class A Units of the Company will not be identical to owning a direct undivided interest in the underlying Player Revenue Interest because, among other things, the Company will be required to pay corporate taxes before distributions are made to the holders.

***Initially there will be no public market for the resale of the Class A Units, and no such public market may ever develop.***

There is currently no public trading market for any of our Class A Units, and no such public market may ever develop. The Manager has no current plans to facilitate the resale of Class A Units acquired by Investors and potentially help provide liquidity to Investors. If an active public trading market for our Class A Units does not develop or is not sustained, it may be difficult or impossible for you to resell your Class A Units at any price. Even if a public market does develop, the market price could decline below the amount you paid for your Class A Units. Furthermore, the Company's term is not anticipated to last longer than a maximum of 6 years, which further impacts any prospective duration for resales.

***There are few businesses that have pursued a strategy or investment objective similar to the Company's.***

We believe the existence of other companies crowdfunding economic interests in professional golf players' future earnings has been very limited to date. The Company and the Class A Units may not gain market acceptance from potential Investors, professional golf players, or notable figures within the golf industry. This could inhibit market acceptance of the Company.



***While the Offering amount may exceed the value of the underlying Player Revenue Interest, proceeds from the Player Revenue Interest may not be sufficient to repay Investors the amount of their initial investment.***

On the date the Offering closes, the size of the Offering will exceed the amount of funds used to acquire the Player Revenue Interest because the proceeds of the Offering will be used to pay fees, costs and expenses incurred in making this Offering, acquiring the Player Revenue Interest, and establishing reserves to cover Operating Expenses of the Company. If the Player Revenue Interest must be terminated before there has been a substantial return received from the Player Revenue Interest, any proceeds remaining after first paying off any liabilities owed in connection with the Player Revenue Interest at the time of termination may not be sufficient to repay Investors the amount of their initial investment or any additional profits in excess of that amount.

***The Company may not be able to control many of its operating costs, and unexpected costs may adversely affect its financial results.***

We cannot provide assurance that the [Manager's estimates] regarding the price of the Player Revenue Interest and the maintenance, training, and competition costs of Player will prove accurate. Numerous factors may affect the Company's operating expenses, many of which will be beyond its control. The costs of owning the Player Revenue Interest and Player's maintenance, training, and competition costs are substantial and outside the Company's control. The Company expects these costs and expenses to increase over time due to inflationary factors.

Other factors that could cause the Company's expenses to be higher than expected include market fluctuations in the golf industry, interest and currency exchange rates, and other factors that are beyond the Company's control or that cannot be accurately predicted at this time. Outbreaks of infectious diseases could result in quarantines or other restrictions that may halt tours and tournaments or restrict movement, and thus reduce the Company's revenues.

The Company intends to pay its Operating Expenses from the proceeds from the sale of its Class A Units and future operating revenue. Events that increase the Company's operating expenses or reduce its capital resources and liquidity could prevent investors from receiving their anticipated return on investment.

***The Company is controlled by the Manager, and Members must rely solely on the judgment of the Manager's management team.***

The success of the Company will depend upon the experience and business judgment of the Manager, its management team, and the advisors the Manager engages. See 'BUSINESS – Manager' for information about the experience and responsibilities of Company Manager MG Golf, LLC and its manager Mason Green.

The Manager has exclusive control over most decisions as to the use of the proceeds of this offering following the purchase of the Player Revenue Interest. The selection of the Company's Player Revenue Interest is based on evaluations of physical condition and the past performance of Player using such data as performance results, health records, and input from prospective investors and other sources in the golf industry. However, the evaluation of a professional golf player's ability to compete successfully is not an exact science.

The Members of the Company will not be able to exercise any significant control or influence over the operation of the business of the Company, even if Members disagree with the Manager's decisions or disapprove of its performance. Accordingly, no person should invest in the Company unless he or she is willing to entrust all aspects of control to the Manager and to rely on its management ability. The Manager will have full and complete control and authority to act on behalf of the Company with respect to all major decisions, which include, among other things:

- decisions concerning the contractual arrangement relating to the Player Revenue Interest;
- decisions relating to the amount and form of compensation to be paid to persons providing services to the Company.

***The loss of the Manager's key executives could jeopardize the Investor's investment.***

The Company will depend on the efforts and expertise of the Manager's key persons Mason Greene and Sean Green. If the Manager loses or suffers an extended interruption in the service of one or more of its key personnel, the Company and the Class A Units could be adversely affected. The Manager does not expect to maintain key-man insurance on Mason Greene.

### ***Conflicts of Interest Arising from Fees Paid to the Intermediary by the Issuer or Manager***

The Intermediary facilitating the Offering may provide various administrative and management services to the Issuer or Manager for a fee, which may create a conflict of interest. The financial relationship might incentivize the intermediary to prioritize its own interests or those of the Issuer or Manager over the interests of Investors. While there are regulatory and disclosure mechanisms in place to mitigate such risks, they may not fully eliminate the potential for conflicts. Therefore, Investors should be aware of this risk, conduct their own due diligence, and consider the implications of the Intermediary's financial incentives when considering the Offering.

### ***The financial performance of the Company will depend on the quality of the services performed by trainers and other independent contractors.***

Player will utilize the Player Funds to engage independent contractors to perform many essential services required for golf tour and tournament preparation, including training and physical care of Player. These independent contractors often subcontract or employ others who actually perform the contracted for services. Some of these contractors will also be servicing other athletes not associated with Player. Player may have to compete for the services of trainers, and other independent contractors, and conflicts of interest may arise from time to time.

### ***Injury or death of Player could diminish revenue and net asset values.***

The Company plans to acquire an interest in the revenue generated by Player. Because purchasing an interest in Player can be expected to require a substantial investment by the Company, any illness, injury, accident, impairment, or death of Player could have a material adverse effect on the value of the Class A Units. Failure to perform as anticipated due to inability or lack of competitive will, injury, illness, disability, or death of Player, if uninsured or underinsured, could materially diminish the Company's net asset value.

### ***Absence of physical facilities; reliance on others for maintenance.***

Neither MG Golf, LLC nor the Company currently own any physical facilities for the training of Player. Therefore, Player will rely on third parties to train and prepare for competitions. Should any third-party contractor fail to competently train or care for Player, the health and/or value of Player could suffer, which could negatively affect the net asset values of the Company.

### ***Damage to the reputation of Player could negatively impact our business, financial condition, and results of operations.***

We believe that Player's ability to generate revenue will depend on Player's reputation and ability to be viewed favorably by the public. Prior to entering into the Master Player Agreement, we assessed the character and reputation of Player through our independent assessments and other methods. However, there can be no assurance that our review process uncovers all facts and characteristics that could adversely affect the reputation of Player or the value of his future revenue. Even if our review process provides us with an accurate assessment of the character and integrity of Player as of the date of our review, there can be no assurance that circumstances in the future will not change, or that Player will continue to behave in a manner consistent with past behavior. Any harm to the public reputation of Player, or association of Player's name with a public scandal, may reduce Player's ability to enter into and compete in future competitions and generate revenue, and as a result, the financial performance of the Company will suffer.

Player's reputation and the quality of Player's brand are critical to our business and success in existing markets and will be critical to our success as we enter new markets. Player may be adversely affected by any negative publicity, regardless of its accuracy. Also, there has been a marked increase in the use of social media platforms and similar devices, including blogs, social media websites and other forms of internet-based communications that provide individuals with access to a broad audience of consumers and other interested persons. The availability of information on social media platforms is virtually immediate as is its impact. Information posted may be adverse to our interests or may be inaccurate, each of which may harm our performance, prospects or business. The harm may be immediate and may disseminate rapidly and broadly, without affording us an opportunity for redress or correction.

***Changes in federal, state, and local laws, government regulation, and professional rules could adversely impact our business.***

The Company is subject to legislation and regulation at the federal, state, and local levels. In particular, the Company is subject to the rules of the Professional Golfers' Association of America. New laws and regulations may impose new and significant disclosure obligations and other operational, marketing and compliance-related obligations and requirements, which may lead to additional costs, risks of non-compliance, and diversion of our management's time and attention from strategic initiatives. Additionally, federal, state, and local legislators or regulators may change current laws or regulations which could adversely impact our business. Further, court actions or regulatory proceedings could also change our rights and obligations under applicable federal, state, local and international laws, which cannot be predicted. Modifications to existing requirements or imposition of new requirements or limitations could have an adverse impact on our business.

***The amount of capital the Company is attempting to raise in this Offering may not be enough to sustain the Company's current business plan.***

In order to achieve the Company's near and long-term goals, the Company may need to procure funds in addition to the amount raised in the Offering. There is no guarantee the Company will be able to raise such funds on acceptable terms or at all. If we are not able to raise sufficient capital in the future, we may not be able to execute our business plan, our continued operations will be in jeopardy and we may be forced to cease operations and sell or otherwise transfer all or substantially all of our remaining assets, which could cause Investors to lose all or a portion of their investment.

**Risks Related to the Golf Industry**

***Risks Associated with Investing in Professional Golfers.***

While investing in professional golfers may offer the opportunity for significant gains, these investments also involve a high degree of business and financial risk. The marketability and value of any investment in professional golfers will depend upon many factors beyond the Company's control. Player's performance may have substantial variations in earnings from period to period, Player will face intense competition, and Player's performance could experience declines in results at any stage. Volatility of earnings generated by Player may adversely affect the value of the Company's investment in the Player Revenue Interest.

***Professional golf is highly competitive and is undertaken by individuals and entities with significantly greater financial resources than the Company.***

Player will compete in professional golf tours and tournaments in the United States and across the world as one of [his/her] primary activities. Future competitive success will depend upon the ability of Player to develop [his/her] capabilities, whether [he/she] is being trained by highly skilled professionals. Professional golf is a competitive activity, and Player and the Company will be competing with individuals and entities with substantially greater experience and financial resources than Player and the Company. The highly competitive nature of the industry might make it more difficult to achieve a return on the investment.

***Player's ability to compete successfully depends on intangible factors that are difficult to evaluate.***

Player's successful performance in winning competitions and achieving earnings is critical to our success. Our financial performance will be significantly determined by Player's success in tournaments and competitions. The ability of a professional golf player to compete successfully depends on intangible behavioral factors, such as the ability to withstand the rigors of training and competing while maintaining the appropriate demeanor and composure. Factors related to competing at the highest levels, as Player intends to do, such as frequent travel (often international), change of environment, golf course quality, extreme weather and soundness issues may compromise the ability to properly train for and compete in key tours and tournaments. Ultimately, some professional golf players simply do not have the will to win at the highest levels, even though they may possess the physical talent to do so. This intangible factor cannot be determined with any certainty as physical health and management of the professional golf career of Player are often factors in the development or destruction of a player's willingness to perform at the highest levels. If Player is unable to generate sufficient earnings in tournaments, we could see insufficient returns which will harm our financial performance.

***The number of tours and tournaments and available competitive opportunities could decrease.***

A decrease in the number of tours and tournaments would reduce the number of competitions, which would likely reduce the total revenues available. [In recent years, the operating environment for golf competitions has become increasingly challenging.] [The 2022-2023 PGA Tour hosted a total of 54 events, while the 2023-2024 PGA Tour currently only features 39 events as scheduled.] Decreasing attendance and competition, coupled with increasing costs, could jeopardize the continued existence of certain golf courses. If the number of golf courses decreases, reduction or elimination of tour or tournament dates due to Covid-19 restrictions or other unanticipated business interruptions could reduce demand for professional golf competitions and depress market values, either of which could adversely affect the Company and its Class A Units.

***Global crises and geopolitical events, including without limitation, COVID-19 can have a significant effect on business operations and revenue projections.***

A significant outbreak of contagious diseases, such as COVID-19, in the human population could result in a widespread health crisis. Additionally, geopolitical events, such as wars or conflicts, could result in global disruptions to supplies, political uncertainty and displacement. Each of these crises could adversely affect the economies and financial markets of many countries, including the United States where we principally operate, resulting in an economic downturn that could reduce the demand for our products and services and impair our business prospects, including as a result of being unable to raise additional capital on acceptable terms to us, if at all.

***Government regulation of the professional golf industry could increase.***

Though valuable to federal, state, and local government as a source of revenue, professional golf could be subjected, at any time, to more restrictive regulation. The value of the Player Revenue Interest could be drastically diminished by stricter regulation, which would have a material adverse effect on the Company and the value of its Class A Units.

**Risks Related to the Offering**

***The Company could potentially be found to have not complied with securities law in connection with this Offering related to “Testing the Waters.”***

Prior to filing this Form C, the Company engaged in “testing the waters” permitted under Regulation Crowdfunding (17 CFR 227.206), which allows issuers to communicate to determine whether there is interest in the offering. All communication sent is deemed to be an offer of securities for purposes of the antifraud provisions of federal securities laws. Investors who expressed interest prior to the date of this Offering should read this Form C thoroughly and rely only on the information provided herein and not on any statement made prior to the Offering. The communications sent to Investors prior to the Offering are attached as Exhibit F. Some of these communications may not have included proper disclaimers required for “testing the waters.”

***No guarantee of Closing.***

There can be no guarantee that the Company will reach its funding target from potential Investors with respect to the Offering. If the Company does not reach its funding target, it may not be able to achieve its investment objectives by acquiring the Player Revenue Interest and generating revenue to enable distributions for Investors.

***Lack of diversification.***

It is not anticipated that the Company would own any assets other than the Player Revenue Interest, plus potential cash reserves for assorted expenses and amounts earned by the Company from tours and tournaments. Investors looking for diversification will have to create their own diversified portfolio by investing in other opportunities in addition to the Company.

***Industry concentration and general downturn in industry.***

Given the concentrated nature of the Player Revenue Interest (*i.e.*, only an interest in revenues generated by Player), any downturn in the professional golf industry is likely to impact the value of the Player Revenue Interest, and consequently the value of the Class A Units. In the event of a downturn in the industry, the value of the Player Revenue Interest is likely to decrease.

***Difficulties in determining the valuation.***

As explained in the ‘BUSINESS – Description of the Business’ section herein, the prospective future earnings of professional golf players is difficult to value. The valuation of the Player Revenue Interest that the Company acquires will be based upon a subjective approach taken by the executive officers of [the Manager], using such data as health records, past performances, and examinations, as well as input from prospective investors and other sources in the professional golf industry. The [Manager] sources data from reputable valuation providers in the industry[\*\*], among others. Consequently, valuations may be uncertain.

The value of the Player Revenue Interest, and consequently the value of Investors’ Class A Units can go down as well as up. Valuations are not guarantees of realizable price and do not necessarily correspond to the price at which the Class A Units may be offered. The value of the Player Revenue Interest may be materially affected by a number of factors outside the control of the Company, including any volatility in the economic markets and the condition of the professional golf industry.

***The U.S. Securities and Exchange Commission does not pass upon the merits of the Securities or the terms of the Offering, nor does it pass upon the accuracy or completeness of any Offering document or literature.***

You should not rely on the fact that our Form C is accessible through the U.S. Securities and Exchange Commission’s EDGAR filing system as an approval, endorsement or guarantee of compliance as it relates to this Offering. The U.S. Securities and Exchange Commission has not reviewed this Form C, nor any document or literature related to this Offering.

***Neither the Offering nor the Securities have been registered under federal or state securities laws.***

No governmental agency has reviewed or passed upon this Offering or the Securities. Neither the Offering nor the Securities have been registered under federal or state securities laws. Investors will not receive any of the benefits available in registered offerings, which may include access to quarterly and annual financial statements that have been audited by an independent accounting firm. Investors must therefore assess the adequacy of disclosure and the fairness of the terms of this Offering based on the information provided in this Form C and the accompanying exhibits.

***The Company has the right to limit individual Investors’ commitment amounts based on the Company’s determination of an Investors’ sophistication.***

The Company may prevent Investors from committing more than a certain amount in this Offering based on the Company’s determination of Investors’ sophistication and ability to assume the risk of the investment. This means that your desired investment amount may be limited or lowered based solely on the Company’s determination and not in line with relevant investment limits set forth by the Regulation CF rules. This also means that other Investors may receive larger allocations of the Offering based solely on the Company’s determination.

***If the sum of the investment commitments of the Offering does not equal or exceed the Target Offering Amount before the end of the Offering Deadline, no securities will be sold, all investments will be returned, and all commitments will be canceled.***

The Company has set a Target Offering Amount of \$79,900 for this Offering. However, there exists a risk that we may not be able to secure the full amount of investment commitments before the end of the Offering Deadline. In the event that the sum of the investment commitments does not equal or exceed the Target Offering Amount at the Offering Deadline, no securities will be sold in the Offering, all investment commitments will be cancelled, and all committed funds will be returned to the respective investors. Our ability to achieve the Target Offering Amount is contingent on a variety of factors, including market conditions, investor interest, and economic circumstances, which may be beyond our control. Failure to reach the Target Offering Amount could limit our access to the necessary capital to support our strategic initiatives, potentially affecting our business expansion, product development, and overall financial stability.



***The Company has the right to extend the Offering Deadline.***

The Company may extend the Offering Deadline beyond what is currently stated herein. This means that your investment may continue to be held in escrow while the Company attempts to raise the Target Offering Amount even after the Offering Deadline stated herein is reached. While you have the right to cancel your investment in the event the Company extends the Offering Deadline, if you choose to reconfirm your investment, your investment will not be accruing interest during this time and will simply be held until such time as the new Offering Deadline is reached without the Company receiving the Target Offering Amount, at which time it will be returned to you without interest or deduction, or the Company receives the Target Offering Amount, at which time it will be released to the Company to be used as set forth herein. Upon or shortly after the release of such funds to the Company, the Securities will be issued and distributed to you.

***The Company may also end the Offering early.***

If the Target Offering Amount is met after 21 calendar days, but before the Offering Deadline, the Company can end the Offering by providing notice to Investors at least 5 business days prior to the end of the Offering. This means your failure to participate in the Offering in a timely manner, may prevent you from being able to invest in this Offering – it also means the Company may limit the amount of capital it can raise during the Offering by ending the Offering early.

***The Company has the right to conduct multiple closings during the Offering.***

If the Company meets certain terms and conditions, an intermediate close of the Offering can occur, which will allow the Company to draw down on half of the proceeds committed and captured in the Offering during the relevant period. The Company may choose to continue the Offering thereafter. Investors should be mindful that this means they can make multiple investment commitments in the Offering, which may be subject to different cancellation rights. For example, if an intermediate close occurs and later a material change occurs as the Offering continues, Investors whose investment commitments were previously closed upon will not have the right to re-confirm their investment as it will be deemed to have been completed prior to the material change.

***The Company is not registered and will not be registered as an investment company under the Investment Company Act of 1940, as amended (the “Investment Company Act”), and the Manager is not and will not be registered as an investment adviser under the Investment Advisers Act of 1940, as amended (the “Investment Advisers Act”).***

The Class A Units will not have the benefit of the protections of the Investment Company Act or the Investment Advisers Act. The Company and the Manager have taken the position that the interests in the underlying Player Revenue Interest are not “securities” within the meaning of the Investment Company Act or the Investment Advisers Act, and thus the Company’s assets will comprise of less than 40% investment securities under the Investment Company Act and the Manager will not be advising with respect to securities under the Investment Advisers Act. This position, however, is based upon applicable case law that is inherently subject to judgments and interpretation. If the Company were to be required to register under the Investment Company Act or [the Manager] were to be required to register under the Investment Advisers Act, it could have a material and adverse impact on the results of operations and expenses of the Company, and the Manager may be forced to liquidate and wind up the Company or rescind any Offering of its Class A Units.

***There may be possible changes in federal tax laws.***

The Internal Revenue Code (the “Code”) is subject to change by Congress, and interpretations of the Code may be modified or affected by judicial decisions, by the Treasury Department through changes in regulations and by the Internal Revenue Service through its audit policy, announcements, and published and private rulings. Although significant changes to the tax laws historically have been given prospective application, we cannot assure you that any changes made in the tax law affecting an investment in the Company would be limited to prospective effect. Accordingly, the ultimate effect on Investors’ tax situation may be governed by laws, regulations or interpretations of laws or regulations which have not yet been proposed, passed, or made, as the case may be.

### ***Investors' Data and Personal Information May be Disclosed to Issuer, Intermediary, and Partners***

In connection with the Offering, Investors' personal information, including personally identifiable information (PII), will be collected and may be shared as part of the investment process with the Intermediary, the Issuer, and the Issuer's Intermediary's partners. This information may include, but is not limited to, the Investors' name, contact information, social security number, financial data, and other relevant details necessary to complete the investment transaction. While the Issuer, Intermediary, and their partners implement robust security measures to protect your PII, no system can be completely secure. Investors acknowledge and accept sharing of their information and the risks of data breaches, regulatory compliance issues, and varying levels of security practices among third-party service providers. By participating in this Reg CF offering, Investors agree to the privacy policy of the Issuer and the Intermediary, as well as of their third-party partners.

### **Risks Related to the Securities**

***Holders of the Class A Units have limited voting rights. As a result, holders of Class A Units will not have any ability to influence the outcome of important transactions and decision.***

The Manager has the unilateral ability to amend the Operating Agreement and the allocation policy in certain circumstances without the consent of the Investors, and the Investors only have limited voting rights in respect of the Company. Investors will have voting rights only with respect to certain matters, primarily relating to amendments to the Operating Agreement that would adversely change the rights of their Units and removal of the Manager for "cause." Investors will therefore be subject to any amendments the Manager makes (if any) to the Operating Agreement and allocation policy and also any decision it takes in respect of the Company, which the Investors do not get a right to vote upon. Investors may not necessarily agree with such amendments or decisions, and such amendments or decisions may only be in the best interests of only a limited number of the Investors, but not Investors as a whole.

Furthermore, the Manager can only be removed as manager of the Company in a very limited circumstance, following a non-appealable judgment of a court of competent jurisdiction to have committed fraud in connection with the Company. Investors would therefore not be able to remove the Manager merely because they did not agree, for example, with how the Manager was managing the Company.

***The Manager will have substantial discretion to determine whether and when you receive any distributions and the amounts distributed.***

The Operating Agreement provides that the Manager will distribute cash available for distribution to the Members of the Company as soon as reasonably practicable after the relevant amounts have been received by the Company, but only after the Manager has reserved amounts reasonably believed to provide adequate future working capital for the Company's ongoing operations and to meet any future contemplated obligations or contingencies. As revenue generated by racing activity is intermittent and highly unpredictable, planning for the Company's future cash needs will require the Manager to exercise substantial judgment as to the amounts reasonably available at anytime for distribution to the Company's Members. Investors should not expect to receive distributions regularly, if at all.

A Class A Units Holder's ownership of the Company may be diluted if the Manager issues additional Class A Units of the Company after the closing of the Offering. The Manager may sell additional Class A Units of the Company from time to time after the closing of the Offering in order to raise capital to cover the Company's ongoing operating expenses. If additional Class A Units are issued, Investors would have their ownership interest diluted. Dilution could reduce both the current value of the Class A Units of the Company held by existing Investors and the amount of any future distributions payable to the diluted Investors.



***The Manager and its affiliates will not be liable to the Company absent fraud, willful misconduct, or gross negligence. In addition, the Company is obligated to indemnify its officers and the Manager from liability to third parties.***

None of the Manager, nor any current or former directors, officers, employees, partners, shareholders, members, controlling persons, agents or independent contractors of the Manager, nor persons acting at the request of the Company in certain capacities with respect to other entities (collectively, the “**Covered Persons**”) will be liable to the Company, or any Class A Units Holders for any act or omission taken by the Covered Persons in connection with the business of the Company that has not been determined in a final, non-appealable decision of a court, arbitrator or other tribunal of competent jurisdiction to constitute fraud, willful misconduct or gross negligence.

The Operating Agreement requires the Company to indemnify the Covered Persons out of its assets against all liabilities and losses (including amounts paid in respect of judgments, fines, penalties or settlement of litigation, including legal fees and expenses) to which they become subject by virtue of serving as Covered Persons with respect to any act or omission that has not been determined by a final, non-appealable decision of a court, arbitrator or other tribunal of competent jurisdiction to constitute fraud, willful misconduct or gross negligence. The costs of meeting any indemnification will be allocated pro rata across the Company based on the value of the underlying Player Revenue Interest. If the Company is required to indemnify any person as described above, any such payment may reduce or dissipate the assets of the Company.]

***Conflicts of interest.***

The Manager will devote only such time to our business as it deems necessary. The Operating Agreement allows the Manager and its affiliates to participate in business ventures that are similar to, and that may compete with, our business. If the Manager organizes other companies in the future, we will be competing with the other companies for the time and talents of the personnel employed by the Manager rendering services to us.

***The offering price for the Class A Units determined by us may not necessarily bear any relationship to established valuation criteria such as earnings, book value of assets that may be agreed to between purchasers and sellers in private transactions or that may prevail in the market if and when our Class A Units can be traded publicly.***

The price of the Class A Units of the Company was not derived as a result of arms-length negotiations but was instead based upon various factors including the valuation of the Player Revenue Interest, anticipated market demand, our future prospects, our capital structure, as well as certain expenses incurred in connection with the Offering and ongoing training costs. These estimated values and Class A Units prices do not necessarily accurately reflect the actual value of the Class A Units or the price that may be realized upon disposition of the Class A Units.

***If a market ever develops for the Class A Units, the market price and trading volume of our Class A Units may be volatile.***

If a market develops for the Class A Units, the market price of the Class A Units could fluctuate significantly for many reasons, including reasons unrelated to our performance or the underlying Player Revenue Interest, such as the competition performance of related professional golf players, reports by industry analysts, investor perceptions and general economic and industry conditions. For example, to the extent that other companies, whether large or small, within the golf industry experience declines in their share price, the value of Class A Units may decline as well.

In addition, fluctuations in operating results of the Company or the failure of operating results to meet the expectations of investors may negatively impact the price of our Class A Units. Operating results may fluctuate in the future due to a variety of factors that could negatively affect revenues or expenses in any particular reporting period, including vulnerability of our business to a general economic downturn; changes in the laws that affect our operations; competition from other entertainment enterprises; compensation related expenses; application of accounting standards; seasonality; injury to Player, and our ability to obtain and maintain all necessary regulatory approvals, government certifications or licenses to conduct our business.

***There may be state law restrictions on Investors' ability to sell the Class A Units.***

Each state has its own securities laws, often called “blue sky” laws, which (1) limit sales of securities to a state’s residents unless the securities are registered in that state or qualify for an exemption from registration and (2) govern the reporting requirements for broker-dealers and stockbrokers doing business directly or indirectly in the state. Before a security is sold in a state, there must be a registration in place to cover the transaction, or it must be exempt from registration. Also, the broker must be registered in that state. We do not know whether our securities will be registered, or exempt, under the laws of any states. There may be significant state blue-sky law restrictions on the ability of Investors to sell, and on purchasers to buy, our Class A Units. In addition, because the Securities have not been registered under the Securities Act or under the securities laws of any state or foreign jurisdiction, the Securities have transfer restrictions and cannot be resold in the United States except pursuant to Rule 501 of Regulation CF. It is not currently contemplated that registration under the Securities Act or other securities laws will be effected. Investors should consider the resale market for our Class A Units to be limited. Investors may be unable to resell their Class A Units, or they may be unable to resell them without the significant expense of state registration or qualification or opinions to our satisfaction that no such registration or qualification is required. If Investors purchase Class A Units in an unregistered state/territory, the Company has the right to rescind the sale.

***Funds from purchasers accompanying subscriptions for the Class A Units will not accrue interest while in escrow prior to admission of the subscriber as a Member to the Company, if it occurs, in respect of such subscriptions.***

The funds paid by purchasers for the Class A Units will be held in a non-interest-bearing escrow account until the admission of the subscribers as Investors, if it occurs, in respect of the applicable subscriptions. Purchasers may not have the use of such funds or receive interest thereon pending the completion of the Offering. No subscriptions will be accepted, nor Class A Units sold unless valid subscriptions for the Offering are received and accepted prior to the termination of the Offering Period. If we terminate the Offering prior to accepting a subscriber’s subscription, escrowed funds will be returned, without interest or deduction, to the proposed Investors.

***Any dispute in relation to the Operating Agreement is subject to the exclusive jurisdiction of the Court of Chancery of the State of Delaware, except where federal law requires that certain claims be brought in federal courts. Our Operating Agreement, to the fullest extent permitted by applicable law, provides for investors to waive their right to a jury trial.***

Our Operating Agreement, to the fullest extent permitted by applicable law and subject to limited exceptions, provides for investors and transferees who become Class A Unit holders to consent to exclusive jurisdiction of the Delaware Court of Chancery and to waive the right to a trial by jury with respect to claims relating to the Operating Agreement. These provisions may have the effect of limiting the ability of Class A Unit holders to bring a legal claim against us due to geographic limitations and may limit Investors’ ability to bring such a claim in a judicial forum that it finds favorable for disputes with us. Furthermore, waiver of a trial by jury may disadvantage you to the extent a judge might be less likely than a jury to resolve an action in your favor. In addition, if waiver of a trial by jury is determined to be inapplicable to, or unenforceable in respect of, an action or proceeding against us, it may cause us to incur additional costs associated with resolving these matters in other jurisdictions, which could adversely affect our business and financial condition.

Neither of these provisions will apply to claims or suits under federal securities laws. Section 27 of the Exchange Act creates exclusive federal jurisdiction over all suits brought to enforce any duty or liability created by the Exchange Act or the rules and regulations thereunder. As a result, the exclusive forum provision will not apply to suits brought to enforce any duty or liability created by the Exchange Act or any other claim for which the federal courts have exclusive jurisdiction. Furthermore, Section 22 of the Securities Act creates concurrent jurisdiction for federal and state courts over all suits brought to enforce any duty or liability created by the Securities Act or the rules and regulations thereunder. As a result, the exclusive forum provisions will not apply to suits brought to enforce any duty or liability created by the Securities Act or any other claim for which the federal and state courts have concurrent jurisdiction, and investors will not be deemed to have waived our compliance with the federal securities laws and the rules and regulations thereunder.

***The Securities will not be freely tradable under the Securities Act until one year from the initial purchase date. Although the Securities may be tradable under federal securities law, state securities regulations may apply, and Investors should consult with their attorney.***

You should be aware of the long-term nature of this investment. There is not now and likely will not ever be a public market for the Securities. Because the Securities have not been registered under the Securities Act or under the securities laws of any state or foreign jurisdiction, the Securities have transfer restrictions and cannot be resold in the United States except pursuant to Rule 501 of Regulation CF. It is not currently contemplated that registration under the Securities Act or other securities laws will be affected. Limitations on the transfer of the Securities may also adversely affect the price that you might be able to obtain for the Securities in a private sale. Investors should be aware of the long-term nature of their investment in the Company. Investors in this Offering will be required to represent that they are purchasing the Securities for their own account, for investment purposes and not with a view to resale or distribution thereof.

***There is no present market for the Securities, and we have arbitrarily set the price.***

The Offering price was not established in a competitive market. We have arbitrarily set the price of the Securities with reference to the general status of the securities market and other relevant factors. The Offering price for the Securities should not be considered an indication of the actual value of the Securities and is not based on our asset value, net worth, revenues or other established criteria of value. We cannot guarantee that the Securities can be resold at the Offering price or at any other price.

***In the event of the dissolution or bankruptcy of the Company, Investors will not be treated as debt holders and therefore are unlikely to recover any proceeds.***

In the event of the dissolution or bankruptcy of the Company, the holders of the Securities that have not been converted will be entitled to distributions as described in the Securities. This means that such holders will only receive distributions once all of the creditors and more senior security holders, including any holders of preferred stock, have been paid in full. Holders of the Securities cannot be guaranteed any proceeds in the event of the dissolution or bankruptcy of the Company.

***There is no guarantee of a return on an Investors' investment.***

There is no assurance that Investors will realize a return on their investment or that they will not lose their entire investment. For this reason, Investors should read this Form C and all exhibits carefully and should consult with their attorney and business advisor prior to making any investment decision.

***Our Operating Agreement contains provisions that reduce or eliminate duties (including fiduciary duties) of [the Manager].***

Our Operating Agreement provides that [the Manager], in exercising its rights in its capacity as [the Manager], will be entitled to consider only such interests and factors as it desires, including its own interests, and will have no duty or obligation (fiduciary or otherwise) to give any consideration to any interest of or factors affecting us or any of our investors and will not be subject to any different standards imposed by our Operating Agreement, the Delaware Limited Liability Company Act or under any other law, rule or regulation or in equity. These modifications of fiduciary duties are expressly permitted by Delaware law.

***We do not have a conflicts of interest policy.***

The Company, [the Manager] and their affiliates will try to balance the Company's interests with their own. To the extent that such parties take actions that are more favorable to other entities than the Company, however, these actions could have a negative impact on the Company's financial performance and, consequently, on distributions to Investors and the value of the Units. The Company has not adopted, and does not intend to adopt in the future, either a conflicts of interest policy or a conflicts resolution policy.

***Payments from the Company to the Manager and its employees or affiliates.***

If the Operating Expenses exceed the revenue from the underlying Player Revenue Interest and any cash reserves, [the Manager] has the option to cause the Company to incur an Operating Expenses Reimbursement Obligation to cover such excess. As interest may be payable on such loan, [the Manager] may be incentivized to cause the Company to incur an Operating Expenses Reimbursement Obligation to pay Operating Expenses rather than look elsewhere for additional sources of income or to repay any outstanding Operating Expenses Reimbursement Obligation as soon as possible rather than make distributions to Investors. The Manager may also choose to issue additional Units to pay for Operating Expenses instead of causing the Company to incur an Operating Expenses Reimbursement Obligation, even if any interest payable by the Company on any Operating Expenses Reimbursement Obligation may be economically more beneficial to Unit Holders than the dilution incurred from the issuance of additional Units.

The Manager determines the timing and amount of distributions made to Investors. As a consequence, the Manager also determines the timing and amount of payments made to itself, since payments to the Manager are made when distributions are made to the Investors. The Manager may thus be incentivized to make distributions more frequently and in greater quantities rather than leaving excess revenue on the balance sheet to cover future Operating Expenses.

***The Manager's discretionary authority to amend the Operating Agreement.***

The Manager has the ability to unilaterally amend the Operating Agreement. As the Manager is a party, or is subject, to these documents, it may be incentivized to amend them in a manner that is beneficial to it as Manager of the Company, but which may not benefit all Investors equally. In addition, the Operating Agreement seeks to limit the fiduciary duties that the Manager owes to Investors. Therefore, the Manager is permitted to act in its own best interests rather than the best interests of the Investors. ## BUSINESS

### Description of the Business

#### *Overview*

The golf industry had an estimated impact on the United States economy of \$226.3B in 2023. Historically, participation in the golf industry has been largely limited to wealthy individuals, due to the substantial financial investment required. The Company aims to democratize access to investment opportunities in the golf industry by providing golf enthusiasts with the opportunity for greater involvement in the sport by enabling them to acquire an equity interest in a professional golf player.

The Company's principal objective will be to acquire a fractional interest in the Player Revenue (defined below) of Mason Greene. By doing so, it aims to generate revenue, provide capital appreciation, and distribute revenue to equity investors. This revenue includes cash received from tours, tournaments and competitions, which will be managed by the Manager for the benefit of the Company.

Proceeds from the sale of Class A Units will be used to finance certain Player expenses, which will be actively monitored pursuant to the terms of the Master Player Agreement.

#### *Player Overview: Mason Greene*

### Personal

Mason Greene was born in Mission Viejo, California, to parents Peggy and Sean Greene. Mason enjoys the challenges and unpredictability of golf, which requires a great deal of patience and determination. In addition to golf, he participates in various sports, enjoys time at the beach, and likes body surfing. A key moment in his athletic career came when he shot a final-round score of 5-under 67 to win the 2017 Toyota Tour Cup Championship. Mason has a variety of interests, including the actor Robert Downey, Jr., the film "The Avengers," the television series "Game of Thrones," and the musician DaBaby. He earned his undergraduate degree from UCLA in political science with a minor in entrepreneurship.

### Career Highlights

GCAA All-America Scholar (2022-2023)

#### **2023-24**

Greene recorded a scoring average of 72.8 over 30 rounds across 10 tournaments during his graduate season. He achieved one top-20 finish at the Husky Individual Invitational on September 18-19, where he tied for 20th place with a score of -3, 213 (69-74-70). He finished under par in two of his 10 tournaments and posted four rounds under par, including two rounds in the 60s. At the Hamptons Intercollegiate on October 2-3, he tied for 30th place with a score of +4, 220 (74-72-74). He carded a season-low -4, 68 in the first round of The Cal Poly Invitational, ultimately tying for 25th place at -2, 214 (68-73-73) for the tournament. He tied for 22nd at the Pauma Valley Invitational on March 18-19, shooting even par with a score of 213 (71-71-71). At the Pac-12 Championships, he tied for 48th place with a score of +20, 304 (75-81-74-74). In the NCAA Stanford Regional, he started with a +4, 74 in the first round. After being substituted out in the second round, he returned to the lineup and shot +3, 73 in the third round, contributing to a total of 22 out of 24 counting rounds.

#### **2022-23**

Greene recorded a top 20 finish and posted a 72.5 scoring average across eight events and 24 rounds in his senior season at UCLA. He led the team with 10 rounds under par and seven rounds under 70. His best finish was a tie for 15th at the Lamkin San Diego Classic, where he finished at 2-under (73-73-68). This marked his first under-par tournament finish since 2020. Greene set a new career-low single-round score twice in 2022-23 with a 68 and a 67, shooting 67 twice—once in the third round of The Goodwin on April 1 and again in the second round of the Pac-12 Championships on April 29. He was UCLA's top golfer at the Pac-12 Championships, finishing 29th at 2-over (73-67-73-69). He also tied for 23rd at the El Macero Classic, finishing even par (69-76-71), and tied for 25th at the Southwestern Invitational with a score of 6-over (81-70-71). In third-round play, he averaged 71.1 strokes, including five rounds under par, with 22 out of 24 counting rounds.

## **2021-22**

Greene competed in three events and 10 rounds, averaging a score of 75.8. His best finish was at the El Macero Classic, where he tied for 57th place with a total of 9-over 225. In this event, he posted his only under-par round with a 3-under 69 in the second round. He finished 64th at the Pac-12 Championships, with counting scores of 3-over 74 in the second round and 1-over 72 in the third round. At the Thunderbird Collegiate, he tied for 72nd with a score of 16-over 229. Of his seven rounds, three were counting score rounds. His low round score for the 2021-22 season was 66, achieved in the second round at the El Macero Classic on April 21.

Green competed in seven events and 22 rounds, posting a 75.1 average score. He tied for 40th at the Duck Invitational with a total of 14-over (227), including first and second round scores of 73 and 74, respectively. He also tied for 45th at the Wyoming Desert Collegiate with a score of 5-over (221). Additionally, he recorded a pair of 72s in the first and second rounds of The Goodwin.

Mason competed in six tournaments, achieving a 74.2 scoring average, two Top 10 finishes, and four under-par rounds. He placed sixth at the Providence Seabeggar Invitational and tied for sixth at The Joust with a score of 5-over (215), including a final round 1-under 69. He tied for 12th at the Bill Cullum Invitational with a score of 5-under (211), featuring a 2-under 70 in his first collegiate round and finishing the tournament with a season-best 3-under 69. Additionally, he tied for 15th at The Prestige Individual Invitational with a score of 1-under (215), including a 1-under 71 in the second round.

Greene was a four-year varsity golfer at Orange Lutheran High School in Orange, California. Greene earned the second-most medals in Orange County and was an individual winner at the Villa Park and JSerra Invitionals. He also posted a second-place finish at the league finals and won the 2019 AJGA Lake Las Vegas Junior, hosted by Danielle Kang. Additionally, he tied for seventh in stroke play at the 2019 Pacific Northwest Amateur with a score of 1-under (143) and reached the quarterfinals in match play. Greene finished second at the 2018 AJGA Las Vegas Junior at Reflection Bay, presented by Live View Golf.

## Manager: MG Golf, LLC

The Operating Agreement of the Company designates the Manager as the managing member of the Company. MG Golf, LLC serves as the Manager of the Company. Mason Greene is the Managing Member and an Officer of MG Golf LLC.

The Manager is responsible for directing the Company's operations, implementing strategies, and overseeing day-to-day affairs under the terms of the Operating Agreement. The Manager is tasked with making decisions regarding generating revenue and maximizing value. The Manager's responsibilities encompass various aspects, including player sourcing, partnership selection, media, overseeing Team operations such as training and playing, and maintaining relationships with Class A Unit holders. It oversees the creation of offering materials, regulatory filings, and marketing materials, and coordinates administrative functions related to the Offering. Additionally, the Manager engages service providers, allocates revenues and costs, and manages communications with Class A Unit holders while determining distribution policies and authorizing revenue distributions. Certain responsibilities of the Manager may be delegated to or otherwise performed by a third-party administrator. See '**CMNWLTH Services, LLC**' below for more information.

## CMNWLTH Services, LLC

The Company anticipates engaging CMNWLTH Services, LLC to provide certain administrative services to the Company post-Offering. Such duties will include management of investor relations and accounting functions, provision of event management, content production, investor and regulatory reporting, accounting, cash management, investor management, and shareholder recordkeeping and stock transfer. In return for its services, the Company will pay CMNWLTH Services, LLC certain fees, which are anticipated to amount to \$600 per month, as specified in Exhibit H. Distributions of Player Revenue, other related earnings of the Company, and cash generated by sale of assets are subject to a distribution fee of 10%.

## The Master Player Agreement

### *Overview*

The Company and Player have entered into that certain Master Player Agreement, dated as of August 18, 2024, attached hereto as Exhibit G (the "**Master Player Agreement**"), pursuant to which Player is obligated to pay to the Company a certain Percentage, ranging from 10% to 30%, in the Player Revenue, during the Term. In no event shall Player be obligated to pay to the Company an amount greater than the Player Obligation Cap, which is 2x the amount of player funds used.



Player, in its sole discretion, may elect to pay the Company the Buyout Amount, in whole, at any time prior to the expiration or termination of the Term of the Agreement, effectively reducing the Percentage of Player Revenue owed to the Company.

In exchange for this payment obligation, within fifteen (15) days after the closing of the Offering, the Company is required to deposit into a holding bank account 100% of the proceeds from the Offering, less any operating expenses, reserves, and intermediary compensation (the “**Player Funds**”) (and less any fees charged by any third party in connection with such transfer, such as bank fees).

If Player voluntarily resigns from [his/her] participation as a Professional Athlete at any time prior to the expiration or termination of the Term for any reason *other than* Good Reason (such date of resignation, the “**Termination Date**”), Player shall pay to the Company, not later than thirty (30) days following the Termination Date, an amount equal to (a) the Player Funds, less (b) the sum of all Player Obligations and the Buyout Amount, if applicable, previously paid to the Company.

Player will be able to utilize the Player Funds from time to time, in [his/her] sole discretion, provided that such Player Funds are utilized solely and exclusively for Approved Expenses, as defined in the Master Player Agreement. “**Approved Expenses**” include (a) travel and lodging, including airfare, car rental, hotels, and meals, during tournament travel; (b) fixed caddie fees during tournament weeks, not inclusive of purse share; (c) tournament costs, including entry fees, yardage books, range balls, and other miscellaneous pecuniary expenses directly related to such tournament; (d) golf coach; (e) physical fitness; (f) insurance; (g) club membership dues (base rate only, no incidentals), and (h) equipment and training aids (which must be commercially reasonable).

#### *Key Definitions*

“**Excluded Income**” is set forth on Schedule 1 to the Master Player Agreement, and includes:

1. All proceeds paid to Player or the heirs, executors, administrators, successors and assigns of Player solely with respect to any life, disability, or injury insurance policy or any insurance policy pertaining to and/or corresponding income designation, purchased by Player after the date of the initial Closing of the Offering.

2. All compensation from tournaments prior to the date of the initial Closing of the Offering including, but not limited to, any performance-based pay amounts, or the equivalent thereof, earned prior to the date of the initial Closing of the Offering, or any supplemental cash benefits related to, arising from, or in any way connected with, the same, regardless as to when such compensation is paid.

3. All compensation from non-Tournament activities, including, but not limited to, sponsorships and endorsements, appearance fees, and merchandising and licensing deals.

“**Initial Term**” means six (6) years] beginning on the date of the initial Closing of the Offering; provided that, should the Maximum Offering Amount not be raised in the Offering, then the initial term shall equal a number of years equal to: the gross cash proceeds received by the Company resulting from the Offering, divided by Maximum Offering Amount, multiplied by [six (6)]. *For illustration purposes only, if the Gross Proceeds are \$100,000, and the Maximum Offering Amount is \$200,000, then the Initial Term would equal  $100,000/200,000 \times 6$ , or three (3) years.]*

“**Percentage**” shall initially mean:

- (a) 10%, with respect to PGA Tour;
- (b) 10%, with respect to LIV Golf men’s golf tour;
- (c) 20%, with respect to DP World Tour;
- (d) 25%, with respect to Korn Ferry Tour;
- (e) 30%, with respect to PGA Tour Americas;
- (f) 30%, with respect to Challenge Tour; and
- (g) 30%, with respect to all other Tournaments.

Player may, however, opt-into the following Percentage schedule by paying the Buyout Amount and pursuant to the Terms of the Master Player Agreement:

- (a) 2%, provided that less than \$50,000 has been used for Approved Expenses;
- (b) 4%, provided that between \$50,000 and \$149,999 has been used for Approved Expenses; and
- (c) 5%, provided that \$150,000 or more has been used for Approved Expenses.

**“Player Obligation”** means an amount equal to the product obtained by multiplying (a) any and all Player Revenue earned by Player (whether or not contracted or paid through any third party for or on behalf of Player, such as a personal services corporation, agency, or otherwise) during the Term by (b) the applicable Percentage.

**“Player Revenue”** means an amount equal to any and all gross cash proceeds received by Company resulting from the Offering, other than Excluded Income, payable to Player (or any affiliate of Player) after the date of the initial closing of the Offering as a result of Player’s performance in any Tournament.

**“Term”** means the Initial Term, together with the Absence Period(s), and relates the period of time that shall commence as of the date of the initial Closing of the Offering and shall continue until the earlier of: (i) Player’s retirement as a Professional Athlete, (ii) the expiration of the Term, or (iii) Issuer’s receipt of the Player Obligation in an amount equal to the Player Obligation Cap. Notwithstanding the foregoing, should Player, for any reason, be unable to compete for a period of ninety (90) days or more or performs in less than twelve (12) Tournaments in any given calendar year (where any such period of time is referred to herein as the **“Absence Period”**), the Initial Term shall be extended by any such Absence Period(s).

**“Tournament”** means any activities related to the PGA Tour, LIV Golf men’s golf tour, DP World Tour, Korn Ferry Tour, PGA Tour Americas, Challenge Tour, or any other tournament wherein Player is acting in the capacity of a Professional Athlete.

We request that you please review the Master Player Agreement attached as Exhibit G, in conjunction with the foregoing summary information.

### **Training Player Development**

Training and Player development will occur throughout the year, including between tournaments, with a focus on Player progress in all areas of Golf, including physical, mental, professional, and strategic development. The player may utilize Player Funds to contract and/or hire a strength and conditioning trainer, a golf coach, and often a physiotherapist or mental conditioning coach. All training and Player development is intended to improve Player performance and increase their ranking and Player Revenue.

### **Competitions and Scheduling**

Because of competition level variables, the tours, tournaments, and competitions which Player will be entered into will be selected based upon the recommendation of the Manager with the input of the trainers, advisors and the Manager’s officers. The Player will maintain a competitive schedule with the goal of achieving and maintaining the best status on any PGA sanctioned Tour or well established tour outside the United States, with a minimum schedule of 15 tournaments a year. The Player will schedule and participate in Tournaments, training, and related activities aimed at reaching this goal, and the Player will make reasonable efforts to implement any necessary schedule and performance adjustments addressed in such quarterly meetings in an effort to achieve the aforementioned goal.

In order to compete in the tour and tournaments, the Player will incur tournament costs, including entry fees, practice court fees, stringing, practice balls, and other miscellaneous pecuniary expenses directly related to the tournaments and tours. The Player has just graduated from the University of California, Los Angeles (UCLA) in 2024 and is striving for tour status in the 2024-2025 Season.

## Operating Expenses

Upon the Closing, the Company will be responsible for the following costs and expenses attributable to the activities of the Company (together, the “**Operating Expenses**”):

- Fees, costs, and expenses incurred in connection with preparing any reports and accounts of the Company, including any required federal or state securities filings and any annual audit of the accounts of the Company;
- Fees, costs, and expenses incurred in connection with making any tax filings on behalf of the Company;
- Any indemnification payments; and
- Any similar expenses that may be determined to be Operating Expenses, as determined by the Manager in its reasonable discretion.

If the Operating Expenses exceed the amount of revenues generated from the Player Revenue Interest and cannot be covered by any Operating Expense reserves on the balance sheet of the Company, the Manager may (a) pay such Operating Expenses and not seek reimbursement, (b) loan the amount of the Operating Expenses to the Company, on which the Manager may impose a reasonable rate of interest, and be entitled to reimbursement of such amount from future revenues generated by the Company (an “**Operating Expenses Reimbursement Obligation**”), and/or (c) cause additional Class A Units to be issued by the Company in order to cover such additional amounts.

## Oversight and Governance

The Company will be able to pay a fee or commission to any advisor or other person affiliated with or related to the Manager, advisors, or any Member only with the approval of the principals of the Manager who are not parties to the transaction and will be fully disclosed to the Company owners. In such situations, the Manager may consult with unaffiliated advisors who also are not parties to the transaction.

## Indemnification of the Manager

The Operating Agreement provides that none of the Manager, nor any current or former directors, officers, employees, partners, shareholders, members, controlling persons, agents or independent contractors of the Manager, advisors, nor persons acting at the request of the Company in certain capacities with respect to other entities (collectively, the “**Covered Persons**”) will be liable to the Company or any interest holders for any act or omission taken by the Covered Persons in connection with the business of the Company that has not been determined in a final, non-appealable decision of a court, arbitrator or other tribunal of competent jurisdiction to constitute fraud, willful misconduct or gross negligence.

The Company will indemnify the Covered Persons out of its assets against all liabilities and losses (including amounts paid in respect of judgments, fines, penalties or settlement of litigation, including legal fees and expenses) to which they become subject by virtue of serving as Covered Persons with respect to the Company and with respect to any act or omission that has not been determined by a final, non-appealable decision of a court, arbitrator or other tribunal of competent jurisdiction to constitute fraud, willful misconduct or gross negligence.

## Company Revenue

The Company will generate revenue largely from the tour, tournament, and competition activities of Player.

## Marketplace and Competition

The markets in which we compete are highly competitive. The Company faces competition from other companies and individuals with better funding or more experience in the professional golf industry. These competitors include both players and other professional golf organizations worldwide. The competitive landscape of professional golf is characterized by athletes competing on prestigious domestic and international circuits such as PGA Tour America, Korn Ferry Tour and PGA Tour to improve their rankings through performance in The Masters, U.S Open, The Open, the PGA Tour Championship and other PGA/Korn Ferry/PGA Tour America-sanctioned tournaments. Revenue opportunities in the industry are driven by tournament winnings, sponsorship deals, media rights, and endorsement opportunities, driven by the players' on-court success and personal branding.

**Governmental/Regulatory Approval and Compliance**

The Company is subject to and affected by the laws and regulations of U.S. federal, state and local governmental authorities. Changes in laws, regulations and related interpretations, including changes in accounting standards, taxation requirements, and increased enforcement actions and penalties may alter the environment in which we do business. Our ability to continue to meet these challenges could have an impact on our legal, reputational, and business risk.

**Litigation**

From time to time, the Company may be involved in legal proceedings. The results of such legal proceedings and claims cannot be predicted with certainty, and regardless of the outcome, legal proceedings could have an adverse impact on Company's business or the development of the platform because of defense and settlement costs, diversion of resources and other factors. The Company is currently not subject to litigation.

## USE OF PROCEEDS

### Operations

Greene Nation LLC is an LLC whose primary purpose is to acquire a fractional interest in certain future revenues generated by Player, and to generate revenue therefrom. The Company was formed in Delaware as a limited liability corporation on September 18, 2024. The Company aims to provide golf enthusiasts with the opportunity for greater involvement in the sport by enabling them to acquire an indirect interest in future earnings of a professional golf player.

### Cash and Cash Equivalents

As of September 20, 2024, the Company together with its Manager, hold an aggregate of \$0.00 in cash and cash equivalents, leaving the Company's Manager with approximately 0 months of runway. The Company had \$0.00 in cash and total assets in an amount of \$0.00 as of September 20, 2024, with no runway available aside from our Manager's commitment to make additional capital contributions in the event of the Company's insolvency during the term of the Offering. We must raise capital in this Offering to improve our liquidity position and continue as a going concern.

### Liquidity and Capital Resources

The proceeds from the Offering are essential to our operations. We plan to use the proceeds as set forth above under the section titled "*Use of Proceeds*," which is an indispensable element of our business strategy.

The Company currently does not have any additional outside sources of capital other than the proceeds from the Offering.

## TRANSACTIONS WITH RELATED PERSONS AND CONFLICTS OF INTEREST

From time to time the Company may engage in transactions with related persons. Related persons are defined as any director or officer of the Company; any person who is the beneficial owner of twenty percent (20%) or more of the Company's outstanding voting equity securities, calculated on the basis of voting power; any promoter of the Company; any immediate family member of any of the foregoing persons or an entity controlled by any such person or persons. Additionally, the Company will disclose here any transaction since the beginning of the issuer's last fiscal year, or any currently proposed transaction, to which the issuer was or is to be a party and the amount involved exceeds five percent (5%) of the aggregate amount of capital raised by the issuer in reliance on section 4(a)(6), including the Target Offering Amount of this Offering, and the counterparty is either (i) any director or officer of the issuer; (ii) any person who is, as of the most recent practicable date but no earlier than 120 days prior to the date the offering statement or report is filed, the beneficial owner of twenty percent (20%) or more of the issuer's outstanding voting equity securities, calculated on the basis of voting power; (iii) if the issuer was incorporated or organized within the past three years, any promoter of the issuer; or (iv) any member of the family of any of the foregoing persons, which includes a child, stepchild, grandchild, parent, stepparent, grandparent, spouse or spousal equivalent, sibling, mother-in-law, father-in-law, son-in-law, daughter-in-law, brother-in-law, or sister-in-law, and shall include adoptive relationships. The term *spousal equivalent* means a cohabitant occupying a relationship generally equivalent to that of a spouse.

The Company has conducted no transactions with related persons.

We have identified the following conflicts of interest that may arise in connection with the Class A Units, in particular, in relation to the Company, the Manager and the underlying Player. The conflicts of interest described in this section should not be considered as an exhaustive list of the conflicts of interest that prospective Investors should consider before investing in the Class A Units.

**1. Limitations of Manager's Fiduciary Duties to Company.** Our Operating Agreement contains provisions that reduce or eliminate duties (including fiduciary duties) of the Manager. Our Operating Agreement provides that the Manager, in exercising its rights in its capacity as the Manager, will be entitled to consider only such interests and factors as it desires, including its own interests, and will have no duty or obligation (fiduciary or otherwise) to give any consideration to any interest of or factors affecting us or any of our investors and will not be subject to any different standards imposed by our Operating Agreement, the Delaware Limited Liability Company Act or under any other law, rule or regulation or in equity. These modifications of fiduciary duties are expressly permitted by Delaware law.

**2. No Conflicts of Interest Policy.** The Company, the Manager and their affiliates will try to balance the Company's interests with their own. To the extent that such parties take actions that are more favorable to other entities than the Company, however, these actions could have a negative impact on the Company's financial performance and, consequently, on distributions to Investors and the value of the Class A Units. The Company has not adopted, and does not intend to adopt in the future, either a conflicts of interest policy or a conflicts resolution policy.

**3. Payments from the Company to the Manager and its Employees or Affiliates.** If the Operating Expenses exceed the revenue from the underlying Player Revenue Interest and any cash reserves, the Manager has the option to cause the Company to incur an Operating Expenses Reimbursement Obligation to cover such excess. As interest may be payable on such loan, the Manager may be incentivized to cause the Company to incur an Operating Expenses Reimbursement Obligation to pay Operating Expenses rather than look elsewhere for additional sources of income or to repay any outstanding Operating Expenses Reimbursement Obligation as soon as possible rather than make distributions to Investors. The Manager may also choose to issue additional Class A Units to pay for Operating Expenses instead of causing the Company to incur an Operating Expenses Reimbursement Obligation, even if any interest payable by the Company on any Operating Expenses Reimbursement Obligation may be economically more beneficial to Class A Units Holders than the dilution incurred from the issuance of additional Class A Units.

**4. Manager's Discretionary Authority to Amend the Operating Agreement.** The Manager has the ability to unilaterally amend the Operating Agreement and allocation policy. As the Manager is a party, or is subject, to these documents, it may be incentivized to amend them in a manner that is beneficial to it as Manager of the Company, but which may not benefit all Investors equally. In addition, the Operating Agreement seeks to limit the fiduciary duties that the Manager owes to Investors. Therefore, the Manager is permitted to act in its own best interests rather than the best interests of the Investors. See '*THE OFFERING AND THE SECURITIES – Other Key Material Terms*' for more information.

**5. Conflicts between the Legal Counsel, the Company, and the Manager Parties.** The counsel of the Company is also counsel to the Manager and its affiliates (“**Legal Counsel**”) and may serve as counsel with respect to other entities managed by the Manager (collectively, the “**Manager Parties**”). Because Legal Counsel represents both the Company and the Manager Parties, certain conflicts of interest exist and may arise. To the extent that an irreconcilable conflict develops between the Company and any of the Manager Parties, Legal Counsel may represent the Manager Parties and not the Company. Legal Counsel may, in the future, render services to the Company or the Manager Parties with respect to activities relating to the Company as well as other unrelated activities. Legal Counsel is not representing any prospective Investors of the Company in connection with this Offering and will not be representing the members of the Company other than the Manager. Prospective Investors are advised to consult their own independent counsel with respect to the other legal and tax implications of an investment in the Class A Units.

### The Offering

**NOTE 1 – ORGANIZATION AND NATURE OF ACTIVITIES**

Greene Nation LLC (the “Company”) is a Delaware Limited Liability Company formed on August 26, 2024. The Company’s purpose is for fans and enthusiasts to fund Mason Greene’s professional player expenses in exchange for a share of their professional earnings.

The Company will conduct a crowdfunding campaign under regulation CF in 2024 to raise operating capital.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Presentation

Our financial statements are prepared in accordance with U.S. generally accepted accounting principles (“GAAP”). Our fiscal year ends on December 31. The Company has no interest in variable interest entities and no predecessor entities.

Use of Estimates and Assumptions

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Cash and Cash Equivalents

Cash and cash equivalents include all cash balances, and highly liquid investments with maturities of three months or less when purchased.

Fair Value of Financial Instruments

ASC 820 “*Fair Value Measurements and Disclosures*” establishes a three-tier fair value hierarchy, which prioritizes the inputs in measuring fair value. The hierarchy prioritizes the inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market.

These tiers include:

Level 1: defined as observable inputs such as quoted prices in active markets;

Level 2: defined as inputs other than quoted prices in active markets that are either directly or indirectly observable; and

Level 3: defined as unobservable inputs in which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Concentrations of Credit Risks

The Company’s financial instruments that are exposed to concentrations of credit risk primarily consist of its cash and cash equivalents. The Company places its cash and cash equivalents with financial institutions of high credit worthiness. The Company’s management plans to assess the financial strength and credit worthiness of any parties to which it extends funds, and as such, it believes that any associated credit risk exposures are limited.

### Revenue Recognition

The Company recognizes revenue from the sale of products and services in accordance with ASC 606,” “Revenue Recognition” following the five steps procedure:

- Step 1: Identify the contract(s) with customers
- Step 2: Identify the performance obligations in the contract
- Step 3: Determine the transaction price
- Step 4: Allocate the transaction price to performance obligations
- Step 5: Recognize Revenue When or As Performance Obligations Are Satisfied

The Company will identify and analyze its performance obligations with respect to customer contracts once the first contract is signed.

### Equity based compensation

The Company does not currently have an equity-based compensation plan.

### Income Taxes

The Company is subject to Corporate income and state income taxes in the state it does business.

### Recent accounting pronouncements

The FASB issues ASUs to amend the authoritative literature in ASC. There have been a number of ASUs to date that amend the original text of ASC. Management believes that those issued to date either (i) provide supplemental guidance, (ii) are technical corrections, (iii) are not applicable to us or (iv) are not expected to have a significant impact on our financial statements.

## **NOTE 3 – RELATED PARTY TRANSACTIONS**

The Company follows ASC 850, “Related Party Disclosures,” for the identification of related parties and disclosure of related party transactions.

See “Note 7 – Subsequent Events”.

## **NOTE 4 – CONTINGENCIES, COMPLIANCE WITH LAWS AND REGULATIONS**

We are currently not involved with or know of any pending or threatening litigation against the Company or any of its officers. Further, the Company is currently complying with all relevant laws and regulations.

## **NOTE 5 – DEBT**

None.

## **NOTE 6 – EQUITY**

The Company operates on Membership Interest and has two classes, Class A and Class B, of Membership Units. As of August 26<sup>th</sup>, 2024, 1 Class B Membership unit has been issued representing 100% ownership of the company.

Class A Units have no voting rights and are entitled to distributions, and Class B Units have the right to vote on all matters presented to members for approval.

In the event of a conversion, Class A and B Units will be convertible into common stock with similar rights and privileges as set forth in the Company’s operating agreement.

## **NOTE 7 – SUBSEQUENT EVENTS**

The Company has evaluated events subsequent to August 26<sup>th</sup>, 2024 to assess the need for potential recognition or disclosure in this report. Such events were evaluated through September 19, 2024, the date these financial statements were available to be issued.

The company entered into a post-offering services agreement with a 3rd party for administrative services in which the company has agreed to pay \$600 every month for four years, totaling \$28,800, dated September 19<sup>th</sup>, 2024. Late payments are subject to a 1% per month financing charge on any unpaid balance but only up to the extent permitted by law.

The Company entered into a listing agreement with a 3rd party, dated September 10<sup>th</sup>, 2024, in which the company has agreed to: pay compensation equal 10% of the proceeds received from crowdfunding, and issue shares equal to 2% of the number of securities issued, to the 3rd party

The Company entered into a master player agreement with a related party, dated August 12<sup>th</sup>, 2024 whereby the company has agreed to finance up to \$225,000 of the related party's approved professional expenses.


## **NOTE 8 – GOING CONCERN**

The accompanying balance sheet has been prepared on a going concern basis, which contemplates the realization of assets and the satisfaction of liabilities in the normal course of business. 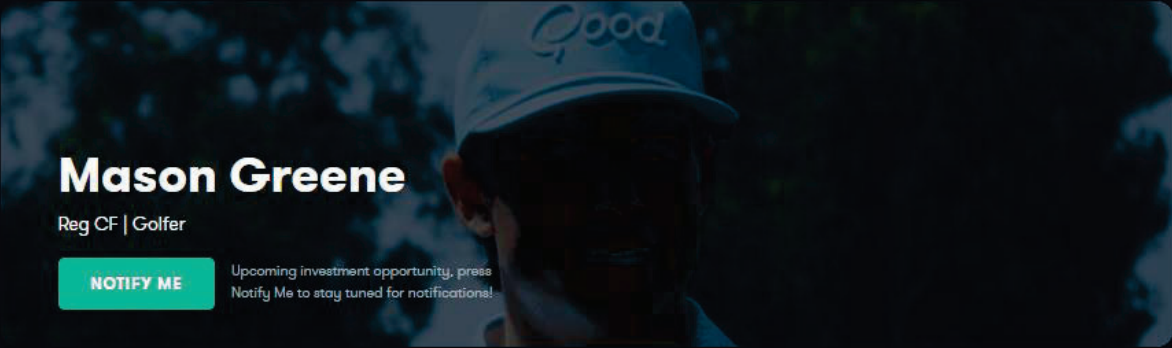
Fresh off his collegiate career, Mason went to PGA TOUR America's Q-School at Soboba Springs but was forced to withdraw from the event after the first round due to illness.

THEREFORE, SUCH INTERESTS CANNOT BE RESOLD, TRANSFERRED, PLEDGED, HYPOTHECATED, OR OTHERWISE DISPOSED OF AT ANY TIME UNLESS THEY ARE REGISTERED UNDER SUCH ACT AND LAWS OR UNLESS AN EXEMPTION FROM REGISTRATION IS AVAILABLE, AND THE HOLDER COMPLIES WITH THE OTHER SUBSTANTIAL RESTRICTIONS ON TRANSFERABILITY SET FORTH IN THIS AGREEMENT.



## LIMITED LIABILITY COMPANY AGREEMENT

OF

### GREENE NATION LLC

This Limited Liability Company Agreement (this “**Agreement**”) of Greene Nation, LLC a Delaware limited liability company (the “**Company**”), is entered into as of August 27, 2024, by and among the Company, MG Golf LLC a Delaware limited liability company (the “**Manager**”), and the Persons (as defined below) listed in the books and records of the Company that become parties to this Agreement in accordance with its terms and are admitted to the Company as Members (as defined below).

### RECITALS

**WHEREAS**, the Company was formed as a limited liability company pursuant to the filing of the Certificate of Formation with the Secretary of State of the State of Delaware on August 26, 2024 (the “**Certificate of Formation**”), in accordance with the provisions of the Delaware Act (as defined herein);

**NOW, THEREFORE**, in consideration of the mutual covenants contained herein and other valuable consideration, the receipt, adequacy, and sufficiency of which are hereby acknowledged, the undersigned, intending to be legally bound hereby, state the following:

### ARTICLE I DEFINITIONS

**Section 1.01 Definitions.** Capitalized terms used herein and not otherwise defined shall have the meanings set forth in this Section 1.01:

“**Additional Capital Contributions**” means the contribution of cash, cash equivalents, or property in addition to the initial Capital Contributions.

“**Affiliate**” means, with respect to any Person, any other Person who, directly or indirectly (including through one or more intermediaries), controls, is controlled by, or is under common control with, such Person. For purposes of this definition, “control,” when used with respect to any specified Person, shall mean the power, direct or indirect, to direct or cause the direction of the management and policies of such Person, whether through ownership of voting securities or partnership or other ownership interests, by contract or otherwise; and the terms “controlling” and “controlled” shall have correlative meanings.

“**Aggregate Ownership Limit**” means, in respect of an Initial Offering or a Subsequent Offering, not more than 10% of the aggregate Outstanding Units, and in respect of a Transfer, not more than 19.9% of the aggregate Outstanding Units, or as determined by the Manager in its sole discretion and as may be waived by the Manager in its sole discretion.

“**Agreement**” means this Limited Liability Company Agreement, as executed and as it may be amended, modified, supplemented, or restated from time to time, as provided herein.

“**Applicable Law**” means all applicable provisions of (a) constitutions, treaties, statutes, laws (including the common law), rules, regulations, decrees, ordinances, codes, proclamations, declarations, or orders of any Governmental Authority; (b) any consents or approvals of any Governmental Authority; and (c) any orders, decisions, advisory or interpretative opinions, injunctions, judgments, awards, decrees of, or agreements with, any Governmental Authority.

**“Bankruptcy”** means, with respect to a Member, the occurrence of any of the following: (a) the filing of an application by such Member for, or a consent to, the appointment of a trustee of such Member's assets; (b) the filing by such Member of a voluntary petition in bankruptcy or the filing of a pleading in any court of record admitting in writing such Member's inability to pay its debts as they come due; (c) the making by such Member of a general assignment for the benefit of such Member's creditors; (d) the filing by such Member of an answer admitting the material allegations of, or such Member's consenting to, or defaulting in answering a bankruptcy petition filed against such Member in any bankruptcy proceeding; or (e) the expiration of sixty (60) days following the entry of an order, judgment or decree by any court of competent jurisdiction adjudicating such Member a bankrupt or appointing a trustee of such Member's assets.

**“Book Depreciation”** means, with respect to any Company asset for each Fiscal Year, the Company's depreciation, amortization, or other cost recovery deductions determined for federal income tax purposes, except that if the Book Value of an asset differs from its adjusted tax basis at the beginning of such Fiscal Year, Book Depreciation shall be an amount which bears the same ratio to such beginning Book Value as the federal income tax depreciation, amortization, or other cost recovery deduction for such Fiscal Year bears to such beginning adjusted tax basis; *provided*, that if the adjusted basis for federal income tax purposes of an asset at the beginning of such Fiscal Year is zero and the Book Value of the asset is positive, Book Depreciation shall be determined with reference to such beginning Book Value using any permitted method selected by the Manager in accordance with Treasury Regulations Section 1.704-1(b)(2)(iv)(g)(3).

**“Book Value”** means, with respect to any Company asset, the adjusted basis of such asset for federal income tax purposes, except as follows:

(a) the initial Book Value of any Company asset contributed by a Member to the Company shall be the gross Fair Market Value of such Company asset as of the date of such contribution;

(b) immediately prior to the distribution by the Company of any Company asset to a Member, the Book Value of such asset shall be adjusted to its gross Fair Market Value as of the date of such distribution;

(c) the Book Value of all Company assets shall be adjusted to equal their respective gross Fair Market Values, as reasonably determined by the Members, as of the following times:

(i) the acquisition of an additional Membership Interest in the Company by a new or existing Member in consideration for more than a *de minimis* Capital Contribution;

(ii) the distribution by the Company to a Member of more than a *de minimis* amount of property (other than cash) as consideration for all or a part of such Member's Membership Interest; and

(iii) the liquidation of the Company within the meaning of the Code and the Treasury Regulations;

(d) *provided*, that adjustments pursuant to clauses (i) and (ii) above need not be made if the Manager reasonably determines that such adjustment is not necessary or appropriate to reflect the relative economic interests of the Members and that the absence of such adjustment does not adversely and disproportionately affect any Member;

(e) the Book Value of each Company asset shall be increased or decreased, as the case may be, to reflect any adjustments to the adjusted tax basis of such Company asset pursuant to the Code Section 734(b) or Code Section 743(b), but only to the extent that such adjustments are taken into account in determining Capital Account balances pursuant to the Treasury Regulations Section 1.704-1(b)(2)(iv)(m); *provided*, that Book Values shall not be adjusted pursuant to this paragraph (d) to the extent that an adjustment pursuant to paragraph (c) above is made in conjunction with a transaction that would otherwise result in an adjustment pursuant to this paragraph (d); and

(f) if the Book Value of a Company asset has been determined pursuant to paragraph (a) or adjusted pursuant to paragraphs (c) or (d) above, such Book Value shall thereafter be adjusted to reflect the Book Depreciation taken into account with respect to such Company asset for purposes of computing Net Income and Net Losses.

**“Broker”** means any Person who has been appointed by the Company (and as the Manager may select in its reasonable discretion) to provide execution and other services relating to an Initial Offering to the Company, or its successors from time to time, or any other broker in connection with any Subsequent Offering.

**“Business”** has the meaning set forth in Section 2.05(a).

**“Business Day”** means a day other than a Saturday, Sunday, or other day on which commercial banks in the City of New York are authorized or required to close.

**“Capital Account”** has the meaning set forth in Section 3.01.

**“Capital Contribution”** means, for any Member, the total amount of cash and cash equivalents and the Book Value of any property contributed to the Company by such Member.

**“Certificate of Formation”** has the meaning set forth in the Recitals.

**“Class A Member Percentage Interest”** means the number of Class A Units held by any Class A Member divided by the total number of Class A Units then outstanding held by all Class A Members, multiplied by 100.

**“Code”** means the Internal Revenue Code of 1986, as amended.

**“Company”** has the meaning set forth in the Preamble.

**“Company Interest Rate”** has the meaning set forth in Section 6.04(c).

**“Company Minimum Gain”** means “partnership minimum gain” as defined in Treasury Regulations Section 1.704-2(b)(2), substituting the term “Company” for the term “partnership” as the context requires.

**“Confidential Information”** has the meaning set forth in Section 13.03(a).

**“Covered Person”** has the meaning set forth in Section 8.01(a).

**“Delaware Act”** means the Delaware Limited Liability Company Act, codified in the Delaware Code, Title 6, Subtitle II, Chapter 18, as amended from time to time.

**“Electronic Transmission”** means any form of communication not directly involving the physical transmission of paper that creates a record that may be retained, retrieved, and reviewed by a recipient thereof and that may be directly reproduced in paper form by such a recipient through an automated process.

**“Exchange Act”** means the Securities Exchange Act of 1934.

**“Fair Market Value”** of any asset as of any date means the purchase price that a willing buyer having all relevant knowledge would pay a willing seller for such asset in an arm's length transaction, as determined jointly by the Members.

**“Fiscal Year”** means the calendar year, unless the Company is required to have a taxable year other than the calendar year, in which case Fiscal Year shall be the period that conforms to its taxable year.

**“Form of Adherence”** means, in respect of an Initial Offering or Subsequent Offering, a subscription agreement or other agreement substantially in the form appended to the Offering Document pursuant to which a prospective Member agrees to adhere to this Agreement's terms or, in respect of a Transfer, a form of adherence or instrument of Transfer, each in a form satisfactory to the Manager from time to time, pursuant to which a Transferee agrees to adhere to this Agreement's terms.

**“Free Cash Flow”** means any available cash for distribution generated from the Net Income received by the Company, as determined by the Manager to be in the nature of income as defined by U.S. GAAP, plus (i) any change in the net working capital (as shown on the balance sheet of the Company); (ii) any amortization (as shown on the income statement of the Company); (iii) any depreciation (as shown on the income statement of the Company); and (iv) any other non-cash Operating Expenses less (a) any capital expenditure (as shown on the cash flow statement of the Company), (b) any other liabilities or obligations of the Company, in each case to the extent not already paid or provided for, and (c) upon the termination and winding up of the Company, all costs and expenses incidental to such termination and winding.

**“GAAP”** means United States generally accepted accounting principles in effect from time to time.

**“Governmental Authority”** means any federal, state, local or foreign government or political subdivision thereof, or any agency or instrumentality of such government or political subdivision, or any self-regulated organization or other non-governmental regulatory authority or quasi-governmental authority (to the extent that the rules, regulations or orders of such organization or authority have the force of law), or any arbitrator, court, or tribunal of competent jurisdiction.

**“Individual Aggregate Limit”** means, with respect to any individual holder, 10% of the greater of such holder's annual income or net worth or, with respect to any entity, 10% of the greater of such holder's annual revenue or net assets at Fiscal Year-end.

**“Initial Offering”** means the first offering or private placement and issuance of Units, other than the issuance to the Manager.

**“Joinder Agreement”** means the joinder agreement in form and substance attached hereto as Exhibit A.

**“Liquidator”** has the meaning set forth in Section 11.03(a).

**“Majority Vote”** means, the affirmative vote of the holders of Outstanding Units representing at least a majority of the total votes that may be cast by all such Outstanding Units then eligible to vote.

**“Manager”** means, initially, MG Golf LLC, a Delaware limited liability company, or such other Person as may be designated or become the Manager pursuant to the terms of this Agreement.

**“Member”** means (a) the Manager and (b) each Person who is hereafter admitted as a Member in accordance with the terms of this Agreement and the Delaware Act. The Members shall constitute the “members” (as that term is defined in the Delaware Act) of the Company.

**“Membership Interest”** means an interest in the Company owned by a Member, including such Member's right (a) to its distributive share of the assets of the Company; (b) to vote on, consent to or otherwise participate in any decision of the Members as provided in this Agreement; and (c) to any and all other benefits to which such Member may be entitled as provided in this Agreement or the Delaware Act. The Membership Interest of each Member shall be expressed in the form of Units or as a Percentage Interest and shall be as set forth on Schedule A or as maintained in book entry form by the Company's transfer agent. Class A Members will hold Units of Class A Membership Interest; Class B Members will hold Units of Class B Membership Interest. At the date of this Agreement, there are no subsequent classes of Membership Interest.

**“Net Cash Flow”** means, for any fiscal year, (A) the sum of (i) all cash receipts of the Company from any sources for such period other than Capital Contributions or loan proceeds, plus (ii) any funds not otherwise expended and released into the general fund by the Manager from previously established reserves (referred to in (B)(ii) below) less (B) the sum of (i) all cash expenditures of the Company for such period not funded by Capital Contributions, loan proceeds or paid out of previously established reserves, plus (ii) any increases in reserves as reasonably determined by the Manager.

**“Net Income”** and **“Net Loss”** mean, for each Fiscal Year or other period specified in this Agreement, an amount equal to the Company's taxable income or taxable loss, or particular items thereof, determined in accordance with the Code Section 703(a) (where, for this purpose, all items of income, gain, loss or deduction required to be stated separately pursuant to Code Section 703(a)(1) shall be included in taxable income or taxable loss), but with the following adjustments:

(a) any income realized by the Company that is exempt from federal income taxation, as described in Code Section 705(a)(1)(B), shall be added to such taxable income or taxable loss, notwithstanding that such income is not includible in gross income;

(b) any expenditures of the Company described in Code Section 705(a)(2)(B), including any items treated under Treasury Regulations Section 1.704-1(b)(2)(iv)(I) as items described in Code Section 705(a)(2)(B), shall be subtracted from such taxable income or taxable loss, notwithstanding that such expenditures are not deductible for federal income tax purposes;

(c) any gain or loss resulting from any disposition of Company property with respect to which gain or loss is recognized for federal income tax purposes shall be computed by reference to the Book Value of the property so disposed, notwithstanding that the adjusted tax basis of such property differs from its Book Value;

(d) any items of depreciation, amortization and other cost recovery deductions with respect to Company property having a Book Value that differs from its adjusted tax basis shall be computed by reference to the property's Book Value (as adjusted for Book Depreciation) in accordance with Treasury Regulations Section 1.704-1(b)(2)(iv)(g);

(e) if the Book Value of any Company property is adjusted as provided in the definition of Book Value, then the amount of such adjustment shall be treated as an item of gain or loss and included in the computation of such taxable income or taxable loss; and

(f) to the extent an adjustment to the adjusted tax basis of any Company property pursuant to Code Sections 732(d), 734(b) or 743(b) is required, pursuant to Treasury Regulations Section 1.704-1(b)(2)(iv)(m), to be taken into account in determining Capital Accounts, the amount of such adjustment to the Capital Accounts shall be treated as an item of gain (if the adjustment increases the basis of the asset) or loss (if the adjustment decreases such basis).

**“Offering Document”** means the prospectus, offering memorandum, offering circular, offering statement, offering circular supplement, private placement memorandum or other offering documents related to the Initial Offering of such Units, in the form approved by the Manager and, to the extent required by Applicable Law, approved or qualified, as applicable, by any applicable Governmental Authority, including without limitation the U.S. SEC.

**“Offering Expenses”** means the following fees, costs and expenses incurred in connection with executing the Initial Offering or a Subsequent Offering, consisting of underwriting, legal, accounting, escrow and compliance costs related to a specific offering.

**“Officers”** has the meaning set forth in Section 7.02(a).

**“Operating Expenses”** means the following fees, costs and expenses:

(a) any and all fees, costs and expenses incurred in connection with the management of the Player;

(b) any fees, costs and expenses incurred in connection with preparing any reports and accounts of the Units, including any blue sky filings required in order for the Units to be made available to Investors in certain states and any annual audit of the accounts of the Units (if applicable) and any reports to be filed with the U.S. SEC including annual reports on Forms C-AR.

(c) any and all insurance premiums or expenses, including director and officer liability insurance of the directors and officers of the Manager;

(d) any withholding or transfer taxes imposed on the Company or any of the Members as a result of its or their earnings, investments or withdrawals;

(e) any governmental fees imposed on the capital of the Company or incurred in connection with compliance with applicable regulatory requirements;

(f) any legal fees and costs (including settlement costs) arising in connection with any litigation or regulatory investigation instituted against the Company in connection with the affairs of the Company;

(g) the fees and expenses of any administrator, if any, engaged to provide administrative services to the Company;

(h) all custodial fees, costs and expenses in connection with the holding of the Units;



(i) any fees, costs and expenses of a third-party registrar and transfer agent appointed by the Manager on behalf of the Company;

(j) the cost of the audit of the Company's annual financial statements and the preparation of its tax returns, and the fees, costs and expenses incurred in connection with making of any tax filings on behalf of the Company and circulation of reports to Members;

(k) any indemnification payments to be made pursuant to Section 8.03(a);

(l) the fees and expenses of the Company's counsel in connection with advice directly relating to the Company's legal affairs;

(m) the costs of any other outside appraisers, valuation firms, accountants, attorneys or other experts or consultants engaged by the Manager in connection with the operations of the Company; and

(n) any similar expenses that may be determined to be Operating Expenses, as determined by the Manager in its reasonable discretion.

**"Operating Expenses Reimbursement Obligation(s)"** means agreements between the Manager and the Company whereunder the Manager loans an amount to the Company equal to the remaining excess Operating Expenses. The Manager, in its sole discretion, may impose a reasonable rate of interest (a rate no less than the Applicable Federal Rate (as defined in the Code)) on any Operating Expenses Reimbursement Obligation. The Operating Expenses Reimbursement Obligation(s) shall become repayable when cash becomes available for such purpose in accordance with ARTICLE VI.

**"Outstanding"** means all Units that are issued by the Company and reflected as outstanding on the Company's books and records as of the date of determination.

**"Percentage Interest"** means the number of Units held by any Member divided by the total number of Units then outstanding held by all Members, multiplied by 100.

**"Permitted Transfer"** means a Transfer of Membership Interests carried out pursuant to Section 9.01.

**"Permitted Transferee"** means a recipient of a Permitted Transfer.

**"Person"** means an individual, corporation, partnership, joint venture, limited liability company, Governmental Authority, unincorporated organization, trust, association, or other entity.

**"Record Date"** means the date established by the Manager for determining (a) the identity of the Record Holders entitled to notice of, or to vote at, any meeting of Members associated or entitled to exercise rights in respect of any lawful action of Members or (b) the identity of Record Holders entitled to receive any report or distribution or to participate in any offer.

**"Record Holder"** or holder means the Person in whose name such Units are registered on the books of the Company as of the opening of business on a particular Business Day, as determined by the Manager in accordance with this Agreement.

**"Representative"** means, with respect to any Person, any and all directors, officers, employees, consultants, financial advisors, counsel, accountants and other agents of such Person.



“**Secretary of State**” means the Secretary of State of the State of Delaware.

“**SEC**” means the U.S. Securities and Exchange Commission.

“**Securities Act**” means the Securities Act of 1933.

“**Subsidiary**” means, with respect to any Person, any other Person of which a majority of the outstanding shares or other equity interests having the power to vote for directors or comparable managers are owned, directly or indirectly, by the first Person.

“**Super Majority Vote**” means, the affirmative vote of the holders of Outstanding Units representing at least two-thirds of the total votes that may be cast by all such Outstanding Units then eligible to vote.

“**Subsequent Offering**” means any further issuance of Units, excluding any Initial Offering or Transfer.

“**Taxing Authority**” has the meaning set forth in Section 6.04(b).

“**Transfer**” means to, directly or indirectly, sell, transfer, assign, pledge, encumber, hypothecate or similarly dispose of, either voluntarily or involuntarily, by operation of law or otherwise, or to enter into any contract, option or other arrangement or understanding with respect to the sale, transfer, assignment, pledge, encumbrance, hypothecation or similar disposition of, any Membership Interests owned by a Person or any interest (including a beneficial interest or any direct or indirect economic or voting interest) in any Membership Interests owned by a Person; *provided* that none of an issuance, disposition, redemption or repurchase of any equity securities in the ultimate parent entity of a Member shall be deemed to be a Transfer of Membership Interests, including by means of a disposition of equity interests in a Member or in a Person that directly or indirectly holds any equity interests in a Member. “**Transfer**” when used as a noun shall have a correlative meaning.

“**Transferor**” and “**Transferee**” mean a Person who makes or receives a Transfer, respectively.

“**Treasury Regulations**” means the final or temporary regulations issued by the United States Department of Treasury pursuant to its authority under the Code, and any successor regulations.

“**Units**” shall be the measure by which each Member’s Percentage Interest is determined, even though such ownership may be different from (more or less than) the Member’s proportionate Capital Account. The Company is not obligated to issue certificates to represent any Units. Only Units owned by Members entitled to vote may vote on any matter as to which this Agreement requires or permits a vote. A transfer of Units will include a transfer of the Capital Account that is attributable to such Units as of the effective date of such transfer determined in accordance with Section 9.01 below, and such will be determined on a proportionate basis if fewer than all of the Units owned by any Member are being transferred by such Member. The Company shall not issue fractional Units.

(a) “**Class A Units**” means Units held by a Class A Member in his, her or its capacity as a Class A Member, and shall not be entitled to vote unless the right to vote is expressly granted by the Manager, this Agreement, or by Applicable Law.

(b) “**Class B Units**” means Units held by a Class B Member in his, her, or its capacity as a Class B Member, and shall be entitled to vote on all matters presented to the Members for approval; and

(c) Subsequent classes of Units may be created by the Manager as provided herein and shall be designated by letters or in any other way the Manager may deem appropriate. Such Units, when authorized, shall mean Units held by a Member in such class or classes in his, her or its capacity as a Member, and shall hold such economic interest, right to vote, and other rights as may be specified by the managers in the resolutions establishing the class.

“**Withholding Advances**” has the meaning set forth in Section 6.04(b).

**Section 1.02 Interpretation.** For purposes of this Agreement: (a) the words “include,” “includes” and “including” shall be deemed to be followed by the words “without limitation”; (b) the word “or” is not exclusive; and (c) the words “herein,” “hereof,” “hereby,” “hereto” and “hereunder” refer to this Agreement as a whole. The definitions given for any defined terms in this Agreement shall apply equally to both the singular and plural forms of the terms defined. Whenever the context may require, any pronoun shall include the corresponding masculine, feminine and neuter forms. Unless the context otherwise requires, references herein: (x) to Articles, Sections, and Exhibits mean the Articles and Sections of, and Exhibits attached to, this Agreement; (y) to an agreement, instrument or other document means such agreement, instrument or other document as amended, supplemented or modified from time to time to the extent permitted by the provisions thereof; and (z) to a statute means such statute as amended from time to time and includes any successor legislation thereto and any regulations promulgated thereunder. This Agreement shall be construed without regard to any presumption or rule requiring construction or interpretation against the party drafting an instrument or causing any instrument to be drafted. The Exhibits and Schedules referred to herein shall be construed with, and as an integral part of, this Agreement to the same extent as if they were set forth verbatim herein.

## **ARTICLE II ORGANIZATION**

### **Section II.01 Formation.**

(a) The Company was formed on August 26, 2024, pursuant to the provisions of the Delaware Act, upon the filing of the Certificate of Formation with the Secretary of State.

(b) This Agreement shall constitute the “operating agreement” (as that term is used in the Delaware Act) of the Company. The rights, powers, duties, obligations, and liabilities of the Members shall be determined pursuant to the Delaware Act and this Agreement. To the extent that the rights, powers, duties, obligations, and liabilities of any Member are different by reason of any provision of this Agreement than they would be under the Delaware Act in the absence of such provision, this Agreement shall, to the extent permitted by the Delaware Act, control.

**Section II.02 Name.** The name of the Company is “Greene Nation, LLC” or such other name or names as may be designated by the Manager; *provided*, that the name shall always contain the words “Limited Liability Company” or the abbreviation “L.L.C.” or the designation “LLC.” The Manager shall give prompt notice to the Members of any change to the name of the Company.

**Section II.03 Principal Office.** The principal place of business of the Company shall be at such place or places, within or without the State of Delaware as shall be designated, from time to time, by the Manager. The Manager shall give prompt notice of any such change to each of the Members.

#### **Section II.04 Registered Office; Registered Agent.**

(a) For purposes of the Delaware Act, the registered office for service of process for the Company in the State of Delaware shall be located at 2140 South Dupont Hwy, Camden, Delaware, United States, 19934, and the name of the statutory agent of the Company at such registered office shall be Heather Larson. The Manager may change the registered office or agent for service of process for the Company from time to time as permitted under the Delaware Act and Applicable Law and shall give prompt notice of any such change to each of the Members.

#### **Section II.05 Purpose; Powers.**

(a) The purpose of the Company shall be to (i) promote, conduct or engage in, directly or indirectly, any business, purpose or activity that lawfully may be conducted by a limited liability company organized pursuant to the Delaware Act; (ii) exercise all of the rights and powers conferred upon the Company with respect to its interests therein, and (iii) conduct any and all activities related or incidental to the foregoing purposes ((i), (ii), and (iii), collectively the “**Business**”).

(b) The Company shall have all the powers necessary or convenient to carry out the purposes for which it is formed, including the powers granted by the Delaware Act.

**Section II.06 Term.** The term of the Company commenced on the date the Certificate of Formation was filed with the Secretary of State and shall continue in existence perpetually until the Company is dissolved in accordance with the provisions of this Agreement.

**Section II.07 No State Law Partnership.** The Members intend that the Company shall not be a partnership or joint venture, and that no Member shall be a partner or joint venturer of any other Member in connection with this Agreement, for any purpose other than federal, state, and local tax purposes, and the provisions of this Agreement shall not be construed otherwise.

#### **Section II.08 Classes of Interests.**

(a) The Company shall have multiple classes of Membership Interest as determined by the Manager. The initial classes of Membership Interests shall be:

(i) “**Class A Interests**” and the Members holding (and entitled to hold) such Membership Interests shall be “**Class A Members**.” The Class A Interests are being issued in accordance with that certain Initial Offering (or Subsequent Offering) of the Class A Interests of the Company in reliance on section 4(a)(2) and/or section 4(a)(6) of the Securities Act of 1933, as amended (“**Regulation Crowdfunding**”), and shall only be held by Persons who acquired such Membership Interests in connection with such Regulation Crowdfunding offering (or offerings), Permitted Transferees following the close of such Regulation Crowdfunding offering(s), or by the Manager.

(ii) “**Class B Interests**” and the Members holding (and entitled to hold) such Interests shall be “**Class B Members**.”

(b) The Manager has the power and the authority to create new classes or series of Membership Interests at any time and from time to time upon Supermajority Vote of the Class A Members.

**Section II.09 Conversion to Corporation.** The Company may in the future convert from a limited liability company into a corporation by conversion, merger, or other transaction (a “**Conversion**”). Any such Conversion may be approved by the Manager in its sole and absolute discretion. In the event of any such Conversion, the Class A Members shall receive capital stock in the corporation in the form of non-voting common stock, and the Class B Members shall receive capital stock in the corporation in the form of voting common stock, and in each case with the rights, preferences, powers, privileges, and the restrictions, qualifications, and limitations in substantially the same form as attributed to the Class A Units and Class B Units under this Agreement, respectively. In the event that the Manager approves such conversion, then, each Member agrees to take any and all actions as are reasonably necessary to give effect to the Conversion.

### **ARTICLE III CAPITAL ACCOUNTS**

**Section III.01 Maintenance of Capital Accounts.** The Company shall establish and maintain for each Member a separate capital account (a “**Capital Account**”) on its books and records in accordance with this Section 3.01. Each Capital Account shall be established and maintained in accordance with the following provisions:

- (a) Each Member's Capital Account shall be increased by the amount of:
  - (i) such Member's Capital Contributions, including such Member's initial Capital Contribution and any Additional Capital Contributions;
  - (ii) any Net Income or other item of income or gain allocated to such Member;  
and
  - (iii) any liabilities of the Company that are assumed by such Member or secured by any property distributed to such Member.
- (b) Each Member's Capital Account shall be decreased by:
  - (i) the cash amount or Book Value of any property distributed to such Member pursuant to ARTICLE VI and Section 11.03(c);
  - (ii) the amount of any Net Loss or other item of loss or deduction allocated to such Member; and
  - (iii) the amount of any liabilities of such Member assumed by the Company or that are secured by any property contributed by such Member to the Company.

**Section III.02 Succession Upon Transfer.** In the event that any Membership Interests are Transferred in accordance with the terms of this Agreement, the Transferee shall succeed to the Capital Account of the Transferor to the extent it relates to the Transferred Membership Interest and shall receive allocations and distributions pursuant to ARTICLE VI and ARTICLE X in respect of such Membership Interest.

**Section III.03 Negative Capital Accounts.** In the event that any Member shall have a deficit balance in its Capital Account, such Member shall have no obligation, during the term of the Company or upon dissolution or liquidation of the Company, to restore such negative balance or make any Capital Contributions to the Company by reason thereof, except as may be required by Applicable Law or in respect

of any negative balance resulting from a withdrawal of capital or dissolution in contravention of this Agreement.

**Section III.04 No Withdrawals From Capital Accounts.** No Member shall be entitled to withdraw any part of its Capital Account or to receive any distribution from the Company, except as otherwise provided in this Agreement. No Member, including the Manager, shall receive any interest, salary, management, or service fees or drawing with respect to its Capital Contributions or its Capital Account, except as otherwise provided in this Agreement. The Capital Accounts are maintained for the sole purpose of allocating items of income, gain, loss, and deduction among the Members and shall have no effect on the amount of any distributions to any Members, in liquidation or otherwise.

**Section III.05 Loans From Members.** Loans by any Member to the Company shall not be considered Capital Contributions and shall not affect the maintenance of such Member's Capital Account, other than to the extent provided in Section 3.01, if applicable.

**Section III.06 Modifications.** The foregoing provisions and the other provisions of this Agreement relating to the maintenance of Capital Accounts are intended to comply with Treasury Regulations Section 1.704-1(b) and shall be interpreted and applied in a manner consistent with such Treasury Regulations. If the Manager determines that it is prudent to modify the manner in which the Capital Accounts, or any increases or decreases to the Capital Accounts, are computed in order to comply with such Treasury Regulations, the Manager may authorize such modifications.

## **ARTICLE IV MEMBERS**

### **Section IV.01 Members; Initial Capital Contributions.**

(a) The Class A Members of the Company are listed on the books and records of the Company, each of which has agreed to be bound by this Agreement and upon such agreement has been admitted to the Company. Each Class A Member's initial Capital Contribution is set forth in the books and records of the Company. The Class B Members of the Company are listed on the books and records of the Company, each of which has executed this Agreement and is hereby admitted to the Company as a Member. Each Class B Member's initial Capital Contribution, if any, is set forth in the books and records of the Company.

(b) Except as may be otherwise agreed between the Company, on the one hand, and a Member, on the other hand, any Member shall be entitled to and may have business interests and engage in business activities in addition to those relating to the Company, including business interests and activities in direct competition with the Company. None of the Company or any other Members shall have any rights by virtue of this Agreement in any such business interests or activities of any Member.

(c) MG Golf LLC, the Class B Member, was appointed as the Company's Manager with effect from the date of the formation of the Company on August 26, 2024 and shall continue as Manager of the Company until the earlier of (i) the dissolution of the Company pursuant to ARTICLE XI, or (ii) its removal or replacement pursuant to Section 7.08 or Section 7.09.

(d) The minimum number of Units a Member may acquire is one (1) Unit or such higher or lesser amount as the Manager may determine from time to time. Persons acquiring Units through an Initial Offering or Subsequent Offering shall make a Capital Contribution to the Company in an amount equal to the per Unit price determined in connection with such Initial

Offering or Subsequent Offering, as applicable. Persons acquiring Units in a manner other than through an Initial Offering or Subsequent Offering or pursuant to a Transfer shall make such Capital Contribution as shall be determined by the Manager in its sole discretion.

(e) Except as expressly permitted by the Manager, in its sole discretion (i) initial and any Additional Capital Contributions to the Company by any Member shall be payable in cash and (ii) initial and any Additional Capital Contributions shall be payable in one installment and shall be paid prior to the date of the proposed acceptance by the Manager of a Person's admission as a Member (or a Member's application to acquire additional Units) (or within five (5) business days thereafter with the Manager's approval). No Member shall be required to make an Additional Capital Contribution to the Company but may make an Additional Capital Contribution to acquire additional Units at such Member's sole discretion, subject to Section 4.03 and Section 4.09 herein. All such Additional Capital Contributions, if any, shall be set forth in the books and records of the Company.

(f) All Capital Contributions under this Section 4.01 shall be credited to the contributing Member's Capital Account.

(g) No Member shall have any obligation to the Company or to any other Member's Capital Account. No interest shall be paid by the Company on any Capital Contributions.

**Section IV.02 Limited Liability.** Except as otherwise provided in this Agreement or the Delaware Act, no Member (or former Member) shall be liable for the obligations of the Company for any amounts in excess of the amount of its Capital Contributions to the Company (or the amount of Capital Contributions that were required to be made to the Company, if greater), plus such Member's share of the undistributed profits of the Company to which they are entitled, plus, to the extent required by law, or as otherwise described in this Agreement, any amounts distributed by the Company to such Member; provided, that the foregoing shall not be construed in any way to alleviate a Member's obligations to the Company.

**Section IV.03 Investment Representation.** Each Member, by agreeing to be bound to this Agreement, represents and warrants that its Membership Interest in the Company has been acquired by it for its own account, for investment and not with a view to resale, distribution, subdivision or fractionalization thereof, no other Person will have any direct or indirect beneficial interest in or right to such Membership Interest, that such acquisition will not cause such Person's holding to be in excess of the Aggregate Ownership Limit, that its investment in the Units did not exceed the Individual Aggregate Limit, that it acknowledges that ownership of its Membership Interest does not provide it with direct ownership of the Company's assets and it, pursuant to this Agreement, irrevocably waives during the term of the Company any right that it may have to maintain any action for partition with respect to the property of the Company, and that it is fully aware that in agreeing to admit it as a Member, the Manager and the Company are relying upon the truth and accuracy of such representation and warranty.

**Section IV.04 Meetings of the Members.** The Company shall not be required to hold annual or other meetings of the Members. Subject to the foregoing, a meeting of the Members may be called at any time by the Manager. If called, the Manager shall give written notice of the meeting to each Member not less than three (3) days before each meeting. The notice shall state the time, place, and purpose of the meeting. Notwithstanding the foregoing provisions, each Member who is entitled to notice waives notice if, before or after the meeting, the Member signs a waiver of notice. Members may participate in a meeting by telephone conference or similar communications equipment by means of which all Persons participating in the meeting can speak to and hear each other. Such participation shall constitute presence in Person at the meeting.



**Section IV.05 Other Activities.** Except as otherwise provided herein, each of the parties hereto shall be entitled to engage in and/or possess any interest in other businesses and investment ventures or transactions, of any nature or description, independently or with others, whether existing as of the date hereof or hereafter coming into existence, and whether or not directly or indirectly competitive with the business of the Company and no party shall be obligated to present any investment or business opportunity to the Company, even if such opportunity involves a business similar to the Company's business.

**Section IV.06 Admission of New Members.**

(a) New Members may be admitted from time to time (i) in connection with the issuance of Membership Interests by the Company either as a result of an Initial Offering or a Subsequent Offering, subject to compliance with the provisions of this Section 4.06, or (ii) in connection with a Transfer of Membership Interests, subject to compliance with the provisions of ARTICLE IX, and in either case, following compliance with the provisions of Section 4.06(b) in the sole discretion of the Manager. The Manager may withhold its consent to the admission of any Person as a Member for any reason, including, but not limited to, when it determines in its reasonable discretion that such admission could: (i) result in there being 2,000 or more beneficial owners (as such term is used under the Exchange Act) or 500 or more beneficial owners that are not accredited investors (as defined under the Securities Act), as specified in Section 12(g)(1)(A)(ii) of the Exchange Act, (ii) cause such Person's holding to be in excess of the Aggregate Ownership Limit, (iii) cause the Person's investment in the Units to exceed the Individual Aggregate Limit, (iv) adversely affect the Company or subject the Company, the Manager, or any of their respective Affiliates to any additional regulatory or governmental requirements or cause the Company to be disqualified as a limited liability company, or subject the Company, the Manager, or any of their respective Affiliates to any tax to which it would not otherwise be subject, (v) cause the Company to be required to register as an investment company under the Investment Company Act, (vi) cause the Manager or any of its Affiliates being required to register under the Investment Advisers Act, (vii) result in a loss of its status as a corporation for US federal income tax purposes. A Person may become a Record Holder without the consent or approval of any of Class A Members. A Person may not become a Member without acquiring a Unit.

(b) In order for any Person not already a Member of the Company to be admitted as a Member, whether pursuant to an issuance or Transfer of Membership Interests, such Person shall have completed, signed and delivered to the Manager, a completed Form of Adherence and/or Joinder Agreement, or by other means, in the sole discretion of the Manager. Upon the amendment of Schedule A of the Agreement by the Manager or the transfer agent, as applicable, and the satisfaction of any other applicable conditions, including the receipt by the Company of payment for the issuance of Membership Interests, such Person shall be admitted as a Member and deemed listed as such on the books and records of the Company. The Manager shall also adjust the Capital Accounts of the Members as necessary in accordance with Section 3.01.

**Section IV.07 Return of Capital Contributions.** Except as otherwise expressly provided herein, no Member shall be entitled to the return of any part of his, her or its Capital Contributions or to be paid interest in respect of his, her or its Capital Contributions. No Member shall have any personal liability for the return of the Capital Contribution of any other Member and no Member shall have any priority over any other Member with respect to the return of any Capital Contribution. Members shall not have any right to resign or redeem their Units from the Company; provided that when a transferee of a Member's Units becomes a Record Holder of such Units, such transferring Member shall cease to be a Member of the Company with respect to the Units so transferred and the Members shall cease to be Members when the Company is finally liquidated in accordance with Section 11.03.

**Section IV.08 No Interest in Company Property.** No assets (real or personal, tangible or intangible, including cash) of the Company, owned or held by the Company, whether owned or held by the Company at the date of its formation or thereafter acquired, shall be deemed to be owned by any Member individually, but shall be owned by, and title shall be vested solely in, the Company. Without limiting the foregoing, each Member hereby irrevocably waives during the term of the Company any right that such Member may have to maintain any action for partition with respect to the property of the Company.

**Section IV.09 Authorization to Issue Units.**

(a) The Company may issue Units, and options, rights and warrants relating to Units, for any Company purpose at any time and from time to time to such Persons for such consideration (which may be cash, property, services or any other lawful consideration) or for no consideration and on such terms and conditions as the Manager shall determine, all without the approval of the Members. Each Unit shall have the rights and be governed by the provisions set forth in this Agreement.

(b) Subject to Section 4.09(a), the Company is authorized to issue an unlimited number of Units. All Units issued pursuant to, and in accordance with the requirements of, this ARTICLE IV shall be validly issued Units in the Company, except to the extent otherwise provided in the Delaware Act or this Agreement.

**Section IV.10 Certificates.**

(a) The Manager may, but shall not be required to, issue certificates to the Members representing the Membership Interests held by such Member.

(b) If the Manager shall issue certificates representing Class A Units or Class B Units in accordance with Section 4.10(a) or this Section 4.10(b), respectively, then in addition to any other legend required by Applicable Law, all certificates representing issued and outstanding Class A Units or Class B Units, or other form of notation evidencing the underlying securities, shall bear a legend substantially in the following form:

THE MEMBERSHIP INTERESTS REPRESENTED BY THIS CERTIFICATE ARE SUBJECT TO A LIMITED LIABILITY COMPANY AGREEMENT AMONG THE COMPANY AND ITS MEMBERS, A COPY OF WHICH IS ON FILE AT THE PRINCIPAL EXECUTIVE OFFICE OF THE COMPANY. NO TRANSFER, SALE, ASSIGNMENT, PLEDGE, HYPOTHECATION OR OTHER DISPOSITION OF THE MEMBERSHIP INTERESTS REPRESENTED BY THIS CERTIFICATE MAY BE MADE EXCEPT IN ACCORDANCE WITH THE PROVISIONS OF SUCH LIMITED LIABILITY COMPANY AGREEMENT.

THE MEMBERSHIP INTERESTS REPRESENTED BY THIS CERTIFICATE HAVE NOT BEEN REGISTERED UNDER THE SECURITIES ACT OF 1933, AS AMENDED, OR UNDER ANY OTHER APPLICABLE SECURITIES LAWS AND MAY NOT BE TRANSFERRED, SOLD, ASSIGNED, PLEDGED, HYPOTHECATED OR OTHERWISE DISPOSED OF EXCEPT PURSUANT TO (A) A REGISTRATION STATEMENT EFFECTIVE UNDER SUCH ACT AND LAWS, OR (B) AN EXEMPTION FROM REGISTRATION THEREUNDER.

**Section IV.11 Prohibition on Issuance of Preference Units.** No Units shall entitle any Member to any preemptive, preferential or similar rights.



#### **Section IV.12 Splits.**

(a) Subject to paragraph (c) of this Section 4.12 and Section 4.09, the Company may make a pro rata distribution of Units to all Record Holders, or may effect a subdivision or combination of Units, in each case, on an equal per Unit basis and so long as, after any such event, any amounts calculated on a per Unit basis or stated as a number of Units are proportionately adjusted.

(b) Whenever such a distribution, subdivision or combination of Units is declared, the Manager shall select a date as of which the distribution, subdivision or combination shall be effective. The Manager shall send notice thereof at least twenty (20) days prior to the date of such distribution, subdivision or combination to each Record Holder. The Manager also may cause a firm of independent public accountants selected by it to calculate the number of Units to be held by each Record Holder after giving effect to such distribution, subdivision or combination. The Manager shall be entitled to rely on any certificate provided by such firm as conclusive evidence of the accuracy of such calculation.

(c) The Company shall not issue fractional Units upon any distribution, subdivision or combination of Units. If a distribution, subdivision or combination of Units would otherwise result in the issuance of fractional Units, each fractional Unit shall be rounded to the nearest whole Unit (and a 0.5 Unit shall be rounded to the next higher Unit).

### **ARTICLE V DISTRIBUTIONS**

**Section V.01 Applications of Cash.** Any Free Cash Flows of the Company, after allowance for payment of all Company obligations then due and payable, including Management Fees, Operating Expenses Reimbursement Obligations, debt service, Operating Expenses, and for such reasonable reserves as the Manager shall determine to meet future Operating Expenses, shall be distributed to the Class A Members, *pro rata* and *pari passu* in proportion to their Class A Member Percentage Interest.

**Section V.02 Application of Amounts upon the Liquidation of the Company.** Subject to Section 6.03 and Article X, any amounts available for distribution following the liquidation of the Company, net of any fees, costs and liabilities, as determined by the Manager in its sole discretion, shall be applied and distributed 100% to the Members (pro rata to their Units and which, for the avoidance of doubt, may include the Manager and its Affiliates).

#### **Section V.03 Timing of Distributions.**

(a) Subject to the applicable provisions of the Delaware Act and except as otherwise provided herein, the Manager shall pay distributions to the Members pursuant to Section 6.01, at such times as the Manager shall reasonably determine, and pursuant to Section 6.02, as soon as reasonably practicable after the relevant amounts have been received by the Company; provided that, the Manager shall not be obliged to make any distribution pursuant to this Section (i) unless there are sufficient amounts available for such distribution or (ii) which, in the reasonable opinion of the Manager, would or might leave the Company with insufficient funds to meet any future contemplated obligations or contingencies including to meet any Operating Expenses and outstanding Operating Expenses Reimbursement Obligations (and the Manager is hereby authorized to retain any amounts within the Company to create a reserve to meet any such obligations or contingencies), or which otherwise may result in the Company having unreasonably small capital for the Company to continue its business as a going concern. Distributions shall be paid to the holders of the Units on an equal per Unit basis as of the Record Date selected by

Manager. Notwithstanding any provision to the contrary contained in this Agreement, the Company shall not be required to make a distribution to any Member on account of its Units if such distribution would violate § 18-607 of the Delaware Act or other Applicable Law or if such distribution is prohibited by the LLC's then-applicable debt-financing agreements.

(b) Notwithstanding Section 6.02 and Section 6.03(a), in the event of the termination and liquidation of the Company, all distributions shall be made in accordance with, and subject to the terms and conditions of, ARTICLE XI.

(c) Each distribution in respect of any Units shall be paid by the Company, directly or through any other Person or agent, only to the Record Holder of such Units as of the Record Date set for such distribution. Such payment shall constitute full payment and satisfaction of the Company's liability in respect of such payment, regardless of any claim of any Person who may have an interest in such payment by reason of an assignment or otherwise.

## **ARTICLE VI MANAGEMENT**

**Section VI.01 Management of the Company.** The management and control of the Company shall be vested exclusively in the Manager, and the business and affairs of the Company shall be managed under the direction of the Manager. The Manager shall have full and complete discretion to manage and control the business and affairs of the Company, to make all decisions affecting the business and affairs of the Company and to take all such actions as it deems necessary or appropriate to accomplish the purposes of the Company set forth in Section 2.05. The actions of the Manager taken in accordance with the provisions of this Agreement shall bind the Company. No other Member of the Company shall have any authority or right to act on behalf of or bind the Company, unless otherwise provided herein or unless specifically authorized by the Manager pursuant to a resolution expressly authorizing such action which resolution is duly adopted by the Manager.

### **Section VI.02 Officers.**

(a) The Manager may appoint individuals as officers of the Company (the "**Officers**") as it deems necessary or desirable to carry on the business of the Company and the Manager may delegate to such Officers such power and authority as the Manager deems advisable. No Officer needs to be a Member of the Company. Any individual may hold two or more offices of the Company. Each Officer shall hold office until his successor is designated by the Manager or until his earlier death, resignation, or removal. Any Officer may resign at any time on written notice to the Manager. Any Officer may be removed by the Manager with or without cause at any time. A vacancy in any office occurring because of death, resignation, removal or otherwise, may, but need not, be filled by the Manager.

(b) The authority and functions of the Manager, on the one hand, and of the Officers, on the other hand, shall be identical to the authority and functions of the board of directors and officers, respectively, of a corporation organized under the DGCL in addition to the powers that now or hereafter can be granted to managers under the Delaware Act. No Member, by virtue of its status as such, shall have any management power over the business and affairs of the Company or actual or apparent authority to enter into, execute or deliver contracts on behalf of, or to otherwise bind, the Company.

**Section VI.03 Authority of the Manager.** The Manager shall have the power on behalf of and in the name of the Company to take any action or make any decisions hereunder on behalf of the Company

in furtherance of the purposes of the Company as set forth in Section 2.05, to carry out any and all of the objects and purposes of the Company and to perform all acts and enter into and perform all contracts and other undertakings which it may deem necessary or advisable or incidental thereto, including, without limitation, the power to:

- (a) enter into an Operating Expenses Reimbursement Obligation;
- (b) the making of tax, regulatory and other filings, or rendering of periodic or other reports to governmental or other agencies having jurisdiction over the business or assets of the Company (including, but not limited to, the filing of annual reports on Form C-AR with the U.S. SEC), and the making of any tax elections;
- (c) obtaining or renewing all necessary licenses and permits, and otherwise assisting in the compliance with all applicable federal, state and local laws, rules and regulations, with any fees payable by the Company;
- (d) the acquisition, disposition, mortgage, pledge, encumbrance, hypothecation or exchange of any or all of the assets of the Company or the merger or other combination of the Company with or into another Person and for the avoidance of doubt, any action taken by the Manager pursuant to this sub-paragraph shall not require the consent of the Members;
- (e) the use of the assets of the Company (including cash on hand) for any purpose consistent with this Agreement's terms, including the financing of the conduct of the operations of the Company and the repayment of obligations of the Company;
- (f) the negotiation, execution and performance of any contracts, conveyances or other instruments (including instruments that limit the liability of the Company under contractual arrangements to all or particular assets of the company);
- (g) providing general administration services, including office administration, reception, scheduling, clerical services, managing inventory and overhead, and administering and paying accounts payable of the Company;
- (h) the declaration and payment of distributions of Free Cash Flows or other assets to Members;
- (i) the election and removal of Officers of the Company;
- (j) the selection, retention and dismissal of employees, agents, outside attorneys, accountants, consultants and contractors, and the determination of their compensation and other terms of employment, retention or hiring, and the payment of fees, expenses, salaries, wages and other compensation to such Persons;
- (k) managing the business operations of the Company, including assisting with preparation of business plans and operating budgets and attending to all matters reasonably necessary to afford the Company the opportunity to realize its business goals;
- (l) developing and implementing short-term and long-term strategies for the Team, with the intent to maximize its potential value and appreciation;

(m) providing financial services including, but not limited to, bookkeeping, record creation and maintenance, collection, banking, accounting, budget development, auditing and tax return preparation (provided this shall not include personal income tax returns), as well as such other accounting services as are reasonably required;

(n) providing billing and collection services for the Company, managing its cash, and making payments on its behalf, including any Management Fees that become payable;

(o) the solicitation of proxies from holders of Units issued on or after the date of this Agreement that entitles the holders thereof to vote on any matter submitted for consent or approval of the Members under this Agreement;

(p) the maintenance of insurance, including director and officer liability insurance for the directors and officers of the Manager, for the benefit of the Company and the Covered Persons and the distribution by the Manager in its sole discretion, of any proceeds received by the Company from an insurance claim to the Class A Members, *pro rata* and *pari passu* in proportion to their Class A Member Percentage Interest;

(q) the placement of any Free Cash Flow funds in deposit accounts in the name of the Company or of a custodian for the account of the Company, pending the application of those Free Cash Flow funds in meeting liabilities of the Company or making distributions or other payments to the Members (as the case may be);

(r) the control of any matters affecting the rights and obligations of the Company, including the bringing, prosecuting and defending of actions at law or in equity and otherwise engaging in the conduct of litigation, arbitration or remediation, and the incurring of legal expense and the settlement of claims and litigation, including in respect of taxes;

(s) the indemnification of any Person against liabilities and contingencies to the maximum extent permitted by law;

(t) the giving of consent of or voting by the Company in respect of any securities that may be owned by the Company;

(u) the waiver of any condition or other matter by the Company;

(v) the entering into of listing agreements with any National Securities Exchange, broker-dealer alternative trading system, or over-the-counter market and the delisting of some or all of the Units from, or requesting that trading be suspended on, any such exchange or market;

(w) the issuance, sale or other disposition, and the purchase or other acquisition, of Units or options, rights or warrants relating to Units;

(x) the registration of any offer, issuance, sale or resale of Units or other securities issued or to be issued by the Company under the Securities Act and any other applicable securities laws (including any resale of Units or other securities by Members or other security holders);

(y) the selection of Broker(s) of the Company;

(z) the execution and delivery of agreements with Affiliates of the Company or other Persons to render services to the Company;

(aa) the selection of auditors for the Company;

(bb) the selection of any transfer agent or depositor for any securities of the Company, and the entry into such agreements and provision of such other information as shall be required for such transfer agent or depositor to perform its applicable functions; and

(cc) unless otherwise provided in this Agreement, the calling of a vote of the Members as to any matter to be voted on by all Members of the Company or if a particular class of Members, as applicable.

**Section VI.04 Other Authority of the Manager.** The Manager is hereby authorized (but not required) to take any action it has determined in good faith to be necessary, desirable, or appropriate in order that (i) the Company not be an “investment company” as such term is defined in the Investment Company Act; (ii) each of the Company, the Members, and each of their respective Affiliates not be subject to a material adverse effect as a result of their Interest in the Company, services provided to or by the Company, as applicable; and (iii) each of the Company, the Members, the Manager, and each of their respective Affiliates, not be in violation of any law or regulation applicable to such party, including, without limitation:

(a) making structural, operating, or other changes in the Company by amending this Agreement in order to cure any violation of law or regulation; *provided* that such amendment does not have a material adverse effect on the Members as a whole;

(i) requiring the sale, in whole or in part, of any Member’s Interest in the Company, or otherwise causing the withdrawal of any Member from the Company; and/or

(ii) dissolving the Company.

(b) Any action taken by the Manager pursuant to this Section 7.04 shall not require the approval of any Member.

**Section VI.05 Determinations by the Manager.** In furtherance of the authority granted to the Manager pursuant to Sections 7.03 and 7.04 of this Agreement, the determination as to any of the following matters, made in good faith by or pursuant to the direction of the Manager consistent with this Agreement, shall be final and conclusive and shall be binding upon the Company and every holder of Units:

(a) the amount of Free Cash Flow for any period and the amount of assets at any time legally available for the payment of distributions on Units of the Company;

(b) the amount of paid-in surplus, net assets, other surplus, annual or other cash flow, funds from operations, net profit, net assets in excess of capital, undivided profits or excess of profits over losses on sales of assets; the amount, purpose, time of creation, increase or decrease, alteration or cancellation of any reserves or charges and the propriety thereof (whether or not any obligation or liability for which such reserves or charges shall have been created shall have been paid or discharged);

(c) any interpretation of the terms, preferences, conversion or other rights, voting powers or rights, restrictions, limitations as to distributions, qualifications or terms or conditions of redemption of any Units;

- (d) the fair value, or any sale, bid or asked price to be applied in determining the fair value, of any asset owned or held by the Company, or of any Units;
- (e) the number of Units of any class of membership interests of the Company;
- (f) any matter relating to the acquisition, holding and disposition of any assets;
- (g) each of the matters set forth in Section 7.03 (a) through Section 7.03(x); or
- (h) any other matter relating to the business and affairs of the Company or required or permitted by Applicable Law, this Agreement or otherwise to be determined by the Manager.

**Section VI.06 Other Activities.** Nothing contained in this Agreement shall prevent any Member, including the Manager, or any of its Affiliates from engaging in any other activities or businesses, regardless of whether those activities or businesses are similar to or competitive with the Business. None of the Members nor any of their Affiliates shall be obligated to account to the Company or to the other Member for any profits or income earned or derived from other such activities or businesses. None of the Members nor any of their Affiliates shall be obligated to inform the Company or the other Member of any business opportunity of any type or description.

**Section VI.07 Compensation and Reimbursement of Manager.** Except as otherwise provided herein, the Manager shall not be compensated for its services as the Manager, but the Company shall reimburse the Manager for all reasonable, ordinary, necessary, and direct expenses incurred by the Manager on behalf of the Company in carrying out the Company's business activities, including, without limitation, salaries of officers and employees of the Manager who are carrying out the Company's business activities. All reimbursements for expenses shall be reasonable in amount in the aggregate for any Fiscal Year.

**Section VI.08 Removal or Resignation of Manager.**

(a) Class A Members of the Company, acting by way of a Super Majority Vote, may elect to remove the Manager at any time if the Manager is found by a non-appealable judgment of a court of competent jurisdiction to have committed fraud in connection with the Company and which has a material adverse effect on the Company. The Manager shall call a meeting of all of the Class A Members of the Company within thirty (30) calendar days of such final non-appealable judgment of a court of competent jurisdiction, at which the Class A Members may (i) by Super Majority Vote, remove the Manager of the Company in accordance with this Section and (ii) if the Manager is so removed, by a plurality, appoint a replacement Manager or liquidate, dissolve and terminate the Company in accordance with ARTICLE X. If the Manager fails to call a meeting as required by this Section, then any Class A Member shall have the ability to demand a list of all Record Holders of the Company pursuant to Section 10.01 and to call a meeting at which such a vote shall be taken. In the event of its removal, the Manager shall be entitled to receive all amounts that have accrued and are then currently due and payable to it pursuant to this Agreement but shall forfeit its right to any future distributions. Prior to its admission as a Manager, any replacement Manager shall acquire the Units held by the departing Manager for Fair Market Value and in cash immediately payable on the Transfer of such Units.

(b) Except in the case of the Manager's removal pursuant to Section 7.08(a), the Manager may resign and appoint a replacement Manager, including an Affiliate of the Manager, as the Manager of the Company without the consent of any Members. The resignation of the Manager shall not affect its rights as a Member and shall not constitute a withdrawal of a Member. In the



event of resignation, the departing Manager shall not be required to sell its Units to the replacement Manager.

**Section VI.09 Events Affecting the Manager.** If the Manager withdraws, resigns, or dies without appointing a successor Manager, then a successor Manager may be promptly appointed by the Class A Members of the Company, acting by way of a Majority Vote. The death, withdrawal, bankruptcy, dissolution, liquidation, reorganization, merger, sale of all or substantially all the stock or assets of, or other change in the ownership or nature of the Manager shall not dissolve the Company, and upon the happening of any such event, the affairs of the Company shall be continued without dissolution by the Manager or any successor entity.

**Section VI.10 Delegation.** The Manager may delegate to any Person or Persons any of the powers and authority vested in it hereunder and may engage such Person or Persons to provide administrative, compliance, technological and accounting services to the Company, on such terms and conditions as it may consider appropriate.

## **ARTICLE VII EXCULPATION AND INDEMNIFICATION**

### **Section VII.01 Exculpation of Covered Persons.**

(a) As used herein, the term “**Covered Person**” shall mean (i) each Member, including the Manager; (ii) each officer, director, stockholder, partner, member, Affiliate, employee, agent, or representative of each Member, Manager, and each of their Affiliates; and (iii) each Officer, employee, agent, or representative of the Company.

(b) No Covered Person shall be liable to the Company or any other Covered Person for any loss, damage or claim incurred by reason of any action taken or omitted to be taken by such Covered Person in good faith reliance on the provisions of this Agreement, so long as such action or omission does not constitute fraud, gross negligence, willful misconduct, or a material breach or knowing violation of this Agreement by such Covered Person.

(c) A Covered Person shall be fully protected in relying in good faith upon the records of the Company and upon such information, opinions, reports or statements (including financial statements and information, opinions, reports or statements as to the value or amount of the assets, liabilities, Net Income or Net Losses of the Company or any facts pertinent to the existence and amount of assets from which distributions might properly be paid) of the following Persons or groups: (i) another Member; (ii) one or more Officers or employees of the Company; (iii) any attorney, independent accountant, appraiser or other expert or professional employed or engaged by or on behalf of the Company; or (iv) any other Person selected in good faith by or on behalf of the Company, in each case as to matters that such relying Person reasonably believes to be within such other Person's professional or expert competence.

### **Section VII.02 Liabilities and Duties of Covered Persons.**

(a) This Agreement is not intended to, and does not, create or impose any fiduciary duty on any Covered Person. Furthermore, each of the Members and the Company hereby waives any and all fiduciary duties that, absent such waiver, may be implied by Applicable Law, and in doing so, acknowledges and agrees that the duties and obligation of each Covered Person to each other and to the Company are only as expressly set forth in this Agreement. The provisions of this Agreement, to the extent that they restrict the duties and liabilities of a Covered Person otherwise

existing at law or in equity, are agreed by the Members to replace such other duties and liabilities of such Covered Person.

(b) Whenever in this Agreement a Covered Person is permitted or required to make a decision (including a decision that is in such Covered Person's "discretion" or under a grant of similar authority or latitude), such Covered Person shall be entitled to consider only such interests and factors as such Covered Person desires, including its own interests, and shall have no duty or obligation (fiduciary or otherwise) to give any consideration to any interest of or factors affecting the Company, the Members, or any other Person. Whenever in this Agreement a Covered Person is permitted or required to make a decision in such Covered Person's "good faith," the Covered Person shall act under such express standard and shall not be subject to any other or different standard imposed by this Agreement or any other Applicable Law. The Manager shall not have any duty (including any fiduciary duty) to the Company, the Members or any other Person, including any fiduciary duty associated with self-dealing or corporate opportunities, all of which are hereby expressly waived. This Section shall not in any way reduce or otherwise limit the specific obligations of the Manager expressly provided in this Agreement or in any other agreement with the Company.

### **Section VII.03 Indemnification.**

(a) Subject to other applicable provisions of this ARTICLE VIII including Section 8.02, the Covered Persons shall not be liable to the Company for any acts or omissions by any of the Covered Persons arising from the exercise of their rights or performance of their duties and obligations in connection with the Company, this Agreement or any investment made or held by the Company, including with respect to any acts or omissions made while serving at the request of the Company as an officer, director, member, partner, fiduciary or trustee of another Person, other than such acts or omissions that have been determined in a final, non-appealable decision of a court of competent jurisdiction to constitute fraud, willful misconduct or gross negligence. The Covered Persons shall be indemnified by the Company to the fullest extent permitted by law, against all expenses and liabilities (including judgments, fines, penalties, interest, amounts paid in settlement with the approval of the Company and counsel fees and disbursements on a solicitor and client basis) (collectively, "**Expenses and Liabilities**") arising from the performance of any of their duties or obligations in connection with their service to the Company, this Agreement, or any investment made or held by the Company, including in connection with any civil, criminal, administrative, investigative or other action, suit or proceeding to which any such Person may hereafter be made party by reason of being or having been a Manager of the Company under Delaware law, an Officer of the Company or an officer, director, member, partner, fiduciary or trustee of another Person, provided that this indemnification shall not cover Expenses and Liabilities that arise out of the acts or omissions of any Covered Person that have been determined in a final, non-appealable decision of a court, arbitrator or other tribunal of competent jurisdiction to have resulted primarily from such Covered Person's fraud, willful misconduct or gross negligence. Without limitation, the foregoing indemnity shall extend to any liability of any Covered Person, pursuant to a loan guaranty or otherwise, for any indebtedness of the Company (including any indebtedness which the Company has assumed or taken subject to), and the Manager or the Officers are hereby authorized and empowered, on behalf of the Company, to enter into one or more indemnity agreements consistent with the provisions of this Section in favor of any Covered Person having or potentially having liability for any such indebtedness. It is the intention of this paragraph that the Company indemnify each Covered Person to the fullest extent permitted by law, provided that this indemnification shall not cover Expenses and Liabilities that arise out of the acts or omissions of any Covered Person that have been determined in a final, non-appealable decision of



a court, arbitrator or other tribunal of competent jurisdiction to have resulted primarily from such Covered Person's fraud, willful misconduct or gross negligence.

(b) This Agreement's provisions, to the extent they restrict the duties and liabilities of a Covered Person otherwise existing at law or in equity, including Section 8.02, are agreed by each Member to modify such duties and liabilities of the Covered Person to the maximum extent permitted by law.

(c) Any indemnification under this Section (unless ordered by a court) shall be made by the Company. To the extent, however, that a Covered Person has been successful on the merits or otherwise in defense of any action, suit or proceeding described above, or in defense of any claim, issue or matter therein, such Covered Person shall be indemnified against expenses (including attorneys' fees) actually and reasonably incurred by such Covered Person in connection therewith.

(d) Any Covered Person may apply to the Delaware Court of Chancery or any other court of competent jurisdiction in Delaware for indemnification to the extent otherwise permissible under paragraph (a) of this Section. The basis of such indemnification by a court shall be a determination by such court that indemnification of the Covered Person is proper in the circumstances because such Covered Person has met the applicable standards of conduct set forth in paragraph (a). Neither a contrary determination in the specific case under paragraph (c) of this Section, nor the absence of any determination thereunder, shall be a defense to such application or create a presumption that the Covered Person seeking indemnification has not met any applicable standard of conduct. Notice of any application for indemnification pursuant to this paragraph shall be given to the Company promptly upon the filing of such application. If successful, in whole or in part, the Covered Person seeking indemnification shall also be entitled to be paid the expense of prosecuting such application.

(e) To the fullest extent permitted by law, expenses (including attorneys' fees) incurred by a Covered Person in defending any civil, criminal, administrative or investigative action, suit or proceeding may, at the option of the Manager, be paid by the Company in advance of the final disposition of such action, suit or proceeding upon receipt of an undertaking by or on behalf of such Covered Person to repay such amount if it shall ultimately be determined that such Covered Person is not entitled to be indemnified by the Company as authorized in this Section.

(f) The indemnification and advancement of expenses provided by or granted pursuant to this Section shall not be deemed exclusive of any other rights to which those seeking indemnification or advancement of expenses may be entitled under this Agreement, or any other agreement, vote of Members or otherwise, and shall continue as to a Covered Person who has ceased to serve in such capacity and shall inure to the benefit of the heirs, successors, assigns and administrators of the Covered Person unless otherwise provided in a written agreement with such Covered Person or in the writing pursuant to which such Covered Person is indemnified, it being the policy of the Company that indemnification of the persons specified in paragraph (a) shall be made to the fullest extent permitted by law. The provisions of this Section shall not be deemed to preclude the indemnification of any person who is not specified in paragraph (a) but whom the Company has the power or obligation to indemnify under the provisions of the Delaware Act.

(g) The Company may, but shall not be obligated to, purchase and maintain insurance on behalf of any Person entitled to indemnification under this Section against any liability asserted against such Person and incurred by such Person in any capacity to which they are entitled to indemnification hereunder, or arising out of such Person's status as such, whether or not the

Company would have the power or the obligation to indemnify such Person against such liability under the provisions of this Section.

(h) The indemnification and advancement of expenses provided by, or granted pursuant to, this Section shall, unless otherwise provided when authorized or ratified, inure to the benefit of the heirs, executors and administrators of any person entitled to indemnification under this Section.

(i) The Company may, to the extent authorized from time to time by the Manager, provide rights to indemnification and to the advancement of expenses to employees and agents of the Company.

(j) If this Section or any portion of this Section shall be invalidated on any ground by a court of competent jurisdiction, the Company shall nevertheless indemnify each Covered Person as to expenses (including attorneys' fees), judgments, fines, and amounts paid in settlement with respect to any action, suit, proceeding or investigation, whether civil, criminal or administrative, including a grand jury proceeding or action or suit brought by or in the right of the Company, to the full extent permitted by any applicable portion of this Section that shall not have been invalidated.

(k) Each of the Covered Persons may, in the performance of his, her or its duties, consult with legal counsel, accountants, and other experts, and any act or omission by such Person on behalf of the Company in furtherance of the interests of the Company in good faith and reliance upon, and in accordance with, the advice of such legal counsel, accountants or other experts will be full justification for any such act or omission, and such Person will be fully protected for such acts and omissions;

(l) Provided that such legal counsel, accountants, or other experts were selected with reasonable care by or on behalf of such Covered Person, a Covered Person shall not be denied indemnification in whole or in part under this Section because the Covered Person had an interest in the transaction with respect to which the indemnification applies if the transaction was otherwise permitted by this Agreement's terms.

(m) Any liabilities which a Covered Person incurs as a result of acting on behalf of the Company (whether as a fiduciary or otherwise) in connection with the operation, administration or maintenance of an employee benefit plan or any related trust or funding mechanism (whether such liabilities are in the form of excise taxes assessed by the Internal Revenue Service, penalties assessed by the Department of Labor, restitutions to such a plan or trust or other funding mechanism or to a participant or beneficiary of such plan, trust or other funding mechanism, or otherwise) shall be treated as liabilities indemnifiable under this Section, to the maximum extent permitted by law.

(n) The Manager shall, in the performance of its duties, be fully protected in relying in good faith upon the records of the Company and on such information, opinions, reports or statements presented to the Company by any of the Officers or employees of the Company, or by any other Person as to matters the Manager reasonably believes are within such other Person's professional or expert competence.

(o) Any amendment, modification or repeal of this Section or any provision hereof shall be prospective only and shall not in any way affect the limitations on the liability of or other rights of any indemnitee under this Section as in effect immediately prior to such amendment, modification or repeal with respect to claims arising from or relating to matters occurring, in whole

or in part, prior to such amendment, modification or repeal, regardless of when such claims may arise or be asserted and provided such Person became an indemnitee hereunder prior to such amendment, modification or repeal.

**Section VII.04 Survival.** The provisions of this ARTICLE VIII shall survive the dissolution, liquidation, winding up and termination of the Company.

## **ARTICLE VIII TRANSFER**

### **Section VIII.01 Restrictions on Transfer.**

(a) Except as otherwise provided in this ARTICLE IX, no Member shall Transfer all or any portion of its Units without the written consent of the Manager (which consent may be granted or withheld in the sole discretion of the Manager) (a “**Permitted Transfer**”). No Transfer of Units to a Person not already a Member of the Company shall be deemed completed until the prospective Transferee is admitted as a Member of the Company in accordance with Section 4.06(b) hereof.

(b) Notwithstanding any other provision of this Agreement (including Section 9.02), each Member agrees that it will not Transfer all or any portion of its Units, and the Company agrees that it shall not issue any Units:

(i) if such Transfer or issuance would result in the prospective Transferee directly or indirectly owning in excess of the Aggregate Ownership Limit;

(ii) if such Transfer or issuance would result in there being 2,000 or more beneficial owners (as such term is used under the Exchange Act) or 500 or more beneficial owners that are not accredited investors (as defined under the Securities Act), as specified in Section 12(g)(1)(A)(ii) of the Exchange Act, unless such Units have been registered under the Exchange Act or the Company is otherwise an Exchange Act reporting company or exempt therefrom;

(iii) except as permitted under the Securities Act and other applicable federal or state securities or blue sky laws, and then, with respect to a Transfer of Units, only upon delivery to the Company of an opinion of counsel in form and substance satisfactory to the Company to the effect that such Transfer may be effected without registration under the Securities Act;

(iv) if such Transfer or issuance would cause the Company to be considered a “publicly traded partnership” under Section 7704(b) of the Code within the meaning of Treasury Regulations Section 1.7704-1(h)(1)(ii), including the look-through rule in Treasury Regulations Section 1.7704-1(h)(3);

(v) if such Transfer or issuance would affect the Company's existence or qualification as a limited liability company under the Delaware Act;

(vi) if such Transfer or issuance would cause the Company to lose its status as a corporation for federal income tax purposes;

(vii) if such Transfer or issuance would cause the Company to be required to register as an investment company under the Investment Company Act of 1940, as amended;

(viii) if such Transfer or issuance would require the registration of the Company or any Units under any securities laws of the United States of America, any state thereof or any other jurisdiction; or

(ix) if such Transfer or issuance would violate or be inconsistent with any representation or warranty made by the transferring Member.

(c) The proposed Transferee, or such Member's legal representative, shall give the Manager prior written notice before making any voluntary Transfer and notice within thirty (30) days after any involuntary Transfer pursuant to Section 9.03 (unless such notice period is otherwise waived by the Manager), and shall provide sufficient information to allow legal counsel acting for the Company to make the determination that the proposed Transfer will not result in any of the consequences referred to in paragraphs (b)(i) through (b)(x) above. If a Transfer occurs by reason of the death of a Member or assignee, the notice may be given by the duly authorized representative of the estate of the Member or assignee. The notice must be supported by proof of legal authority and valid assignment in form and substance acceptable to the Manager.

(d) If any Transfer permitted by this Section shall result in beneficial ownership by multiple Persons of any Member's interest in the Company, the Manager may require one or more trustees or nominees to be designated to represent a portion of or the entire interest transferred for the purpose of receiving all notices which may be given and all payments which may be made under this Agreement, and for the purpose of exercising the rights which the transferor as a Member had pursuant to this Agreement's provisions.

(e) A Transferee shall be entitled to any future distributions attributable to the Units transferred to such Transferee and to transfer such Units in accordance with this Agreement's terms; provided, however, that such Transferee shall not be entitled to the other rights of a Member as a result of such Transfer until the Transferee is admitted as a Member pursuant to Section 4.06(b) herein.

(f) The Company shall incur no liability for distributions made in good faith to the Transferor until a written instrument of Transfer has been received by the Company and recorded on its books and the effective date of Transfer has passed.

(g) Any other provision of this Agreement to the contrary notwithstanding, any Transferee admitted as a Member shall be bound by the provisions hereof. Prior to recognizing any Transfer in accordance with this Section, the Manager may require, in its sole discretion:

(i) the Transferor and each Transferee to execute one or more deeds or other instruments of Transfer in a form satisfactory to the Manager;

(ii) each Transferee to acknowledge its assumption (in whole or, if the Transfer is in respect of part only, in the proportionate part) of the obligations of the Transferor by executing a Form of Adherence (or any other equivalent instrument as determined by the Manager);

(iii) each Transferee to provide all the information required by the Manager to satisfy itself as to anti-money laundering, counter-terrorist financing and sanctions compliance matters; and

(iv) payment by the Transferor, in full, of the costs and expenses referred to in paragraph (h) below,

and no Transfer shall be completed or recorded in the books of the Company, and no proposed Transferee shall be admitted to the Company as a Member, unless and until each of these requirements has been satisfied or, at the sole discretion of the Manager, waived.

(h) The Transferor shall bear all costs and expenses arising in connection with any proposed Transfer, whether or not the Transfer proceeds to completion, including any legal fees incurred by the Company or any broker or dealer, any costs or expenses in connection with any opinion of counsel, and any transfer taxes and filing fees.

(i) Any Transfer or attempted Transfer of any Unit in violation of this Agreement shall be null and void, no such Transfer shall be recorded on the Company's books and the purported Transferee in any such Transfer shall not be treated (and the purported Transferor shall continue be treated) as the owner of such Unit for all purposes of this Agreement.

(j) For the avoidance of doubt, any Transfer of a Unit permitted by this Agreement shall be deemed a sale, transfer, assignment, or other disposal of such Unit in its entirety as intended by the parties to such Transfer, and shall not be deemed a sale, transfer, assignment or other disposal of any less than all of the rights and benefits described in the definition of the term "Membership Interest," unless otherwise explicitly agreed to by the parties to such Transfer.

**Section VIII.02 Other Permitted Transfers.** The provisions of Section 9.01(a) shall not apply to any Transfer by any Member of all or any portion of its Units to its Affiliate.

**Section VIII.03 Involuntary Transfers.** In the event that any Unit owned by any Member shall be subject to an involuntary Transfer, including by reason of (a) bankruptcy or insolvency proceedings, whether voluntary or involuntary, (b) distraint, levy, execution or other involuntary Transfer, unless, in the case of this clause (b), the transferee releases such Interests within five (5) business days of the occurrence of any such involuntary Transfer, (c) a Transfer by operation of law (including in connection with a divorce or pursuant to applicable laws of descent and distribution in the event of the death of an individual Member holding such Class A Interests or Class B Interests) unless such Transfer constitutes a Permitted Transfer, or (d) Disability (each such subsections (a) through (e), an "**Involuntary Transfer**"), such Member (or his, her or its personal representative) shall give the Company written notice of such Involuntary Transfer stating the terms of such proposed Transfer, the identity of the proposed transferee and the price or other consideration, if readily determinable, for which the subject Unit is to be transferred. After receipt of such notice, the Company (or its assignee, as determined by the Manager) shall have the right to purchase up to all of the Units held by such Member (or his, her or its personal representative) at the price and on the terms applicable to such proposed Transfer, which right shall be exercised by written notice given by the Company to the Member (or his, her or its personal representative) within ninety (90) days after the Company's receipt of such notice.

**Section VIII.04 Approved Sale; Drag Along.** If the Manager approves a sale of the Company to a good faith purchaser (an "**Approved Sale**"), then each Member shall be deemed to vote for, consent to and raise no objections against such Approved Sale. If the Approved Sale is structured as a (i) merger or

consolidation, each Member holding any Units shall waive any dissenters rights, appraisal rights or similar rights in connection with such merger or consolidation or (ii) sale of Membership Interest, each holder of Units shall agree to sell all of his, her or its Units and rights to acquire a Unit on the terms and conditions approved by the Manager, including, without limitation, any and all representations and warranties provided by the Members, indemnification obligations of the Members, escrow and other holdback arrangements, contingent purchase price arrangements, covenants and restrictive covenants made by the Members in connection therewith.

#### **Section VIII.05 No Withdrawal.**

(a) So long as a Member continues to hold any Units, such Member shall not have the ability to withdraw or resign as a Member prior to the dissolution and winding up of the Company and any such withdrawal or resignation or attempted withdrawal or resignation by a Member prior to the dissolution or winding up of the Company shall be null and void. As soon as any Person who is a Member ceases to hold any Units, such Person shall no longer be a Member.

(b) Notwithstanding Section 9.05(a), the Manager may require a Member to withdraw all or any portion of its Units in the Company immediately, with no prior notice, if the Manager deems it to be in the best interests of the Company to do so because the continued participation of such Member in the Company might cause the Company to violate any law, rule or regulation, expose the Company or the Manager to the risk of litigation, arbitration, administrative proceedings or any similar action or proceeding or otherwise have an adverse effect (whether legal, regulatory, tax otherwise) on the other Members, the Company, the Manager or any of its or their Affiliates.

**Section VIII.06 Remedies for Breach.** If the Manager shall at any time determine in good faith that a Transfer or other event has taken place that results in a violation of this ARTICLE IX, the Manager shall take such action as it deems advisable to refuse to give effect to or to prevent such Transfer or other event, including, without limitation, causing the Company to redeem shares, refusing to give effect to such Transfer on the books of the Company or instituting proceedings to enjoin such Transfer or other event.

### **ARTICLE IX ACCOUNTING; TAX MATTERS**

#### **Section IX.01 Records and Accounting.**

(a) The Manager shall keep or cause to be kept at the principal office of the Company or such other place as determined by the Manager appropriate books and records with respect to the business of the Company, including all books and records necessary to provide to the Members any information required to be provided pursuant to this Agreement or Applicable Law. Any books and records maintained by or on behalf of the Company in the regular course of its business, including the record of the Members, books of account and records of Company proceedings, maybe kept in such electronic form as may be determined by the Manager; provided, that the books and records so maintained are convertible into clearly legible written form within a reasonable period of time. The books of the Company shall be maintained, for tax and financial reporting purposes, on an accrual basis in accordance with U.S. GAAP, unless otherwise required by Applicable Law or other regulatory disclosure requirement.

(b) Each Member shall have the right, upon reasonable demand for any purpose reasonably related to the Member's Units as a member of the Company (as reasonably determined by the Manager) to such information pertaining to the Company, as provided in Section 18-305 of the Delaware Act; provided, that prior to such Member having the ability to access such



information, the Manager shall be permitted to require such Member to enter into a confidentiality agreement in form and substance reasonably acceptable to the Manager.

(c) As soon as available, and in any event within one hundred twenty (120) days after the end of each Fiscal Year, the Manager shall provide the Members with unaudited balance sheets of the Company as at the end of each such Fiscal Year and unaudited consolidated statements of income, cash flows and Members' equity for such Fiscal Year, in each case setting forth in comparative form the figures for the previous Fiscal Year; provided that, notwithstanding the foregoing, if the Company is required to disclose financial information pursuant to the Securities Act or the Exchange Act (including without limitation the ongoing reports under Regulation Crowdfunding of the Securities Act), then compliance with such provision shall be deemed compliance with this Section and no further or earlier financial reports shall be required to be provided to the Members.

**Section IX.02 Income Tax Status.** It is the intent of this Company and the Members that this Company shall be treated as a corporation for U.S., federal, state, and local income tax purposes. The Manager, in its sole and absolute discretion may make an election for the Company to be classified as other than a corporation pursuant to Treasury Regulations Section 301.7701-3.

**Section IX.03 Tax Returns.** At the expense of the Company, the Manager (or any Officer that it may designate pursuant to Section 7.02(a)) shall endeavor to cause the preparation and timely filing (including extensions) of all tax returns required to be filed by the Company pursuant to the Code as well as all other required tax returns in each jurisdiction in which the Company owns property or does business. As soon as reasonably possible after the end of each Fiscal Year, the Manager or designated Officer will cause to be delivered to each Person who was a Member at any time during such Fiscal Year, such information with respect to the Company as may be necessary for the preparation of such Person's federal, state, and local income tax returns for such Fiscal Year.

**Section IX.04 Company Funds.** All funds of the Company shall be deposited in its name, or in such name as may be designated by the Manager, in such checking, savings or other accounts, or held in its name in the form of such other investments as shall be designated by the Manager. The funds of the Company shall not be commingled with the funds of any other Person. All withdrawals of such deposits or liquidations of such investments by the Company shall be made exclusively upon the signature or signatures of such Officer or Officers as the Manager may designate.

## **ARTICLE X DISSOLUTION AND LIQUIDATION**

**Section X.01 Events of Dissolution.** The Company shall be dissolved, and its affairs wound up only upon the occurrence of any of the following events:

- (a) The determination of the Manager to dissolve the Company;
- (b) The sale, exchange, involuntary conversion, or other disposition or Transfer of all or substantially all the assets of the Company;
- (c) The entry of a decree of judicial dissolution under § 18-802 of the Delaware Act;
- (d) At any time there are no Members of the Company, unless the business of the Company is continued in accordance with the Delaware Act; or



(e) A vote of the Members to dissolve the Company following the for-cause removal of the Manager in accordance with Section 7.08.

**Section X.02 Effectiveness of Dissolution.** Dissolution of the Company shall be effective on the day on which the event described in Section 11.01 occurs, but the Company shall not terminate until the winding up of the Company has been completed, the assets of the Company have been distributed as provided in Section 11.03 and the Certificate of Formation shall have been cancelled as provided in Section 11.04.

**Section X.03 Liquidation.** If the Company is dissolved pursuant to Section 11.01, the Company shall be liquidated and its business and affairs wound up in accordance with the Delaware Act and the following provisions:

(a) The Manager shall select one or more Persons (which may be the Manager) to act as liquidator to wind up the Company (the “**Liquidator**”). The Liquidator shall have full power and authority to sell, assign, and encumber any or all of the Company’s assets and to wind up and liquidate the affairs of the Company in an orderly and business-like manner. In the case of a dissolution of the Company, (i) the Liquidator shall be entitled to receive compensation for its services as Liquidator; (ii) the Liquidator shall agree not to resign at any time without fifteen (15) days prior notice to the Manager and may be removed at any time by the Manager; and (iii) upon dissolution, death, incapacity, removal or resignation of the Liquidator, a successor and substitute Liquidator (who shall have and succeed to all rights, powers and duties of the original Liquidator) shall within thirty (30) days be appointed by the Manager. The right to approve a successor or substitute Liquidator in the manner provided herein shall be deemed to refer also to any such successor or substitute Liquidator approved in the manner herein provided. Except as expressly provided in this ARTICLE X, the Liquidator approved in the manner provided herein shall have and may exercise, without further authorization or consent of any of the parties hereto, all of the powers conferred upon the Manager under this Agreement’s terms (but subject to all of the applicable limitations, contractual and otherwise, upon the exercise of such powers) necessary or appropriate to carry out the duties and functions of the Liquidator hereunder for and during the period of time required to complete the winding up and liquidation of the Company as provided for herein.

(b) As promptly as possible after dissolution and again after final liquidation, the Liquidator shall cause a proper accounting to be made by a recognized firm of certified public accountants of the Company’s assets, liabilities, and operations through the last day of the calendar month in which the dissolution occurs or the final liquidation is completed, as applicable.

(c) In connection with the liquidation of the Company, the Liquidator shall proceed to dispose of the assets, discharge its liabilities, and otherwise wind up its affairs in such manner and over such period as determined by the Liquidator, subject to Sections 18-215 and 18-804 of the Delaware Act, and the following:

(i) Subject to Section 11.03(c)(iii), the assets may be disposed of by public or private sale on such terms as the Liquidator may determine. The Liquidator may defer liquidation for a reasonable time if it determines that an immediate sale or distribution of all or some of the assets would be impractical or would cause undue loss to the Members.

(ii) Liabilities include amounts owed to the Liquidator as compensation for serving in such capacity (subject to the terms of Section 11.03(a)) as well as any outstanding Operating Expenses Reimbursement Obligations and any other amounts owed

to Members otherwise than in respect of their distribution rights under ARTICLE VI. With respect to any liability that is contingent, conditional or unmatured or is otherwise not yet due and payable, the Liquidator shall either settle such claim for such amount as it thinks appropriate or establish a reserve of Free Cash Flows or other assets to provide for its payment. When paid, any unused portion of the reserve shall be applied to other liabilities or distributed as additional liquidation proceeds. Liabilities shall be distributed, with priority to creditors, in the order of priority as provided by law, including, to the extent permitted by law, Members who are creditors; and secondly to Members as creditors, to the extent they did not receive distributions pursuant to Section 11.03(c)(i), and to Members in satisfaction of the Company's liability for distributions.

(iii) All property and all Free Cash Flows in excess of that required to discharge liabilities as provided in Section 11.03(c)(ii) shall be distributed to the holders of the Units on an equal per Unit basis.

(d) Notwithstanding the provisions of Section 11.03 that require the liquidation of the assets of the Company, but subject to the order of priorities set forth in Section 11.03(c), if upon dissolution of the Company the Liquidator reasonably determines that an immediate sale of part or all of the Company's assets would be impractical or could cause undue loss to the Members, the Liquidator may defer the liquidation of any assets except those necessary to satisfy Company liabilities and reserves, and may, upon unanimous consent of the Members, distribute to the Members, in lieu of cash, as tenants in common and in accordance with the provisions of Section 11.03(c), undivided interests in such Company assets as the Liquidator deems not suitable for liquidation. Any such distribution in kind shall be subject to such conditions relating to the disposition and management of such properties as the Liquidator deems reasonable and equitable and to any agreements governing the operating of such properties at such time. For purposes of any such distribution, any property to be distributed will be valued at its Fair Market Value, as determined by the Liquidator in good faith.

**Section X.04 Cancellation of Certification of Formation.** Upon completion of the distribution of the assets of the Company as provided in Section 11.03(c) hereof, the Company shall be terminated, and the Liquidator shall cause the cancellation of the Certificate of Formation in the State of Delaware and of all qualifications and registrations of the Company as a foreign limited liability company in jurisdictions other than the State of Delaware and shall take such other actions as may be necessary to terminate the Company.

**Section X.05 Survival of Rights, Duties and Obligations.** Dissolution, liquidation, winding up or termination of the Company for any reason shall not release any party from any Loss that at the time of such dissolution, liquidation, winding up or termination already had accrued to any other party or thereafter may accrue in respect of any act or omission prior to such dissolution, liquidation, winding up or termination. For the avoidance of doubt, none of the foregoing shall replace, diminish, or otherwise adversely affect any Member's right to indemnification pursuant to Section 8.03.

**Section X.06 Recourse for Claims.** Each Member shall look solely to the assets of the Company for all distributions with respect to the Company, such Member's Capital Account, and such Member's share of Net Income, Net Loss and other items of income, gain, loss, and deduction, and shall have no recourse therefor (upon dissolution or otherwise) against the Liquidator or any other Member.

**Section X.07 Waiver of Partition.** To the maximum extent permitted by law, each Member hereby waives any right to partition of the Company.

## **ARTICLE XI MEMBER MEETINGS**

**Section XI.01 Meetings.** The Company shall not be required to hold an annual meeting of the Members. The Manager may, whenever it thinks fit, convene meetings of the Company. The non-receipt by any Member of a notice convening a meeting shall not invalidate the proceedings at that meeting.

**Section XI.02 Quorum.** No business shall be transacted at any meeting unless a quorum of Members is present at the time when the meeting proceeds to business; in respect of meetings of the Company, Members holding fifty percent (50%) of the Units present in person or by proxy shall be a quorum. If a quorum for a meeting is not present, the Manager may adjourn or cancel the meeting, as it determines in its sole discretion.

**Section XI.03 Chairman.** Any designee of the Manager shall preside as chairman of any meeting of the Company.

**Section XI.04 Voting Rights.** Subject to the provisions of any class or series of Units then Outstanding, the Members shall be entitled to vote only on those matters provided for under this Agreement's terms.

**Section XI.05 Extraordinary Actions.** Except as specifically provided in this Agreement, notwithstanding any provision of law permitting or requiring any action to be taken or authorized by the affirmative vote of the holders of a greater number of votes, any such action shall be effective and valid if taken or approved by the affirmative vote of holders of Units entitled to cast a majority of all the votes entitled to be cast on the matter.

**Section XI.06 Manager Approval.** Other than as provided for in this ARTICLE XI, the submission of any action of the Company to Members for their consideration shall first be approved by the Manager.

**Section XI.07 Actions by Members without a Meeting.** Any action required or permitted to be taken by the holders of the Units may be taken without a meeting by the written consent of such holders or Members entitled to cast a sufficient number of votes to approve the matter as required by statute or this Agreement, as the case may be.

**Section XI.08 Manager.** Unless otherwise expressly provided in this Agreement, the Manager or any of its Affiliates who hold any Units shall not be entitled to vote in its capacity as holder of such Units on matters submitted to the Members for approval, and no such Units shall be deemed Outstanding for purposes of any such vote.

## **ARTICLE XII MISCELLANEOUS**

**Section XII.01 Expenses.** Except as otherwise expressly provided herein, all costs and expenses, including fees and disbursements of counsel, financial advisors, and accountants, incurred in connection with the preparation and execution of this Agreement, or any amendment or waiver hereof, and the transactions contemplated hereby shall be paid by the party incurring such costs and expenses.

**Section XII.02 Further Assurances.** In connection with this Agreement and the transactions contemplated hereby, the Company and each Member hereby agrees, at the request of the Company or any other Member, to execute and deliver such additional documents, instruments, conveyances, and assurances

and to take such further actions as may be required to carry out the provisions hereof and give effect to the transactions contemplated hereby.

### **Section XII.03 Confidentiality.**

(a) Each Member acknowledges that during the term of this Agreement, it will have access to and become acquainted with trade secrets, proprietary information and confidential information belonging to the Company and its Affiliates that are not generally known to the public, including, without limitation, information regarding the financial status, customers, profits, profit margins, and any other information about the Company that may not be known generally or publicly outside of the Company, in any format whatsoever (including oral, written, electronic or any other form or medium) (collectively, “**Confidential Information**”). In addition, each Member acknowledges that: (i) the Company has invested, and continues to invest, substantial time, expense, and specialized knowledge in developing its Confidential Information; (ii) the Confidential Information provides the Company with a competitive advantage over others in the marketplace; and (iii) the Company would be irreparably harmed if the Confidential Information were disclosed to competitors or made available to the public. Without limiting the applicability of any other agreement to which any Member is subject, no Member shall, directly or indirectly, disclose or use (other than solely for the purposes of such Member monitoring and analyzing its investment in the Company) at any time, including, without limitation, use for personal, commercial, or proprietary advantage or profit, either during its association with the Company or thereafter, any Confidential Information of which such Member is or becomes aware. Each Member in possession of Confidential Information shall take all appropriate steps to safeguard such information and to protect it against disclosure, misuse, espionage, loss, and theft.

(b) Nothing contained in Section 13.03(a) shall prevent any Member from disclosing Confidential Information: (i) upon the order of any court or administrative agency; (ii) upon the request or demand of any regulatory agency or authority having jurisdiction over such Member; (iii) to the extent compelled by legal process or required or requested pursuant to subpoena, interrogatories or other discovery requests; (iv) to the extent necessary in connection with the exercise of any remedy hereunder; (v) to the other Member; (vi) to such Member's Representatives who, in the reasonable judgment of such Member, need to know such Confidential Information and agree to be bound by the provisions of this Section as if a Member; or (vii) to any potential Permitted Transferee in connection with a proposed Transfer of Units from such Member, as long as such Transferee agrees to be bound by the provisions of this Section as if a Member; *provided*, that in the case of clause (i), (ii) or (iii), such Member shall notify the Company and other Member of the proposed disclosure as far in advance of such disclosure as practicable (but in no event make any such disclosure before notifying the Company and other Member) and use reasonable efforts to ensure that any Confidential Information so disclosed is accorded confidential treatment satisfactory to the Company, when and if available.

(c) The restrictions of Section 13.03(a) shall not apply to Confidential Information that: (i) is or becomes generally available to the public other than as a result of a disclosure by a Member in violation of this Agreement; (ii) is or has been independently developed or conceived by such Member without use of Confidential Information; or (iii) becomes available to such Member or any of its Representatives on a non-confidential basis from a source other than the Company, the other Member or any of their respective Representatives, *provided*, that such source is not known by the receiving Member to be bound by a confidentiality agreement regarding the Company.

(d) The obligations of each Member under this Section shall survive (i) the termination, dissolution, liquidation and winding up of the Company, and (ii) such Member's Transfer of its Units.

**Section XII.04 Notices.** All notices, requests, consents, claims, demands, waivers and other communications hereunder shall be in writing and shall be deemed to have been given: (a) when delivered by hand (with written confirmation of receipt); (b) when received by the addressee if sent by a nationally recognized overnight courier (receipt requested); (c) on the date sent by facsimile or e-mail of a PDF document (with confirmation of transmission) if sent during normal business hours of the recipient, and on the next Business Day if sent after normal business hours of the recipient; or (d) on the third day after the date mailed, by certified or registered mail, return receipt requested, postage prepaid. Such communications must be sent to the respective parties at the following addresses (or at such other address for a party as shall be specified in a notice given in accordance with this Section 13.04):

**Section XII.05 Headings.** The headings in this Agreement are inserted for convenience or reference only and are in no way intended to describe, interpret, define, or limit the scope, extent or intent of this Agreement or any provision of this Agreement.

**Section XII.06 Severability.** If any term or provision of this Agreement is held to be invalid, illegal, or unenforceable under Applicable Law in any jurisdiction, such invalidity, illegality, or unenforceability shall not affect any other term or provision of this Agreement or invalidate or render unenforceable such term or provision in any other jurisdiction. Except as provided in Section 8.03, upon such determination that any term or other provision is invalid, illegal, or unenforceable, the parties hereto shall negotiate in good faith to modify this Agreement so as to effect the original intent of the parties as closely as possible in a mutually acceptable manner in order that the transactions contemplated hereby be consummated as originally contemplated to the greatest extent possible.

**Section XII.07 Entire Agreement.** This Agreement, together with the Certificate of Formation and all related Exhibits and Schedules, constitutes the sole and entire agreement of the parties to this Agreement with respect to the subject matter contained herein and therein, and supersedes all prior and contemporaneous understandings, agreements, representations, and warranties, both written and oral, with respect to such subject matter.

**Section XII.08 Successors and Assigns.** Subject to the restrictions on Transfers set forth herein, this Agreement shall be binding upon and shall inure to the benefit of the parties hereto and their respective heirs, executors, administrators, successors and permitted assigns. This Agreement may not be assigned by



any Member except as permitted by this Agreement and any assignment in violation of this Agreement shall be null and void.

**Section XII.09 No Third-Party Beneficiaries.** Except as provided in ARTICLE VIII, which shall be for the benefit of and enforceable by Covered Persons as described therein, this Agreement is for the sole benefit of the parties hereto (and their respective heirs, executors, administrators, successors and assigns) and nothing herein, express or implied, is intended to or shall confer upon any other Person, including any creditor of the Company, any legal or equitable right, benefit or remedy of any nature whatsoever under or by reason of this Agreement.

#### **Section XII.10 Amendment.**

(a) This Agreement may be amended or modified from time to time only by the written consent of the Manager; provided, however, that no such amendment may: (a) (i) decrease the percentage of Outstanding Units required to take any action hereunder; (ii) materially adversely affect the rights of any of the Members; (iii) give any Person the right to dissolve the Company (other than the Manager); (iv) modify the term of the Company; (v) modify the limited liability of a Member; or (vi) modify the indemnification and exculpation rights of any indemnified party under this Agreement; or (b) amend or waive any provision of this Section.

(b) If the Manager desires to amend any provision of this Agreement in a manner prohibited under Section 13.10(a), then it shall first adopt a resolution setting forth the amendment proposed, declaring its advisability, and then call a meeting of the Members entitled to vote in respect thereof for the consideration of such amendment. Amendments to this Agreement may be proposed only by or with the consent of the Manager. Such meeting shall be called and held upon notice in accordance with ARTICLE XI of this Agreement. The notice shall set forth such amendment in full or a brief summary of the changes to be implemented thereby, as the Manager shall deem advisable. At the meeting, a vote of Members entitled to vote thereon shall be taken for and against the proposed amendment. A proposed amendment shall be effective upon its approval by Majority Vote, with Members voting together as a single class, unless a greater percentage is required under this Agreement or by Delaware law. The Company shall deliver to each Member prompt notice of the adoption of every amendment made to this Agreement pursuant to this ARTICLE XII.

**Section XII.11 Waiver.** No waiver by any party of any of the provisions hereof shall be effective unless explicitly set forth in writing and signed by the party so waiving. No waiver by any party shall operate or be construed as a waiver in respect of any failure, breach or default not expressly identified by such written waiver, whether of a similar or different character, and whether occurring before or after that waiver. No failure to exercise, or delay in exercising, any right, remedy, power, or privilege arising from this Agreement shall operate or be construed as a waiver thereof, nor shall any single or partial exercise of any right, remedy, power, or privilege hereunder preclude any other or further exercise thereof or the exercise of any other right, remedy, power, or privilege. For the avoidance of doubt, nothing contained in this Section shall diminish any of the explicit and implicit waivers described in this Agreement.

#### **Section XII.12 Governing Law.**

(a) This Agreement and the rights of the parties shall be governed by and construed in accordance with Delaware law. Non-contractual obligations (if any) arising out of or in connection with this agreement (including its formation) shall also be governed by Delaware law. The rights and liabilities of the Members in the Company and as between them shall be determined pursuant to the Delaware Act and this Agreement. To the extent the rights or obligations of any Member are

different by reason of any provision of this Agreement than they would otherwise be under the Delaware Act in the absence of any such provision, or even if this Agreement is inconsistent with the Delaware Act, this Agreement shall control, except to the extent the Delaware Act prohibits any particular provision of the Delaware Act to be waived or modified by the Members, in which event any contrary provisions hereof shall be valid to the maximum extent permitted under the Delaware Act.

(b) To the fullest extent permitted by Applicable Law, any suit, action or proceeding seeking to enforce any provision of, or based on any matter arising out of or in connection with this Agreement, or the transactions contemplated hereby shall be brought in Delaware Chancery Court, and each Member hereby consents to the exclusive jurisdiction of the Delaware Chancery Court (and of the appropriate appellate courts therefrom) in any suit, action or proceeding, and irrevocably waives, to the fullest extent permitted by Applicable Law, any objection which it may now or hereafter have to the laying of the venue of any such suit, action or proceeding in any such court or that any such suit, action or proceeding which is brought in any such court has been brought in an inconvenient forum. To the fullest extent permitted by Applicable Law, each Member hereby waives the right to commence an action, suit or proceeding seeking to enforce any provisions of, or based on any matter arising out of or in connection with this Agreement, or the transactions contemplated hereby or thereby in any court outside of the Delaware Chancery Court except to the extent otherwise explicitly provided herein. The provisions of this Section 13.12(b) shall not be applicable to an action, suit or proceeding to the extent it pertains to a matter as to which the claims are exclusively vested in the jurisdiction of a court or forum other than the Delaware Chancery Court, or if the Delaware Chancery Court does not have jurisdiction over such matter.

(c) Process in any suit, action or proceeding may be served on any party anywhere in the world, whether within or without the jurisdiction of any court. Without limiting the foregoing, each party agrees that service of process on such party by written notice pursuant to Section 13.04 will be deemed effective service of process on such party.

(d) TO THE FULLEST EXTENT PERMITTED BY APPLICABLE LAW, EVERY PARTY TO THIS AGREEMENT AND ANY OTHER PERSON WHO BECOMES A MEMBER OR HAS RIGHTS AS AN ASSIGNEE OF ANY PORTION OF ANY MEMBER'S MEMBERSHIP INTEREST HEREBY WAIVES ANY RIGHT TO A JURY TRIAL AS TO ANY MATTER UNDER THIS AGREEMENT OR IN ANY OTHER WAY RELATING TO THE COMPANY OR THE RELATIONS UNDER THIS AGREEMENT OR OTHERWISE AS TO THE COMPANY AS BETWEEN OR AMONG ANY SAID PERSONS.

**Section XII.13 Equitable Remedies.** Each party hereto acknowledges that a breach or threatened breach by such party of any of its obligations under this Agreement would give rise to irreparable harm to the other parties, for which monetary damages would not be an adequate remedy, and hereby agrees that in the event of a breach or a threatened breach by such party of any such obligations, each of the other parties hereto shall, in addition to any and all other rights and remedies that may be available to them in respect of such breach, be entitled to equitable relief, including a temporary restraining order, an injunction, specific performance and any other relief that may be available from a court of competent jurisdiction (without any requirement to post bond).

**Section XII.14 Attorneys' Fees.** In the event that any party hereto institutes any legal suit, action or proceeding, including arbitration, against another party in respect of a matter arising out of or relating to this Agreement, the prevailing party in the suit, action or proceeding shall be entitled to receive, in addition to all other damages to which it may be entitled, the costs incurred by such party in conducting the suit, action or proceeding, including reasonable attorneys' fees and expenses and arbitration costs.



**Section XII.15 Remedies Cumulative.** The rights and remedies under this Agreement are cumulative and are in addition to and not in substitution for any other rights and remedies available at law or in equity or otherwise, except to the extent expressly provided in Section 8.02 to the contrary.

**Section XII.16 Counterparts.** This Agreement may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this Agreement delivered by facsimile, e-mail or other means of Electronic Transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Agreement.

## **SUBSCRIPTION AGREEMENT AND JOINDER**

This Subscription Agreement and Joinder (the “*Agreement*”) is made and dated as of September 20, 2024, by and between Greene Nation LLC, a Delaware limited liability company (the “*Company*”), and the undersigned subscriber (the “*Subscriber*”).

**WHEREAS**, the Subscriber understands that the Offering of the Class A Units is made pursuant to the Form C, dated September 20, 2024, as the same may be amended or supplemented (the “*Form C*”);

**WHEREAS**, the Subscriber wishes to subscribe for and purchase the Class A Units.

**NOW, THEREFORE, upon the execution and delivery of this Agreement, the Company and the Subscriber agree as follows:**

1. **SUBSCRIPTION.** Subject to the terms and conditions of this Agreement (i) the Company agrees to sell to the Subscriber, and the Subscriber irrevocably subscribes for and agrees to purchase from the Company, a number of Class A Units in the Company set forth on the signature page hereto for the aggregate purchase price set forth on the signature page hereto, which is payable as described in Section 4 hereof and (ii) the Subscriber agrees to its membership in the Company pursuant to the terms conditions of this Agreement and the Company’s limited liability company agreement dated August 27, 2024, as amended (the “*Operating Agreement*”); *provided, however*, that the Company reserves the right to accept or reject this

subscription for Class A Units, in whole or in part. If the Company elects to accept this subscription for Class A Units in part, it shall promptly notify the Subscriber on the signature page countersigned by the Company and delivered to the Subscriber.

2. **ACCEPTANCE OF SUBSCRIPTION AND ISSUANCE OF SECURITIES.** It is understood and agreed that the Company shall have the sole right, at its complete discretion, to accept or reject this subscription, in whole or in part, for any reason and that the same shall be deemed to be accepted by the Company only when it is signed by a duly authorized officer of the Company and delivered to the Subscriber at the Closing referred to in Section 3 hereof. Subscriptions need not be accepted in the order received, and the Class A Units may be allocated among Subscribers.

3. **THE CLOSING.** Provided that the subscriptions are received in an amount equal to or greater than \$97,700 (the “**Target Offering Amount**”), the closing of the purchase and sale of the Securities (the “**Closing**”) shall take place on the Company’s offering deadline specified in the Form C, or at such other time and place as the Company may designate by notice to the undersigned (the “**Closing Date**”).

4. **PAYMENT FOR SECURITIES.** Payment for the Class A Units shall be received by North Capital Private Securities Corporation (the “**Escrow Facilitator**”) from the Subscriber by wire transfer of immediately available funds or other means as instructed by the Intermediary. The Escrow Facilitator shall release such funds to the Company as instructed by the Intermediary. The Subscriber shall receive notice and evidence of the aggregate dollar amount of the Class A Units owned by Subscriber reflected on the books and records of the Company, which shall bear a notation that the Class A Units were sold in reliance upon an exemption from registration under the Securities Act.

respect of, or notice to, or filing or registration with, any governmental body, agency or official is required by or with respect to the Company in connection with the execution, delivery and performance by the Company of this Agreement except (i) for such filings as may be required under Regulation CF promulgated under the Securities Act, or under any applicable State Securities Laws, (ii) for such other filings and approvals as have been made or obtained, or (iii) where the failure to obtain any such order, license, consent, authorization, approval or exemption or give any such notice or make any filing or registration would not have a material adverse effect on the ability of the Company to perform its obligations hereunder.

- f) Complete copies of the Company's financial statements consisting of the statement of financial position of the Company as of August 26, 2024, since inception (the "**Financial Statements**") have been made available to the Subscriber and appear in the Form C and on the platform of ALAO Invest LLC (the "**Intermediary**"). The Financial Statements are based on the books and records of the Company and fairly present the financial condition of the Company as of the respective dates they were prepared for the periods indicated. Mongio and Associates, which has reviewed the Financial Statements, is an independent accounting firm within the rules and regulations adopted by the SEC. The Financial Statements comply with the requirements of Rule 201 of Regulation Crowdfunding, as promulgated by the SEC.

The Subscriber will comply with all applicable laws and regulations in effect in any jurisdiction in which the Subscriber purchases or sells the Class A Units and obtain any consent, approval or permission required for such purchases or sales under the laws and regulations of any jurisdiction to which the Subscriber is subject or in which the Subscriber makes such purchases or sales, and the Company shall have no responsibility therefor.
- iv. The Subscriber acknowledges, and is purchasing the Class A Units in compliance with, the investment limitations as set forth in Rule 100(a)(2) of Regulation CF.

b) Information Concerning the Company.

- i. The Subscriber has received a copy of the Form C. With respect to information provided by the Company, the Subscriber has relied solely on the information contained in the Form C to make the decision to purchase the Class A Units.
- ii. The Subscriber understands and accepts that the purchase of the Class A Units involves various risks, including the risks outlined in the Form C and in this Agreement. The Subscriber represents that it is able to bear any, and all loss associated with an investment in the Class A Units.
- iii. The Subscriber confirms that it is not relying and will not rely on any communication (written or oral) of the Company, the Intermediary, or any of their respective affiliates, as investment advice or as a recommendation to purchase the Class A Units. It is understood that information and explanations related to the terms and conditions of the Class A Units provided in the Form C or otherwise by the Company, the Intermediary or any of their respective affiliates shall not be considered investment advice or a recommendation to purchase the Class A Units, and that neither the Company, the Intermediary nor any of their respective affiliates is acting or has acted as an advisor to the Subscriber in deciding to invest in the Class A Units. The Subscriber acknowledges that neither the Company, the Intermediary, nor any of their respective affiliates have made any representation regarding the proper characterization of the Class A Units for purposes of determining the Subscriber's authority or suitability to invest in the Class A Units.
- iv. The Subscriber is familiar with the business and financial condition and operations of the Company, all as generally described in the Form C. The Subscriber has had access to such information concerning the Company and the Class A Units as it deems necessary to enable it to make an informed investment decision concerning the purchase of the Class A Units.
- v. The Subscriber understands that, unless the Subscriber notifies the Company in writing to the contrary at or before a Closing Date, each of the Subscriber's representations and warranties contained in this Agreement will be deemed to have been reaffirmed and confirmed as of the respective Closing Date, taking into account all information received by the Subscriber.
- vi. The Subscriber acknowledges that the Company has the right in its sole and absolute discretion to abandon this Offering at any time prior to the completion of the Offering. This Agreement shall thereafter have no force or effect and the Company shall return any previously paid subscription price of the Securities, without interest thereon, to the Subscriber.
- vii. The Subscriber understands that no federal or state agency has passed upon the merits or risks of an investment in the Class A Units or made any finding or determination concerning the fairness or advisability of this investment.

c) No Guaranty.

The Subscriber confirms that the Company has not (A) given any guarantee or representation as to the potential success, return, effect or benefit (either legal, regulatory, tax, financial, accounting or otherwise) of an investment in the Class A Units or (B) made any representation to the Subscriber regarding the legality of an investment in the Class A Units under applicable legal investment or similar laws or regulations. With the assistance of the Subscriber's own professional advisors, to the extent that the Subscriber has deemed appropriate, the Subscriber has made its own legal, tax, accounting and financial evaluation of the merits and risks of an investment in the Class A Units and the consequences of this Agreement. The Subscriber has considered the suitability of the Class A Units as an investment in light of its own circumstances and financial condition and the Subscriber is able to bear the risks associated with an investment in the Class A Units and its authority to invest in the Class A Units.
- ii. If Subscriber is not a United States person (as defined by Section 7701(a)(30) of the Internal Revenue Code of 1986, as amended), Subscriber hereby represents that it has satisfied itself as to the full observance of the laws of its jurisdiction in connection with any invitation to subscribe for the Class A Units or any use of this Agreement, including (i) the legal requirements within its jurisdiction for the purchase of the Class A Units, (ii) any foreign exchange restrictions applicable to such purchase, (iii) any governmental or other consents that may need to be obtained, and (iv) the income tax and other tax consequences, if any, that may be relevant to the purchase, holding, redemption, sale, or transfer of the Class A Units. Subscriber's subscription and payment for and continued beneficial ownership of the Class A Units will not violate any applicable securities or other laws of the Subscriber's jurisdiction.

e) Restrictions on Transfer or Sale of Securities.

- i. The Subscriber is acquiring the Class A Units solely for the Subscriber's own beneficial account, for investment purposes, and not with a view to, or for resale in connection with, any distribution of the Class A Units. The Subscriber understands that the Class A Units have not been registered under the Securities Act or any State Securities Laws by reason of specific exemptions under the provisions thereof which depend in part upon the investment intent of the Subscriber and of the other representations made by the Subscriber in this Agreement. The Subscriber understands that the Company is relying upon the representations and agreements contained in this Agreement (and any supplemental information) for the purpose of determining whether this transaction meets the requirements for such exemptions.
- ii. The Subscriber understands that the Class A Units are restricted from transfer for a period of time under applicable federal securities laws and that the Securities Act and the rules of the U.S. Securities and Exchange Commission (the "**Commission**") provide in substance that the Subscriber may dispose of the Class A Units only pursuant to an effective registration statement under the Securities Act, an exemption therefrom or as further described in Rule 501 of Regulation CF, after which certain state restrictions may apply.

- b) **Target Amount.** Prior to the offering deadline specified in the Form C, the Company shall have received aggregate subscriptions for the Class A Units in an aggregate investment amount of at least the Target Offering Amount specified in the Form C and at the time of the first Closing, the Company shall have received into the escrow account established with the Escrow Facilitator in cleared funds, and is accepting, subscriptions for the Class A Units having an aggregate investment amount of at least the Target Offering Amount specified in the Form C.

8. **OBLIGATIONS IRREVOCABLE.** Following the respective Closing Date, the obligations of the Subscriber shall be irrevocable.

9. **LEGEND.** The certificates, book entry or other form of notation representing the Securities sold pursuant to this Agreement will be notated with a legend or designation, which communicates in some manner that the Securities were issued pursuant to Section 4(a)(6) of the Securities Act and may only be resold pursuant to Rule 501 of Regulation CF.

10. **WAIVER, AMENDMENT.** Neither this Agreement nor any provisions hereof shall be modified, changed, discharged or terminated except by an instrument in writing, signed by the party against whom any waiver, change, discharge or termination is sought.

11. **ASSIGNABILITY.** Neither this Agreement nor any right, remedy, obligation or liability arising hereunder or by reason hereof shall be assignable by either the Company or the Subscriber without the prior written consent of the other party.

13. **DISPUTE RESOLUTION; ARBITRATION.** Any dispute, controversy or claim arising out of, relating to or in connection with this instrument, including the breach or validity thereof, shall be determined by final and binding arbitration administered by the American Arbitration Association (the “AAA”) under its Commercial Arbitration Rules and Mediation Procedures (“*Commercial Rules*”). The award rendered by the arbitrator shall be final, non-appealable and binding on the parties and may be entered and enforced in any court having jurisdiction. There shall be one arbitrator agreed to by parties within twenty (20) days of

receipt by respondent of the request for arbitration or, in default thereof, appointed by the AAA in accordance with its Commercial Rules. The place of arbitration shall be Delaware. Except as may be required by law or to protect legal rights, neither a party nor the arbitrator may disclose the existence, content, or results of any arbitration without the prior written consent of the other parties.

14. **GOVERNING LAW.** This Agreement shall be governed by and construed in accordance with the laws of Delaware, without regard to conflict of law principles thereof.

15. **SECTION AND OTHER HEADINGS.** The section and other headings contained in this Agreement are for reference purposes only and shall not affect the meaning or interpretation of this Agreement.

16. **COUNTERPARTS.** This Agreement may be executed in any number of counterparts, each of which when so executed and delivered shall be deemed to be an original and all of which together shall be deemed to be one and the same agreement.

17. **NOTICES.** All notices and other communications provided for herein shall be in writing and shall be deemed to have been duly given if delivered personally or sent by registered or certified mail, return receipt requested, postage prepaid or email to the following addresses (or such other address as either party shall have specified by notice in writing to the other):

19. **SURVIVAL.** All representations, warranties and covenants contained in this Agreement shall survive (i) the acceptance of the subscription by the Company, (ii) changes in the transactions, documents and instruments described in the Form C which are not material, or which are to the benefit of the Subscriber and (iii) the death or disability of the Subscriber.

## MASTER PLAYER AGREEMENT

This Master Player Agreement (“Agreement”) is entered into as of August 12, 2024 by and between Greene Nation LLC (“Issuer”), on the one hand, and Mason Greene (“Player”) on the other hand. Each of Player and Issuer are also referred to herein as a “Party” and together as the “Parties.”

### RECITALS

WHEREAS, Issuer has engaged ALAO Invest LLC to serve as an intermediary in connection with Issuer’s offering of securities under Regulation Crowdfunding (the “Offering”), wherein investors may purchase membership interests in Issuer representing their indirect interest in the Issuer’s rights under this Agreement;

WHEREAS, Issuer desires to finance up to \$225,000 of certain Approved Expenses (as defined below) for the benefit of Player’s professional development and career prospects in consideration for an interest in Player Revenue (as defined below), using the net proceeds of the Offering, all pursuant to the terms and conditions of this Agreement; and

WHEREAS, Player desires to assign to Issuer an interest in certain Player Revenue pursuant to the terms and conditions of this Agreement for the Initial Term (as defined below) of six (6) years.

NOW THEREFORE, in consideration of good and valuable consideration as set forth in this Agreement, the Parties do hereby agree as follows:

#### 1. Defined Terms.

The following terms have the meanings specified or referred to in this Section 1:

“Affiliate” means, with respect to any specified Person, any Person that directly or indirectly Controls, or is under common Control with, or is Controlled by, such specified Person.

“Agreement” means this Master Player Agreement, together with all exhibits, schedules and related documents attached hereto or referenced herein, including:

Exhibit A: Standard Terms and Conditions;

Exhibit B: Closing Certificate.

“Approved Expenses” means: (a) travel and lodging, including airfare, car rental, hotels, and meals, during tournament travel; (b) fixed caddie fees during tournament weeks, not inclusive of purse share; (c) tournament costs, including entry fees, yardage books, range balls, and other miscellaneous pecuniary expenses directly related to such tournament; (d) coaching; (e) physical fitness; (f) insurance; (g) club membership dues (base rate only, no incidentals), and (h) equipment and training aids (which must be commercially reasonable).

“Closing” has the meaning set forth in Section 2.1.

“Contract” means any contract, commitment, or other arrangement or understanding (and all amendments and supplements thereto), whether written or oral.

“Control” (including, with its correlative meanings, “Controlled by” and “under common Control with”) means possession, directly or indirectly, of power to direct or cause the direction of management or policies (whether through ownership of securities or partnership or other ownership interests, by contract or otherwise).

“Effective Date” means the date of the initial Closing of the Issuer’s Offering.

“Excluded Income” means as described on Schedule 1 attached to this Agreement.

“FINRA” means the Financial Industry Regulatory Authority, Inc.

“Gross Monies” means any and all gross monies paid to Player, and/or received by Player or Player’s heirs, executors, administrators or assigns, or by any other Person on Player’s behalf, including, without limitation, an Affiliate, for winnings in any Tour as a Professional Athlete.

“Gross Proceeds” means an amount equal to the gross cash proceeds received by Issuer resulting from the Offering.

“Holding Bank Account” means such segregated bank account maintained by Issuer in which the Player Funds are deposited.

“Initial Term” means a term of six (6) years beginning on the Effective Date; provided that, should the Maximum Offering Amount not be raised in the Offering, then the Initial Term shall equal a number of years equal to: Gross Proceeds, divided by Maximum Offering Amount, multiplied by six (6). *For illustration purposes only, if the Gross Proceeds are \$100,000, and the Maximum Offering Amount is \$200,000, then the Initial Term would equal  $(100,000/200,000)*6$ , or three (3) years.*

“Intermediary” means ALAO Invest LLC, a funding portal member of FINRA, registered with the SEC.

“Major Injury” means any injury, illness or medical condition sustained or incurred after the initial Closing.

“Nonrecurring Player Revenue” means the Player Revenue payable to Player under any Player Revenue Contract pursuant to which Player is only entitled to receive a single payment under such Player Revenue Contract.

“Offering” means an offering of the Issuer to the public under Section 4(a)(6) of the Securities Act, pursuant to the Offering Statement.

“Offering Statement” means an offering statement for the Issuer on Form C filed with the SEC.

“On-Course Revenue” means any and all Gross Monies paid to Player, and/or received by Player or Player’s heirs, executors, administrators or assigns, or by any other Person on Player’s behalf, including, without limitation, an Affiliate, for winnings in any Tournament, or revenue generated from any Tour, as a Professional Athlete.

“Paydown Amount” means an amount equal to two times (2x) the amount of funds disbursed as of such date and time from the Holding Bank Account to pay Approved Expenses.

“Percentage” shall mean:

- (a) 10%, with respect to PGA Tour;
- (b) 10%, with respect to LIV Golf men’s golf tour;
- (c) 20%, with respect to DP World Tour;
- (d) 25%, with respect to Korn Ferry Tour;
- (e) 30%, with respect to PGA Tour Americas;
- (f) 30%, with respect to Challenge Tour; and
- (g) 30%, with respect to all other tournaments.

Player may, however, opt-into the following Reduced Tier Percentage schedule by paying the Paydown Amount (defined below) and pursuant to the terms of Section 4.1 of the Terms and Conditions:

- (a) 2%, provided that less than \$50,000 has been used for Approved Expenses;
- (b) 4%, provided that between \$50,000 and \$149,999 has been used for Approved Expenses; and
- (c) 5%, provided that \$150,000 or more has been used for Approved Expenses.

“Player” has the meaning set forth in the preamble to this Agreement.



“Player Funds” means an amount equal to 100% of the Gross Proceeds of the Offering less Offering expenses, Reserves, and Intermediary compensation.

“Player Obligation” means an amount equal to the product obtained by multiplying (a) any and all Player Revenue earned by Player (whether or not contracted or paid through any third party for or on behalf of Player, such as a personal services corporation, agency, or otherwise) during the Term by (b) the applicable Percentage.

“Player Obligation Cap” means an amount equal to five (5) times the value of the Player Funds.

“Player’s Persona” means Player’s name, voice, likeness, image, caricature, biography, signature (including facsimile signature), personal talents, or live, photographed or recorded performance.

“Player Revenue” means an amount equal to any and all Touring Revenue, other than Excluded Income, payable to Player (or any Affiliate of Player) after the Effective Date as a result of Player’s performance in any Tour. For the avoidance of doubt, this includes appearance fees, bonuses, bonus pools, and any Touring Revenue even if not paid in cash as a result of a credit against the prior Earnings Assurance Program payment.

“Player Revenue Contract” means any Contract to which Player is compensated or becomes a party that is compensated, or under which Player is obligated to perform and is compensated, or from which Player receives any benefit, and in each case which is on a Tour and is compensated, other than Contracts excluded in their entirety (if any).

“Party” and “Parties” has the meaning set forth in the preamble to this Agreement.

“Person” means any individual, corporation, company, voluntary association, partnership, limited liability company, joint venture, trust, unincorporated organization or government (or any agency, instrumentality or political subdivision thereof).

“Personal Information Schedule” refers to the schedule of information provided by Player to Issuer in a separate document to this Agreement as of the Effective Date.

“Principal Business” means the sport played by the Player, at the professional, college or other level, regardless of the country in which it is played or the league, association or other governing body as applicable, or other profession of the Player pursuant to which the Player’s Player Revenue is derived.

“Professional Athlete” means a professional golfer.

“Remaining Player Funds” means Player Funds in the Holding Bank Account.

“Remaining Term” means the Term less the time elapsed from the Effective Date through the date of Early Retirement.

“Reserves” means funds set aside by the Issuer to cover anticipated and unforeseen Issuer operating expenses, which may include, but are not limited to, administrative costs, accounting fees, banking charges, legal fees, taxes, and any other costs necessary for the maintenance and operation of Issuer.

“SEC” means the United States Securities and Exchange Commission.

“Securities Act” means the United States Securities Act of 1933, as amended, and the rules and regulations promulgated thereunder.

“Target Offering Amount” means an offering target of \$72,000 the same definition as in the Offering’s Form C.

“Term” has the meaning set forth in Section 5.

“Termination Date” has the meaning set forth in Section 4.

“Terms and Conditions” means the Master Player Agreement Standard Terms and Conditions in the form attached to this Agreement as Exhibit A.

“Tour” refers to the series of Tournaments that Professional Athletes participate in throughout the year, which include but shall not be limited to the PGA Tour, LIV Golf League, DP World Tour, Korn Ferry Tour, PGA Tour Americas, Challenge Tour, PGA Tour Champions, PGA Tour China, National Team Competitions (Ryder Cup, Presidents Cup), any professional Tour, any “exhibition event”, or any other tournament wherein Player is acting in the capacity of a Professional Athlete.

“Touring Revenue” means any and all On-Course Revenue plus Gross Monies paid to Player, and/or received by Player or Player’s heirs, executors, administrators or assigns, or by any other Person on Player’s behalf, including, without limitation, an Affiliate, from organizing body of the Tour(s), for Player’s performance in such Tour(s), such as bonus pools (e.g., FedEx Cup, Race to Dubai), ranking bonuses, and performance incentives (e.g., PIP, Comcast Business).

“Tournament” means any activities related to any Tour or any other tournament wherein Player is acting in the capacity of a Professional Athlete. For avoidance of doubt, this includes the Majors (Masters, US Open, Open Championship, PGA Championship) and unaffiliated events.

### **1. Offering.**

**1.1.** Subject to the terms and conditions of this Agreement, Issuer will use commercially reasonable efforts to conduct the Offering as promptly as practicable after the execution of this Agreement.

**1.2.** Upon written request from Player from time to time after the commencement of the Offering, Issuer shall provide to Player reasonable information regarding the progress of the Offering.

### **2. Closing.**

**2.1.** Each interim closing of the Offering, if applicable, and the final consummation of the Offering (each, a “Closing”) shall occur on such dates as shall be reasonably determined by Issuer.

**2.2.** Upon each Closing, Player will execute and provide to Issuer a written certification in the form attached as Exhibit B.

### **3. Player Obligation; Assignment for Security.**

**3.1.** Player shall pay to Issuer an amount of cash equal to the Player Obligation, subject and pursuant to the terms of Section 4.1 of the Terms and Conditions. To secure Issuer’s right to receive the payment equal to the Player Obligation, to the maximum extent permitted under applicable law in effect from time to time, Player hereby assigns (as and when earned), or will assign when Player has an assignable interest in any future Player Obligations, to Issuer, all right, title and interest in and to the Player Obligation. Player agrees to have all Player Obligations wire deposited into the wire account specified by Issuer.

**3.2.** Installments of the Player Obligation shall be received by Player as agent for Issuer, and Player shall pay and deliver such installments of the Player Obligation to Issuer promptly after the receipt of the corresponding Player Revenue by Player (but in no event later than the fifteenth (15th) day following the receipt of such Player Revenue) pursuant to the timing and other terms as set forth in Section 4.1 of the Terms and Conditions.

### **4. Term of Agreement.**

**4.1.** The term of this Agreement shall commence as of the Effective Date and shall continue until the earlier of: (i) Player’s retirement as a Professional Athlete, (ii) the expiration of the Term, or (iii) Issuer’s receipt of the Player Obligation in an amount equal to the Player Obligation Cap. Notwithstanding the foregoing, should Player, for any reason, be unable to compete for a period of ninety (90) days or more (where any such period of time is referred to herein as the (“Absence Period”), the Initial Term shall be extended by any such Absence Period(s) (the Initial Term, together with the Absence Period(s), referred to herein as the “Term”).

4.2. If Player at any time prior to the expiration or termination of the Term provides notice of their voluntary resignation from participation as a Professional Athlete, or if the Player has not accessed Player Funds nor earned Player Revenue for a period of 12 consecutive months without providing notice of retirement or an Absence Period, the Player shall be deemed to have voluntarily resigned from participation as a Professional Athlete, (“Early Retirement”).

4.3. In the event of Early Retirement, Issuer shall return Remaining Player Funds to Class A Members of the Issuer no later than thirty (30) days following the notice or triggering of Early Retirement. If the Player subsequently returns as a Professional Athlete and earns any Player Revenue, the Remaining Term will resume from the first date Player earns Player Revenue.

## **5. Limited Player Revenue Encumbrances.**

5.1. Without Issuer’s prior written approval, Player shall not enter into any other arrangement similar to this Agreement (i.e., pursuant to which Player receives compensation in exchange for a portion of Player’s future Player Revenue) with respect to any portion of the Player Revenue.

5.2. During the Term, Player shall maintain a competitive schedule with the goal of achieving and maintaining Tour status. Player shall schedule and participate in Tournaments, training, and related activities aimed at reaching this goal. The Player’s schedule, progress, and performance strategies shall be discussed and reviewed in quarterly meetings with the Issuer Parties, in accordance with Section 5.1 of the Terms and Conditions, and Player will make reasonable efforts to implement any necessary schedule and performance adjustments addressed in such quarterly meetings in an effort to achieve the aforementioned goal.

5.3. All notices, requests, consents and other communications required or given by the Parties hereunder shall be in writing and shall be deemed to be delivered to the addresses of the applicable Party set forth below:

All proceeds paid to Player or the heirs, executors, administrators, successors and assigns of Player solely with respect to any life, disability, or injury insurance policy or any insurance policy pertaining to and/or corresponding income designation, purchased by Player after the Effective Date.
2. All compensation prior to the Effective Date regardless as to when such compensation is paid.
3. All compensation from non-Tour activities, including, but not limited to, sponsorships and endorsements, non-Tournament appearance fees, and merchandising and licensing deals.
4. All advances to Players through the PGA Tour's Earnings Assurance Program. However, any Touring Revenue earned by Player will not be excluded even if earnings are cashless as a result of credit against the prior Earnings Assurance Program payment.

## **Exhibit A**

### **Master Player Agreement Standard Terms and Conditions**

#### **1. General; Definitions; Interpretation.**

These Master Player Agreement Standard Terms and Conditions (these “Terms and Conditions”) are incorporated by reference into and made a part of that certain Player Agreement between Issuer and Player to which it is attached (the “Agreement”). Capitalized terms used in these Terms and Conditions and not otherwise defined herein, shall have the meaning set forth in the Agreement. In the event of any inconsistency or conflict between these Terms and Conditions and the Agreement to which these Terms and Conditions are attached, the terms of the Agreement shall govern.

#### **2. Offering.**

**2.1. Offering.** Issuer will use commercially reasonable efforts to conduct the Offering as promptly as practicable after the execution of the Agreement. In connection with such Offering, Player recognizes that Issuer shall have the sole and exclusive right to (and to authorize any other Person to) promote and offer for sale its membership interests in connection with the Offering.

**2.2. Further Assurances; Credit Report Consent.** Player shall reasonably cooperate with Issuer, upon Issuer’s specific request, in connection with the offering, marketing and sales of the Offering and the interests; provided, that any such cooperation that would require any personal services on the part of Player shall be at times and for durations mutually agreed to by Issuer and Player; provided further, that any such personal services in the form of a personal appearance by Player shall be on terms mutually agreed to by Issuer and Player. Player hereby consents to Issuer and its agents or representatives (i) obtaining reports of Player’s credit records from time to time throughout the Term of this Agreement (as reasonably determined by Issuer and at Issuer’s sole cost and expense). and (ii) using the information from that report in connection with any due diligence related to Player and the Offering, and reporting obligations under applicable law. Upon request by Player, Issuer shall provide to Player a copy of any report of Player’s credit records that is received by Issuer.

**2.3. Player Name and Likeness.** Issuer shall have the non-exclusive, irrevocable, fully paid, worldwide right to use and to authorize other Persons, as determined by Issuer, in its reasonable discretion, to use Player’s Persona from the date of execution of this Agreement, in accordance with the terms and conditions set forth herein, until the termination of this Agreement through any and all distribution channels in connection with its performance under the Agreement.

#### **2.4. Player Restrictions.**

(i) **No Assignment of Similar Rights.** Player has not and will not assign or grant to any other Person rights to receive a portion of Player Revenue other than (a) as may be granted in the ordinary course of pursuing activities in the Principal Business (such as commissions payable to an agent, marketing representative, or financial advisors or legal fees paid to an attorney); (b) in a manner that will not conflict with the rights granted to Issuer, or the obligations of Player, hereunder with respect to any installment payment of the Player Obligation, and (c) in an amount that would not violate any other terms of this Agreement.

#### **3. Player Funds; Approved Expense Coverage.**

**3.1. Payment of Player Funds.** Within fifteen (15) days after each Closing of the Offering, Issuer shall deposit into the Holding Bank Account the Player Funds (and less any fees charged by any third party in connection with such transfer, such as bank fees).

**3.2. Approved Expense Coverage.** Player may utilize the funds of the Holding Bank Account from time to time, in his sole discretion, provided that such funds are utilized solely and exclusively for Approved Expenses.

#### **4. Player Obligation.**

##### **4.1. Payment Terms.**

(i) **Payment of Player Obligation; Timing.** Upon receipt of Player Revenue, Player will deliver such portion of the Player Obligation to Issuer as and when (or as promptly as practicable after) corresponding Player Revenue is received by Player; *provided, however*, that in no case shall any Player Obligation be delivered to Issuer later than seven (7) business days after the end of each calendar month in which funds were received by Player (or any other Person on behalf of Player) during the Term.

(iii) **Payment of the Paydown Amount.** Player, in its sole discretion, may elect to pay Issuer the Paydown Amount, in whole, at any time prior to the expiration or termination of the Term of the Agreement. In connection with such election, Player shall provide Issuer with written notice of such election, in accordance with Section 5.3 of the Agreement, describing (i) the intended effective date of the new Percentage, (ii) the amount of funds disbursed from the Holding Bank Account to specifically pay for Player's Approved Expenses as of such effective date; and (iii) the Paydown Amount, which, in addition to being specified, shall be delivered to Issuer no later than such effective date, in accordance with Section 4.1(iv) herein.

(iv) **Wire Transfer.** Except as otherwise approved by Issuer in writing, each installment payment of the Player Obligation, and the Paydown Amount, if applicable, shall be made via wire transfer pursuant to the wire transfer instructions provided by Issuer to Player in writing, as may be updated by Issuer from time to time; provided, however, that to the extent that any individual installment payment of the Player Obligation is less than \$500, such amount may be paid via check.

##### **4.2. Branding and Logo Placement:**

(i) The Intermediary shall have the primary logo placement on the athlete's hat. This placement is reserved for the Intermediary unless the athlete has a hat sponsor at the time of signing this agreement or the location is sold to a third-party sponsor, as provided below. In such case, the Intermediary's logo will be relocated to the next available prime location, in order of priority, i. Left Chest ii. Right Chest iii. Right Sleeve iv. Left Sleeve.

(ii) For each "sold" placement that necessitates the demotion or relocation of the Intermediary's logo, the third-party sponsor must pay at-minimum a specified dollar amount for the desired logo position, as follow:

Left Chest: \$50,000	Left Chest: \$25,000	Left Chest: \$15,000

Right Sleeve: \$40,000	Right Sleeve: \$20,000	Right Sleeve: \$10,000

(iii) The Intermediary shall have a significant presence on the athlete's golf bag. If Player uses a carry bag/stand bag on tour, the Intermediary's logo and branding will occupy the ball packet. If a third-party sponsor purchases the ball pocket placement on the carry bag/stand bag, for a minimum of \$10,000, the Intermediary's logo can be placed in the bottom third of the full-length apparel pocket. If Player uses a staff bag on tour, the Intermediary's logo and branding will occupy the lower 1/3 of the belly of the staff bag. These placements are to ensure visibility during tournaments and events.

**4.3. Social Media Reposting.** If the Intermediary or its affiliate posts content related to the Player on any social media platform, the Player agrees to repost the content on their own social media accounts within 1 day of notification by the Intermediary or its affiliate. The Player may make minor modifications to the reposted content, such as adding personal captions or tags, provided these do not alter the original message or intent of the Intermediary or affiliate's post. Both parties agree to cooperate in good faith to ensure that the content is reposted in a manner consistent with their respective branding and public image.



#### **4.4. Additional Provisions.**

(i) In the event that any payment due to Issuer hereunder is not paid in full by the applicable date due (unless there is a cure period, then by the date the cure period ends), then, without limiting any other rights or remedies of Issuer, Player shall also pay to Issuer interest on such amount at the rate of the lesser of (a) the then current prime rate (as reported in the Wall Street Journal) plus three percent (3%) per year, compounded monthly, or (b) the maximum rate permitted by applicable law, measured from the later of: (A) the date such amount became past due, or (B) expiration of the cure period, until it is fully paid.

(ii) Player acknowledges and agrees that Issuer may disclose to the public any material breach by Player of this Agreement, including any intentional failure of Player to pay any amounts as and when due hereunder (subject to applicable notice and cure periods contained herein), including reporting such material breach to a credit bureau; provided that, Issuer covenants and agrees not to make any such disclosure without first notifying Player in writing and giving Player a reasonable amount of time to cure such breach which shall be no less than ten (10) days, except that no such cure period is required in the event of at least two prior instances of a similar breach (with such notice provided in each instance) during the 12-month period prior to such breach.

**4.5. Records.** Player shall, and shall cause its Affiliates to, maintain (until at least twelve months after termination of this Agreement), records of all Player Revenue Contracts, receipts, invoices, reports and other documents relating to the Player Revenue, Player Obligation, the Holding Bank Account, and Approved Expenses for at least the then-current year and previous two (2) calendar years (or such longer period as may be required by law); provided that, the foregoing obligation shall not apply to any time period prior to the Effective Date

**4.6. Audit Rights.** Commencing upon the Effective Date and continuing through the date that is twelve (12) months after termination of this Agreement (“Audit Period”), Issuer or its authorized representatives, including CMNWLTH Services, LLC (the “Issuer Parties”) shall have the right to inspect and make copies of the books and records of Player (and its Affiliates) relating to the Player Revenue Contracts, the Player Revenue, Player Obligation, the Holding Bank Account, and Approved Expenses. Such audit shall not cover any period greater than the current year and previous two (2) calendar years at the time of such audit, *provided* that, if an audit reveals (i) an underpayment of the Player Obligation by greater than five percent (5%) for the period being audited, or (ii) an unauthorized use of the Holding Bank Account funds for a non-Approved Expense in an amount greater than five hundred dollars (\$500) for the period being audited, then, either (a) Player shall promptly pay to Issuer any underpaid amount, together with any interest thereon as provided in Section 4.2(ii) of these Terms and Conditions, (b) Issuer shall promptly pay to Player any overpaid amount together with interest at the same rate provided in Section 4.2(ii) of these Terms and Conditions, provided that, at Player’s sole and exclusive election, Player may set off against the immediately following installment payment of the Player Obligation an amount equal to such overpayment; or (c) Player shall reimburse the Holding Bank Account in the amount of any unauthorized use of the Holding Bank Account funds for a non-Approved Expense. The Issuer Parties shall have the sole discretion to audit Player’s books, bank accounts, and records up to two (2) times per year during the Audit Period. Issuer shall provide Player with reasonable advance written notice which shall be no less than seventy-two (72) hours that it will be conducting an audit, and any such audit shall be conducted during normal business hours.

#### **5. Information Rights; New Contracts.**

##### **5.1. Information Rights.**

(i) **Monthly Statements.** Within five (5) business days after the end of each calendar month during the Term, Player and/or its Affiliates shall provide the Issuer Parties a report, prepared in accordance with a template provided by the Issuer Parties, which shall detail all Approved Expenses and the associated Holding Bank Account transactions. Player shall additionally provide the corresponding records and receipts of such Approved Expenses, and bank transactions, upon the request of the Issuer Parties.

(ii) **Quarterly Reports and Meeting.** Within ten (10) business days after the end of each calendar quarter during the Term, Player and/or its Affiliates shall provide to the Issuer Parties a report in the form mutually agreed by the Parties with such template prepared and provided by the Issuer Parties (each a “Quarterly Report”), which shall detail all Player Revenue earned during such quarter, detail the calculation of the Player Obligation for such quarter with respect to such Player Revenue, and provide such additional information and certifications required to be included in the Quarterly Report, as required by the Issuer Parties. Player and the Issuer Parties will also have a Quarterly Meeting to discuss certain business matters in preparation for the subsequent quarter.

**5.2. Material Change.** If at any time after the Effective Date and during the Term of this Agreement, there occurs any condition, restriction, disability or obligation (whether physical, legal, or contractual) that will or could reasonably be expected to (i) prevent or materially interfere with Player’s continued performance under any Player Revenue Contract and/or participation in the Principal Business as a Professional Athlete, (ii) result in any of the representations or warranties made by the Player in the Agreement to be untrue in any material respect; provided that, Player shall not have any obligation to notify Issuer of the contents of any Player Revenue Contract provided by Player to Issuer, including the expiration of any contract pursuant to its terms.

**5.3. Player Revenue Contracts.** Throughout the Term, Player shall promptly (and in any case, no later than five (5) business days after the occurrence of the applicable event, and prior to any public announcement thereof) notify Issuer, in writing, and provide copies of all relevant documents and correspondence related to each such occurrence (including copies of all Player Revenue Contracts), in the event that:

(i) Player enters into any Player Revenue Contract, including any amendments, modifications or supplements to an existing Player Revenue Contract, after the Effective Date (“New Player Revenue Contract”);

(ii) Player receives any notice of termination, cancellation, breach or default under any Player Revenue Contract;

(iii) Player becomes aware of any event which, with the passage of time or the giving of notice or both, would result in any material default, breach or event of noncompliance by Player under any Player Revenue Contract;

(iv) Player becomes aware that any other party to any Player Revenue Contract is in material breach thereof or default thereunder; or

(v) There are any renegotiations of or outstanding rights to renegotiate any material amounts paid or payable to Player under any of the Player Revenue Contracts with any Person, or Player receives any demand or request for such renegotiation.

**5.4. New Player Revenue Contracts.** Upon the execution of a New Player Revenue Contract, Player shall be deemed to represent and warrant that such New Player Revenue Contract is valid, binding and enforceable against Player, and enforceable by Player against the other parties thereto, in accordance with their respective terms, subject to the effect of any applicable bankruptcy, reorganization, insolvency, moratorium or similar laws affecting creditors’ rights generally, and subject, as to enforceability, to the effect of general principles of equity, as may apply.

**5.5. Disclosure of Player Revenue Contracts.**

(i) Notwithstanding anything herein to the contrary, Issuer may publicly disclose the terms and conditions of any New Player Revenue Contract, to the extent such disclosure is required in connection with any filing related to the Offering, as reasonably determined by Issuer upon advice of counsel in connection with such disclosure, and such disclosure does not violate any confidentiality provisions contained in such New Player Revenue Contract.

(ii) Player shall use reasonable efforts to cause each counterparty to a Player Revenue Contract containing a legal, valid and binding confidentiality obligation of Player existing as of the Effective Date (each, a “Confidential Player Revenue Contract”), to consent to Issuer’s disclosure of the terms and conditions of such Confidential Player Revenue Contract to the extent required by any governmental or quasi-governmental bodies or agencies, or self-regulatory organizations, including the SEC and FINRA; provided, that Issuer shall not make any disclosure of any terms or conditions of such an existing Confidential Player Revenue Contract if such counterparty fails to so consent; provided further, that failure to obtain a counterparty’s consent with respect to an existing Confidential Player Revenue Contract shall not in itself be a breach of this Agreement by Player so long as Player has complied with the terms of this paragraph. Player shall use reasonable efforts to ensure that any necessary consents to permit disclosure of each New Player Revenue Contract (subject to the terms and conditions of Section 6.5(i) herein) are obtained so that such disclosure will not result in any breach of any confidentiality obligation to any Person.

(iii) Issuer shall, in consultation with Player, use best efforts to secure confidential treatment, or similar protection, with respect to any disclosure of any information contained in any New Player Revenue Contract which could reasonably be expected to be sensitive to, or the confidential information of, any counterparty to such New Player Revenue Contract.

(iv) Player may decide in its sole, exclusive, and absolute discretion whether or not to execute any potential Player Revenue Contract (or any renewal of a Player Revenue Contract).

**5.6. Player Revenue Statements.** Concurrent with delivery of each Quarterly Report (as required by Section 5.1 of these Terms and Conditions), Player shall also provide copies of all receipts, invoices, pay stubs, or other documents evidencing all Player Revenue referenced in the applicable Quarterly Report.

**5.7. Marital Status.** If a portion of the Player Revenue of Player is deemed “community property” or Player’s spouse can otherwise claim legal ownership to any Player Revenue, then Player shall nonetheless be required to calculate and deliver any installment payments of the Player Obligation based on the entirety of the Player Revenue (including any such portion thereof that is deemed to be such spouse’s share of community property or otherwise property of such spouse).

**5.8. Additional Information.** Player shall provide to Issuer such additional information as Issuer shall reasonably request from time to time (in a reasonable amount of time after such request) in connection with the Player Revenue and Player’s participation in the Principal Business; provided, that Issuer shall use commercially reasonable efforts to limit any such requests to no more than once per calendar quarter.

## **6. Taxes.**

**6.1. Related to the Player Funds.** Player shall be solely responsible for the payment of all taxes on the Player Funds payable to Player in connection with the Approved Expenses. Issuer shall be entitled to deduct and withhold any amounts required by applicable law to be deducted and withheld from the Player Funds, should such requirement arise, and such withheld amounts shall be treated as paid to Player. Issuer shall not be required to indemnify or “gross up” Player for any such amounts withheld. Player will indemnify Issuer for and hold it harmless from and against any taxes of Player, which may be sought against, imposed upon or suffered by Issuer or which Issuer may incur as a result of Issuer’s failure to deduct and withhold such taxes from the Player Funds payable under this Agreement.

**6.2. Related to Player Obligations.** Issuer shall be solely responsible for the payment of all taxes on the Player Obligations. Player shall be entitled to deduct and withhold any amounts required by applicable law to be deducted and withheld from any installment payment of the Player Obligation. Player shall not be required to indemnify or “gross up” Issuer for any such amounts withheld. Issuer will indemnify Player for and hold it harmless from and against any taxes of Issuer which may be sought against, imposed upon or suffered by Player or which Player may incur as a result of Player’s failure to deduct and withhold such taxes from any installment payment of the Player Obligation to be delivered under this Agreement.

**7. Player Representations and Warranties.** Player hereby represents, warrants and covenants, as applicable, to Issuer that the statements contained in the Agreement, including in this Section 7, are and will be true and correct as of the Effective Date and throughout the Term (except only if a different time period is expressly provided).

**7.1. Organization.** Player is duly incorporated, validly existing and in good standing under the laws of the State of Delaware.

**7.2. Authority.** Player possesses all requisite corporate power and authority necessary to enter into and carry out the transactions contemplated by this Agreement. Player, furthermore, is free and authorized to enter into this Agreement, to make the covenants, representations and warranties contained herein and to grant the rights granted herein.

**7.3. Binding Agreement.** This Agreement constitutes a valid and binding obligation of Player (and its successors and heirs), enforceable in accordance with its terms subject to the effect of any applicable bankruptcy, reorganization, insolvency, moratorium or similar laws affecting creditors' rights generally, and subject, as to enforceability, to the effect of general principles of equity, as may apply. Player and its successors and heirs, as applicable, will not challenge the validity or enforceability of this Agreement, or any portion thereof, in any action, proceeding, arbitration or otherwise.

**7.4. No Conflict.** Player has not made nor will make any grant, license or assignment whatsoever, which will or could reasonably be expected to conflict with or impair the substantial enjoyment of the rights and privileges granted to Issuer hereunder; and, the execution and performance of this Agreement by Player does not, and will not, violate or conflict with any agreement, arrangement, understanding or restriction, written or oral, between Player and any other Person.

**7.5. Brokerage.** Except as expressly contemplated by this Agreement, there are no claims for brokerage commissions, finders' fees or similar compensation in connection with the transactions contemplated by this Agreement based on any contract to which Player is a party or that is otherwise binding upon Player.

**7.6. Intellectual Property.** No intellectual property provided by Player to Issuer at any time in connection with this Agreement will violate the rights of privacy or publicity, constitute a libel or slander or infringe upon the copyright, literary, personal, private, civil, property or other rights of any Person.

**8. Issuer Representations and Warranties.** Issuer represents, warrants and covenants, as applicable, to Player, as of the Effective Date and throughout the Term:

**8.1. Organization.** Issuer is duly incorporated, validly existing and in good standing under the laws of the State of Delaware.

**8.2. Authority.** Issuer possesses all requisite corporate power and authority necessary to enter into and carry out the transactions contemplated by this Agreement.

**8.3. Binding Agreement.** This Agreement constitutes a valid and binding obligation of Issuer, enforceable in accordance with its terms subject to the effect of any applicable bankruptcy, reorganization, insolvency, moratorium or similar laws affecting creditors' rights generally, and subject, as to enforceability, to the effect of general principles of equity, as may apply. Issuer will not challenge the validity or enforceability of this Agreement, or any portion thereof, in any action, proceeding, arbitration or otherwise.

**8.4. No Conflict.** The execution and performance of this Agreement by Issuer does not, and will not, violate or conflict with any agreement, arrangement, understanding or restriction, written or oral, between Issuer and any other Person.

**8.5. Brokerage.** Except as expressly contemplated by this Agreement, there are no claims for brokerage commissions, finders' fees or similar compensation in connection with the transactions contemplated by this Agreement based on any contract to which Issuer is a party or that is otherwise binding upon Issuer.

## **9. Confidentiality; Public Statements/Disclosures.**

**9.1. Confidentiality.** Each Party agrees that the Confidential Information of the other Party will be maintained confidentially and will not be disclosed to any other Person except: (a) as may be required by law or to comply with a valid order of a court of competent jurisdiction, in which event the Party making such disclosure shall promptly notify the other Party and shall seek confidential treatment of such information; (b) to a Party's employees, agents and representatives (including accountants, auditors, legal advisors, underwriters, etc.), provided that such recipients of the Confidential Information are bound by confidentiality obligations with respect to such disclosure; (c) in order to enforce such Party's rights under this Agreement; or (d) if mutually agreed to by the Parties in writing or otherwise permitted under this Agreement. "**Confidential Information**" means all confidential, proprietary, or commercially sensitive data, materials and/or other information that is either identified as, or reasonably expected to be, confidential information. Confidential Information includes non-public information in connection with the Offering, Player, or Issuer or its Affiliates. This Section 9.1 shall survive the expiration or termination of this Agreement.

**9.2. Issuer Disclosures.** Notwithstanding anything herein to the contrary, Issuer shall have the right to disclose the terms and conditions of this Agreement and/or any other information provided by Player related to this Agreement or the Offering (including Player Revenue Contracts, subject to Section 6.5 of these Terms and Conditions), to the extent that such disclosure is required by applicable law in connection with any filing related to the Offering. Issuer shall, in consultation with Player, use best efforts to secure confidential treatment, or similar protection, with respect to any disclosure of personal and confidential information provided by Player, including the terms and conditions of this Agreement and such information as is provided in the Personal Information Schedule.

**10. Follow-On Offerings.** Following the initial Offering, Issuer reserves the right, in its sole and absolute discretion, to offer additional securities, whether by way of an offering pursuant to Regulation Crowdfunding or another offering exempt from registration pursuant to the Securities Act (a "**Follow-On Offering**"). Any such Follow-On Offering will be subject to the same terms and conditions as the Offering, including the payment of the Player Funds to the Player.

## **11. Termination.**

**11.1. Conclusion of Term.** Upon the expiration or termination of the Term, this Agreement shall terminate, subject to Section 11.3 of these Terms and Conditions.

**11.2. By Inability to Raise Funds.** If Issuer is unable to raise the Target Offering Amount for the Offering by the scheduled final Closing date (which in no event shall be less than twenty-one (21) days from the commencement of the Offering) and has indicated the same to Player, this Agreement may be terminated by either Player or Issuer.

**11.3. Effect of Termination.** Upon the effective date of termination, the rights and obligations of the Parties under this Agreement will cease, except for rights and obligations arising out of Sections 4, 6, 9, 14, 15, 16 and 17 of these Terms and Conditions (to the extent applicable).

## **12. Assignment.**

**12.1.** The rights and obligations of Issuer under this Agreement will inure to the benefit of and will be binding upon the successors and assigns of Issuer, and Issuer shall have the right to assign its rights and delegate its obligations hereunder (a) in whole or in part to any Affiliate of Issuer (including the Series), and (b) in connection with a merger, acquisition, corporate restructuring, financing, sale of all or substantially all of its assets, or similar such transaction.

**12.2.** This Agreement is personal to Player, and Player does not have the right to assign this Agreement, whether by operation of law or otherwise, or to delegate any duties or obligations imposed upon Player under this Agreement without Issuer's prior written consent; except only that this Agreement shall be automatically assigned and binding on Player's successors and heirs upon the death of Player; provided, that any assignment and assumption of this Agreement by a personal services corporation (or "loan-out" corporation) that is wholly owned and Controlled by Player shall be expressly authorized hereunder so long as Player remains the Player hereunder, jointly and severally with such surviving corporation.



### **13. Indemnification.**

**13.1.** Player hereby agrees to indemnify and hold harmless Issuer, its parents, subsidiaries, Affiliates, assigns, successors, and each of their respective officers, directors, agents, representatives and employees (collectively, “Issuer Indemnified Party(ies)”), from and against any and all liabilities, actions, claims, suits, proceedings or investigations of government, quasi-government or administrative agencies, liens, judgments, demands, losses, costs, expenses and damages, including reasonable attorneys’ fees and costs and any and all damages of any kind and nature whatsoever (a “Claim”), arising out of or relating to any breach by Player, directly or indirectly through any other Person, of any of the terms, covenants, conditions, representations or warranties contained in this Agreement.

**13.2.** Issuer hereby agrees to indemnify and hold harmless Player and its Affiliates, heirs, assigns, successors, and each of their respective officers, directors, members, managers, agents, representatives and employees, as applicable, (collectively, “Player Indemnified Party(ies)”), from and against any and all Claims by any third party (including any and all Claims brought by any holder of the Offering, Series, or group of class thereof) arising out of or relating to Player being a party to this Agreement (except those arising out of or relating to any material breach by Player, directly or indirectly through any other Person, of any of the terms, covenants, conditions, representations or warranties contained in this Agreement), including any and all Claims arising out of or relating to (a) any breach by Issuer of any of the terms, covenants, conditions, representations or warranties contained in this Agreement, (b) any violation of any law by Issuer, including any securities laws or any rules or regulations promulgated thereunder, or (c) the Offering, the Series, or the Offering Statement.

**13.3.** An Issuer Indemnified Party or Player Indemnified Party, as applicable (the “Indemnified Party”), shall promptly deliver a written notice to the Party from whom indemnification is sought (the “Indemnifying Party”), providing notice (a “Claim Notice”) of any Claim asserted or filed by a third party (a “Third-Party Action”) within twenty (20) days (or such shorter period as reasonably necessary to permit timely response to such Claim) after receipt by the Indemnified Party of notice of such Third-Party Action. Delay or failure to notify the Indemnitor in accordance with this Section 13.3 will not relieve the Indemnifying Party of any liability that it may have to the Indemnified Party, except to the extent the defense of such Claim is materially prejudiced by the Indemnified Party’s delay or failure to give such Claim Notice. In Third-Party Actions in which the Indemnified Party is controlling the defense, the Indemnified Party shall not agree to any settlement of, or the entry of any judgment arising from, any such Third-Party Action without the prior written consent of the Indemnifying Party, which shall not be unreasonably withheld, conditioned or delayed.

### **14. Disclaimer of Warranties.**

**14.1.** Except as expressly provided in this Agreement and to the maximum extent permitted by law, neither Party makes any representation or warranty of any kind, whether implied, statutory, or otherwise and disclaims, without limitation, implied warranties of merchantability, fitness for a particular use, and non-infringement. Each Party acknowledges that it does not rely and has not relied upon any representation or statement made by the other Party or any of its representatives relating to the subject matter of this Agreement except as expressly set forth herein.

**14.2.** In addition to, and without limiting the effect of, Section 14.1 of these Terms and Conditions, Player expressly acknowledges and agrees that Issuer makes no representation or warranty regarding the results of the Offering, including the amount of Gross Proceeds to be collected or otherwise.

### **15. Agents.**

**15.1.** Subject to the agreed upon distribution of the Escrow Holdback, Issuer shall not be liable for any claims or demands for commissions or otherwise of any agent of Player and Player hereby agrees to indemnify and hold harmless Issuer, its Affiliates, advertisers, employees and all holders of the Series harmless against any liabilities, damages or expenses (including reasonable attorneys’ fees) incurred by them as a result of any such claims or demands.

## **16. General Terms.**

**16.1. Entire Agreement; Amendments.** The Agreement (including all exhibits thereto, including these Terms and Conditions) contains the complete, final, exclusive and binding statement of all of the agreements between the Parties with respect to the subject matter thereof and hereof, and supersedes all existing agreements, contracts, understandings, negotiations, offers, proposals, communications, correspondence, discussions, or commitments between the Parties, whether oral or written, express or implied, concerning the same subject matter. writing executed by Issuer and Player.

**16.2. Amendments and Modifications** This Agreement cannot be amended, modified, terminated, or any provisions or obligations waived or changed except by a supermajority vote of the Class A Units of the Issuer. For the purposes of this Agreement, a supermajority vote is defined as the affirmative vote of at least eight percent (80%) of the issued and outstanding Class A Units.

**16.3. Waiver.** The failure or delay of a Party to insist on strict adherence to any term of this Agreement will not be considered a waiver of, or deprive that Party of, the right thereafter to insist on strict adherence to that term or any other term of this Agreement. No waiver of any breach or default of the other Party shall be construed as a continuing waiver of the same or any other breach or default under this Agreement.

**16.4. Further Actions; Attorney-in-Fact.** Player will, as applicable, at the request of Issuer, execute and deliver to Issuer all such documents as Issuer may from time to time deem reasonably necessary or desirable to effectuate assignment of, and for Issuer to receive all installment payments of, the Player Obligation and otherwise effectuate the purposes of this Agreement. If Player fails or refuses to execute or deliver to Issuer any such document within a reasonable period of time following receipt of Issuer's written request therefor, then Player irrevocably appoints Issuer as Player's agent and attorney-in-fact to sign any such documents in Player's name and to make appropriate disposition of them, consistent with this Agreement; provided, that prior to exercising any rights under such power of attorney, Issuer shall notify Player and Player's authorized representative in writing of its intention to do so. Player acknowledges that Issuer's agency and power of attorney are coupled with an interest.

**16.5. Interpretation.** Words importing the singular include the plural and vice versa, as the context requires. Whenever any of the words "include," "includes" or "including" or the abbreviation "e.g." is used in this Agreement (including any exhibits hereto), such shall be deemed to be followed by the words "without limitation." The words "hereof," "herein" and "hereunder" and words of similar import when used in this Agreement shall refer to this Agreement as a whole and not to any particular provision of this Agreement. Any reference to "this Agreement," even if such reference is contained in these Terms and Conditions, shall be a reference to the Agreement and all of the exhibits and schedules attached thereto. The term "or" is not exclusive. Any obligations or rights of any of the Parties contained in Section 1 of the Agreement shall be valid and binding on the Parties as if it were contained in any other section of this Agreement.

**16.6. Governing Law; Arbitration.** The law of Delaware (exclusive of conflict or choice of law rules) shall govern, construe and enforce all of the rights and duties of the Parties arising or in any way relating to the subject matter of this Agreement. In the event of any dispute, claim or controversy arising out of or relating to this Agreement (including any claim based on contract, tort or statute) or the breach, termination, enforcement, interpretation or validity thereof, including the determination of the scope or applicability of this agreement to arbitrate, (a "Dispute"), then the Parties shall engage in informal, good faith discussions and attempt to resolve the Dispute. If the Parties are unable to resolve the Dispute, then the Dispute shall be determined by confidential binding arbitration in Los Angeles, CA before one arbitrator. The arbitration shall be administered by JAMS pursuant to its Streamlined Arbitration Rules and Procedures. Judgment on any award pursuant to arbitration may be entered in any court of competent jurisdiction. The arbitrator shall be a retired judge with at least five years of experience presiding over disputes related to complex commercial transactions. The arbitrator shall be appointed by mutual agreement of the Parties or, if no agreement can be reached, then each Party shall appoint one JAMS arbitrator for the purpose of selecting the arbitrator to govern the Dispute, and those two arbitrators shall select the arbitrator to govern the Dispute. Without limiting the effect of Section 4.2(iii) of these Terms and Conditions, the Parties shall maintain the confidential nature of the arbitration proceeding and the award, except as may be necessary in connection with a judicial challenge to an award or its enforcement, or unless otherwise required by law or judicial decision.



**16.7. Severability.** Wherever possible, each provision of this Agreement (or portion thereof) will be interpreted in such manner as to be effective and valid under applicable law, but if any provision of this Agreement (or portion thereof) is held to be null, void, invalid, illegal or unenforceable in any respect under any applicable law or rule by any arbitrator or court of competent jurisdiction, then (a) such provision (or portion thereof) shall be deemed to be restated, to the extent possible, to reflect as nearly as possible the original intentions of the Parties in accordance with applicable law, and if such restatement is not possible, then such provision (or portion thereof) shall be severed, and (b) the remaining provisions, terms or covenants and restrictions in this Agreement will remain in full force and effect.

**16.8. No Third-Party Beneficiaries.** Nothing herein, express or implied, is intended to nor shall be construed to confer upon or give to any Person, other than the Parties, any interests, rights, remedies or other benefits with respect to or in connection with any agreement or provision contained herein or contemplated hereby.

**16.9. Independent Contractors; No Fiduciaries.**

(i) The Parties mutually agree that Player and Issuer are each acting as independent contractors, and that Player and Issuer are not: (a) engaging in any form of employment, partnership, co-ownership or collaboration for the purpose of sharing any profits or ownership in common, or (b) acting in the capacity of joint venture Players.

(ii) Player and Issuer each acknowledges and agrees that: (a) this Agreement, and the exercise of rights and performance of obligations hereunder, does not create any agency, advisory or fiduciary relationship between Player and Issuer and its Affiliates; (b) Issuer is not, and at any time during the Term will not be, an agent, representative or advisor to Player; and (c) Player has relied on its own personal counsel and advisors with respect to legal, tax, accounting and other issues in connection with entering into and performing under this Agreement.

**16.10. Limitation on Liabilities.** In no event shall either Party or any of their representatives be liable under this Agreement to the other Party for any consequential, incidental, indirect, exemplary, special or punitive damages, including damages for business interruption, loss of use, revenue or profit, whether arising out of breach of contract, tort (including negligence and intentional torts), statute or otherwise, regardless of whether such damages were foreseeable and whether or not such Party was advised of the possibility of such damages. For the avoidance of doubt, in the event that any Player Revenue Contract is suspended or terminated or the amount of Player Revenue committed to be paid to Player is reduced as a result of any action or omission by Player that constitutes a breach of this Agreement, then (without limiting the effect of Section 16.10) the Player Obligation that would have been attributed to such lost or reduced Player Revenue shall be considered direct damages of Issuer resulting from such breach and shall not be excluded or waived by Issuer as a result of this Section 16.9.

**16.11. Cumulative Remedies.** None of the rights, powers or remedies conferred upon any Party under this Agreement will be mutually exclusive. Each such right, power or remedy will be cumulative and in addition to every other right, power or remedy available to such Party, whether available at law, in equity, or otherwise.

**16.12. Counterparts; Binding Agreement.** This Agreement may be executed in multiple counterparts, each of which individually constitutes an original, but all of which together will constitute one single agreement between the Parties. The Parties acknowledge and agree that this Agreement shall be legally binding upon the electronic transmission, including by facsimile, DocuSign, or email delivery of a .pdf or similar file, by each Party of a signed signature page hereof to the other Party.

## POST-OFFERING SERVICES AGREEMENT

This Post-Offering Services Agreement (the “**Agreement**”), dated as of September 19, 2024, (the “**Effective Date**”), is by and between Greene Nation LLC, a Delaware limited liability company (“**Company**”), and CMNWLTH Services LLC, a California limited liability company (“**CMNWLTH**”).

### Recitals

WHEREAS, MG Golf LLC is the Company’s Manager and is responsible for managing the Company’s business affairs and providing certain clerical, bookkeeping and other administrative and management services;

WHEREAS, CMNWLTH provides certain administrative services to privately owned companies; and

WHEREAS, the Company and its Manager desire to appoint CMNWLTH to perform certain administrative services for the Company and on behalf of the Manager, and CMNWLTH has indicated its willingness to so act, subject to the terms and conditions of this Agreement.

NOW, THEREFORE, in consideration of the premises and mutual covenants hereinafter contained, the parties hereto agree as follows:

### 1. CMNWLTH Appointment and Duties.

#### 1.1 Appointment and Services.

(a) The Company hereby appoints CMNWLTH to provide the administrative services for the Company set forth in Appendix A hereto, as amended from time to time, upon mutual written agreement of the parties upon the terms and conditions hereinafter set forth. CMNWLTH hereby accepts such appointments and agrees to furnish such specified services. CMNWLTH shall for all purposes be deemed to be an independent contractor and shall, except as otherwise expressly authorized in this Agreement, have no authority to act for or represent the Company in any way or otherwise be deemed an agent of the Company.

#### 1.2 Duties.

(a) CMNWLTH may employ or associate itself with a person or persons or organizations as CMNWLTH believes to be desirable in the performance of its duties hereunder; provided that, in such event, the compensation of such person or persons or organizations shall be paid by and be the sole responsibility of CMNWLTH, and the Company shall bear no cost or obligation with respect thereto; and provided further that CMNWLTH shall not be relieved of any of its obligations under this Agreement in such event and shall be responsible for all acts of any such person or persons or organizations taken in furtherance of this Agreement to the same extent it would be for its own acts.

### 2. CMNWLTH Compensation; Expenses.

#### 2.1 Compensation.

(a) In consideration for the services to be performed hereunder by CMNWLTH, the Company shall pay CMNWLTH the fees listed in Appendix B hereto. Notwithstanding anything to the contrary in this Agreement, fees billed for the services to be performed by CMNWLTH under this Agreement are based on information provided by the Company's Manager and such fees are subject to renegotiation between the parties hereto to the extent such information is determined to be materially different from what the Company's Manager originally provided to CMNWLTH. During each year of the term of this Agreement, unless the parties shall otherwise agree and provided that the service mix and volumes remain consistent with those provided in the previous year of this Agreement, the fee that would be charged for the same services would be the base fee rate (as reflected in Appendix B)

## 2.2 Expenses.

(a) CMNWLTH will bear all expenses in connection with the performance of its services under this Agreement, except as otherwise provided herein. CMNWLTH will not bear any of the costs of Company personnel. Other Company expenses incurred shall be borne by the Company or the Company's Manager, including, but not limited to, initial organization and offering expenses; litigation expenses; taxes; expenses of conducting repurchase offers for the purpose of repurchasing Company shares, if applicable; transfer agency and custodial expenses; interest; Company Manager fees; brokerage fees and commissions; state and federal registration fees; advisory fees; insurance premiums; fidelity bond premiums; Company and Manager related legal expenses; costs of maintenance of Company existence; printing and delivery of materials in connection with meetings of the Company's Manager; printing and mailing or other costs of dissemination of shareholder reports, prospectuses, statements of additional information other offering documents, supplements, proxy materials and other communications to shareholders; securities pricing data and expenses in connection with electronic filings with the U.S. Securities and Exchange Commission (the "SEC").

## 3. **Right to Receive Advice.**

### 3.1 Advice of the Company and Company Service Providers.

(a) If CMNWLTH is in doubt as to any action it should or should not take, CMNWLTH may request directions, advice or instructions from the Company or, as applicable, the Company's Manager, custodian or other service providers.

### 3.2 Advice of Counsel.

(a) If CMNWLTH is in doubt as to any question of law pertaining to any action it should or should not take, CMNWLTH may request advice from counsel of its own choosing (who may be counsel for the Company, the Company's Manager or CMNWLTH, at the option of CMNWLTH).

### 3.3 Conflicting Advice.

(a) In the event of a conflict between directions, advice or instructions CMNWLTH receives from the Company or any Company service provider and the advice CMNWLTH receives from counsel, CMNWLTH may in its sole discretion rely upon and follow the advice of counsel. CMNWLTH will provide the Company with prior written notice of its intent to follow advice of counsel

that is materially inconsistent with directions, advice or instructions from the Company. Upon request, CMNWLTH will provide the Company with a copy of such advice of counsel.

#### 4. **Standard of Care; Limitation of Liability; Indemnification.**

##### 4.1 Standard of Care.

(a) CMNWLTH shall be obligated to act in good faith and to exercise commercially reasonable care and diligence in the performance of its duties under this Agreement.

##### 4.2 Limitation of Liability.

(a) None of CMNWLTH, its affiliates, or any of their respective directors, members, stockholders, partners, officers, employees or controlling persons (collectively, “**Servicing Parties**”) shall be liable to the Company or Manager for (i) any act or omission performed or failed to be performed by any Servicing Party (other than any criminal wrongdoing) arising from the exercise of such Servicing Party’s rights or obligations hereunder, or for any losses, claims, costs, damages, or liabilities arising therefrom, in the absence of criminal wrongdoing, willful misfeasance or gross negligence on the part of such Servicing Party, (ii) any tax liability imposed on the Company or the Thoroughbred Asset, or (iii) any losses due to the actions or omissions of Manager, the Company or any brokers or other current or former agents or advisers of Manager or the Company.

##### 4.3 Indemnification.

(a) To the fullest extent permitted by applicable law, Manager will indemnify CMNWLTH and its Servicing Parties against any and all losses, damages, liabilities, judgments, costs and expenses (including, without limitation, reasonable attorneys’ fees and disbursements) and amounts paid in settlement (collectively, “**Losses**”) to which such person may become subject in connection with any matter arising out of or in connection with this Agreement, except to the extent that any such Loss results solely from the acts or omissions of a Servicing Party that have been determined in a final, non-appealable decision of a court, arbitrator or other tribunal of competent jurisdiction to have resulted primarily from such Servicing Party’s fraud, willful misconduct or gross negligence. If this Section 4 or any portion hereof shall be invalidated on any ground by a court of competent jurisdiction, Manager shall nevertheless indemnify the Servicing Party for any Losses incurred to the full extent permitted by any applicable portion of this Section that shall not have been invalidated.

(b) Notwithstanding anything in this Agreement to the contrary, neither party shall be liable under this Agreement to the other party hereto for any punitive, consequential, special or indirect losses or damages. Any indemnification payable by a party to this Agreement shall be net of insurance maintained by the indemnified party as of the time the claim giving rise to indemnity hereunder is alleged to have arisen to the extent it covers such claim.

(c) No party shall be liable for losses, delays, failures, errors, interruptions or losses of data in its performance of its obligations under this Agreement if and to the extent it is caused, directly or indirectly, by reason of circumstances beyond their reasonable control, including without limitation, acts of God, action or inaction of civil or military authority, war, terrorism, riot, fire, flood, sabotage, labor disputes, elements of nature or non-performance by a third party. In any such event, the

non-performing party shall be excused from any further performance and observance of obligations so affected only for so long as such circumstances prevail and such party continues to use commercially reasonable efforts to recommence performance or observance as soon as practicable.

5. **Activities of CMNWLTH.** The services of CMNWLTH under this Agreement are not to be deemed exclusive, and CMNWLTH shall be free to render similar services to others. The Company recognizes that from time to time directors, officers and employees of CMNWLTH may serve as directors, officers and employees of other corporations or businesses (including other investment companies) and that such other corporations and businesses may include CMNWLTH as part of their name and that CMNWLTH or its affiliates may enter into administrative agreements or other agreements with such other corporations and businesses.

6. **Accounts and Records.** The records maintained by CMNWLTH on behalf of the Company shall be the property of the Company. The Company shall have access to such records at all times during CMNWLTH's normal business hours. Upon the reasonable request of the Company, copies of any such books and records shall be provided by CMNWLTH to the Company at the Company's expense. CMNWLTH shall assist the Company, the Company's independent auditors, or, upon approval of the Company, any regulatory body, in any requested review of the Company's records and reports by CMNWLTH or its independent accountants concerning its accounting system and internal auditing controls will be open to such entities for audit or inspection upon reasonable request.

7. **Representations and Warranties.**

7.1 CMNWLTH Representations and Warranties.

(a) CMNWLTH represents and warrants to the Company that:

- (i) It is duly organized and existing as a corporation and in good standing under the laws of the State of California.
- (ii) It is empowered under applicable laws and by formation and governance documents to enter into and perform this Agreement.
- (iii) All requisite corporate proceedings have been taken to authorize it to enter into and perform this Agreement.
- (iv) It has and will continue to have access to the necessary facilities, equipment and personnel to perform its duties and obligations under this Agreement in accordance with industry standards.



7.2 Company Representations and Warranties.

- (a) The Company represents and warrants to CMNWLTH that:
  - (i) It is duly organized and existing as a corporation and in good standing under the laws of the State of Delaware.
  - (ii) It is empowered under applicable laws and by formation and governance documents to enter into and perform this Agreement.
  - (iii) All requisite corporate proceedings have been taken to authorize it to enter into and perform this Agreement.
  - (iv) Notwithstanding anything in this Agreement to the contrary, the Company agrees not to make any modifications to its LLC Agreement or adopt any policies which would affect materially the obligations or responsibilities of CMNWLTH hereunder without the prior written approval of CMNWLTH, which approval shall not be unreasonably withheld or delayed.

8. **Documents.** The Company has furnished or will furnish, upon request, CMNWLTH with copies of the Company's organizational documents and the Company's advisory agreement, custodian agreement, transfer agency agreement, administration agreement, current prospectus, statement of additional information, periodic Company reports and all forms relating to any plan, program or service offered by the Company. The Company shall furnish, within a reasonable time period, to CMNWLTH a copy of any amendment or supplement to any of the above-mentioned documents. Upon request, the Company shall furnish promptly to CMNWLTH any additional documents necessary or advisable to perform its functions hereunder. As used in this Agreement the terms "registration statement," "prospectus" and "statement of additional information" shall mean any registration statement, prospectus and statement of additional information filed by the Company with the SEC and any amendments and supplements thereto that are filed with the SEC.

9. **Banking.** During the Initial Term and Renewal Term of this Agreement, The Company agrees to conduct all banking activities through Relay Financial at Thread Bank ("Relay Financial"), including but not limited to the receipt of funds from escrow, disbursement of funds, Company operations, and any other financial transactions. CMNWLTH reserves the right to change the designated banking institution or financial services provider at any time. Should CMNWLTH decide to make such a change, it will provide the Company with written notice at least 14 days prior to the effective date of the change. The Company agrees to comply with any new banking arrangements as specified by CMNWLTH upon receiving such notice. The Company agrees to comply with all policies, procedures, and requirements set forth by Relay Financial or any subsequent banking institution designated by CMNWLTH. This includes but is not limited to account management, transaction processing, and compliance with applicable financial regulations.

10. **Consultation Between the Parties.** CMNWLTH and the Company shall regularly consult with each other regarding CMNWLTH's performance of its obligations under this Agreement. In connection therewith, the Company shall submit to CMNWLTH at a reasonable time in advance of filing with the SEC reasonably final copies of any amended or supplemented offering statement (including exhibits) or annual reports under the Securities Act of 1933; provided, however, that nothing contained in this Agreement shall in any way limit the Company's right to file at any time such amendments to any offering statement and/or supplements to any prospectus or statement of additional information, of whatever character, as the Company may deem advisable, such right being in all respects absolute and unconditional.

12. **Liaison with Accountants.** CMNWLTH shall act as a liaison with the Company's independent public accountants and shall provide account analysis, fiscal year summaries, and other audit-related schedules with respect to the services provided to the Company. CMNWLTH shall take all reasonable action in the performance of its duties under this Agreement to assure that the necessary information is made available to such accountants as reasonably requested or required by the Company.

12. **Duration and Termination of this Agreement.**

12.1 Initial Term. This Agreement shall become effective as of Effective Date and shall continue thereafter throughout the period that ends three (3) years after the Effective Date (the "**Initial Term**"), provided that, should the Maximum Offering Amount not be raised in the Offering, then the Initial Term shall equal a number of years equal to: Gross Proceeds, divided by Maximum Offering Amount, multiplied by six (6). *For illustration purposes only, if the Gross Proceeds are \$100,000, and the Maximum Offering Amount is \$200,000, then the Initial Term would equal  $(100,000/200,000)*6$ , or three (3) years.* Until the end of the Initial Term, this Agreement may be terminated without penalty only by agreement of the parties or for cause pursuant to Section 11.3 hereof.

12.2 Renewal Term. If not sooner terminated, this Agreement shall renew at the end of the Initial Term and shall thereafter continue for successive annual periods until terminated by either party upon not less than sixty (60) days' written notice prior to the expiration of the then current renewal term or for cause pursuant to Section 11.3 hereof.

12.3 Cause. Notwithstanding anything to the contrary elsewhere in this Agreement, the Company may terminate this Agreement for cause immediately at any time, without penalty, without default and without the payment of any termination payment or other liquidated damages. For purposes of this Section 11, "cause" shall mean:

- (i) willful misfeasance, bad faith, negligence or reckless disregard on the part of CMNWLTH in the performance of its duties, obligations and responsibilities set forth in this Agreement, provided, however, that in the event of a material breach by CMNWLTH hereof such termination shall not take effect until twenty (20) days after CMNWLTH has been provided with notice thereof and CMNWLTH has not remedied the cause of the breach during such time;
- (ii) in the event CMNWLTH is no longer permitted to perform its duties, obligations or responsibilities hereunder pursuant to applicable law, or regulatory, administrative or judicial proceedings against CMNWLTH which result in a determination that CMNWLTH

has violated, or has caused the Company to violate, in any material respect any applicable law, rule, regulation, order or code of ethics, or any material investment restriction, policy or procedure adopted by the Company of which CMNWLTH had knowledge (it being understood that CMNWLTH is deemed to have knowledge of all investment restrictions, policies or procedures set out in the Company's public filings or otherwise provided to CMNWLTH); or

(iii) financial difficulties on the part of CMNWLTH which are evidenced by the authorization or commencement of, or involvement by way of pleading, answer, consent or acquiescence in, a voluntary or involuntary case under Title 11 of the United States Code, as from time to time in effect, or any applicable law other than said Title 11, of any jurisdiction relating to the liquidation or reorganization of debtors or to the modification or alteration of the rights of creditors.

12.4 Deliveries Upon Termination. Upon termination of this Agreement, CMNWLTH agrees to cooperate in the orderly transfer of administrative duties and shall deliver to the Company or as otherwise directed by the Company (at the expense of the Company) all records and other documents made or accumulated in the performance of its duties for the Company hereunder. In the event CMNWLTH gives notice of termination under this Agreement, it will continue to provide the services contemplated hereunder after such termination at the contractual rate for up to one hundred eighty (180) days, provided that the Company uses all reasonable commercial efforts to appoint such replacement on a timely basis.

12.5 Fees and Expenses Upon Termination. Should either party exercise its right to terminate, all reasonable out-of-pocket expenses or costs associated with the movement of records and material will be borne by the Company. Additionally, except in the case of a termination for cause pursuant to Section 11.3 thereof, CMNWLTH reserves the right to charge a reasonable fee for its transitional support services.

13. **Amendment.** This Agreement may not be amended except by a written instrument signed by all of the parties to this Agreement.

14. **Entire Agreement.** This Agreement constitutes the entire agreement between the parties and supersedes all prior agreements, representations, warranties, statements, promises, information, arrangements and undertakings, whether oral or written, express or implied, with respect to the subject matter of this Agreement.

15. **Severability.** If any provision of this Agreement shall be waived, or be invalid or unenforceable, the remaining provisions of this Agreement shall be unaffected thereby and shall remain binding and in full force and effect, and in the case any provision is found to be invalid or unenforceable, each of the parties shall use its best efforts to find and employ an alternative means to achieve the same or substantially the same results as that contemplated by such provision.

16. **Remedies Cumulative.** Any rights or remedies of either party in the event of default are intended to be cumulative rather than exclusive. Moreover, if either party chooses not to insist upon strict performance of any provision of this Agreement, that choice shall not impair its rights to insist on strict performance in the event of subsequent acts of default, and the waiver by a party of any breach of any

provision of this Agreement by the non-breaching party shall not operate or be construed as a waiver of any subsequent breach by that party.

17. **Notices.** All notices and other communications hereunder shall be in writing, shall be deemed to have been given when received or when sent by telex or facsimile, and shall be given to the following addresses (or such other addresses as to which notice is given):

Jurisdiction and venue for any litigation or arbitration arising out of this agreement shall lie in Los Angeles, California.

19. **Headings.** The underlined headings of paragraphs in this Agreement are included for reference only and are not a part of this Agreement.

20. **Counterparts.** This Agreement may be executed in counterparts, each of which when so executed shall be deemed to be an original, and such counterparts together shall constitute one and the same agreement.

21. **Assignment.** Neither of the parties hereto shall have the right to assign, transfer or convey any of its rights or interest under this Agreement, or to delegate any of its duties or obligations under this Agreement, without the prior written approval of the other party, which consent may be withheld at the other party's sole and absolute discretion.
