The cost of acquiring new customers is high in the cosmetics industry with many players. We may not be able to get the cost of ads down to a profitable level fast enough.

We may be copied by larger companies before we can establish ourselves as the leader in the makeup-for-acne space.

We may not be able to get into retailers in 2025 and then when we do have the opportunity we may not be financially stable enough to handle it.

The clean beauty market is highly competitive, with established brands and new entrants regularly launching similar products. The Good Mineral may face challenges in differentiating its products and maintaining market share.

The company relies on specific suppliers for clean and hypoallergenic ingredients. Disruptions in the supply chain or increases in raw material costs could impact production



or increases in raw material costs could impact production and profitability.

As a makeup brand, The Good Mineral must comply with various FDA regulations, as well as labeling and safety standards. Failure to comply with these requirements could result in fines or product recalls, impacting brand reputation and finances.

Since The Good Mineral targets consumers with sensitive and acne-prone skin, any adverse reactions to products could lead to liability claims, impacting the company financially and harming its reputation.

The brand's growth relies heavily on consumer loyalty and positive reviews. If consumer preferences shift or customer satisfaction declines, it could significantly impact revenue.

If The Good Mineral outsources production, any delays or quality control issues at manufacturing facilities could affect product availability and quality, leading to potential sales loss or reputational damage.

The company's formulas, trademarks, and brand image are valuable assets. If competitors replicate The Good Mineral's products or branding, it could erode the company's market position, especially in the absence of strong intellectual property protection.

In times of economic uncertainty, consumers may cut back on discretionary purchases like cosmetics, which could reduce demand for The Good Mineral's products and impact revenue.

As consumer expectations around environmental responsibility grow, failure to meet sustainability standards or provide eco-friendly packaging may deter potential customers, affecting the company's growth.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

Sarah Dusek, Natasha Iwegbu and Jacob Dusek are part-time officers. As such, it is likely that the company will not make the same progress as it would if that were not the case.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. # Ownership and Capital Structure

## THE OFFERING

13. Describe the terms of the securities being offered.

To view a copy of the SAFE you will purchase, please see [Appendix B, Investor Contracts](#). The main terms of the SAFEs are provided below.

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity (“SAFE”), which provides Investors the right to **Preferred Stock** in the Company (“**Preferred Stock**”), when and if the Company sponsors an equity offering that involves **Preferred Stock**, on the standard terms offered to other Investors.

*Conversion to Preferred Equity.* Based on our SAFEs, when we engage in an offering of equity interests involving **Preferred Stock**,

**Investors will receive a number of Preferred Stock calculated using the method that results in the greater number of Preferred Stock:**

- i. the total value of the Investor’s investment, divided by
  - a. the price of **Preferred Stock** issued to new Investors multiplied by
  - b. the **discount rate** (90%), or
- ii. if the valuation for the company is more than **\$4,000,000.00** (the “Valuation Cap”), the amount invested by the Investor divided by the quotient of
  - a. the Valuation Cap divided by
  - b. the total amount of the Company’s capitalization at that time.
- iii. For investors up to the first **\$70,000.00** of the securities, investors will receive a valuation cap of **\$3,500,000.00** and a **discount rate of 90%**. Wefunder VIP investors will be entitled to these terms for the entire duration of the offering, even if the threshold limit noted above is met.

*Additional Terms of the Valuation Cap.*

For purposes of option (ii) above, the Company’s

capitalization calculated as of immediately prior to the Equity Financing and (without double-counting, in each case calculated on an as-converted to Common Stock basis):

- Includes all shares of Capital Stock issued and outstanding;
- Includes all Converting Securities;
- Includes all (i) issued and outstanding Options and (ii) Promised Options; and
- Includes the Unissued Option Pool, except that any increase to the Unissued Option Pool in connection with the Equity Financing shall only be included to the extent that the number of Promised Options exceeds the Unissued Option Pool prior to such increase.

*Liquidity Events.* If the Company has an initial public offering or is acquired by, merged with, or otherwise taken over by another company or new owners prior to Investors in the SAFEs receiving **Preferred Stock**, Investors will receive proceeds equal to the greater of

1. the Purchase Amount (the "Cash-Out Amount") or
2. the amount payable on the number of shares of Common **Stock** equal to the Purchase Amount divided by the Liquidity Price (the "Conversion Amount")

*Liquidity Priority.* In a Liquidity Event or Dissolution Event, this Safe is intended to operate like standard nonparticipating **Preferred Stock**. The Investor's right to receive its Cash-Out Amount is:

1. Junior to payment of outstanding indebtedness and creditor claims, including contractual claims for payment and convertible promissory notes (to the extent such convertible promissory notes are not actually or notionally converted into Capital **Stock**);
2. On par with payments for other Safes and/or **Preferred Stock**, and if the applicable Proceeds are insufficient to permit full payments to the Investor and such other Safes and/or **Preferred Stock**, the applicable Proceeds will be distributed pro rata to the Investor and such other Safes and/or **Preferred Stock** in proportion to the full payments that would otherwise be due; and
3. Senior to payments for Common **Stock**.

### **VIP Bonus**

The Good Mineral Company will offer a discount to the normal terms listed in this Form C for all investments that are committed by investors who are part of Wefunder, Inc's VIP program. This means eligible Wefunder investors will receive a discount for any securities they purchased in this

receive a discount for any securities they purchased in this offering. For more specific details on the company's discount, please review the description of the terms above.

The discount is only valid until the offering closes. Investors eligible for the bonus will also receive priority if they are on a waitlist to invest and the company exceeds its maximum funding goal. They will be given the first opportunity to invest if space in the offering becomes available due to the cancellation or failure of previous investments.

### **Securities Issued by the SPV**

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV is formed concurrently with the filing of the Form C. Given this, the SPV does not have any financials to report. The SPV is managed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

### **Voting Rights**

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

### **Proxy to the Lead Investor**

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the

through a power of attorney granted by investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

### **Restriction on Transferability**

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

- *Revenues & Gross Margin.* For the period ended December 31, 2023, the Company had revenues of \$78,432 compared to the year ended December 31, 2022, when the Company had revenues of \$61,207. Our gross margin was 94.07% in fiscal year 2023, and 88.95% in 2022.
- *Assets.* As of December 31, 2023, the Company had total assets of \$156,427.17, including \$5,506.98 in cash. As of December 31, 2022, the Company had \$170,423.92 in total assets, including \$31,733.18 in cash.
- *Net Loss.* The Company has had net losses of \$61,448.65 and net losses of \$239,755.17 for the fiscal years ended December 31, 2023 and December 31, 2022, respectively.
- *Liabilities.* The Company's liabilities totaled \$305,564.41 for the fiscal year ended December 31, 2023 and \$258,213.54 for the fiscal year ended December 31, 2022.

### **Liquidity & Capital Resources**

To-date, the company has been financed with \$31,000 in debt, \$333,000 in equity, and \$300,000 in promissory notes.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 12 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 18 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be

increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

### **Runway & Short/Mid Term Expenses**

The Good Mineral Company cash in hand is \$4,699, as of October 2024. Over the last three months, revenues have averaged \$19,317/month, cost of goods sold has averaged \$1,293/month, and operational expenses have averaged \$21,465/month, for an average burn rate of \$3,441 per month. Our intent is to be profitable in 5 months.

Revenue has significantly increased in 2024 due to digital ad spend. In February we decided to increase the daily spend on Google PMax campaign and a META Reach ad.

Looking forward over the next 6 to 12 months, based on this raise and spending \$17,000 per month on digital ads, with online shopping peaking in November and the holidays we expect to generate double our average current monthly revenue; approximately \$40,000 per month. We expect expenses to also increase, to \$27,000 per month.

We are not profitable yet. We are short on average \$7,000 per month, as we are investing significantly in advertising to drive continued revenue growth. We plan to be profitable in 5 months, thanks to the revenue growth that can come from the capital we raise on Wefunder.

We have a bank overdraft of \$15000, access to Shopify loans (renewal due in early December) and a credit card.

All projections in the above narrative are forward-looking and not guaranteed.

The Proxy is irrevocable unless and until a Successor Lead Investor takes the place of the Lead Investor, in which case, the Investor has a five (5) calendar day period to revoke the Proxy. Pursuant to the Proxy, the Lead Investor or his or her successor will make voting decisions and take any other actions in connection with the voting on Investors' behalf.

The Lead Investor is an experienced investor that is chosen to act in the role of Lead Investor on behalf of Investors that have a Proxy in effect. The Lead Investor will be chosen by the Company and approved by Wefunder Inc. and the identity of the initial Lead Investor will be disclosed to Investors before Investors make a final investment decision to purchase the securities related to the Company.

The Lead Investor can quit at any time or can be removed by Wefunder Inc. for cause or pursuant to a vote of investors as detailed in the Lead Investor Agreement. In the event the Lead Investor quits or is removed, the Company will choose a Successor Lead Investor who must be approved by Wefunder Inc. The identity of the Successor Lead Investor will be disclosed to Investors, and those that have a Proxy in effect can choose to either leave such Proxy in place or revoke such Proxy during a 5-day period beginning with notice of the replacement of the Lead Investor.

The Lead Investor will not receive any compensation for his or her services to the SPV. The Lead Investor may receive

or other services to the SPV. The Lead Investor may receive compensation if, in the future, Wefunder Advisors LLC forms a fund ("Fund") for accredited investors for the purpose of investing in a non-Regulation Crowdfunding offering of the Company. In such as circumstance, the Lead Investor may act as a portfolio manager for that Fund (and as a supervised person of Wefunder Advisors) and may be compensated through that role.

Although the Lead Investor may act in multiple roles with respect to the Company's offerings and may potentially be compensated for some of its services, the Lead Investor's goal is to maximize the value of the Company and therefore maximize the value of securities issued by or related to the Company. As a result, the Lead Investor's interests should always be aligned with those of Investors. It is, however, possible that in some limited circumstances the Lead Investor's interests could diverge from the interests of Investors, as discussed in section 8 above.

Investors that wish to purchase securities related to the Company through Wefunder Portal must agree to give the Proxy described above to the Lead Investor, provided that if the Lead Investor is replaced, the Investor will have a 5-day period during which he or she may revoke the Proxy. If the Proxy is not revoked during this 5-day period, it will remain in effect.

**Tax Filings.** In order to complete necessary tax filings, the SPV is required to include information about each investor who holds an interest in the SPV, including each investor's taxpayer identification number ("TIN") (e.g., social security number or employer identification number). To the extent they have not already done so, each investor will be required to provide their TIN within the earlier of (i) two (2) years of making their investment or (ii) twenty (20) days prior to the date of any distribution from the SPV. If an investor does not provide their TIN within this time, the SPV reserves the right to withhold from any proceeds otherwise payable to the Investor an amount necessary for the SPV to satisfy its tax withholding obligations as well as the SPV's reasonable estimation of any penalties that may be charged by the IRS or other relevant authority as a result of the investor's failure to provide their TIN. Investors should carefully review the terms of the SPV Subscription Agreement for additional information about tax filings.

4. the issuer or another party purchases or repurchases all of the securities issued pursuant to Section 4(a)(6), including any payment in full of debt securities or any complete redemption of redeemable securities; or the issuer liquidates or dissolves in accordance with state law.
