In making an investment decision, investors must rely on their own examination of the issuer and the terms of the offering, including the merits and risks involved. These securities have not been recommended or approved by any federal or state securities commission or regulatory authority. Furthermore, these authorities have not passed upon the accuracy or adequacy of this document.

The U.S. Securities and Exchange Commission does not pass upon the merits of any securities offered or the terms of the offering, nor does it pass upon the accuracy or completeness of any offering document or literature.

These securities are offered under an exemption from registration; however, the U.S. Securities and Exchange Commission has not made an independent determination that these securities are exempt from registration.

Dolomite Energy Corporation was incorporated in 2026 and has a very limited operating history upon which investors can evaluate our business, financial performance, and prospects. We are an early-stage company with only three employees and have not yet acquired the oil and gas working interests that form the basis of our business plan. Our prospects must be considered in light of the risks, expenses, and difficulties frequently encountered by companies in their early stages of development, particularly companies in the capital-intensive oil and gas industry. There can be no assurance that we will be successful in addressing these risks and challenges, and our failure to do so could have a material adverse effect on our business, financial condition, and results of operations.

Our success depends heavily on the continued services and performance of our small management team and our three employees. The loss of any key personnel could significantly impair our ability to identify, evaluate, and acquire suitable oil and gas working interests, manage operations, and execute our business strategy. Given our limited resources and early stage of development, we may face challenges in attracting and retaining qualified personnel with the technical expertise and industry experience necessary to successfully operate in the oil and gas sector. We do not maintain key person life insurance on any of our personnel. The inability to retain our current team or attract additional qualified personnel could materially harm our business prospects and operations.

Our business plan depends on our ability to successfully identify, evaluate, negotiate, and acquire working interests in oil and gas assets. The acquisition of oil and gas properties is highly competitive, and we will be competing against companies with substantially greater financial resources, technical expertise, and industry relationships. There can be no assurance that suitable acquisition opportunities will be available on acceptable terms, or at all. Additionally, the evaluation of oil and gas properties is inherently uncertain and involves numerous assumptions regarding reserves, production rates, operating costs, and commodity prices. We may acquire properties that do not perform as expected, contain fewer reserves than anticipated, or require greater capital expenditures than projected. Any failure to successfully execute our acquisition strategy could prevent us from generating the revenue necessary to sustain our operations.

Oil and gas operations are subject to numerous operational risks and hazards, including well blowouts, explosions, fires, equipment

failures, uncontrollable flows of oil, gas or well fluids, pipeline ruptures, and environmental contamination. These risks could result in substantial losses due to injury or loss of life, severe damage to or destruction of property and equipment, pollution, and environmental damage. We may not be adequately insured against all of these risks, and insurance may not be available at economically acceptable premiums or at all. The occurrence of any of these events could result in substantial costs, regulatory penalties, operational delays, or the suspension of operations, any of which could materially adversely affect our financial condition and results of operations.

We have not yet generated any revenue from operations and have no assurance of when, or if, we will become profitable. Our ability to generate revenue depends entirely on successfully acquiring working interests in producing oil and gas properties and managing those interests to generate positive cash flow. Even after acquiring working interests, we will face ongoing operational costs, capital expenditure requirements, and the inherent volatility of commodity prices. We expect to incur losses for the foreseeable future as we deploy capital to acquire assets and build our operations. There can be no assurance that we will ever achieve or sustain profitability, and failure to do so would prevent investors from realizing any return on their investment.

We will require substantial additional capital beyond the proceeds of this offering to fully develop our business, acquire additional working interests, fund ongoing operations, and meet our capital expenditure obligations for drilling and production activities. We have no commitments or arrangements for additional financing, and there can be no assurance that additional capital will be available on acceptable terms, if at all. Our ability to obtain additional financing may be limited by our financial condition, the volatility of oil and gas prices, and general market conditions. If we raise additional funds through the issuance of equity securities, existing investors will experience dilution of their ownership percentage. The inability to obtain additional capital when needed could restrict our ability to grow, require us to curtail operations, or force us to sell assets on unfavorable terms.

Our financial performance and the value of our working interests will be substantially dependent on prevailing prices for oil and natural gas, which are subject to significant volatility due to factors beyond our control. These factors include global supply and demand dynamics, geopolitical events, decisions by the Organization of Petroleum Exporting Countries and other major producers, weather conditions, technological advances, availability of alternative energy sources, and overall economic conditions. Sustained periods of low commodity prices could render our working interests uneconomical to operate, reduce the value of our assets, impair our ability to generate cash flow, and limit our access to capital. We may not be able to effectively hedge against price volatility, and any hedging strategies we employ may limit our ability to benefit from price increases.

The oil and gas industry is highly competitive, and we face significant competition from major integrated oil companies, independent producers, and other entities with substantially greater financial resources, technical capabilities, and operational experience. Many of our competitors have larger staffs, more extensive databases of available properties, longer operating histories, and established relationships with sellers of oil and gas properties. These competitors may be able to identify and acquire more attractive properties, pay higher prices for acquisitions, and better withstand periods of low commodity prices or operational challenges. Our ability to compete effectively will depend on our success in identifying undervalued or overlooked opportunities, but there can be no assurance that we will be able to do so or that our limited resources will allow us to compete successfully against larger, better-capitalized competitors.

Our business is subject to extensive federal, state, and local laws and regulations governing the exploration, development, production, and transportation of oil and gas, as well as environmental protection, occupational health and safety, and other matters. Compliance with these regulations requires substantial expenditures and imposes significant operational constraints. Regulatory requirements are subject to change, often becoming more stringent over time, and new laws or regulations could be adopted that increase our costs, limit our operational flexibility, or require modifications to our business practices. We may be required to obtain numerous permits and approvals from governmental authorities, and delays in obtaining or failure to obtain such permits could prevent us from conducting operations. Violations of applicable laws and regulations could result in substantial fines, penalties, remediation costs, or restrictions on our operations, any of which could materially harm our business and financial condition.

Oil and gas operations are subject to stringent federal, state, and local environmental laws and regulations governing air emissions, water discharges, waste management, and the remediation of contaminated sites. We may incur substantial costs to comply with environmental requirements, and we could be held liable for environmental contamination caused by current or previous operators of properties in which we acquire working interests, even if we were not responsible for such contamination. Environmental laws and regulations have become increasingly stringent in recent years, and this trend is expected to continue. Growing concerns about climate change have led to increased regulation of greenhouse gas emissions and may result in additional restrictions on oil and gas operations, carbon pricing mechanisms, or other measures that could increase our operating costs or reduce demand for our products. The costs of complying with environmental requirements or remediating environmental contamination could be substantial and could materially adversely affect our financial condition and results of operations.

Our operations are subject to risks from events beyond our control, including natural disasters such as hurricanes, floods, and earthquakes, pandemics and public health emergencies, geopolitical conflicts, terrorist attacks, and other force majeure events. Such events could damage or destroy oil and gas facilities, disrupt production and transportation infrastructure, prevent access to properties, or cause supply chain disruptions. The oil and gas industry has historically been affected by hurricanes and other severe weather events, particularly in major producing regions. Climate change may increase the frequency or severity of such events. Any significant operational disruption could result in lost production, increased costs, and reduced revenue. We may not maintain adequate insurance coverage against all potential losses from such events, and the occurrence of a major force majeure event could have a material adverse effect on our business and financial condition.

An investment in our securities is highly speculative and involves a high degree of risk. We are an early-stage company with no operating history, no revenue, and an unproven business model. We may never successfully acquire oil and gas working interests, generate revenue, or achieve profitability. The success of our business depends on numerous factors, many of which are beyond our control, including commodity prices, our ability to identify and acquire suitable properties, operational execution, and access to capital. Investors must be prepared for the possibility that they could lose their entire investment. Prospective investors should carefully consider whether they can afford to lose their entire investment before purchasing these securities.

There is no public market for our securities, and none is expected to develop in the foreseeable future. The securities offered in this offering have not been registered under the Securities Act of 1933 and are subject to transfer restrictions under federal securities laws. Investors will be required to hold their securities for at least one year from the date of purchase, and even after that period, the securities may only be transferred in limited circumstances pursuant to an effective registration statement or an applicable exemption from registration. The lack of liquidity means that investors may not be able to sell their securities when desired or at all, and even if a sale is possible, it may be at a price substantially less than the purchase price. Investors should be prepared to hold their investment for an indefinite period and should not invest funds that they may need for other purposes.

Investors in this offering will hold a minority equity position in the company and will have no ability to control or significantly influence corporate decisions, including decisions regarding business strategy, acquisitions, capital expenditures, financing activities, or the

election of directors. The company's management and existing shareholders will retain control over these matters. As minority shareholders, investors will be dependent on management's judgment and decisions, which may not always align with the interests of minority investors. Management will have broad discretion in how to use the proceeds from this offering, and investors will have limited ability to challenge or influence those decisions. The rights of minority shareholders are limited, and there can be no assurance that the company will be managed in a manner that maximizes value for all shareholders.

The founder of Dolomite Energy Corporation has designated themselves as the lead investor who will sign documents and make decisions on behalf of all investors in connection with this offering. This arrangement creates a significant conflict of interest because the founder simultaneously represents the interests of the company as its founder and operator, while also purporting to represent the interests of investors. These interests may not always align, and in situations where they diverge, the founder may prioritize the company's interests over those of investors. The founder will have access to material non-public information about the company that other investors do not have, creating an information asymmetry that could disadvantage other investors. Additionally, there is no independent third-party investor advocate or representative to protect the interests of crowdfunding investors or to provide a check on management decisions. Investors should be aware that they will not have an independent representative acting solely in their interests, and decisions made by the founder in their capacity as lead investor may not reflect what an independent fiduciary would determine to be in the best interests of investors.

USE OF FUNDS

9. What is the purpose of this offering?

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from this Offering. Accordingly, the Company will have broad discretion in using these proceeds.

Book Entry and Investment in the Co-Issuer. Investors will make their investments by investing in interests issued by one or more co-issuers, each of which is a special purpose vehicle ("SPV"). The SPV will invest all amounts it receives from investors in securities issued by the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. All references in this Form C to an Investor's investment in the Company (or similar phrases) should be interpreted to include investments in a SPV.

12. How can an investor cancel an investment commitment?

The intermediary will notify investors when the target offering amount has been met. Dolomite Energy Corporation is offering up to 2,500,000 shares of Series B Preferred Stock, at a price per share of \$2.50.

Investors in the first \$125,000.00 of the offering will receive stocks at a price per share of \$2.00, and a pre-money valuation of \$49,333,334.00 Wefunder VIP investors will be entitled to these terms for the entire duration of the offering, even if the threshold limit noted above is met.

The campaign maximum is \$5,000,000.00 and the campaign minimum is \$50,000.00.

VIP BonusDolomite Energy Corporation will offer a discount to the normal terms listed in this Form C for all investments that are committed by investors who are part of Wefunder, Inc's VIP program. Securities Issued by the SPVInstead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV is formed concurrently with the filing of the Form C. Given this, the SPV does not have any financials to report. The SPV is managed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. While the Issuer may be required to pay an annual administrative fee for the maintenance of the SPV, investors should note the Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

Voting RightsIf the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

Proxy to the Lead InvestorThe SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

Management's Discussion and Analysis of Financial Condition and Results of Operations

Overview of the Business and Financial Condition

The Company was formed for the purpose of acquiring, developing, and operating oil and gas properties, including working interests and overriding royalty interests in oil and gas leases. As of May 31, 2026, the Company had not commenced revenue-generating operations and was in the organizational stage of establishing its business activities.

We are an early-stage company and have incurred operating losses and negative cash flows from operations since inception. We expect to continue to incur operating losses in the near term.

As of August 4, 2026, we had cash and cash equivalents of approximately \$103,551.

Our ability to continue operations is dependent on managing our expenses and, if necessary, obtaining additional financing.

This discussion should be read in conjunction with the financial statements and related notes included in this offering statement.

Business and Operating Uncertainty

Our business operates in an environment subject to various risks, uncertainties, and changing conditions, which makes it difficult to evaluate our business, financial condition, and prospects and may limit the comparability of our results of operations from period to period.

Financial Condition

As of May 31, 2026, our total assets were \$112,255 and our current and non-current liabilities, as reflected in available financial statement fields, were \$2,500.

Our financial statements reflect an early-stage company with limited operating history. Investors should not place undue reliance on historical financial information given the company's limited operating history and the likelihood that future results will differ from historical results.

Liquidity and Capital Resources

As of May 31, 2026, we had cash and cash equivalents of approximately \$112,250.

Based on our current operations, we have a monthly net cash burn of approximately \$5,000.

Our monthly net cash burn or profit may vary significantly from month to month due to the timing of receipts and expenditures and other short-term factors. As a result, period-to-period comparisons may not be meaningful.

Based on our current plan, we expect to have sufficient cash to fund operations for at least the next 12 months.

To date, our operations have been funded through minimal cash resources and have not included any external financing.

Liquidity Assumptions

Our assessment of our liquidity and ability to fund operations is not a projection and is based on current assumptions regarding operating expenses, cash requirements, and capital needs. These assumptions may change, and actual results may differ materially due to changes in operating conditions, timing of receipts and payments, and other factors.

Dependence on Additional Financing

There can be no assurance that additional financing will be available on acceptable terms, or at all. If we are unable to raise additional capital when needed, we may be required to materially reduce or suspend operations.

Indebtedness and Capital Structure

As of the date of this offering statement, we had total outstanding indebtedness consisting of 1 loan and approximately \$2,500 in aggregate principal obligations. The indebtedness consists of \$2,500 (related party). The material terms of such indebtedness are described in Item 24 of this Form C and include no stated interest rate, no stated maturity date.

(For the avoidance of doubt, SAFEs are not treated as indebtedness.)

During the past three years, we have conducted no exempt offerings.

The Lead Investor. As described above, each investor that has entered into the Investor Agreement will grant a power of attorney to make voting decisions on behalf of that investor to the Lead Investor (the "Proxy"). The Proxy is irrevocable unless and until a Successor Lead Investor takes the place of the Lead Investor, in which case, the Investor has a five (5) calendar day period to revoke the Proxy. Pursuant to the Proxy, the Lead Investor or his or her successor will make voting decisions and take any other actions in connection with the voting on Investors' behalf.

The Lead Investor is an individual that is chosen to act in the role of Lead Investor on behalf of Investors that have a Proxy in effect. The Lead Investor will be chosen by the Company and approved by Wefunder Inc. and the identity of the initial Lead Investor will be disclosed to Investors before Investors make a final investment decision to purchase the securities related to the Company.

The Lead Investor can quit at any time or can be removed by Wefunder Inc. for cause or pursuant to a vote of investors as detailed in the Lead Investor Agreement. The Lead Investor may receive compensation if, in the future, Wefunder Advisors LLC forms a fund ("Fund") for accredited investors for the purpose of investing in a non-Regulation Crowdfunding offering of the Company. In such circumstances, the Lead Investor may act as a portfolio manager for that Fund (and as a supervised person of Wefunder Advisors) and may be compensated through that role.
