## **IMPORTANT INFORMATION ABOUT THE COMPANY**

**Information about the ReliaStar Life Insurance Company of New York found in your Policy prospectus is deleted and replaced with the following:**

ReliaStar Life Insurance Company of New York (“we,” “us,” “our,” and the “company”) issues the variable universal life insurance policy described in the prospectus and is responsible for providing the policy’s insurance benefits. All guarantees and benefits provided under the policy that are not related to the Variable Account are subject to the claims paying ability of the company and our general account. We are a stock life insurance company incorporated under the laws of the State of New York in 1917. Our headquarters is at 1000 Woodbury Road, Suite 208, P.O. Box 9004, Woodbury, New York 11797.

We are an indirect, wholly owned subsidiary of Voya Financial, Inc. (“Voya<sup>TM</sup>”), which until April 7, 2014, was known as ING U.S., Inc. In May, 2013, the common stock of Voya began trading on the New York Stock Exchange under the symbol “VOYA” and Voya completed its initial public offering of common stock.

Voya is an affiliate of ING Groep N.V. (“ING”), a global financial institution active in the fields of insurance, banking and asset management. In 2009 ING announced the anticipated separation of its global banking and insurance businesses, including the divestiture of Voya, which together with its subsidiaries, including the company, constitutes ING’s U.S.-based retirement, investment management and insurance operations. As of March 25, 2014, ING’s ownership of Voya was approximately 43%. Under an agreement with the European Commission, ING is required to divest itself of 100% of Voya by the end of 2016.

## **IMPORTANT INFORMATION ABOUT THE FUNDS AVAILABLE THROUGH THE POLICIES**

**In connection with the rebranding of ING U.S. as Voya Financial, effective May 1, 2014, the ING Funds were renamed by generally replacing ING in each Fund name with either Voya or VY.**

The following chart lists the Funds that are, effective May 1, 2014, available through the Policies, along with each Fund’s investment adviser/subadviser and investment objective. More detailed information about these Funds can be found in the current prospectus and Statement of Additional Information for each Fund. Subject to shareholder approval, effective after the close of business on or about July 18, 2014 (the “Reorganization Effective Date”), the following Merging Funds will reorganize with and into the following Surviving Funds:

**On the Reorganization Effective Date.** On the Reorganization Effective Date, your investment in a Sub-Account that invests in a Merging Fund will automatically become an investment in the Sub-Account that invests in the corresponding Surviving Fund with an equal total net asset value. You will not incur any tax liability because of this automatic reallocation, and your Policy value immediately before the reallocation will equal your Policy value immediately after the reallocation.

**Automatic Investment in Class I Shares.** On the Reorganization Effective Date, all existing account balances invested in Class S shares of the VY MFS Utilities Portfolio will automatically become investments in Class I shares of the Voya Large Cap Value Portfolio. Class I shares have 0.25% lower total Fund expenses than Class S shares, and the effect of this transaction is to give Policy owners an investment in a similar Fund managed by the same investment adviser at a lower cost.

**Automatic Fund Reallocation After the Reorganization Effective Date.** After the Reorganization Effective Date, the Merging Funds will no longer be available through your Policy. Unless you provide us with alternative allocation instructions, after the Reorganization Effective Date all allocations directed to a Sub-Account that invested in a Merging Fund will be automatically allocated to the Sub-Account that invests in the corresponding Surviving Fund. **See the Transfers section on page 33 of your Policy prospectus for information about making Fund allocation changes.**
