(c) Property and Equipment, page F-6

1. We note from your response to comment 3 in your letter dated June 9, 2010, that you have not reduced the asking price for the Northwind Office Park since it was listed in 2001. Based on this information, this property does not meet the requirements to be classified as held for sale. According to ASC 360-10-55-49(b), this property should have been reclassified as held and used in accordance with ASC 360-10-35-44 after it was unsold for one year, as there was no reduction in the price of the property and therefore it did not meet the criteria in paragraphs ASC 360-10-45-9(b) and ASC 360-10-45-9(e) which state that the property must be available for immediate sale at a price that is reasonable in relation to its current fair value. Please restate your financial statements accordingly. Please also refer to ASC 360-10-45-11.
