TEVA ANNOUNCES TENTATIVE APPROVAL OF LEVOFLOXACIN INJECTION

Jerusalem, Israel, February 13, 2005 **Teva Pharmaceutical Industries Ltd. (Nasdaq: TEVA)** announced today that the U.S. Food and Drug Administration has granted tentative approval for the Company's ANDAs for Levofloxacin Injection, 5 mg/mL in 250 mg/bag and 500 mg/bag (5% dextrose bags) and Levofloxacin Injection, 25 mg/mL in 20 mL and 30 mL vials. Final approval is subject to the resolution of ongoing patent litigation.

Teva's Levofloxacin Injection is the AP-rated generic equivalent of Ortho McNeil's broad-spectrum antibacterial agent Levaquin[®] Injection.

Total annual sales of the brand product, in both configurations, are approximately \$220 million.

Teva Pharmaceutical Industries Ltd., headquartered in Israel, is among the top 25 pharmaceutical companies and among the largest generic pharmaceutical companies in the world. The company develops, manufactures and markets generic and innovative human pharmaceuticals and active pharmaceutical ingredients. Close to 90% of Teva's sales are in North America and Europe.
