**TEVA ANNOUNCES FINAL APPROVAL OF MIRTAZAPINE ORALLY
DISINTEGRATING TABLETS**

Jerusalem, Israel, June 30, 2005 – Teva Pharmaceutical Industries Ltd. (Nasdaq: TEVA) announced today that the U.S Food and Drug Administration has granted final approval for the company's ANDA for Mirtazapine Orally Disintegrating Tablets (ODT), 15 mg, 30 mg and 45 mg. As one of the companies first to file a Paragraph IV certification for the 45 mg tablet, Teva expects to share 180-day marketing exclusivity for this strength. Shipment of this product is expected to begin in the near future.

Teva's Mirtazapine ODT are the AB-rated generic equivalent of Organon's Remeron[®] SolTabs[®], a product indicated for the treatment of major depressive disorder.

Total annual sales of this multi-sourced product in the U.S. are approximately \$100 million.

Teva Pharmaceutical Industries Ltd., headquartered in Israel, is among the top 20 pharmaceutical companies and among the largest generic pharmaceutical companies in the world. Close to 90% of Teva's sales are in North America and Europe. The company develops, manufactures and markets generic and innovative human pharmaceuticals and active pharmaceutical ingredients.
