Jerusalem, Israel, July 26, 2006 – Teva Pharmaceutical Industries Ltd. (NASDAQ: TEVA) announced today that it will release its second quarter 2006 financial results on Tuesday, August 8, 2006, early in the morning (ET). Teva will host a conference call and live webcast on that same day, at 08:45AM ET to discuss its second quarter 2006 results and overall business environment. A Question & Answer session will follow this discussion.
