## The Notes

The Notes are designed for investors who believe the Reference Asset will appreciate moderately over the term of the Notes. If the Reference Return is below the Buffer Percentage, then the Notes are subject to a 1:1 exposure to any potential decline of the Reference Asset beyond the Buffer Percentage of -10.00%.

If the Reference Asset appreciates over the term of the Notes, you will realize a return equal to 125.00% (1.25x) of the Reference Asset appreciation, subject to a Maximum Cap of at least 28.30% (to be determined on the Pricing Date). Should the Reference Asset decline, you will lose 1% of your investment for every 1% decline in the Reference Asset beyond the Buffer Percentage.


## Payoff Example

We reserve the right to withdraw, cancel or modify this offering and to reject orders in whole or in part. Although the offering of Notes relates to the Reference Asset, you should not construe that fact as a recommendation as to the merits of acquiring an investment linked to the Reference Asset or any security included in the Reference Asset or as to the suitability of an investment in the Notes.

You should read this document together with the prospectus dated February 26, 2018, the prospectus supplement dated February 26, 2018 and the Equity Index Underlying Supplement dated February 26, 2018. If the terms of the Notes offered hereby are inconsistent with those described in the accompanying prospectus, prospectus supplement or Equity Index Underlying Supplement, the terms described in this document shall control. You should carefully consider, among other things, the matters set forth in "Risk Factors" beginning on page FWP-8 of this document, page S-1 of the prospectus supplement and page S-1 of the Equity Index Underlying Supplement, as the Notes involve risks not associated with conventional debt securities. You may revoke your offer to purchase the Notes at any time prior to the time at which we accept your offer by notifying HSBC Securities (USA) Inc. We reserve the right to change the terms of, or reject any offer to purchase, the Notes prior to their issuance. In the event of any material changes to the terms of the Notes, we will notify you.

## PAYMENT AT MATURITY

On the Maturity Date, for each Note you hold, we will pay you the Final Settlement Value, which is an amount in cash, as described below:

**If the Reference Return is greater than zero**, you will receive a cash payment on the Maturity Date, per \$1,000 Principal Amount, equal to the lesser of:

- (a)  $\$1,000 + (\$1,000 \times \text{Reference Return} \times \text{Upside Participation Rate})$ ; and

## INVESTOR SUITABILITY

### The Notes may be suitable for you if:

- ▶ You seek an investment with an enhanced return linked to the potential positive performance of the Reference Asset and you believe the value of the Reference Asset will increase over the term of the Notes.
- ▶ You are willing to invest in the Notes based on the Maximum Cap of at least 28.30% (to be determined on the Pricing Date), which may limit your return at maturity.
- ▶ You are willing to make an investment that is exposed to the negative Reference Return on a 1-to-1 basis for each percentage point that the Reference Return is below the Buffer Percentage of -10.00%.
- ▶ You understand and accept that your investment may not provide full return of principal.

You will be subject to significant risks not associated with conventional fixed-rate or floating-rate debt securities.

### **The Notes are subject to the credit risk of HSBC USA Inc.**

The Notes are senior unsecured debt obligations of the Issuer, HSBC, and are not, either directly or indirectly, an obligation of any third party. As further described in the accompanying prospectus supplement and prospectus, the Notes will rank on par with all of the other unsecured and unsubordinated debt obligations of HSBC, except such obligations as may be preferred by operation of law. Any payment to be made on the Notes, including any return of principal at maturity, depends on the ability of HSBC to satisfy its obligations as they come due. As a result, the actual and perceived creditworthiness of HSBC may affect the market value of the Notes and, in the event HSBC were to default on its obligations, you may not receive the amounts owed to you under the terms of the Notes.

### **The Notes will not bear interest.**

As a holder of the Notes, you will not receive interest payments.

### **The Notes are not insured or guaranteed by any governmental agency of the United States or any other jurisdiction.**

The Notes are not deposit liabilities or other obligations of a bank and are not insured or guaranteed by the Federal Deposit Insurance Corporation or any other governmental agency or program of the United States or any other jurisdiction. An investment in the Notes is subject to the credit risk of HSBC, and in the event that HSBC is unable to pay its obligations as they become due, you may not receive the full payments due on the Notes.

### **The Estimated Initial Value of the Notes, which will be determined by us on the Pricing Date, is expected to be less than the price to public and may differ from the market value of the Notes in the secondary market, if any.**

The Estimated Initial Value of the Notes will be calculated by us on the Pricing Date and is expected to be less than the price to public. The Estimated Initial Value will reflect our internal funding rate, which is the borrowing rate we pay to issue market-linked securities, as well as the mid-market value of the embedded derivatives in the Notes. This internal funding rate is typically lower than the rate we would use when we issue conventional fixed or floating rate debt securities. As a result of the difference between our internal funding rate and the rate we would use when we issue conventional fixed or floating rate debt securities, the Estimated Initial Value of the Notes may be lower if it were based on the prices at which our fixed or floating rate debt securities trade in the secondary market. In addition, if we were to use the rate we use for our conventional fixed or floating rate debt issuances, we would expect the economic terms of the Notes to be more favorable to you. We will determine the value of the embedded derivatives in the Notes by reference to our or our affiliates' internal pricing models. These pricing models consider certain assumptions and variables, which can include volatility and interest rates. Different pricing models and assumptions could provide valuations for the Notes that are different from our Estimated Initial Value. These pricing models rely in part on certain forecasts about future events, which may prove to be incorrect. The Estimated Initial Value does not represent a minimum price at which we or any of our affiliates would be willing to purchase your Notes in the secondary market (if any exists) at any time.

### **The price of your Notes in the secondary market, if any, immediately after the Pricing Date is expected to be less than the price to public.**

The price to public takes into account certain costs. These costs, which will be used or retained by us or one of our affiliates, include the underwriting discount, our affiliates' projected hedging profits (which may or may not be realized) for assuming risks inherent in hedging our obligations under the Notes, and the costs associated with structuring and hedging our obligations under the Notes. If you were to sell your Notes in the secondary market, if any, the price you would receive for your Notes may be less than the price you paid for them because secondary market prices will not take into account these costs. The price of your Notes in the secondary market, if any, at any time after issuance will vary based on many factors, including the value of the Reference Asset and changes in market conditions, and cannot be predicted with accuracy. The Notes are not designed to be short-term trading instruments, and you should, therefore, be able and willing to hold the Notes to maturity. Any sale of the Notes prior to maturity could result in a loss to you.

### **If we were to repurchase your Notes immediately after the Original Issue Date, the price you receive may be higher than the Estimated Initial Value of the Notes.**

Assuming that all relevant factors remain constant after the Original Issue Date, the price at which HSBC Securities (USA) Inc. may initially buy or sell the Notes in the secondary market, if any, and the value that may initially be used for customer account statements, if any, may exceed the Estimated Initial Value on the Pricing Date for a temporary period expected to be approximately 6 months after the Original Issue Date. This temporary price difference may exist because, in our discretion, we may elect to effectively reimburse to investors a portion of the estimated cost of hedging our obligations under the Notes and other costs in connection with the Notes that we will no longer expect to incur over the term of the Notes. We will make such discretionary election and determine this temporary reimbursement period on the basis of a number of factors, including the tenor of the Notes and any agreement we may have with the distributors of the Notes. The amount of our estimated costs which we effectively reimburse to investors in this way may not be allocated ratably throughout the reimbursement period, and we may discontinue such reimbursement at any time or revise the duration of the reimbursement period after the Original Issue Date of the Notes based on changes in market conditions and other factors that cannot be predicted.

**Changes that affect the Reference Asset may affect the value of the Reference Asset and the market value of the Notes and the amount you will receive on the Notes and the amount you will receive at maturity.**

The policies of the reference sponsor of the Reference Asset concerning additions, deletions and substitutions of the stocks included in the Reference Asset, and the manner in which the reference sponsor takes account of certain changes affecting those stocks, may affect the value of the Reference Asset. The policies of the reference sponsor with respect to the calculation of the Reference Asset could also affect the value of the Reference Asset. The reference sponsor may discontinue or suspend calculation or dissemination of the Reference Asset. Any such actions could affect the value of the Reference Asset and the value of and the return on the Notes.

**You will not have any ownership interest in the stocks included in the Reference Asset.**

As a holder of the Notes, you will not have any ownership interest in the stocks included in the Reference Asset, such as rights to vote, dividend payments or other distributions. Because the return on the Notes will not reflect any dividends on those stocks, the Notes may underperform an investment in the stocks included in the Reference Asset.

**The Notes lack liquidity.**

The Notes will not be listed on any securities exchange or automated quotation system. HSBC Securities (USA) Inc. is not required to offer to purchase the Notes in the secondary market, if any exists. Even if there is a secondary market, it may not provide enough liquidity to allow you to trade or sell the Notes easily. Because other dealers are not likely to make a secondary market for the Notes, the price at which you may be able to trade your Notes is likely to depend on the price, if any, at which HSBC Securities (USA) Inc. is willing to buy the Notes.

**Potential conflicts of interest may exist.**

An affiliate of HSBC has a minority equity interest in the owner of an electronic platform, through which we may make available certain structured investments offering materials. HSBC and its affiliates play a variety of roles in connection with the issuance of the Notes, including acting as calculation agent and hedging our obligations under the Notes. In performing these duties, the economic interests of the calculation agent and other affiliates of ours are potentially adverse to your interests as an investor in the Notes. We will not have any obligation to consider your interests as a holder of the Notes in taking any action that might affect the value of your Notes.

**Uncertain tax treatment.**

For a discussion of the U.S. federal income tax consequences of your investment in a Note, please see the discussion under "U.S. Federal Income Tax Considerations" herein and the discussion under "U.S. Federal Income Tax Considerations" in the accompanying prospectus supplement.

**Your investment in the Notes may result in a loss.**

You will be exposed to the decline in the Final Value from the Initial Value beyond the Buffer Percentage of -10.00%. Accordingly, if the Reference Return is less than the Buffer Percentage of -10.00%, your Payment at Maturity will be less than the Principal Amount of your Notes. You will lose some or a significant portion (up to 90.00%) of your investment at maturity if the Reference Return is less than the Buffer Percentage.

**The amount payable on the Notes is not linked to the value of the Reference Asset at any time other than on the Final Valuation Date.**

The Final Value will be based on the Official Closing Level of the Reference Asset on the Final Valuation Date, subject to postponement for non-trading days and certain Market Disruption Events. Even if the value of the Reference Asset appreciates during the term of the Notes other than on the Final Valuation Date but then decreases on the Final Valuation Date to a value that is less than the Initial Value, the Payment at Maturity may be less, and may be significantly less, than it would have been had the Payment at Maturity been linked to the value of the Reference Asset prior to such decrease. **The NYFANG has limited actual historical information.**

The NYFANG was launched on September 26, 2017. Because the NYFANG is of recent origin and limited actual historical performance data exists with respect to it, your investment in the Notes may involve a greater risk than investing in securities linked to an index with a more established record of performance.

The historical performance of the NYFANG should not be taken as an indication of its future performance. While the trading prices of the NYFANG's constituents (the "NYFANG constituents") will determine the Official Closing Level, it is impossible to predict whether the Official Closing Level will fall or rise. Trading prices of the NYFANG constituents will be influenced by the complex and interrelated economic, financial, regulatory, geographic, judicial, tax, political and other factors that can affect the capital markets generally and the equity trading markets on which the NYFANG constituents are traded, and by various circumstances that can influence the prices of the NYFANG constituents. Due to the small number of NYFANG constituents, the level of the NYFANG may be materially affected by changes in the level of a small number of NYFANG constituents, or even one NYFANG constituent.

**The NYFANG lacks diversification and is vulnerable to fluctuations in the technology and consumer discretionary industries.**

All of the stocks included in the NYFANG are issued by companies whose primary lines of business are in the technology and consumer discretionary industries. As a result, the stocks that will determine the performance of the NYFANG and hence, the value of the Notes, are concentrated in two industries and vulnerable to events affecting those industries. Although an investment in the Notes will not give holders any ownership or other direct interests in the NYFANG constituents, the return on an investment in the Notes will be subject to certain risks, including those described below, associated with a direct equity investment in companies in the technology and consumer

discretionary industries. Accordingly, by investing in the Notes, you will not benefit from the diversification which could result from an investment linked to companies that operate in multiple sectors. The NYFANG is also subject to the risk that large-capitalization stocks may underperform other segments of the equity market or the equity market as a whole. Larger, more established companies may be unable to respond quickly to new competitive challenges such as changes in technology and may not be able to attain the high growth rate of smaller companies, especially during extended periods of economic expansion.

The NYFANG currently includes constituents in the following categories:

- *Information Technology Sector Risk.* The information technology sector includes companies engaged in internet software and services, technology hardware and storage peripherals, electronic equipment instruments and components, and semiconductors and semiconductor equipment. Information technology companies face intense competition, both domestically and internationally, which may have an adverse effect on profit margins. Information technology companies may have limited product lines, markets, financial resources or personnel. The products of information technology companies may face rapid product obsolescence due to technological developments and frequent new product introduction, unpredictable changes in growth rates and competition for the services of qualified personnel. Failure to introduce new products, develop and maintain a loyal customer base, or achieve general market acceptance for their products could have a material adverse effect on a company's business. Companies in the information technology sector are heavily dependent on intellectual property and the loss of patent, copyright and trademark protections may adversely affect the profitability of these companies.
- *Internet Company Risk.* Many internet-related companies have incurred large losses since their inception and may continue to incur large losses in the hope of capturing market share and generating future revenues. Accordingly, many such companies expect to incur significant operating losses for the foreseeable future, and may never be profitable. The markets in which many internet companies compete face rapidly evolving industry standards, frequent new service and product announcements, introductions and enhancements, and changing customer demands. The failure of an internet company to adapt to such changes could have a material adverse effect on the company's business. Additionally, the widespread adoption of new internet, networking, telecommunications technologies, or other technological changes, could require substantial expenditures by an internet company to modify or adapt its services or infrastructure, which could have a material adverse effect on an internet company's business.
- *Semiconductor Company Risk.* Competitive pressures may have a significant effect on the financial condition of semiconductor companies and, as product cycles shorten and manufacturing capacity increases, these companies may become increasingly subject to aggressive pricing, which hampers profitability. Reduced demand for end-user products, under-utilization of manufacturing capacity, and other factors could adversely impact the operating results of companies in the semiconductor sector. Semiconductor companies typically face high capital costs and may be heavily dependent on intellectual property rights. The semiconductor sector is highly cyclical, which may cause the operating results of many semiconductor companies to vary significantly. The stock prices of companies in the semiconductor sector have been and likely will continue to be extremely volatile.
- *Software Industry Risk.* The software industry can be significantly affected by intense competition, aggressive pricing, technological innovations, and product obsolescence. Companies in the software industry are subject to significant competitive pressures, such as aggressive pricing, new market entrants, competition for market share, short product cycles due to an accelerated rate of technological developments and the potential for limited earnings and/or falling profit margins. These companies also face the risks that new services, equipment or technologies will not be accepted by consumers and businesses or will become rapidly obsolete. These factors can affect the profitability of these companies and, as a result, the value of their securities. Also, patent protection is integral to the success of many companies in this industry, and profitability can be affected materially by, among other things, the cost of obtaining (or failing to obtain) patent approvals, the cost of litigating patent infringement and the loss of patent protection for products (which significantly increases pricing pressures and can materially reduce profitability with respect to such products). In addition, many software companies have limited operating histories. Prices of these companies' securities historically have been more volatile than other securities, especially over the short term.
- *Internet Information Provider Company Risk.* Internet information provider companies provide internet navigation services and reference guide information and publish, provide or present proprietary advertising and/or third party content. These companies often derive a large portion of their revenues from advertising, and a reduction in spending by or loss of advertisers could seriously harm their business. Concerns regarding a company's products, services or processes that may compromise the privacy of users or other privacy related matters, even if unfounded, could damage a company's reputation and adversely affect operating results.
- *Catalog and Mail Order House Company Risk.* Catalog and mail order house companies may be exposed to significant inventory risks that may adversely affect operating results due to, among other factors: seasonality, new product launches, rapid changes in product cycles and pricing, defective merchandise, changes in consumer demand and consumer spending patterns, or changes in consumer tastes with respect to products. Demand for products can change significantly between the time inventory or components are ordered and the date of sale. The acquisition of certain types of inventory or components may require significant lead-time and prepayment and they may not be returnable. Failure to adequately predict customer demand or otherwise optimize and operate distribution centers could result in excess or insufficient inventory or distribution capacity, result in increased costs, impairment charges, or both. Increased website traffic during peak periods could cause system interruptions which may reduce the volume of goods sold and the attractiveness of a company's products and services.

**A limited number of NYFANG constituents may affect the Official Closing Level, and the NYFANG is not necessarily representative of its focus industry.**

Each of the NYFANG constituents represents 10% of the weight of the NYFANG as of each quarterly rebalancing date (based on the 10 NYFANG constituents as of the date of this document). Any reduction in the market price of any of those stocks is likely to have a substantial adverse impact on the Official Closing Level and the value of the Notes. Due to the small number of NYFANG constituents, those NYFANG constituents and the NYFANG itself may not necessarily follow the price movements of the entire technology and consumer discretionary industries. If the NYFANG constituents decline in value, the NYFANG will also decline in value, even if common stock prices of other companies in the technology and consumer discretionary industries generally increase in value. Giving effect to leverage, negative changes in the performance of one NYFANG constituent will be magnified and have a material adverse effect on the value of the Notes.

**A NYFANG constituent may be replaced upon the occurrence of certain adverse events.**

An exchange may delist a NYFANG constituent. Procedures have been established by the ICE Data Indices, LLC to address such an event. Because there are only 10 NYFANG constituents as of the date of this document, there can be no assurance that the replacement or delisting of the NYFANG constituents, or any other force majeure event, will not have an adverse or distortive effect on the Official Closing Level or the manner in which it is calculated and, therefore, may have any adverse impact on the value of the Notes. A NYFANG constituent may also be removed from the NYFANG, as described herein.

**The NYFANG uses a proprietary selection methodology, which may not select the constituent issuers in the same manner as would other index providers or market participants.**

Using a proprietary methodology discussed below, the NYFANG seeks to identify constituent issuers that exhibit characteristics of highly-traded, high-growth technology and internet/media stocks. When selecting future constituent issuers, ICE Data Indices, LLC will focus on distinguishing between traditional technology and service companies and newer, innovative, technology-utilizing companies. There can be no assurances that the proprietary methodology used to identify constituent issuers eligible for inclusion in the NYFANG will be successful. ICE Data Indices, LLC's methodology, to some extent, involves subjective judgments, and there can be no assurance that any or all constituent issuers included in the NYFANG would be selected by other market participants using a similar selection process.

**The NYFANG seeks to identify constituent issuers that exhibit characteristics of highly-traded stocks.**

The NYFANG seeks to identify constituent issuers that exhibit characteristics of highly-traded, high-growth technology and internet/media stocks. Highly-traded stocks may be more susceptible to periods of over-valuation followed by "corrections" or rapid decreases in share price and may also be more sensitive to general market fluctuations or shocks. Consequently, the price of the NYFANG constituents, and therefore the level of the NYFANG, may decrease more rapidly during periods of market stress than other less highly-traded constituents or indices.

**We are not currently affiliated with any of the constituent issuers.**

We are not currently affiliated with any of the constituent issuers. As a result, we have no ability, nor expect to have the ability in the future, to control the actions of such constituent issuers, including actions that could affect the value of the NYFANG constituents or the value of your Notes, and we are not responsible for any disclosure made by any other company. None of the money you pay us will go to any of the constituent issuers represented in the NYFANG and none of the constituent issuers will be involved in the offering of the Notes in any way. The constituent issuers will not have any obligation to consider your interests as a holder of the Notes in taking any corporate actions that might affect the value of your Notes. In the event we become affiliated with any of the constituent issuers, we will have no obligation to consider your interests as a holder of the Notes in taking any action with respect to such constituent issuer that might affect the value of your Notes.

## ILLUSTRATIVE EXAMPLES

The following table and examples are provided for illustrative purposes only and are hypothetical. They do not purport to be representative of every possible scenario concerning increases or decreases in the value of the Reference Asset relative to its Initial Value. The following examples indicate how the Final Settlement Value would be calculated with respect to a hypothetical \$1,000 investment in the Notes.

**Example 1: The value of the Reference Asset increases from the Initial Value of 1,000.00 to a Final Value of 1,113.20.**

Reference Return:	11.32%
<b>Final Settlement Value:</b>	<b>\$1,141.50</b>

Because the Reference Return is positive, and the Reference Return multiplied by the Upside Participation Rate is less than the hypothetical Maximum Cap, the Final Settlement Value would be \$1,141.50 per \$1,000 Principal Amount, calculated as follows:

Example 1 shows that you will receive the return of your principal investment plus a return equal to the Reference Return multiplied by the Upside Participation Rate when the Reference Asset appreciates and such Reference Return multiplied by the Upside Participation Rate does not exceed the hypothetical Maximum Cap.

**Example 2: The value of the Reference Asset increases from the Initial Value of 1,000.00 to a Final Value of 1,339.60.**

Reference Return:	33.96%
<b>Final Settlement Value:</b>	<b>\$1,283.00</b>

Because the Reference Return is positive, and the Reference Return multiplied by the Upside Participation Rate is greater than the hypothetical Maximum Cap, the Final Settlement Value would be \$1,283.00 per \$1,000 Principal Amount, calculated as follows:

Example 2 shows that you will receive the return of your principal investment plus a return equal to the hypothetical Maximum Cap when the Reference Return is positive, and such Reference Return multiplied by the Upside Participation Rate exceeds the hypothetical Maximum Cap.

**Example 3: The value of the Reference Asset decreases from the Initial Value of 1,000.00 to a Final Value of 950.00.**

Reference Return:	-5.00%
<b>Final Settlement Value:</b>	<b>\$1,000.00</b>

Because the Reference Return is less than zero but greater than the Buffer Percentage of -10.00%, the Final Settlement Value would be \$1,000.00 per \$1,000 Principal Amount (a zero return).

**Example 4: The value of the Reference Asset decreases from the Initial Value of 1,000.00 to a Final Value of 850.00.**

Reference Return:	-15.00%
<b>Final Settlement Value:</b>	<b>\$950.00</b>

Because the Reference Return is less than the Buffer Percentage of -10.00%, the Final Settlement Value would be \$950.00 per \$1,000 Principal Amount, calculated as follows:

Example 4 shows that you are exposed on a 1-to-1 basis to declines in the value of the Reference Asset beyond the Buffer Percentage of 10.00%. You will lose some or a significant portion (up to 90.00%) of your investment.

We have not undertaken any independent review or due diligence of such information. ICE Data has no obligation to continue to publish, and may discontinue the publication of, the NYFANG. The description of the NYFANG is summarized from its governing methodology, which is available at [www.theice.com/publicdocs/data/NYSE\\_FANGplus\\_Index\\_Methodology.pdf](http://www.theice.com/publicdocs/data/NYSE_FANGplus_Index_Methodology.pdf). Neither the methodology nor any other information included on that website is included or incorporated by reference into this document.

### Introduction

The NYFANG is an equal-dollar weighted index designed to represent a segment of the technology and consumer discretionary sectors consisting of highly-traded growth stocks of technology and tech-enabled companies such as Facebook, Inc., Apple Inc., Amazon.com, Inc., Netflix, Inc. and Google (Alphabet Inc.). The NYFANG currently has 10 constituents, which is the minimum number, but it may have more than 10 constituents in the future. The NYFANG was launched on September 26, 2017.

### NYFANG Universe

The NYFANG universe will consist of all stocks classified as Consumer Discretionary or Technology by ICE Data that are listed on a major U.S. stock exchange, such as the NYSE, Nasdaq or NYSE American. American Depositary Receipts are eligible for inclusion in the NYFANG.

### NYFANG Constituent Selection

At each quarterly rebalance, the NYFANG universe will be screened utilizing a proprietary methodology that references, among other factors, sector classification, revenue growth and an analysis of the applicable issuer’s business. The following steps will be executed:

- Stocks must have a market capitalization (including all share classes and unlisted shares) of at least \$5 billion;
- Stocks must have a trailing six month average daily traded value (ADTV / turnover) of \$50 million on the specific listing line;
- The ICE Data Indices Governance Committee (the “Governance Committee”) will oversee a process to select FANG and FANG-related stocks. The FANG stocks include Facebook, Inc., Apple Inc., Amazon.com, Inc., Netflix, Inc., Google (Alphabet Inc.). Other stocks selected for the NYFANG, in addition to satisfying the criteria in the two subparagraphs above, should exhibit characteristics of high-growth technology and internet/media stocks. ICE Data and its Governance Committee will focus on distinguishing between traditional technology and services companies and newer, innovative, technology utilizing companies using, among other factors, sector classification, revenue growth and an analysis of the issuer’s business.
- The final list of companies will be equally weighted based upon the prices and NYFANG market capitalization as of the close of trading on the third Friday of March, June, September, and December.

### Rebalances and Frequency

The general aim of the quarterly rebalance of the NYFANG is to ensure that the selection and weightings of the NYFANG constituents continues to reflect as closely as possible the NYFANG’s objective of representing a segment of the technology and consumer discretionary sectors consisting of the most highly-traded and high-growth technology and internet/media stocks such as Facebook, Inc., Apple Inc., Amazon.com, Inc., Netflix, Inc., Google (Alphabet Inc.).

The NYFANG Administrator reserves the right to, at any time, change the number of stocks comprising the NYFANG by adding or deleting one or more stocks, or replacing one or more stocks contained in the NYFANG with one or more substitute stocks of its choice, if in the NYFANG Administrator’s discretion such addition, deletion or substitution is necessary or appropriate to maintain the quality and/or character of the NYFANG. Any such action would need to be approved by the Governance Committee.

Changes to the NYFANG constituents may occur during a scheduled rebalance and as a result of the removal of an NYFANG constituent. The quarterly NYFANG rebalance becomes effective after the close of the third Friday of March, June, September, and December. The rebalance announcement will be made after the close of the Wednesday preceding that third Friday. The reference date for all company-specific data and information utilized in the rebalancing process will be taken from that same day, with exception of the prices utilized to determine the shares, which will be taken from the third Friday.

### Periodical Weighting Adjustment

At quarterly NYFANG rebalances, the NYFANG will be rebalanced according to the methodology described above under “—NYFANG Universe” and “—NYFANG Constituent Selection.”

### NYFANG Calculation

The NYFANG is calculated on a price return basis. The current NYFANG level would be calculated by dividing the current modified NYFANG market capitalization by the NYFANG divisor. The divisor was determined based on the initial capitalization base of the NYFANG and the base level. The divisor is updated as a result of corporate actions and composition changes. The general formula for the NYFANG is:

$$\text{Index(PR)}_t = \frac{\sum_i P_{i,t} Q_{i,t}}{D_t}$$

Where:

$t$  means NYFANG Calculation Date  $t$

$D_t$  means the NYFANG divisor on NYFANG Calculation Date  $t$

$P_{i,t}$  means the price of NYFANG constituent  $i$  on NYFANG Calculation Date  $t$

$Q_{i,t}$  means the number of shares of NYFANG constituent  $i$  on NYFANG Calculation Date  $t$

NYFANG Calculation Date means a U.S. Business Day where all of the Constituent Exchanges are open.

The **NYFANG Divisor  $D_t$**  will be adjusted for corporate actions and any additions, deletions, and share changes for the NYFANG Constituents:

$$D_t = \frac{\sum_i APC_{i,t} Q_t}{\text{Index(PR)}_{t-1}}$$

Where:

$D_t$  means the NYFANG divisor on NYFANG Calculation Date  $t$

$\text{Index(PR)}_{t-1}$  means the Price Return NYFANG Level from Date  $t-1$

$APC_{i,t}$  means the Adjusted Previous Close Price (for corporate actions, and, denominated in the NYFANG Base Currency) of NYFANG Constituent  $i$  on NYFANG Calculation Date  $t-1$

$Q_{i,t}$  means the number of shares of NYFANG constituent  $i$  on NYFANG Calculation Date  $t-1$

The Base Date for the NYFANG is September 19, 2014, and the Base Level is 1,000.00.

### Corporate Actions

*General.* The NYFANG may be adjusted in order to maintain the continuity of the NYFANG level and the composition. Adjustments take place in reaction to events that occur with NYFANG constituents in order to mitigate or eliminate the effect of that event on NYFANG performance.

*Removal of constituents.* Any NYFANG constituent deleted from the NYFANG as a result of a corporate action such as a merger, acquisition, spin-off, delisting or bankruptcy will be replaced by a new stock. Thus, the total number of NYFANG constituents in the NYFANG will stay constant. The Governance Committee would select a replacement stock that reflects the NYFANG's objective and is in line with the rebalancing selection criteria as set forth above under "—NYFANG Universe" and "—NYFANG Constituent Selection." If an NYFANG constituent is removed and replaced in the NYFANG, the divisor will be adjusted to maintain the NYFANG level.

### Mergers and Acquisitions.

- Merger or acquisition between NYFANG constituents: In the event a merger or acquisition occurs between NYFANG constituents, the acquired company is deleted and will be replaced by another company. There will be no change made to the acquiring company's inclusion in the NYFANG.
- Merger or acquisition between a NYFANG constituent and a non-member: A non-member is defined as a company that is not a current NYFANG constituent. A merger or acquisition between a NYFANG constituent and one non-member can take two forms:
  - The acquiring company is a NYFANG constituent and the acquired company is not. There will be no action taken as to inclusion in the NYFANG.
  - The acquiring company is not a NYFANG constituent, but the acquired company is a NYFANG constituent. The acquired company is removed from the NYFANG and will be replaced by another company. It is possible, but not necessary, that the replacement company selected for the NYFANG will be the acquiring company.

*Suspensions and company distress.* Immediately upon a NYFANG constituent filing for bankruptcy, an announcement will be made to remove the stock from the NYFANG effective for the next business day following the bankruptcy. If the stock is trading on an over-the-counter (OTC) market, the last trade or price on that market is utilized as the deletion price on that day.

If the stock does not trade on the relevant exchange between the bankruptcy announcement and the deletion effective date, the stock may be deleted from the NYFANG in that corporate action with a presumed market value of \$0.

*Price sources.* In the event that the trading in shares is suspended or halted, the last known price established during regular daytime trading on the primary exchange will be used. Depending on the particular situation, the NYFANG administrator may choose to value the security at a price of \$0 for purposes of NYFANG calculation and/or NYFANG corporate action. This would be applicable for certain extreme cases such as a company bankruptcy or severe distress when the security is no longer tradeable.

*Spin-offs.* The closing price of the NYFANG constituent is adjusted by the value of the spin-off, and the shares of the NYFANG constituent will be adjusted to maintain its existing weighting in the NYFANG. The divisor will be adjusted to account for any changes in the overall NYFANG market capitalization. Spun-off companies will not be added into the NYFANG at the time of the event.

*Dividends.* The NYFANG calculation incorporates regular cash dividends paid on the NYFANG constituents and reinvests those distributions into the NYFANG at the open of the dividend ex-date.

*Rights issues and other rights.*

In the event of a rights issue, the price is adjusted for the value of the right before the open on the ex-date, and the shares are increased to maintain the NYFANG constituent's existing weighting within the NYFANG. The adjustment assumes that the rights issue is fully subscribed. The amount of the price adjustment is determined from the terms of the rights issue, including the subscription price, and the price of the underlying security. The NYFANG administrator shall only enact adjustments if the rights represent a positive value, or are in-the-money, or alternatively, represent or can be converted into a tangible cash value.

*Bonus issues, stock splits and reverse stock splits.* For bonus issues, stock splits and reverse stock splits, the number of shares included in the NYFANG will be adjusted in accordance with the ratio given in the corporate action. Since the event will also incorporate a corresponding price adjustment and will not change the value of the company included in the NYFANG, the divisor will not be changed because of this.

*Changes in number of shares.* Changes in the number of shares outstanding, typically due to share repurchases, tenders, or offerings, will not be reflected in the NYFANG.

## **NYFANG Governance**

ICE Data is responsible for the day-to-day management of the NYFANG, including retaining primary responsibility for all aspects of the NYFANG determination process, including implementing appropriate governance and oversight, as required under the International Organization of Securities Commission's Principles for Financial Benchmarks (the "IOSCO Principles"). The Governance Committee is responsible for helping to ensure ICE Data's overall compliance with the IOSCO Principles, by performing the Oversight Function which includes overseeing the NYFANG development, design, issuance and operation of the NYFANG, as well as reviewing the control framework. ICE Data is also responsible for decisions regarding the interpretation of the NYFANG methodology and the Governance Committee is responsible for reviewing all rule book modifications and Index constituent changes to ensure that they are made objectively, without bias, and in accordance with applicable law and regulation and ICE Data's policies and procedures. Consequently, all ICE Data's and the Governance Committee discussions and decisions are confidential until released to the public.

*Cases not covered in the methodology.* In cases which are not expressly covered in the methodology, operational adjustments will take place along the lines of the aim of the NYFANG. Operational adjustments may also take place if, in the opinion of the NYFANG administrator, it is desirable to do so to maintain a fair and orderly market in derivatives on the NYFANG and/or this is in the best interests of the investors in products based on the NYFANG and/or the proper functioning of the markets. Any such modifications described in this paragraph will also be governed by any applicable and outstanding policies and procedures in place by ICE Data at such time.

*Methodology changes.* The Governance Committee reviews all methodology modifications and NYFANG changes to ensure that they are made objectively, without bias and in accordance with applicable law and regulation and ICE Data's policies and procedures. The methodology may be supplemented, amended in whole or in part, revised or withdrawn at any time. Supplements, amendments, revisions and withdrawals may also lead to changes in the way the NYFANG is compiled or calculated or affect the NYFANG in another way. Any such modifications described in this paragraph will also be governed by any applicable and outstanding policies and procedures in place by ICE Data at such time.

## **Dissemination**

The NYFANG is calculated from 9:30 a.m. until 6:00 p.m. Eastern Time on those days specified as "NYFANG Business Days," as that term is defined in the NYFANG methodology. Solely for the purpose of the preceding sentence and not for the purpose of any calculation of the value of the Notes, NYFANG Business Days will be classified as days on which the U.S. Equity Markets (NYSE, Nasdaq, and NYSE American) are open for a full or partial day of trading.

## **Exceptional Market Conditions and Corrections**

The NYFANG administrator retains the right to delay the publication of the opening level of the NYFANG. Furthermore, the NYFANG administrator retains the right to suspend the publication of the level of the NYFANG if it believes that circumstances prevent the proper calculation of the Index.

If NYFANG constituent prices are cancelled, the NYFANG will not be recalculated unless the NYFANG administrator decides otherwise.

Commercially reasonable efforts are made to ensure the correctness and validity of data used in real-time NYFANG calculations. If incorrect price or corporate action data affects NYFANG daily highs, lows, or closes, it is corrected retroactively as soon as possible and all revisions are communicated out to the public and market data vendors.

## **Announcements**

Changes to the NYFANG methodology which arise as a result of market feedback, consultations, internal reviews, or otherwise will be communicated by a NYFANG announcement which will be distributed by ICE Data at <https://www.theice.com/market-data/indices/equity-indices> and NYSE Market Data at <https://www.theice.com/market-data/indices/equity-indices/products>. The information included in those websites will not be deemed to be included or incorporated by reference in this document.

As a general rule, the announcement periods that are mentioned below will be applied. However, urgently required corporate action treatments, often resulting from late notices from the relevant company or exchange, may require the NYFANG administrator to deviate from the standard timing.

***Inclusion of new NYFANG constituents.*** The inclusion of new companies in the NYFANG will typically only occur during the quarterly rebalance, although there could be exceptions based on a specific corporate action affecting a current Index constituent during the year. The inclusion of the new company will be announced at least one week before the effective date of the actual inclusion. For example, for the rebalance effective for September 18, 2018, the announcement would have occurred after the close on September 6, 2018.

***Removal of NYFANG constituents.*** NYFANG constituents would be removed from the NYFANG as a result of periodic corporate actions as well as the results of the quarterly rebalance. All removals will be announced at least three trading days before the effective date of the removal. It should be noted that in the case of mergers and acquisitions, every effort will be made to remove the company at some reasonable time ahead of the suspension in trading in the acquired company. There will be certain situations and corporate actions that would require the removal of a company that has already ceased trading. In those cases, the company will be removed from the NYFANG at its last traded price, or, at the discretion of the NYFANG Administrator, at a derived price that most accurately represents its post-suspension value.

***Corporate actions.*** In case of an event that could affect one or more NYFANG constituents, the NYFANG administrator will inform the market about the intended treatment of the event in the Index shortly after the firm details have become available and have been confirmed. When possible, the corporate action will be announced, even if not all information is known, at least one trading day before the effective date of the action. Once the corporate action has been effectuated, the NYFANG administrator will confirm the changes in a separate announcement.

***Methodology changes.*** Barring exceptional circumstances, a period of at least two months should pass between the date a proposed methodology change is published and the date it goes into effect. Exceptions can be made if the change is not in conflict with the interests of a "Stakeholder," which specifically includes external parties that subscribe to the NYFANG data or license it as the basis for an investment product, including, but not limited to, HSBC.

***Reviews; publication of new selection.*** The new composition of the NYFANG, including the companies to be a part of the NYFANG and their corresponding new Index weights, will be announced at least three trading days before the effective date and can be accessed from NYSE Market Data at [www.nyse.com/market-data/indices](http://www.nyse.com/market-data/indices).



An affiliate of HSBC has paid or may pay in the future an amount to broker-dealers in connection with the costs of the continuing implementation of systems to support the Notes.

## U.S. FEDERAL INCOME TAX CONSIDERATIONS

We will not attempt to ascertain whether any of the entities whose stock is included in the Reference Asset would be treated as a passive foreign investment company (“PFIC”) or United States real property holding corporation (“USRPHC”), both as defined for U.S. federal income tax purposes. If one or more of the entities whose stock is included in the Reference Asset were so treated, certain adverse U.S. federal income tax consequences might apply. A “dividend equivalent” payment is treated as a dividend from sources within the United States and such payments generally would be subject to a 30% U.S. withholding tax if paid to a non-U.S. holder. Under U.S. Treasury Department regulations, payments (including deemed payments) with respect to equity-linked instruments (“ELIs”) that are “specified ELIs” may be treated as dividend equivalents if

such specified ELIs reference an interest in an “underlying security,” which is generally any interest in an entity taxable as a corporation for U.S. federal income tax purposes if a payment with respect to such interest could give rise to a U.S. source dividend. However, Internal Revenue Service guidance provides that withholding on dividend equivalent payments will not apply to specified ELIs that are not delta-one instruments and that are issued before January 1, 2023. Based on the Issuer’s determination that the Notes are not “delta-one” instruments, non-U.S. holders should not be subject to withholding on dividend equivalent payments, if any, under the Notes. However, it is possible that the Notes could be treated as deemed reissued for U.S. federal income tax purposes upon the occurrence of certain events affecting the Reference Asset or the Notes, and following such occurrence the Notes could be treated as subject to withholding on dividend equivalent payments. Non-U.S. holders that enter, or have entered, into other transactions in respect of the Reference Asset or the Notes should consult their tax advisors as to the application of the dividend equivalent withholding tax in the context of the Notes and their other transactions.
