

## Contingent Income Auto-Callable Securities due June 14, 2024

Based on the Worst Performing of the Common Equity Securities of Apple, Inc., Alphabet Inc. and Netflix Inc.

### Principal at Risk Securities

Contingent Income Auto-Callable Securities, which we refer to as the securities, do not guarantee the payment of interest or the repayment of the stated principal amount. Instead, the securities offer the opportunity for investors to earn a contingent quarterly payment at an annual rate of at least 10.25% of the stated principal amount, with respect to each determination date on which the closing price of the worst performing underlying is greater than or equal to 70.00% of its initial share price, which we refer to as the downside threshold level. In addition, if the closing price of the worst performing underlying is greater than or equal to its initial share price on any of the first 11 determination dates, the securities will be automatically redeemed for an amount per security equal to the sum of the stated principal amount and the contingent quarterly payment with respect to the related determination date. If the securities have not been previously redeemed and the final share price of the worst performing underlying is greater than or equal to its downside threshold level, the payment at maturity will be the sum of the stated principal amount and the contingent quarterly payment with respect to the final determination date. If the securities have not been previously redeemed and the final share price of the worst performing underlying is less than its downside threshold level, but greater than or equal to its principal barrier level, the payment at maturity will be the principal amount. However, if the securities have not been previously redeemed and the final share price of the worst performing underlying is less than its principal barrier level, you will be exposed to the decline in the closing price of the worst performing underlying, as compared to its initial share price, on a 1 to 1 basis and will receive a payment at maturity that is less than 65.00% of the stated principal amount of the securities and could be zero. The actual contingent quarterly payment will be determined on the pricing date. The contingent quarterly payment, if any, will be payable quarterly on the contingent payment date (which is the third business day after the related determination date) or the maturity date, as applicable. It is possible that the closing price of one or more underlyings could remain below their respective downside threshold levels for extended periods of time or even throughout the term of the securities so that you may receive few or no contingent quarterly payments.

If the determination closing price of the worst performing underlying is greater than or equal to its initial share price on any of the first 11 determination dates, the securities will be automatically redeemed for an early redemption payment equal to the stated principal amount plus the contingent quarterly payment with respect to the related determination date. If the securities have not previously been redeemed and the final share price of the worst performing underlying is greater than or equal to its downside threshold level, the payment at maturity will be the stated principal amount and, the contingent quarterly payment with respect to the final determination date. If the securities have not been previously redeemed and the final share price of the worst performing underlying is less than its downside threshold level, but greater than or equal to its principal barrier level, the payment at maturity will be the principal amount. ### Key Investment Rationale

The securities offer investors an opportunity to earn a contingent quarterly payment at an annual rate of at least 10.25% of the stated principal amount with respect to each determination date on which the determination closing price or the final share price, as applicable, of the worst performing underlying is greater than or equal to its downside threshold level. The actual contingent quarterly payment will be determined on the pricing date. The securities may be redeemed prior to maturity for the stated principal amount per security *plus* the applicable contingent quarterly payment, and the payment at maturity will vary depending on the final share price of the worst performing underlying, as follows:

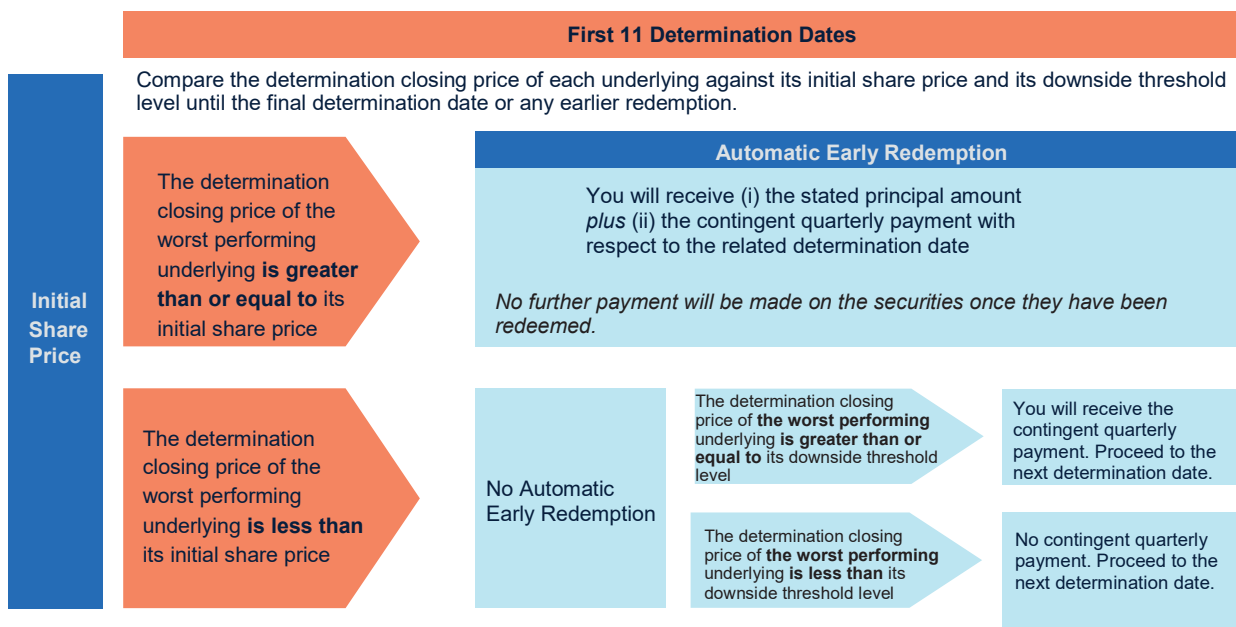

The following diagrams illustrate the potential outcomes for the securities depending on (1) the determination closing price and (2) the final share price of each underlying.

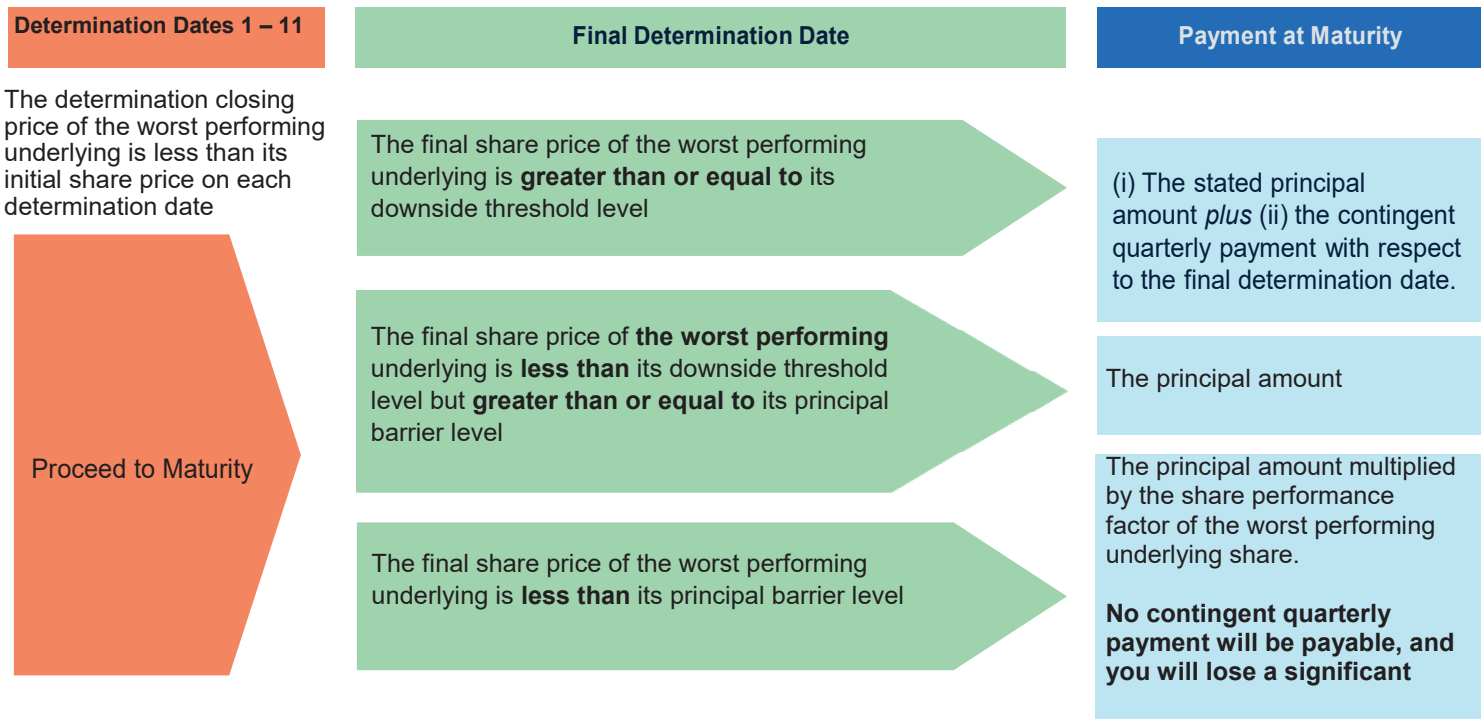
#### Diagram #1: First 11 Determination Dates

### Hypothetical Examples

The below examples are based on the following terms:

Hypothetical Initial Share Price:	With respect to each underlying, \$100.00
Hypothetical Downside Threshold Level:	With respect to each underlying, \$70.00, which is 70.00% of its hypothetical initial share price
Hypothetical Principal Barrier Level:	With respect to each underlying, \$65.00, which is 65.00% of its hypothetical initial share price
Hypothetical Contingent Quarterly Payment:	10.25% per annum (corresponding to \$0.25625 (or 2.5625%) per quarter per security)
Stated Principal Amount:	\$10 per security

In Examples 1 and 2, the closing prices of the underlyings fluctuate over the term of the securities and the determination closing price of the worst performing underlying is greater than or equal to its hypothetical initial share price on one of the first 11 determination dates. Because the determination closing price of the worst performing underlying is greater than or equal to its initial share price on one of the first 11 determination dates, the securities are automatically redeemed following the relevant determination date. In Examples 3 and 4, the determination closing price of at least **one** underlying on the first 11 determination dates is less than its initial share price, and, consequently, the securities are not automatically redeemed prior to, and remain outstanding until, maturity.

\* The early redemption payment includes the unpaid contingent quarterly payment with respect to the determination date on which the determination closing price of each underlying is greater than or equal to its initial share price and the securities are redeemed as a result.

- In **Example 1**, the securities are automatically redeemed following the first determination date as the determination closing price of the worst performing underlying on the first determination date is greater than or equal to its initial share price. You would receive the early redemption payment, calculated as follows:

$$\text{stated principal amount} + \text{contingent quarterly payment} = \$10 + \$0.25625 = \$10.25625$$

*In this example, the early redemption feature limits the term of your investment to approximately 3 months and you may not be able to reinvest at comparable terms or returns. If the securities are redeemed early, you will not receive any additional contingent quarterly payments.*

- In **Example 2**, since the determination closing price of the worst performing underlying on the 1st determination date is greater than its downside threshold level, you would receive the contingent payment of \$0.25625 with respect to that determination date. You would receive no contingent payment with respect to the 2<sup>nd</sup> through 10<sup>th</sup> determination dates, since the determination closing price of at least one underlying on each of those determination dates is less than its downside threshold level. The securities are automatically redeemed following the 11<sup>th</sup> determination date, as the determination closing price of the worst performing underlying on that day is greater than or equal to its initial share price. Following the 11<sup>th</sup> determination date, you would receive an Early Redemption Payment of \$10.25625, which includes the contingent quarterly payment with respect to the 11<sup>th</sup> determination date.

*In this example, the early redemption feature limits the term of your investment to approximately 3 months and you may not be able to reinvest at comparable terms or returns. If the securities are redeemed early, you will not receive any additional contingent quarterly payments.*

Examples 3 and 4 illustrate the payment at maturity per security based on the final share price of the worst performing underlying.

- In **Example 3**, the closing price of at least one underlying is below its principal barrier level on every determination date. As a result, you would not receive any contingent quarterly payments during the term of the securities and, at maturity, you would be fully exposed to the decline in the closing price of the AAPL, which is the worst performing underlying. As the final share price of the worst performing underlying is less than its principal barrier level, your payment at maturity is calculated as follows:

$$\text{Payment at maturity} = \frac{\text{final share price of AAPL}}{\text{initial share price of AAPL}} \times \text{principal amount} = \frac{\$50.00}{\$100.00} \times \$10.00 = \$5.00$$

In this example, the payment you would receive at maturity is significantly less than the stated principal amount. In addition, you would not be entitled to receive any contingent quarterly payments during the term of the securities.

- In **Example 4**, the closing price of at least one underlying is below its downside threshold level on each of the 1st through the 11<sup>th</sup> determination date. As a result, the contingent quarterly payment is not payable for any of those determination dates. At maturity, because the final share price of the worst performing underlying is greater than its downside threshold level, you would receive the stated principal amount, plus a contingent quarterly payment with respect to the final determination date. Your payment at maturity is calculated as follows:

$$\$10 + \$0.25625 = \$10.25625$$

In this example, although the final share price of the worst performing underlying represents a 15% decline from its initial share price, because the final share price of the worst performing underlying is greater than or equal to its downside threshold level, you would receive the stated principal amount plus the contingent quarterly payment, equal to a total payment of \$10.25625 per security at maturity.

- In **Example 5**, the closing price of at least one underlying is below its downside threshold level on each of the 1st through the 11<sup>th</sup> determination date. As a result, the contingent quarterly payment is not payable for any of those determination dates. At maturity, because the final share price of the worst performing underlying is less than its downside threshold level, but greater than or equal to its principal barrier level, you would receive the stated principal amount at maturity.
- *In this example, although the final share price of the worst performing underlying represents a 28% decline from its initial share price, because the final share price of the worst performing underlying is greater than or equal to its principal barrier level, you would receive the stated principal amount at maturity.*

You will be subject to significant risks not associated with conventional fixed-rate or floating-rate debt securities.

#### *Risks Relating to the Structure or Features of the Securities*

- **You may lose your entire initial investment.** The securities do not guarantee any return of principal. The securities differ from ordinary debt securities in that we will not necessarily pay the full principal amount of the securities at maturity. HSBC will only pay you the principal amount of your securities at maturity if the securities have not been automatically redeemed prior to maturity and the final share price of the worst performing underlying is greater than or equal to its principal barrier level. If the final share price of the worst performing underlying is less than its principal barrier level, you will be exposed to the decline in the closing price of the worst performing underlying, as compared to its initial share price, on a 1 to 1 basis and you will receive for each security that you hold at maturity an amount equal to the stated principal amount times the share performance factor of the worst performing underlying. In this case, the payment at maturity will be less than 65.00% of the stated principal amount and could be zero.
- **You will not receive any contingent quarterly payment with respect to any quarterly period where the determination closing price or the final share price, as applicable, of the worst performing underlying is less than its respective downside threshold level on the related determination date.** A contingent quarterly payment will be made with respect to a quarterly period only if the determination closing price or the final share price of the worst performing underlying is greater than or equal to its downside threshold level on the related determination date. It is possible that the closing price of the worst performing underlying could be below its respective downside threshold level on most or all of the determination dates so that you will receive few or no contingent quarterly payments.
- **Investors will not participate in any appreciation of any underlying, and your return on the securities is limited to the principal amount plus any contingent quarterly payments, regardless of any appreciation in the prices of the underlyings.** Investors will not participate in any appreciation of any underlying from its initial share price. Unless the final share price of the worst performing underlying is less than its downside threshold level, you will receive at maturity the stated principal amount plus the contingent quarterly payment with respect to the final determination date, regardless of any appreciation in the prices of the underlyings, which may be significant. The return on the securities will be limited to the contingent quarterly payment that is payable with respect to each determination date on which the determination closing price or the final share price, as applicable, of the worst performing underlying is greater than or equal to its downside threshold level. It is possible that the closing price of the worst performing underlying could be below its downside threshold level on most or all of the determination dates so that you will receive few or no contingent quarterly payments. reinvest the proceeds from an investment in the securities at a comparable return for a similar level of risk following an automatic call.

- **The amounts payable on the securities are not linked to the prices of the underlyings at any time other than on the determination dates, including the final determination date.** The payments on the securities will be based on the closing prices of the underlyings on each determination date, subject to postponement for non-trading days and certain market disruption events. Even if the market price of an underlying appreciates prior to an applicable determination date but then drops on that day to a price that is below its downside threshold level, the contingent quarterly payment on the securities will not be paid. Similarly, the payment at maturity will be less, and may be significantly less, than it would have been had the securities been linked to the prices of the underlyings on a date prior to the final determination date. Although the actual prices of the underlyings on the maturity date or at other times during the term of the securities may be higher than the price on one or more determination dates, the payments on the securities will be based solely on the prices of the underlyings on the determination dates.

To receive any contingent quarterly payments, all underlyings must close at or above their respective downside threshold levels on the applicable determination date. Under this scenario, the payment at maturity will be less than 65.00% of the stated principal amount and could be zero. - **Because the securities are linked to the performance of the worst performing underlying, you are exposed to greater risks of receiving no contingent quarterly payments and sustaining a significant loss on your investment than if the securities were linked to fewer underlyings or just one underlying.** The risk that you will not receive any contingent quarterly payments, or that you will suffer a significant loss on your investment, is greater if you invest in the securities as opposed to substantially similar securities that are linked to the performance of fewer underlyings or just one underlying. ### *General Risk Factors*

- **Credit risk of HSBC USA Inc.** The securities are senior unsecured debt obligations of the issuer, HSBC, and are not, either directly or indirectly, an obligation of any third party. the estimated initial value on the pricing date for a temporary period expected to be approximately 9 months after the original issue date. This temporary price difference may exist because, in our discretion, we may elect to effectively reimburse to investors a portion of the estimated cost of hedging our obligations under the securities and other costs in connection with the securities that we will no longer expect to incur over the term of the securities. We will make such discretionary election and determine this temporary reimbursement period on the basis of a number of factors, including the tenor of the securities and any agreement we may have with the distributors of the securities. The amount of our estimated costs which we effectively reimburse to investors in this way may not be allocated ratably throughout the reimbursement period, and we may discontinue such reimbursement at any time or revise the duration of the reimbursement period after the original issue date of the securities based on changes in market conditions and other factors that cannot be predicted.

- **There is limited anti-dilution protection.** For certain events affecting the underlyings, such as stock splits or extraordinary dividends, the calculation agent may make adjustments to the amount payable at maturity. However, the calculation agent is not required to make an adjustment for every corporate action which affects the shares of the underlyings. If an event occurs that does not require the calculation agent to adjust the amount payable at maturity, the market price of the securities may be materially and adversely affected.

If the Internal Revenue Service (“IRS”) were successful in asserting an alternative treatment for the securities, the timing and character of income or loss on the securities might differ significantly from the tax treatment described herein. **Non-U.S. Holders should note that the entire amount of the contingent quarterly payments will be subject to U.S. federal income tax withholding at a 30% rate (or at a lower rate under an applicable income tax treaty), and we will not be required to pay any additional amounts with respect to amounts withheld.** We do not plan to request a ruling from the IRS regarding the tax treatment of the securities, and the IRS or a court may not agree with the tax treatment described herein.

In 2007, the U.S. Treasury Department and the IRS released a notice requesting comments on the U.S. federal income tax treatment of “prepaid forward contracts” and similar instruments. 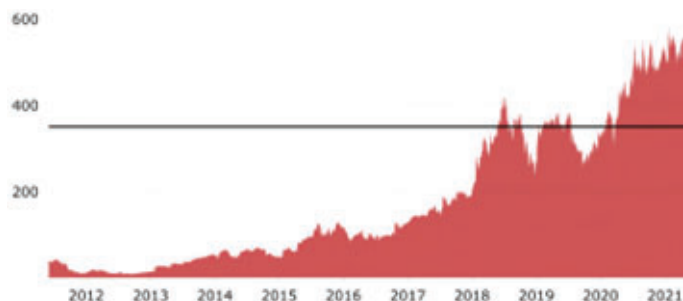
