

## Contingent Income Callable Securities due August 29, 2024

### Based on the Worst Performing of the Russell 2000® Index, the NASDAQ-100 Index® and the iShares® MSCI EAFE ETF

#### Principal at Risk Securities

Contingent Income Callable Securities, which we refer to as the securities, do not guarantee the payment of interest or the repayment of the stated principal amount. Instead, the securities offer the opportunity for investors to earn a contingent quarterly payment at an annual rate of 8.80% of the stated principal amount, with respect to each determination date on which the closing value of **each** underlying is greater than or equal to 75.00% of its initial value, which we refer to as the downside threshold value. The securities may be redeemed early at our discretion on any early redemption notice date, for an amount equal to the sum of the stated principal amount and the applicable contingent quarterly payment. An early redemption will be at our discretion and will not automatically occur based on the performance of any underlying. If the securities have not been previously redeemed and the final value of each underlying is greater than or equal to 60% of its final value, which we refer to as the downside threshold value, the payment at maturity will be the stated principal amount and, if the final value of each underlying is greater than its downside threshold value, the final contingent quarterly payment. However, if the securities have not been previously redeemed and the final value of **any** underlying is less than its downside threshold value, you will be exposed to the decline in the closing value of the worst performing underlying, as compared to its initial value, on a 1 to 1 basis and will receive a payment at maturity that is less than 60.00% of the stated principal amount of the securities and could be zero. ##### Principal at Risk Securities

The Contingent Income Callable Securities due August 29, 2024 Based on the Worst Performing of the Russell 2000® Index, the NASDAQ-100 Index® and the iShares® MSCI EAFE ETF, which we refer to as the securities, provide an opportunity for investors to earn a contingent quarterly payment at an annual rate of 8.80% of the stated principal amount with respect to each quarterly determination date on which the determination closing value or the final value, as applicable, of each underlying is greater than or equal to its downside threshold value. The actual contingent quarterly payment will be determined on the trade date. The contingent quarterly payment, if any, will be payable quarterly on the contingent payment date (which is the third business day after the related determination date) or the maturity date, as applicable. It is possible that the closing value of one or more underlyings could remain below their respective downside threshold values for extended periods of time or even throughout the term of the securities so that you may receive few or no contingent quarterly payments.

The securities may be redeemed **at our discretion** on any early redemption notice date, for the principal amount plus the applicable contingent quarterly payment. An early redemption will be at our discretion and will not automatically occur based on the performance of any underlying. If the securities have not previously been redeemed and the final value of each underlying is greater than or equal to its downside threshold value, the payment at maturity will be the stated principal amount and, the contingent quarterly payment with respect to the final determination date. If the securities have not been previously redeemed and the final value of the worst performing underlying is less than its downside threshold value, but greater than or equal to its principal barrier value, the payment at maturity will be the principal amount. However, if the securities have not previously been redeemed and the final value of any underlying is less than its principal barrier value, investors will be exposed to the decline in the closing value of the worst performing underlying, as compared to its initial value, on a 1 to 1 basis and will receive a payment at maturity that is less than 60.00% of the stated principal amount of the securities and could be zero. Investors in the securities must be willing to accept the risk of losing their entire principal and also the risk of not receiving any contingent quarterly payments. In addition, investors will not participate in any appreciation of any of the underlyings.

### Key Investment Rationale

The securities offer investors an opportunity to earn a contingent quarterly payment at an annual rate of 8.80% of the stated principal amount with respect to each determination date on which the determination closing value or the final value, as applicable, of **each** underlying is greater than or equal to its downside threshold value. The actual contingent quarterly payment will be determined on the trade date. The securities may be redeemed at our discretion on any early redemption notice date prior to maturity for the stated principal amount per security *plus* the applicable contingent quarterly payment, and the payment at maturity will vary depending on the final value of the worst performing underlying, as follows:

#### Scenario 1

**On any of the first 11 determination dates, the determination closing value of each underlying is greater than or equal to its initial value.**

- The securities will be redeemed for (i) the stated principal amount *plus* (ii) the contingent quarterly payment with respect to the related determination date.
- Investors will not participate in any appreciation of the underlyings from their respective initial values.

#### Scenario 2

**The securities are not redeemed prior to maturity and the final value of each underlying is greater than or equal to its downside threshold value.**

- The payment due at maturity will be (i) the stated principal amount *plus* (ii) the contingent quarterly payment with respect to the final determination date.
- Investors will not participate in any appreciation of the underlyings from their respective initial values.

#### Scenario 3

**The securities are not redeemed prior to maturity and the final value of the worst performing underlying is less than its downside threshold value, but greater than or equal to its principal barrier value.**

The payment due at maturity will be the stated principal amount.

#### Scenario 4

**The securities are not redeemed prior to maturity and the final value of any underlying is less than its principal barrier value.**

- The payment due at maturity will be (i) the stated principal amount multiplied by (ii) the performance factor of the worst performing underlying.
- **Investors will lose a significant portion, and may lose all, of their principal in this scenario.**

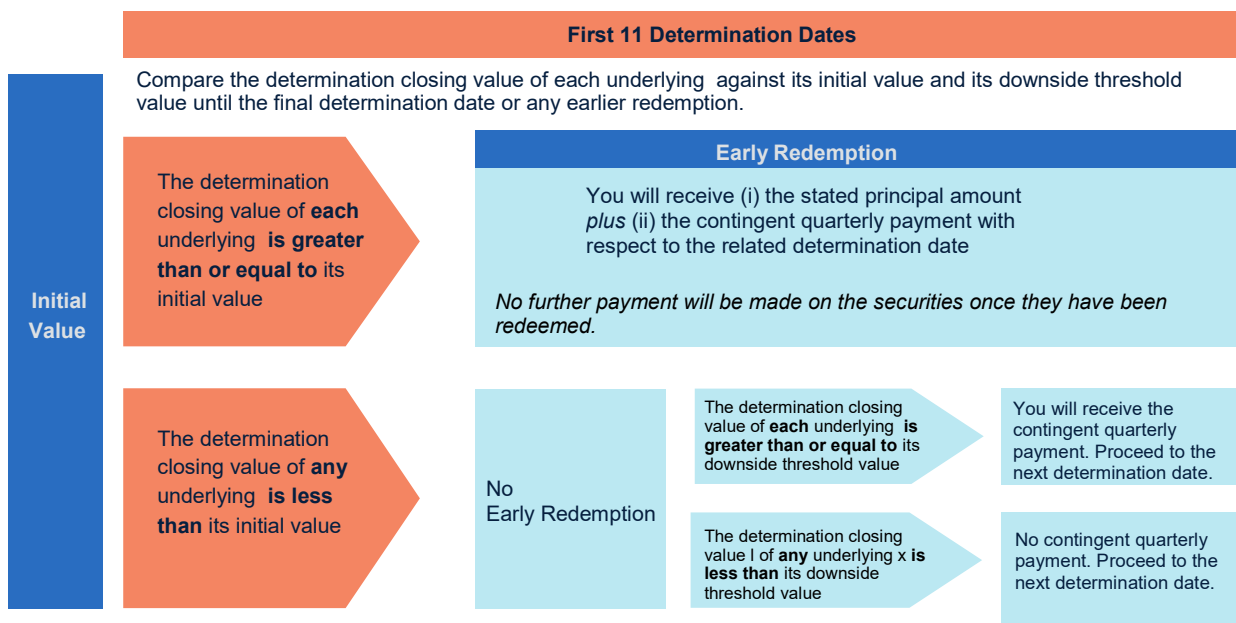

The following diagrams illustrate the potential outcomes for the securities depending on (1) the determination closing value and (2) the final value of each underlying.

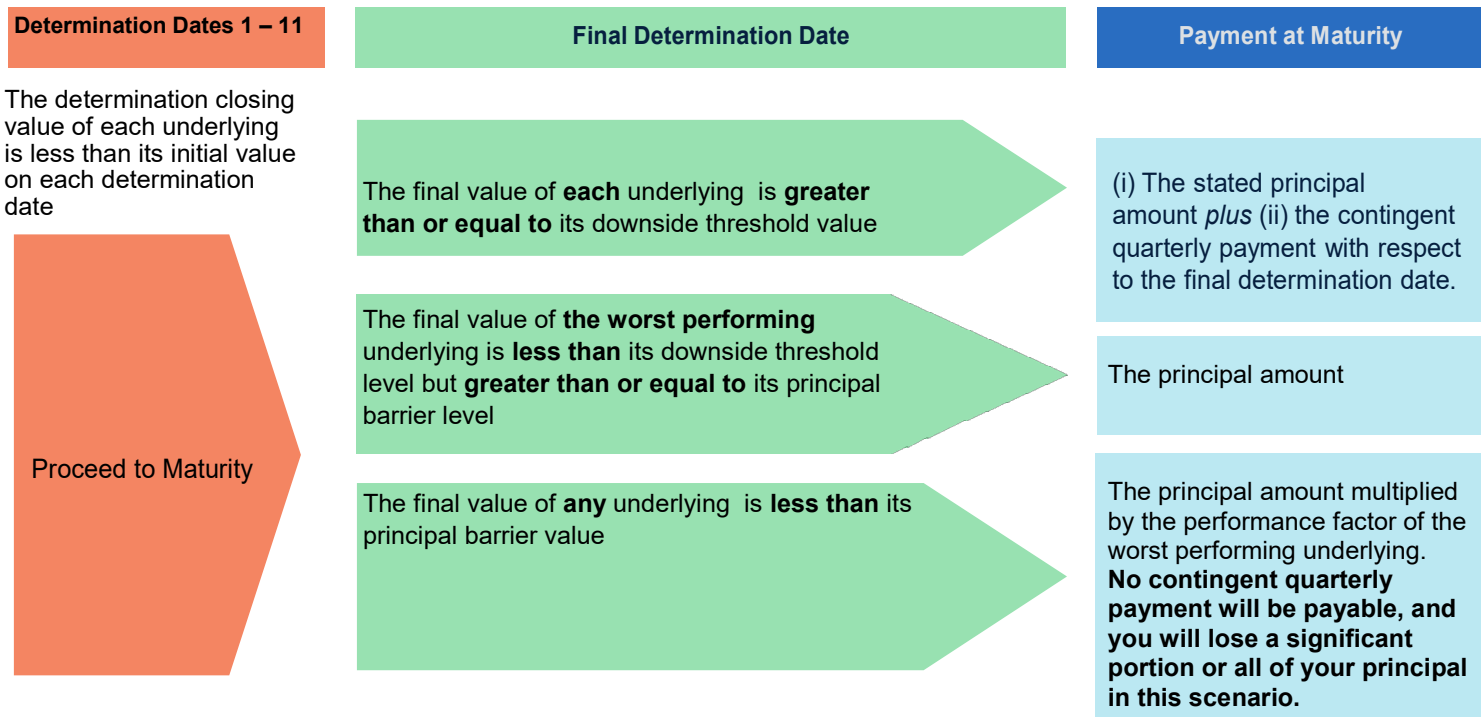
#### Diagram #1: First 11 Determination Dates

### Hypothetical Examples

The below examples are based on the following terms:

Hypothetical Initial Value:	With respect to each underlying, 100.00
Hypothetical Downside Threshold Value:	With respect to each underlying, 75.00, which is 75.00% of its hypothetical initial value
Hypothetical Principal Barrier Value:	With respect to each underlying, 60.00, which is 60.00% of its hypothetical initial value
Hypothetical Contingent Quarterly Payment:	8.80% per annum (corresponding to \$22.00 (or 2.20%) per quarter per security)
Stated Principal Amount:	\$1,000 per security

In Examples 1 and 2, the closing values of the underlyings fluctuate over the term of the securities and the determination closing value of **each** underlying is greater than or equal to its hypothetical downside threshold value on one of the first 11 determination dates, and the securities are redeemed following the relevant determination date. In Examples 3, 4 and 5, the securities are not redeemed prior to, and remain outstanding until, maturity.

\* The early redemption payment includes the unpaid contingent quarterly payment with respect to the determination date on which the determination closing value of each underlying is greater than or equal to its downside threshold value and the securities are redeemed.

- In **Example 1**, the securities are redeemed following the first determination date. You would receive the early redemption payment, calculated as follows:

$$\text{stated principal amount} + \text{contingent quarterly payment} = \$1,000 + \$22.00 = \$1,022.00$$

*In this example, the early redemption feature limits the term of your investment to approximately 3 months and you may not be able to reinvest at comparable terms or returns. If the securities are redeemed early, you will not receive any additional contingent quarterly payments.*

- In **Example 2**, since the determination closing value of each underlying on the 1st determination date is greater than its downside threshold value, you would receive the contingent payment of \$22.00 with respect to that determination date. You would receive no contingent payment with respect to the 2<sup>nd</sup> through the 10<sup>th</sup> determination dates, since the determination closing value of at least one underlying on each of those determination dates is less than its downside threshold value. The securities are redeemed following the 11<sup>th</sup> determination date. Following the 11<sup>th</sup> determination date, you would receive an Early Redemption Payment of \$1,022.00, which includes the contingent quarterly payment with respect to the 11<sup>th</sup> determination date.

*In this example, the early redemption feature limits the term of your investment to approximately 33 months and you may not be able to reinvest at comparable terms or returns. If the securities are redeemed early, you will not receive any additional contingent quarterly payments. Further, although the worst performing underlying has appreciated by 5% from its initial value as of the 11<sup>th</sup> determination date, you only receive a total payment of \$1,022.00 per security and do not benefit from such appreciation.*

\* The final contingent quarterly payment, if any, will be paid at maturity.

Examples 3 and 4 illustrate the payment at maturity per security based on the final value of the worst performing underlying.

- In **Example 3**, the closing value of at least one underlying is below its principal barrier value on every determination date. As a result, you would not receive any contingent quarterly payments during the term of the securities and, at maturity, you would be fully exposed to the decline in the closing value of the RTY, which is the worst performing underlying. As the final value of the worst performing underlying is less than its principal barrier value, your payment at maturity is calculated as follows:

$$\text{Payment at maturity} = \frac{\text{final value of RTY}}{\text{initial value of RTY}} \times \text{principal amount} = \frac{\$50.00}{\$100.00} \times \$1,000.00 = \$500.00$$

*In this example, the payment you would receive at maturity is significantly less than the stated principal amount. In addition, you would not be entitled to receive any contingent quarterly payments during the term of the securities.*

- In **Example 4**, the closing value of at least one underlying is below its downside threshold value on each of the 1<sup>st</sup> through the 11<sup>th</sup> determination date. As a result, the contingent quarterly payment is not payable for any of those determination dates. At maturity, because the final value of each underlying is greater than its downside threshold value, you would receive the stated principal amount, plus a contingent quarterly payment with respect to the final determination date. Your payment at maturity is calculated as follows:

$$\$1,000 + \$22.00 = \$1,022.00$$

*In this example, although the final value of the worst performing underlying represents a 15% decline from its initial value, because the final value of the worst performing underlying is greater than or equal to its downside threshold value, you would receive the stated principal amount plus the contingent quarterly payment, equal to a total payment of \$1,022.00 per security at maturity.*

As a result, the contingent quarterly payment is not payable for any of those determination dates. At maturity, because the final value of the worst performing underlying is less than its downside threshold value, but greater than or equal to its principal barrier value, you would receive the stated principal amount at maturity.
- *In this example, although the final value of the worst performing underlying represents a 32% decline from its initial value, because the final value of the worst performing underlying is greater than or equal to its principal barrier value, you would receive the stated principal amount at maturity.*

contingent quarterly payments. Accordingly, the return on the securities may be significantly less than the return on a direct investment in the securities included in the underlyings during the term of the securities.

- **The securities may be called prior to the maturity date.** If the securities are called early, the holding period over which you will receive contingent quarterly payments could be as short as 3 months. If the securities are redeemed prior to the maturity date, you will receive no more contingent quarterly payments. There is no guarantee that you would be able to reinvest the proceeds from an investment in the securities at a comparable return for a similar level of risk following an early redemption at our discretion. It is more likely that we will redeem the securities when it would be advantageous for you to continue to hold the securities. As such, we will be more likely to redeem the securities when the official closing level of any underlying is at or above its respective coupon barrier value, which could result in an amount of interest payable on the securities that is greater than instruments of a comparable maturity and credit rating trading in the market. On the other hand, we will be less likely to exercise our redemption right when the official closing level of any underlying is below its respective coupon barrier value and/or when the final value of the worst performing underlying is expected to be below its downside threshold value, such that you will receive no contingent quarterly payments and/or that you will suffer a significant loss on your initial investment in the securities at maturity. Therefore, if we do not exercise our redemption right, it is more likely that you will receive few or no contingent quarterly payments and suffer a significant loss at maturity.

- **The amounts payable on the securities are not linked to the values of the underlyings at any time other than on the determination dates, including the final determination date.** The payments on the securities will be based on the closing values of the underlyings on each determination date, subject to postponement for non-trading days and certain market disruption events. Even if the market price of an underlying appreciates prior to an applicable determination date but then drops on that day to a value that is below its downside threshold value, the contingent quarterly payment on the securities will not be paid. Similarly, the payment at maturity will be less, and may be significantly less, than it would have been had the securities been linked to the values of the underlyings on a date prior to the final determination date. securities to be called prior to maturity, the securities are less likely to be called than if the securities were linked to fewer underlyings or just one underlying.

### ***Risks Relating to the Underlying Shares***

- **Adjustments to any underlying could adversely affect the value of the securities.** The publisher of an underlying may add, delete or substitute the securities included in the relevant underlying. In addition, the publisher of an underlying may make other methodological changes that could change the value of that underlying. Further, the publisher of an underlying may discontinue or suspend calculation or publication of that underlying at any time. Any such actions could affect the value of and the return on the securities.
- **Small-capitalization risk.** The RTY tracks companies that are considered small-capitalization. These companies often have greater stock price volatility, lower trading volume and less liquidity than large-capitalization companies and therefore the value of the RTY may be more volatile than an investment in stocks issued by large-capitalization companies. The other special risks associated with foreign securities may include, but are not limited to: less liquidity and smaller market capitalizations; less rigorous regulation of securities markets; different accounting and disclosure standards; governmental interference; currency fluctuations; higher inflation; and social, economic and political uncertainties. prospectus, the securities will rank on par with all of the other unsecured and unsubordinated debt obligations of HSBC, except such obligations as may be preferred by operation of law. Any payment to be made on the securities depends on the ability of HSBC to satisfy its obligations as they come due. As a result, the actual and perceived creditworthiness of HSBC may affect the market value of the securities and, in the event HSBC were to default on its obligations, you may not receive the amounts owed to you under the terms of the securities and could lose your entire investment.

- **The estimated initial value of the securities, which will be determined by us on the trade date, is expected to be less than the price to public and may differ from the market value of the securities in the secondary market, if any.** The estimated initial value of the securities will be calculated by us on the trade date and is expected to be less than the price to public. The estimated initial value will reflect our internal funding rate, which is the borrowing rate we pay to issue market-linked securities, as well as the mid-market value of the embedded derivatives in the securities. This internal funding rate is typically lower than the rate we would use when we issue conventional fixed or floating rate debt securities. As a result of the difference between our internal funding rate and the rate we would use when we issue conventional fixed or floating rate debt securities, the estimated initial value of the securities may be lower if it were based on the values at which our fixed or floating rate debt securities trade in the secondary market. In addition, if we were to use the rate we use for our conventional fixed or floating rate debt issuances, we would expect the economic terms of the securities to be more favorable to you. We will determine the value of the embedded derivatives in the securities by reference to our or our affiliates' internal pricing models. These pricing models consider certain assumptions and variables, which can include volatility and interest rates. Different pricing models and assumptions could provide valuations for the securities that are different from our estimated initial value. These pricing models rely in part on certain forecasts about future events, which may prove to be incorrect. The estimated initial value does not represent a minimum price at which we or any of our affiliates would be willing to purchase your securities in the secondary market (if any exists) at any time.
- **The price of your securities in the secondary market, if any, immediately after the trade date is expected to be less than the price to public.** The price to public takes into account certain costs. These costs include our affiliates' projected hedging profits (which may or may not be realized) for assuming risks inherent in hedging our obligations under the securities and the costs associated with structuring and hedging our obligations under the securities. These costs will be used or retained by us or one of our affiliates. If you were to sell your securities in the secondary market, if any, the price you would receive for your securities may be less than the price you paid for them because secondary market prices will not take into account these costs. The price of your securities in the secondary market, if any, at any time after issuance will vary based on many factors, including the value of the underlyings and changes in market conditions, and cannot be predicted with accuracy. The securities are not designed to be short-term trading instruments, and you should, therefore, be able and willing to hold the securities to maturity. Any sale of the securities prior to maturity could result in a loss to you.
- **If HSBC Securities (USA) Inc. were to repurchase your securities immediately after the original issue date, the price you receive may be higher than the estimated initial value of the securities.** Assuming that all relevant factors remain constant after the original issue date, the price at which HSBC Securities (USA) Inc. may initially buy or sell the securities in the secondary market, if any, and the value that may initially be used for customer account statements, if any, may exceed the estimated initial value on the trade date for a temporary period expected to be approximately 3 months after the original issue date. This temporary price difference may exist because, in our discretion, we may elect to effectively reimburse to investors a portion of the estimated cost of hedging our obligations under the securities and other costs in connection with the securities that we will no longer expect to incur over the term of the securities. adjustments to the hedge as the final determination date approaches. Some of our affiliates may also trade the component securities and other financial instruments related to one or more underlyings on a regular basis as part of their general broker-dealer and other businesses. Any of these hedging or trading activities on or prior to the trade date could potentially increase the initial value of an underlying and, as a result, its downside threshold value, which is the value at or above which that underlying must close on each determination date in order for you to earn a contingent quarterly payment and the value at or above which that underlying must close on the final determination date in order for you to avoid being exposed to the negative performance of the worst performing underlying at maturity. Additionally, such hedging or trading activities during the term of the securities could adversely affect the value of an underlying on the determination dates and, accordingly, whether the securities are called prior to maturity and, if the securities are not called prior to maturity, the payout to you at maturity.

If the Internal Revenue Service (“IRS”) were successful in asserting an alternative treatment for the securities, the timing and character of income or loss on the securities might differ significantly from the tax treatment described herein. **Non-U.S. Holders should note that the entire amount of the contingent quarterly payments will be subject to U.S. federal income tax withholding at a 30% rate (or at a lower rate under an applicable income tax treaty), and we will not be required to pay any additional amounts with respect to amounts withheld.** We do not plan to request a ruling from the IRS regarding the tax treatment of the securities, and the IRS or a court may not agree with the tax treatment described herein.

In 2007, the U.S. Treasury Department and the IRS released a notice requesting comments on the U.S. federal income tax treatment of “prepaid forward contracts” and similar instruments.
