

## Contingent Income Callable Securities due February 13, 2025

Principal at Risk Securities

The Contingent Income Callable Securities, which we refer to as the securities, do not guarantee the payment of interest or the repayment of the stated principal amount. Instead, the securities offer the opportunity for investors to earn a contingent quarterly payment at an annual rate of at least 8.35% (to be determined on the pricing date) of the stated principal amount, but only if the closing level of the underlying index on the relevant quarterly observation date is greater than or equal to 75% of the initial index level, which we refer to as the coupon barrier level. The securities may be redeemed early at our discretion on any early redemption notice date, for an amount equal to the sum of the stated principal amount and the contingent quarterly payment, if any, for the related quarterly observation date. An early redemption will be at our discretion and will not automatically occur based on the performance of the underlying index. If the securities have not been previously redeemed and the final index level is greater than or equal to 75% of the initial index level, which we refer to as the downside threshold level, the payment at maturity will be the stated principal amount and, if applicable, the final contingent quarterly payment. However, if the securities have not been previously redeemed and the final index level is less than the downside threshold level, you will be exposed to the decline in the closing level of the underlying index, as compared to the initial index level, on a 1 to 1 basis and will receive a payment at maturity that is less than 75% of the stated principal amount of the securities and could be zero. As a result, investors must be willing to accept the risk of losing their entire principal and also the risk of not receiving any contingent quarterly payments. The Contingent Income Callable Securities due February 13, 2025 Based on the Performance of the S&P 500® Index, which we refer to as the securities, provide an opportunity for investors to earn a contingent quarterly payment at an annual rate of at least 8.35% of the stated principal amount but only if the closing level of the underlying index on the relevant quarterly observation date is greater than or equal to 75% of the initial index level, which we refer to as the coupon barrier level. The actual contingent quarterly payment will be determined on the pricing date. The contingent quarterly payment will be payable quarterly on the contingent payment date or the maturity date, as applicable. It is possible that the closing level of the underlying index could remain below the coupon barrier level for extended periods of time or even throughout the term of the securities so that you may receive few or no contingent quarterly payments.

The securities may be redeemed at our discretion on any early redemption notice date, for the principal amount plus the contingent quarterly payment, if any, for the related quarterly observation date. An early redemption will be at our discretion and will not automatically occur based on the performance of the underlying index. If the securities have not been previously redeemed and the final index level is greater than or equal to 75% of the initial index level, which we refer to as the downside threshold level, the payment at maturity will be the stated principal amount and, if applicable, the final contingent quarterly payment. However, if the securities have not been previously redeemed and the final index level is less than the downside threshold level, you will be exposed to the decline in the closing level of the underlying index, as compared to the initial index level, on a 1 to 1 basis and will receive a payment at maturity that is less than 75% of the stated principal amount of the securities and could be zero. Investors in the securities must be willing to accept the risk of losing their entire principal and also the risk of not receiving any contingent quarterly payments. ### Key Investment Rationale

The securities do not guarantee the payment of interest or any repayment of the stated principal amount. Instead, the securities offer investors an opportunity to earn a contingent quarterly payment at an annual rate of at least 8.35% of the stated principal amount, but only if the closing level of the underlying index on the relevant quarterly observation date is greater than or equal to 75% of the initial index level, which we refer to as the coupon barrier level. The actual contingent quarterly payment will be determined on the pricing date. The securities may be redeemed at our discretion on any early redemption notice date prior to maturity for the stated principal amount per security plus the contingent quarterly payment, if any, with respect to the related quarterly observation date. If the securities are not redeemed prior to maturity, the payment at maturity will vary depending on the final index level, as follows:

Scenario 1	<p>On the quarterly observation dates, the official closing level for the underlying index is greater than or equal to the coupon barrier level. The final index level is greater than or equal to the downside threshold level. The issuer chooses not to redeem the securities prior to maturity.</p> <ul style="list-style-type: none"> <li>For each of the quarterly observation dates, investors will receive the contingent quarterly payment.</li> <li>The payment due at maturity will be (i) the stated principal amount and (ii) the final contingent quarterly payment.</li> <li>Investors will not participate in any appreciation of the underlying index from the initial index level.</li> </ul>
Scenario 2	<p>On the first 6 quarterly observation dates, the official closing level for the underlying index is greater than or equal to the coupon barrier level. On the final 2 quarterly observation dates, the official closing level of the underlying index is less than the coupon barrier level. The final index level is less than the downside threshold level. The issuer chooses not to redeem the securities prior to maturity.</p> <ul style="list-style-type: none"> <li>For each of the first 6 quarterly observation dates, investors will receive the contingent quarterly payment.</li> <li>The payment due at maturity will be (i) the stated principal amount multiplied by (ii) the index performance factor. No final contingent quarterly payment will be paid at maturity in this scenario.</li> <li>Investors will not participate in any appreciation of the underlying index from the initial index level.</li> <li>Investors will lose a significant portion, and may lose all, of their principal in this scenario.</li> </ul>
Scenario 3	<p>On the first 4 quarterly observation dates, the official closing level for the underlying index is less than the coupon barrier level. On the 5th quarterly observation date, the official closing level for the underlying index is greater than or equal to the coupon barrier level. The issuer chooses to redeem the securities on the 5th early redemption notice date.</p> <ul style="list-style-type: none"> <li>For the first 4 quarterly observation dates, investors will not receive the contingent quarterly payment.</li> <li>The early redemption payment will be (i) the stated principal amount and (ii) the contingent quarterly payment for the 5th quarterly observation date.</li> <li>Investors will not participate in any appreciation of the underlying index from the initial index level.</li> </ul>

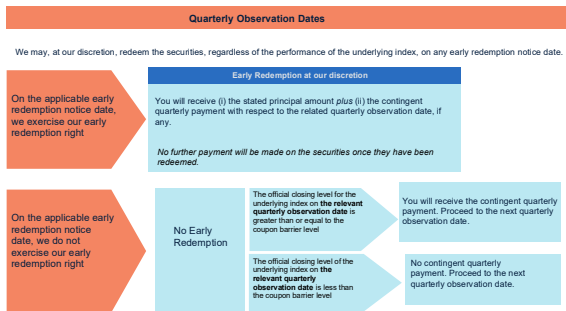

### How the Securities Work

The following diagrams illustrate the potential outcomes for the securities depending on (1) the official closing level for the underlying index on the **relevant quarterly observation date** and (2) if the Issuer chooses to redeem the securities early, **at our discretion** on any early redemption notice date.

### Hypothetical Examples

The below examples are based on the following terms:

Hypothetical Initial Index Level:	100.00
Hypothetical Coupon Barrier Level:	75.00, which is 75% of the hypothetical initial index level
Hypothetical Downside Threshold Level:	75.00, which is 75% of the hypothetical initial index level
Hypothetical Contingent Quarterly Payment:	8.35% per annum (corresponding to \$20.875 (or 2.0875%) per quarter per security)
Stated Principal Amount:	\$1,000.00 per security

How to determine whether a contingent quarterly coupon is payable with respect to a quarterly coupon observation date:

Early Redemption Example		
Hypothetical Quarterly Observation Dates	Lowest Index Closing Value on the Applicable Quarterly Observation Date	Contingent Quarterly Payment
#1	50.00 (below the coupon barrier level)	
#2	50.00 (below the coupon barrier level)	N/A
#3	85.00 (at or above the coupon barrier level)	\$20.875
#4	50.00 (below the coupon barrier level)	N/A
#5	85.00 (at or above the coupon barrier level)	\$20.875

- In **Early Redemption Example**, on the hypothetical quarterly observation date #3, the underlying index closes at or above the coupon barrier level. Therefore, a contingent quarterly coupon is paid on the relevant coupon payment date. On the hypothetical quarterly observation dates #1, #2, and #4 the underlying index closes below the coupon barrier level. Therefore, no contingent quarterly coupon is paid on the relevant contingent payment date. The securities are redeemed at our discretion on the 5th early redemption notice date. You would receive the early redemption payment, calculated as follows:

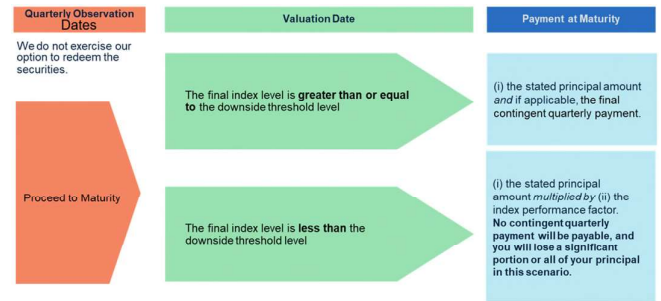
$$\text{stated principal amount} + \text{contingent quarterly payment} = \$1,000.00 + \$20.875 = \$1,020.875$$

In this example, the early redemption feature limits the term of your investment to approximately 15 months and you may not be able to reinvest at comparable terms or returns. If the securities are redeemed early, you will not receive any additional contingent quarterly payments.

### How to calculate the payment at maturity (if the securities have not been redeemed):

Example	Index Closing Value on the Valuation Date (Final Index Value)	Payment at Maturity
#1	85.00 (at or above the downside threshold level)	\$1,000*
#2	50.00 (below the downside threshold level)	\$1,000 * the index performance factor = \$1,000 * (50.00 / 100.00) = \$500.00

\*In addition, the final contingent quarterly coupon will be payable if the official closing level of the underlying index is at or above the coupon barrier level on the final quarterly observation date.

- In **Example #1**, the final index level is at or above the downside threshold level. Therefore, investors receive at maturity the stated principal amount of the securities and, if the official closing level of the underlying index is at or above the coupon barrier level on the final quarterly observation date, the contingent quarterly coupon with respect to such date. Investors will not participate in any appreciation of the underlying index.
- In **Examples #2**, The final index level is below the downside threshold level. Therefore, investors are exposed to the downside performance of the underlying index at maturity and receive at maturity an amount equal to the stated principal amount multiplied by the performance factor.

If the final index value is below the downside threshold level, you will be exposed to the downside performance of the underlying index at maturity, and your payment at maturity will be less than 75% of the stated principal amount and could be zero.

## Investor Suitability

### The securities may be suitable for you if:

- You believe that the closing levels on the **relevant quarterly observation dates** of the underlying index will be equal to or greater than the coupon barrier level, and not below the downside threshold level on the valuation date.
- You are willing to make an investment that is potentially exposed to downside performance of the underlying index on a 1-to-1 basis.
- You understand that you may not receive any contingent quarterly payments.
- You are willing to hold the securities that may be called at **our discretion** on any early redemption notice date.
- You are willing to invest in securities, the maximum potential return of which is limited to any contingent quarterly payments payable on the securities.
- You are willing to forgo distributions paid on the stocks included in the underlying index.
- You are willing to hold the securities to maturity.
- You do not seek an investment for which there will be an active secondary market.
- You are willing to accept the risk and return profile of the securities versus a conventional debt security with a comparable maturity issued by HSBC or another issuer with a similar credit rating.
- You are comfortable with the creditworthiness of HSBC, as Issuer of the securities.

### The securities may not be suitable for you if:

- You believe that the closing levels of the underlying index on **any the relevant quarterly observation dates** will be less than the coupon barrier level, and/or below the downside threshold level on the valuation date.
- You are unwilling to make an investment that is potentially exposed to the downside performance of the underlying index on a 1-to-1 basis.
- You are unable or unwilling to hold the securities that may be called at **our discretion** on any early redemption notice date.
- You are unwilling to invest in securities, the maximum potential return of which is limited to any contingent quarterly payments payable on the securities.
- You are not willing to forgo distributions paid on the stocks included in the underlying index.
- You are unwilling to hold the securities to maturity.
- You prefer to receive guaranteed periodic interest payments on your investment.
- You seek an investment for which there will be an active secondary market.
- You prefer the lower risk, and therefore accept the potentially lower returns, of conventional debt securities with comparable maturities issued by HSBC or another issuer with a similar credit rating.
- You are not willing or are unable to assume the credit risk associated with HSBC, as Issuer of the securities.

On the other hand, we will be less likely to exercise our redemption right when the official closing level of the underlying index is below the coupon barrier level and/or when the final index level is expected to be below the downside threshold level, such that you will receive no contingent quarterly payments and/or that you will suffer a significant loss on your initial investment in the securities at maturity. Therefore, if we do not exercise our redemption right, it is more likely that you will receive few or no contingent quarterly payments and suffer a significant loss at maturity.

- The amounts payable on the securities are linked to the level of the underlying index on the relevant quarterly observation date.** The payments on the securities will be based on the closing level of the underlying index on the relevant quarterly observation date, subject to postponement for non-trading days and certain market disruption events. Even if the level of the underlying index appreciates prior to an applicable contingent payment date but has decreased on the relevant quarterly observation date to a level that is below the coupon barrier level, the contingent quarterly payment on the securities will not be payable for that contingent payment date. Even if the level of the underlying index appreciates prior to the valuation date but then decreases by that day to a level that is below the downside threshold level, the payment at maturity will be less, and may be significantly less, than it would have been had the securities been linked to the level of the underlying index on a date prior to the valuation date. Although the actual level of the underlying index on the maturity date or at other times during the term of the securities may be higher than the levels on one or more contingent payment dates, the payment at maturity will be based on the final index level, and the contingent quarterly payments, including the final contingent quarterly payment for the final quarterly observation date, will be based on the closing levels on the relevant quarterly observation date.
- Higher contingent quarterly payments or a lower downside threshold level are generally associated with an underlying index with greater expected volatility and therefore can indicate a greater risk of loss.** "Volatility" refers to the frequency and magnitude of changes in the level of the underlying index. The greater the expected volatility with respect to the underlying index on the pricing date, the higher the expectation as of the pricing date that the level of the underlying index could close below the downside threshold level on the valuation date, indicating a higher expected risk of loss on the securities. This greater expected risk will generally be reflected in a higher contingent quarterly payment than the yield payable on our conventional debt securities with a similar maturity, or in more favorable terms (such as a lower downside threshold level or a higher contingent quarterly payment) than for similar securities linked to the performance of the underlying index with a lower expected volatility as of the pricing date. You should therefore understand that a relatively higher contingent quarterly payment may indicate an increased risk of loss. Further, a relatively lower downside threshold level may not necessarily indicate that the securities have a greater likelihood of a repayment of principal at maturity. The volatility of the underlying index can change significantly over the term of the securities. The level of the underlying index for your securities could fall sharply, which could result in a significant loss of principal. You should be willing to accept the downside market risk of the underlying index and the potential to lose some or all of your principal at maturity.

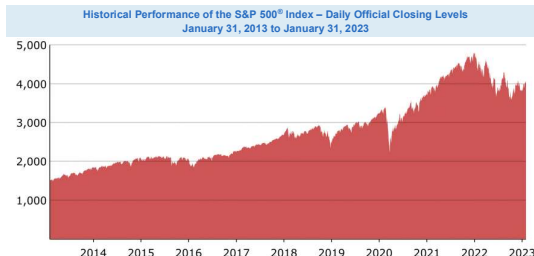

**Tax Treatment of Contingent Quarterly Payment.** Any contingent quarterly payment on the securities should be taxable as ordinary income to a U.S. Holder at the time received or accrued in accordance with the U.S. Holder's regular method of accounting for U.S. federal income tax purposes.

**Sale, Exchange, Early Redemption or Settlement of the Securities.** Upon a sale, exchange, early redemption or settlement of the securities at maturity, a U.S. Holder should recognize capital gain or loss equal to the difference between the amount realized (other than with respect to cash attributable to the contingent quarterly payment, which should be treated as discussed above) on the sale, exchange, early redemption or settlement and the U.S. Holder's tax basis in the securities sold, exchanged, redeemed or settled. Any such gain or loss recognized should be long-term capital gain or loss if the U.S. Holder has held the securities for more than one year at the time of the sale, exchange, early redemption or settlement, and should be short-term capital gain or loss otherwise. The deductibility of capital losses is subject to limitations.

### Possible Alternative Tax Treatments of an Investment in the Securities

Due to the absence of authorities that directly address the proper tax treatment of the securities, no assurance can be given that the IRS will accept, or that a court will uphold, the tax treatment described above. In particular, the IRS could seek to treat a security as a single debt instrument. If a security that has a term of one year or less were treated as a single debt instrument, the security could be treated as a single contingent short-term debt instrument, which would result in tax consequences that are different from those described above. If a security that has a term of more than one year were treated as a single debt instrument, such a debt instrument could be subject to the special tax rules governing contingent payment debt instruments. If a security with a term of more than one year were so treated, a U.S. Holder would generally be required to accrue interest income over the term of the securities based upon the yield at which we would issue a non-contingent fixed-rate debt instrument with other terms and conditions similar to the securities. On December 7, 2007, the U.S. Treasury Department and the IRS released a notice requesting comments on the U.S. federal income tax treatment of "prepaid forward contracts" and similar instruments. The notice focuses on whether to require holders of "prepaid forward contracts" and similar instruments to accrue income over the term of their investment. It also asks

A "dividend equivalent" payment is treated as a dividend from sources within the United States and such payments generally would be subject to a 30% U.S. withholding tax if paid to a Non-U.S. Holder. Under U.S. Treasury Department regulations, payments (including deemed payments) with respect to equity-linked instruments ("ELIs") that are "specified ELIs" may be treated as dividend equivalents if such specified ELIs reference an interest in an "underlying security," which is generally any interest in an entity taxable as a corporation for U.S. federal income tax purposes if a payment with respect to such interest could give rise to a U.S. source dividend. However, IRS guidance provides that withholding on dividend equivalent payments will not apply to specified ELIs that are not delta-one instruments and that are issued before January 1, 2025. Based on the issuer's determination that the securities are not "delta-one" instruments, Non-U.S. Holders should not be subject to withholding on dividend equivalent payments, if any, under the securities. However, it is possible that the securities could be treated as deemed reissued for U.S. federal income tax purposes upon the occurrence of certain events affecting an underlying index or the securities, and following such occurrence the securities could be treated as subject to withholding on dividend equivalent payments. Non-U.S. Holders that enter, or have entered, into other transactions in respect of an underlying index or the securities should consult their tax advisors as to the application of the dividend equivalent withholding tax in the context of the securities and their other transactions. If any payments are treated as dividend equivalents subject to withholding, we (or the applicable paying agent) would be entitled to withhold taxes without being required to pay any additional amounts with respect to amounts so withheld.

### U.S. Federal Estate Tax

Under current law, while the matter is not entirely clear, individual Non-U.S. Holders, and entities whose property is potentially includable in those individuals' gross estates for U.S. federal estate tax purposes (for example, a trust funded by such an individual and with respect to which the individual has retained certain interests or powers), should note that, absent an applicable treaty benefit, the securities are likely to be treated as U.S. situs property, subject to U.S. federal estate tax. These individuals and entities should consult their tax advisors regarding the U.S. federal estate tax consequences of investing in the securities.

### Backup Withholding and Information Reporting

Information returns may be filed with the IRS in connection with payments on the securities and the proceeds from a sale, exchange, early redemption or other disposition. A Non-U.S. Holder may be subject to backup withholding in respect of amounts paid to the Non-U.S. Holder, unless such Non-U.S. Holder complies with certification procedures to establish that it is not a U.S. person for U.S. federal income tax purposes or otherwise establishes an exemption. The amount of any backup withholding from a payment to a Non-U.S. Holder will be allowed as a credit against the Non-U.S. Holder's U.S. federal income tax liability and may entitle the Non-U.S. Holder to a refund, provided that the required information is timely furnished to the IRS.

### Foreign Account Tax Compliance Act

The Foreign Account Tax Compliance Act imposes a 30% U.S. withholding tax on certain U.S. source payments, including interest (and original issue discount), dividends, other fixed or determinable annual or periodical gain, profits, and income, and on the gross proceeds from a disposition of property of a type which can produce U.S. source interest or dividends ("Withholdable Payments"), if paid to a foreign financial institution (including amounts paid to a foreign financial institution on behalf of a holder), unless such institution enters into an agreement with the U.S. Treasury Department to collect and provide to the U.S. Treasury Department substantial information regarding U.S. account holders, including certain account holders that are foreign entities with U.S. owners, or otherwise establishes an exemption. The legislation also generally imposes a withholding tax of 30% on Withholdable Payments made to a non-financial foreign entity unless such entity provides the withholding agent with a certification that it does not have any substantial U.S. owners or a certification identifying the direct and indirect substantial U.S. owners of the entity or otherwise establishes an exemption.

Under proposed regulations (the preamble to which specifies that taxpayers are permitted to rely on them pending finalization), a withholding will apply on payments of gross proceeds. Holders are urged to consult with their own tax advisors regarding the possible implications of this legislation on their investment in the securities.
