Instead, the securities offer the opportunity for investors to earn a contingent quarterly payment at an annual rate of at least 10.20% (to be determined on the pricing date) of the stated principal amount, with respect to each determination date on which the closing value of **each** underlying is greater than or equal to 70.00% of its initial value, which we refer to as the coupon barrier level. The securities may be redeemed early **at our discretion** on any early redemption notice date, for an amount equal to the sum of the stated principal amount and the applicable contingent quarterly payment. An early redemption will be at our discretion and will not automatically occur based on the performance of any underlying. If the securities have not been previously redeemed and the final value of each underlying is greater than or equal to 65.00% of its initial value, which we refer to as the principal barrier level, the payment at maturity will be the stated principal amount and, if applicable, the final contingent quarterly payment. If the securities have not been previously redeemed and the final value of **the worst performing** underlying is less than its coupon barrier level, but greater than or equal to its principal barrier value, the payment at maturity will be the principal amount. However, if the securities have not been previously redeemed and the final value of **any** underlying is less than its principal barrier level, you will be exposed to the decline in the closing level of the worst performing underlying, as compared to its initial value, on a 1 to 1 basis and will receive a payment at maturity that is less than 65.00% of the stated principal amount of the securities and could be zero. The Contingent Income Callable Securities due August 18, 2025 Based on the Worst Performing of the iShares® MSCI EAFE ETF, the Russell 2000® Index and the S&P 500® Index which we refer to as the securities, provide an opportunity for investors to earn a contingent quarterly payment at an annual rate of at least 10.20% of the stated principal amount with respect to each quarterly determination date on which the determination closing value or the final value, as applicable, of each underlying is greater than or equal to its coupon barrier level. The actual contingent quarterly payment will be determined on the pricing date. The contingent quarterly payment, if any, will be payable quarterly on the contingent payment date (which is the third business day after the related determination date) or the maturity date, as applicable. It is possible that the closing value of one or more underlyings could remain below their respective coupon barrier levels for extended periods of time or even throughout the term of the securities so that you may receive few or no contingent quarterly payments.

The securities may be redeemed **at our discretion** on any early redemption notice date, for the principal amount plus the applicable contingent quarterly payment. An early redemption will be at our discretion and will not automatically occur based on the performance of any underlying. If the securities have not been previously redeemed and the final value of **each** underlying is greater than or equal to its coupon barrier value, the payment at maturity will be the stated principal amount and the contingent quarterly payment with respect to the final determination date. If the securities have not been previously redeemed and the final value of **the worst performing** underlying is less than its coupon barrier level, but greater than or equal to its principal barrier value, the payment at maturity will be the principal amount. However, if the securities have not been previously redeemed and the final value of **any** underlying is less than its principal barrier level, you will be exposed to the decline in the closing level of the worst performing underlying, as compared to its initial value, on a 1 to 1 basis and will receive a payment at maturity that is less than 65.00% of the stated principal amount of the securities and could be zero. Key Investment Rationale

The securities offer investors an opportunity to earn a contingent quarterly payment at an annual rate of at least 10.20% of the stated principal amount with respect to each determination date on which the determination closing value or the final value, as applicable, of **each** underlying is greater than or equal to its coupon barrier level. The actual contingent quarterly payment will be determined on the pricing date. The securities may be redeemed at our discretion on any early redemption notice date prior to maturity for the stated principal amount per security *plus* the applicable contingent quarterly payment, and the payment at maturity will vary depending on the final value of the worst performing underlying, as follows:

Scenario 1

On any of the first 5 determination dates, the determination closing value of each underlying is greater than or equal to its initial value.

- The securities will be redeemed for (i) the stated principal amount *plus* (ii) the contingent quarterly payment with respect to the related determination date.
- Investors will not participate in any appreciation of the underlyings from their respective initial values.

Scenario 2

The securities are not redeemed prior to maturity and the final value of each underlying is greater than or equal to its coupon barrier value.

- The payment due at maturity will be (i) the stated principal amount *plus* (ii) the contingent quarterly payment with respect to the final determination date.
- Investors will not participate in any appreciation of the underlyings from their respective initial values.

Scenario 3

The securities are not redeemed prior to maturity and the final value of the worst performing underlying is *less than* its coupon barrier level, but *greater than or equal to* its principal barrier level.

- The payment due at maturity will be the stated principal amount.

Scenario 4

The securities are not redeemed prior to maturity and the final value of any underlying is *less than* its principal barrier level.

- The payment due at maturity will be (i) the stated principal amount multiplied by (ii) the performance factor of the worst performing underlying.
- **Investors will lose a significant portion, and may lose all, of their principal in this scenario.**

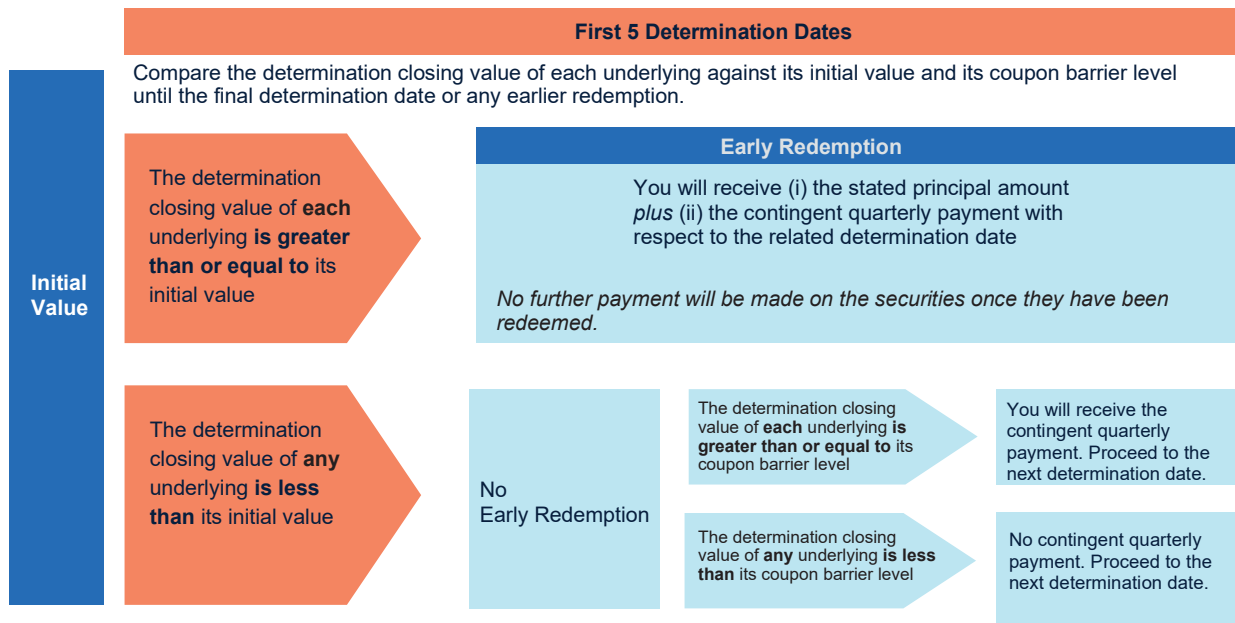

The following diagrams illustrate the potential outcomes for the securities depending on (1) the determination closing value and (2) the final value of each underlying.

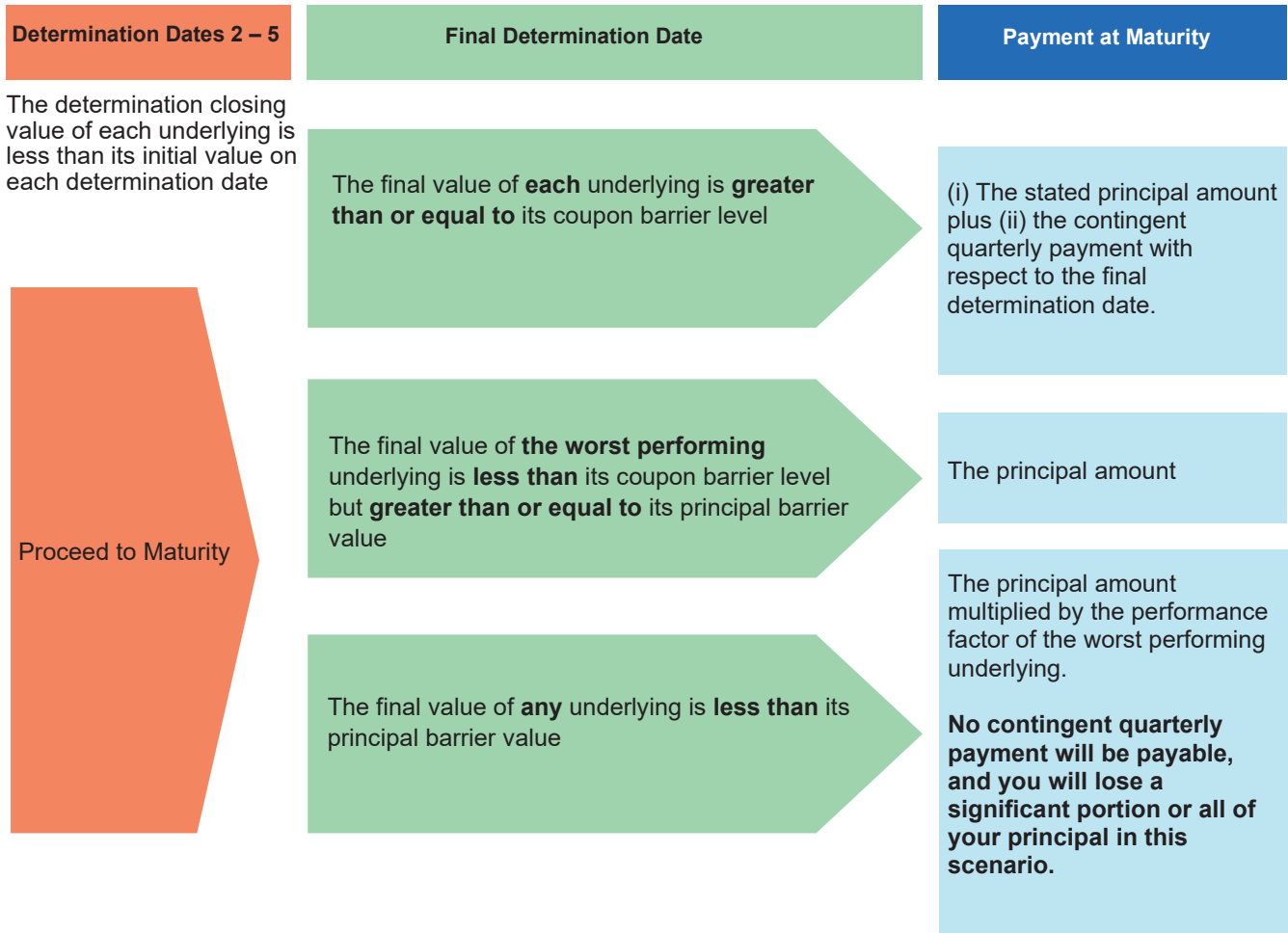
Diagram #1: First 5 Determination Dates

Hypothetical Examples

The below examples are based on the following terms:

Hypothetical Initial Value:	With respect to each underlying, 100.00
Hypothetical Coupon Barrier Level:	With respect to each underlying, 70.00, which is 70.00% of its hypothetical initial value
Hypothetical Principal Barrier Value:	With respect to each underlying, 65.00, which is 65.00% of its hypothetical initial value
Hypothetical Contingent Quarterly Payment:	10.20% per annum (corresponding to \$25.50 (or 2.55%) per quarter per security)
Stated Principal Amount:	\$1,000 per security

In Examples 1 and 2, the closing values of the underlyings fluctuate over the term of the securities and the determination closing value of **each** underlying is greater than or equal to its hypothetical initial value on one of the first 5 determination dates. Because the determination closing value of **each** underlying is greater than or equal to its initial value on one of the first 5 determination dates, and the securities are redeemed following the relevant determination date. In Examples 3, 4 and 5, the securities are not redeemed prior to, and remain outstanding until, maturity.

* The early redemption payment includes the unpaid contingent quarterly payment with respect to the determination date on which the determination closing value of each underlying is greater than or equal to its coupon barrier level and the securities are redeemed.

- In **Example 1**, the securities are redeemed following the first determination date. You would receive the early redemption payment, calculated as follows:

$$\text{stated principal amount} + \text{contingent quarterly payment} = \$1,000 + \$25.50 = \$1,025.50$$

In this example, the early redemption feature limits the term of your investment to approximately 3 months and you may not be able to reinvest at comparable terms or returns. If the securities are redeemed early, you will not receive any additional contingent quarterly payments.

- In **Example 2**, since the determination closing value of each underlying on the 1st determination date is greater than its coupon barrier level, you would receive the contingent payment of \$25.50 with respect to that determination date. You would receive no contingent payment with respect to the 2nd through 4th determination dates, since the determination closing value of at least one underlying on each of those determination dates is less than its coupon barrier level. The securities are redeemed following the 5th determination date. Following the 5th determination date, you would receive an Early Redemption Payment of \$1,025.50, which includes the contingent quarterly payment with respect to the 5th determination date.

In this example, the early redemption feature limits the term of your investment to approximately 15 months and you may not be able to reinvest at comparable terms or returns. If the securities are redeemed early, you will not receive any additional contingent quarterly payments. Further, although the worst performing underlying has appreciated by 5% from its initial value as of the 5th determination date, you only receive a total payment of \$1,025.50 per security and do not benefit from such appreciation.

Examples 3 and 4 illustrate the payment at maturity per security based on the final value of the worst performing underlying.

- In **Example 3**, the closing value of at least one underlying is below its principal barrier level on every determination date. As a result, you would not receive any contingent quarterly payments during the term of the securities and, at maturity, you would be fully exposed to the decline in the closing value of the EFA, which is the worst performing underlying. As the final value of the worst performing underlying is less than its principal barrier level, your payment at maturity is calculated as follows:

$$\text{Payment at maturity} = \frac{\text{final value of EFA}}{\text{initial value of EFA}} \times \text{principal amount} = \frac{\$50.00}{\$100.00} \times \$1,000.00 = \$500.00$$

In this example, the payment you would receive at maturity is significantly less than the stated principal amount. In addition, you would not be entitled to receive any contingent quarterly payments during the term of the securities.

- In **Example 4**, the closing value of at least one underlying is below its coupon barrier level on each of the 1st through the 5th determination date. As a result, the contingent quarterly payment is not payable for any of those determination dates. At maturity, because the final value of each underlying is greater than its coupon barrier level, you would receive the stated principal amount, plus a contingent quarterly payment with respect to the final determination date. Your payment at maturity is calculated as follows:
\$1,000 + \$25.50 = \$1,025.50

In this example, although the final value of the worst performing underlying represents a 15% decline from its initial value, because the final value of the worst performing underlying is greater than or equal to its coupon barrier level, you would receive the stated principal amount plus the contingent quarterly payment, equal to a total payment of \$1,025.50 per security at maturity.

- In **Example 5**, the closing value of at least one underlying is below its coupon barrier level on each of the 1st through the 5th determination date. As a result, the contingent quarterly payment is not payable for any of those determination dates. At maturity, because the final value of the worst performing underlying is less than its coupon barrier level, but greater than or equal to its principal barrier level, you would receive the stated principal amount at maturity.

In this example, although the final value of the worst performing underlying represents a 32% decline from its initial value, because the final value of the worst performing underlying is greater than or equal to its principal barrier level, you would receive the stated principal amount at maturity.

Investor Suitability

The securities may be suitable for you if:

- You believe that the closing value of each underlying will be equal to or greater than its coupon barrier level on one or more of the determination dates, and not below its principal barrier level on the final determination date.
- You are willing to make an investment that is potentially exposed to downside performance of the worst performing underlying on a 1-to-1 basis if its final value is less than the principal barrier level.
- You understand that you may not receive any contingent quarterly payments.
- You are willing to hold the securities that may be called at our discretion on any early redemption notice date.
- You are willing to invest in securities, the maximum potential return of which is limited to any contingent quarterly payments payable on the securities.
- You are willing to forgo distributions paid on the stocks included in any of the underlyings.
- You are willing to hold the securities to maturity.
- You do not seek an investment for which there will be an active secondary market.
- You are willing to accept the risk and return profile of the securities versus a conventional debt security with a comparable maturity issued by HSBC or another issuer with a similar credit rating.

You should understand the risks of investing in the securities and should reach an investment decision only after careful consideration, with your advisors, of the suitability of the securities in light of your particular financial circumstances and the information set forth in this free writing prospectus and the accompanying Equity Index Underlying Supplement and ETF Underlying Supplement, prospectus supplement and prospectus.

Risks Relating to the Structure or Features of the Securities

- **You may lose a significant portion or all of your initial investment.** The securities do not guarantee any return of principal. The securities differ from ordinary debt securities in that we will not necessarily pay the full principal amount of the securities at maturity. HSBC will only pay you the principal amount of your securities at maturity if the securities have not been redeemed prior to maturity and the final value of each underlying is greater than or equal to its principal barrier level. If the final value of any underlying is less than its respective principal barrier level, you will be exposed to the decline in the closing level of the worst performing underlying, as compared to its initial value, on a 1 to 1 basis and you will receive for each security that you hold at maturity an amount equal to the stated principal amount times the performance factor of the worst performing underlying. - **Investors will not participate in any appreciation of any underlying, and your return on the securities is limited to the principal amount plus any contingent quarterly payments, regardless of any appreciation in the values of the underlyings.** Investors will not participate in any appreciation of any underlying from its initial value. Unless the final value of any underlying is less than its coupon barrier level, you will receive at maturity the stated principal amount plus the contingent quarterly payment with respect to the final determination date, regardless of any appreciation in the values of the underlyings, which may be significant. The return on the securities will be limited to the contingent quarterly payment that is payable with respect to each determination date on which the determination closing value or the final value, as applicable, of each underlying is greater than or equal to its coupon barrier level. It is possible that the closing value of any underlying could be below its coupon barrier level on most or all of the determination dates so that you will receive few or no contingent quarterly

payments. Accordingly, the return on the securities may be significantly less than the return on a direct investment in the securities included in the underlyings during the term of the securities.

- **The securities may be called prior to the maturity date.** If the securities are called early, the holding period over which you will receive contingent quarterly payments could be as short as 3 months. If the securities are redeemed prior to the maturity date, you will receive no more contingent quarterly payments. There is no guarantee that you would be able to reinvest the proceeds from an investment in the securities at a comparable return for a similar level of risk following an early redemption at our discretion. It is more likely that we will redeem the securities when it would be advantageous for you to continue to hold the securities. As such, we will be more likely to redeem the securities when the official closing value of any underlying is at or above its respective coupon barrier level, which could result in an amount of interest payable on the securities that is greater than instruments of a comparable maturity and credit rating trading in the market. In other words, we will be more likely to redeem the securities when the securities are paying an above-market coupon.
On the other hand, we will be less likely to exercise our redemption right when the official closing value of any underlying is below its respective coupon barrier level and/or when the final value of the worst performing underlying is expected to be below its coupon barrier level, such that you will receive no contingent quarterly payments and/or that you will suffer a significant loss on your initial investment in the securities at maturity. Therefore, if we do not exercise our redemption right, it is more likely that you will receive few or no contingent quarterly payments and suffer a significant loss at maturity.
- **The amounts payable on the securities are not linked to the values of the underlyings at any time other than on the determination dates, including the final determination date.** The payments on the securities will be based on the closing values of the underlyings on each determination date, subject to postponement for non-trading days and certain market disruption events. Even if the market price of an underlying appreciates prior to an applicable determination date but then drops on that day to a value that is below its coupon barrier level, the contingent quarterly payment on the securities will not be paid. Similarly, the payment at maturity will be less, and may be significantly less, than it would have been had the securities been linked the values of the underlyings on a date prior to the final determination date. - **Because the securities are linked to the performance of the worst performing underlying, you are exposed to greater risks of receiving no contingent quarterly payments and sustaining a significant loss on your investment than if the securities were linked to fewer underlyings or just one underlying.** The risk that you will not receive any contingent quarterly payments, or that you will suffer a significant loss on your investment, is greater if you invest in the securities as opposed to substantially similar securities that are linked to the performance of fewer underlyings or just one underlying. With multiple underlyings, it is more likely that one or more of the underlyings will close below their respective coupon barrier levels on any determination date (including the final determination date) and below its principal barrier level on the final determination date, than if the securities were linked to fewer underlyings or only one underlying. securities to be called prior to maturity, the securities are less likely to be called than if the securities were linked to fewer underlyings or just one underlying.

- **Higher contingent quarterly payments or lower principal barrier levels are generally associated with underlyings with greater expected volatility and therefore can indicate a greater risk of loss.** "Volatility" refers to the frequency and magnitude of changes in the level of the underlyings. The greater the expected volatility with respect to the underlyings on the pricing date, the higher the expectation as of the pricing date that the levels of the underlyings could close below their respective principal barrier levels on the valuation date, indicating a higher expected risk of loss on the securities. This greater expected risk will generally be reflected in a higher contingent quarterly payment than the yield payable on our conventional debt securities with a similar maturity, or in more favorable terms (such as a lower principal barrier level or a higher contingent quarterly payment) than for similar securities linked to the performance of the underlyings with a lower expected volatility as of the pricing date. - **Adjustments to any underlying could adversely affect the value of the securities.** The publisher of an underlying may add, delete or substitute the securities comprising the relevant underlying. Further, the publisher of an underlying may discontinue or suspend calculation or publication of that underlying at any time. Any such actions could affect the value of and the return on the securities.
- **Risks associated with non-U.S. companies.** The value of the EFA depends upon the stocks of non-U.S. companies, and thus involves risks associated with the home countries of those non-U.S. companies. The prices of these non-U.S. stocks may be affected by political, economic, financial and social factors in the home country of each applicable company, including changes in that country's government, economic and fiscal policies, currency exchange laws or other laws or restrictions, which could affect the value of the securities. These foreign securities may have less liquidity and could be more volatile than many of the securities traded in U.S. or other securities markets. Direct or indirect government intervention to stabilize the relevant foreign securities markets, as well as cross shareholdings in foreign companies, may affect trading levels or prices and volumes in those markets. The other special risks associated with foreign securities may include, but are not limited to: less liquidity and smaller market capitalizations; less rigorous regulation of securities markets; different accounting and disclosure standards; governmental interference; currency fluctuations; higher inflation; and social, economic and political uncertainties. These factors may adversely affect the performance of the EFA and, as a result, the value of the securities.
- **The securities will not be adjusted for changes in exchange rates.** Although the equity securities included in the EFA are traded in currencies other than U.S. dollars, and your securities are denominated in U.S. dollars, the amount payable on your securities at maturity, if any, will not be adjusted for changes in the exchange rates between the U.S. dollar and the currencies in which these non-U.S. equity securities are denominated. Changes in exchange rates, however, may also reflect changes in the applicable non-U.S. economies that in turn may affect the value of the EFA and therefore your securities. The amount we pay in respect of your securities on the maturity date, if any, will be determined solely in accordance with the procedures described in this document.
- **Even if our or our affiliates' stocks are held by the EFA, we or our affiliates will not have any obligation to consider your interests.** Our parent HSBC Holdings plc is currently one of the companies included in the MSCI EAFE Index, the underlying index to the EFA. We will not have any obligation to consider your interests as a holder of the Notes in taking any corporate actions.
- **Small-capitalization risk.** The RTY tracks companies that are considered small-capitalization. These companies often have greater stock price volatility, lower trading volume and less liquidity than large-capitalization companies and therefore the

level of the RTY may be more volatile than an investment in stocks issued by large-capitalization companies. Stock prices of small-capitalization companies are also more vulnerable than those of large-capitalization companies to adverse business and economic developments, and the stocks of small-capitalization companies may be thinly traded, making it difficult for the RTY to track them. In addition, small-capitalization companies are typically less stable financially than large-capitalization companies and may depend on a small number of key personnel, making them more vulnerable to loss of personnel. Small-capitalization companies are often subject to less analyst coverage and may be in early, and less predictable, periods of their corporate existences. Such companies tend to have smaller revenues, less diverse product lines, smaller shares of their product or service markets, fewer financial resources and less competitive strengths than large-capitalization companies and are more susceptible to adverse developments related to their products.

General Risk Factors

- **Credit risk of HSBC USA Inc.** The securities are senior unsecured debt obligations of the issuer, HSBC, and are not, either directly or indirectly, an obligation of any third party. The estimated initial value will reflect our and our affiliates' internal funding rate, which is the borrowing rate paid to issue market-linked securities, as well as the mid-market value of the embedded derivatives in the securities. This internal funding rate is typically lower than the rate we would use when we issue conventional fixed or floating rate debt securities. As a result of the difference between our internal funding rate and the rate we would use when we issue conventional fixed or floating rate debt securities, the estimated initial value of the securities may be lower if it were based on the values at which our fixed or floating rate debt securities trade in the secondary market. In addition, if we were to use the rate we use for our conventional fixed or floating rate debt issuances, we would expect the economic terms of the securities to be more favorable to you. We will determine the value of the embedded derivatives in the securities by reference to our or our affiliates' internal pricing models. These pricing models consider certain assumptions and variables, which can include volatility and interest rates. Different pricing models and assumptions could provide valuations for the securities that are different from our estimated initial value. These pricing models rely in part on certain forecasts about future events, which may prove to be incorrect. The estimated initial value does not represent a minimum price at which we or any of our affiliates would be willing to purchase your securities in the secondary market (if any exists) at any time.
- **The price of your securities in the secondary market, if any, immediately after the pricing date is expected to be less than the price to public.** The price to public takes into account certain costs. These costs include our affiliates' projected hedging profits (which may or may not be realized) for assuming risks inherent in hedging our obligations under the securities and the costs associated with structuring and hedging our obligations under the securities. These costs will be used or retained by us or one of our affiliates. If you were to sell your securities in the secondary market, if any, the price you would receive for your securities may be less than the price you paid for them because secondary market prices will not take into account these costs. The price of your securities in the secondary market, if any, at any time after issuance will vary based on many factors, including the value of the underlyings and changes in market conditions, and cannot be predicted with accuracy. The securities are not designed to be short-term trading instruments, and you should, therefore, be able and willing to hold the securities to maturity. Any sale of the securities prior to maturity could result in a loss to you.
- **If HSBC Securities (USA) Inc. were to repurchase your securities immediately after the original issue date, the price you receive may be higher than the estimated initial value of the securities.** Assuming that all relevant factors remain constant after the original issue date, the price at which HSBC Securities (USA) Inc. may initially buy or sell the securities in the secondary market, if any, and the value that may initially be used for customer account statements, if any, may exceed the estimated initial value on the pricing date for a temporary period expected to be approximately 5 months after the original

issue date. This temporary price difference may exist because, in our discretion, we may elect to effectively reimburse to investors a portion of the estimated cost of hedging our obligations under the securities and other costs in connection with the securities that we will no longer expect to incur over the term of the securities. We will make such discretionary election and determine this temporary reimbursement period on the basis of a number of factors, including the tenor of the securities and any agreement we may have with the distributors of the securities. The amount of our estimated costs which we effectively reimburse to investors in this way may not be allocated ratably throughout the reimbursement period, and we may discontinue such reimbursement at any time or revise the duration of the reimbursement period after the original issue date of the securities based on changes in market conditions and other factors that cannot be predicted.

- **Hedging and trading activity by our affiliates could adversely affect the value of the securities.** One or more of our affiliates and/or third-party dealers expect to carry out hedging activities related to the securities (and possibly to other instruments linked to the underlyings or their respective component securities), including trading in the component securities as well as other instruments related to one or more underlyings. As a result, these entities may be unwinding or adjusting hedge positions during the term of the securities, and the hedging strategy may involve greater and more frequent dynamic adjustments to the hedge as the final determination date approaches. Some of our affiliates may also trade the component securities and other financial instruments related to one or more underlyings on a regular basis as part of their general broker-dealer and other businesses. Any of these hedging or trading activities on or prior to the pricing date could potentially increase the initial value of an underlying and, as a result, its coupon barrier level, which is the value at or above which that underlying must close on each determination date in order for you to earn a contingent quarterly payment and the value at or above which that underlying must close on the final determination date in order for you to avoid being exposed to the negative performance of the worst performing underlying at maturity. Additionally, such hedging or trading activities during the term of the securities could adversely affect the value of an underlying on the determination dates and, accordingly, whether the securities are called prior to maturity and, if the securities are not called prior to maturity, the payout to you at maturity.
- **The calculation agent, which is HSBC or one of its affiliates, will make determinations with respect to the securities.** As calculation agent, HSBC or one of its affiliates will determine the initial value, the coupon barrier level of each underlying index, the final value of each underlying, whether the contingent quarterly payment will be paid on each contingent payment date, whether the securities will be redeemed following any determination date, whether a market disruption event has occurred with respect to an underlying index, whether to make any adjustments to any determination closing price or the final value and the payment that you will receive upon an early redemption or at maturity, if any. Moreover, certain determinations made by HSBC or one of its affiliates in its capacity as calculation agent may require it to exercise discretion and make subjective judgments, such as with respect to the occurrence or non-occurrence of market disruption events. no assurance that the volatility will lessen. See “Information about the Underlyings” below. You may receive less, and possibly significantly less, than the stated principal amount if you try to sell your securities prior to maturity.

- **The securities will not be listed on any securities exchange and secondary trading may be limited.** The securities will not be listed on any securities exchange or automated quotation system. Therefore, there may be little or no secondary market for the securities. HSBC Securities (USA) Inc. may, but is not obligated to, make a market in the securities. Even if there is a secondary market, it may not provide enough liquidity to allow you to trade or sell the securities easily. Because we do not expect that other broker-dealers will participate significantly in the secondary market for the securities, the price at which you may be able to trade your securities is likely to depend on the price, if any, at which HSBC Securities (USA) Inc. is willing to transact. 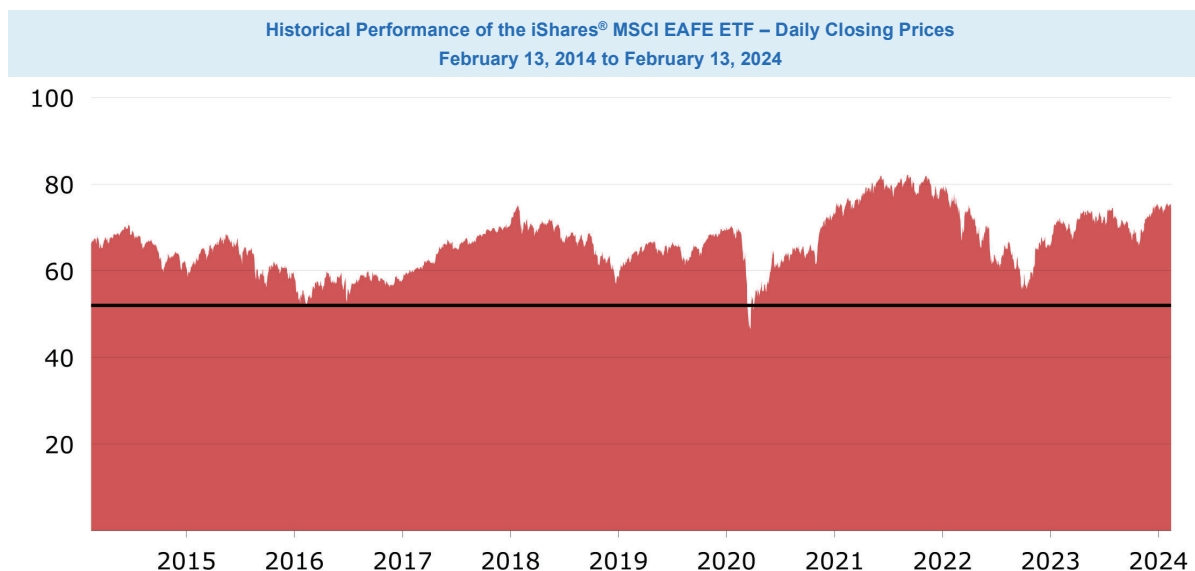

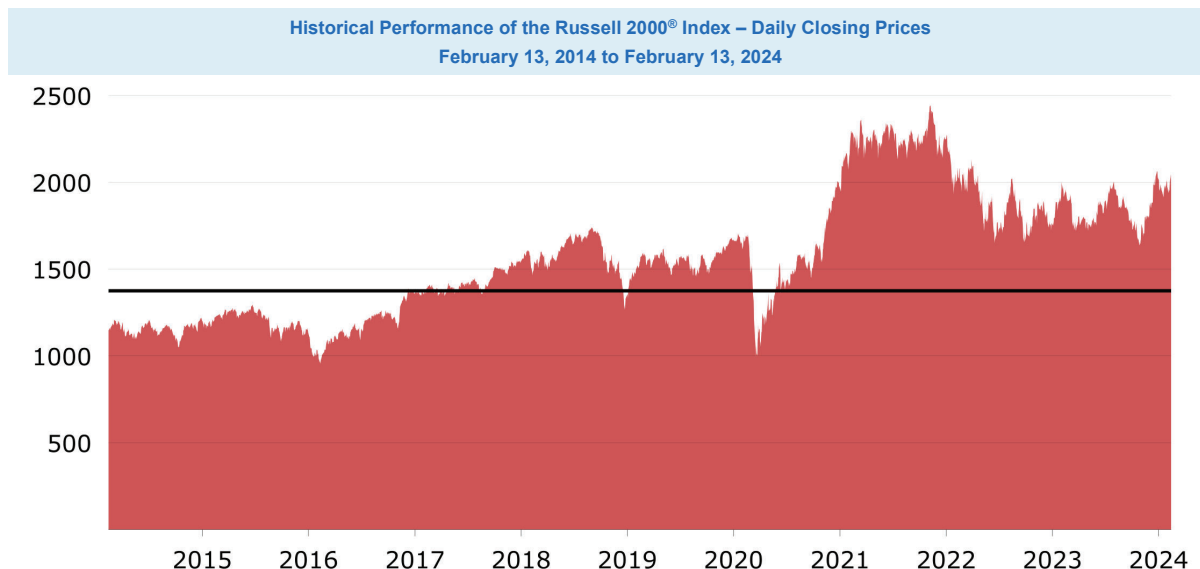
Russell 2000® Index Overview

The Russell 2000® Index ("RTY") is designed to track the performance of the small capitalization segment of the U.S. equity market. 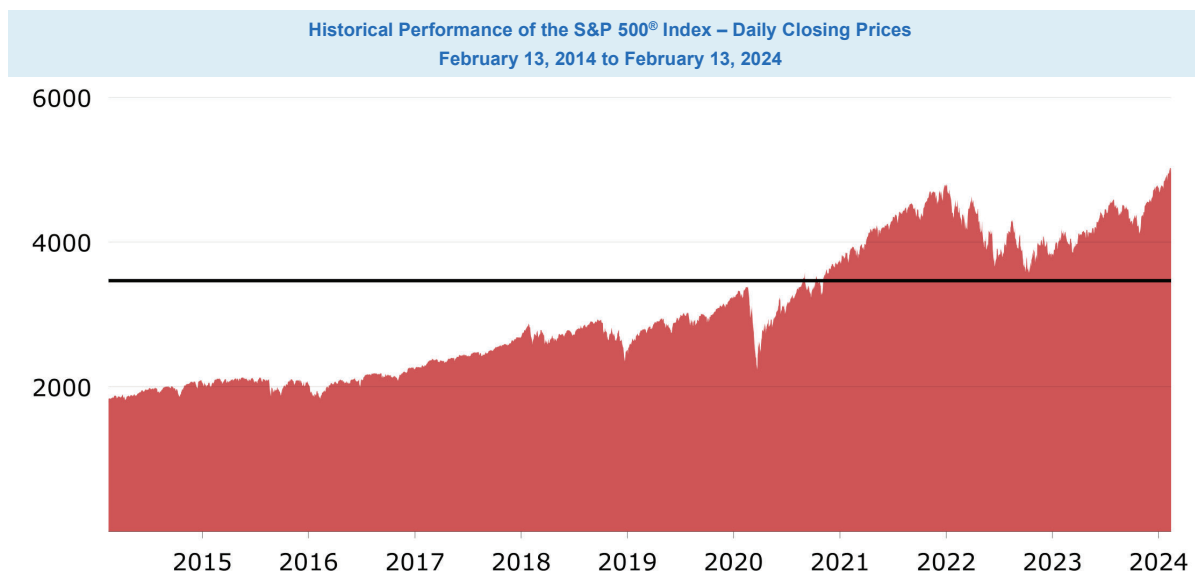
