<b>Market Measure</b>	An approximately equally weighted global equity basket comprised of the Russell 2000® Index (Bloomberg symbol: "RTY"), the EURO STOXX 50® Index (Bloomberg symbol: "SX5E"), and the MSCI Emerging Markets Index (Bloomberg symbol: "MXEF"). Each Basket Component is a price return index.

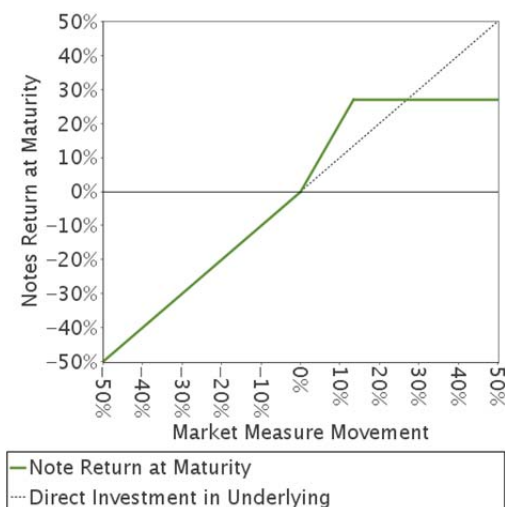
