<b>Issuer</b>	HSBC USA Inc. ("HSBC")
<b>Principal Amount</b>	\$10.00 per unit
<b>Term</b>	Approximately five years, if not called
<b>Market Measure</b>	The EURO STOXX 50® Index (Bloomberg symbol: "SX5E")
<b>Automatic Call</b>	The notes will be called automatically on any Observation Date if the closing level of the Market Measure is equal to or greater than the Call Level
<b>Call Level</b>	100% of the Starting Value
<b>Observation Dates</b>	Approximately one year, two years, three years and four years from the pricing date
<b>Call Amounts</b>	[\$10.85 to \$10.95] if called on the first Observation Date, [\$11.70 to \$11.90] if called on the second Observation Date, [\$12.55 to \$12.85] if called on the third Observation Date and [\$13.40 to \$13.80] if called on the final Observation Date, each to be determined on the pricing date

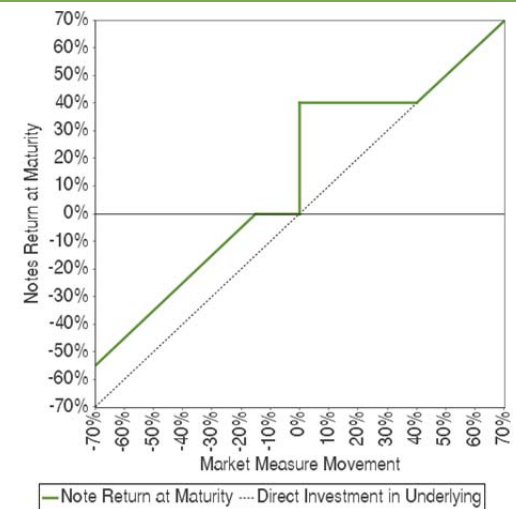
