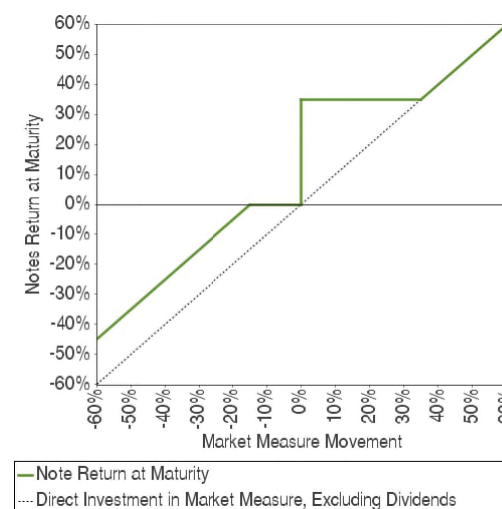


# AUTOCALLABLE MARKET-LINKED STEP UP NOTES

	Autocallable Market-Linked Step Up Notes Linked to the Russell 2000® Index
<b>Issuer</b>	HSBC USA Inc. ("HSBC")
<b>Principal Amount</b>	\$10.00 per unit
<b>Term</b>	Approximately five years, if not called
<b>Market Measure</b>	The Russell 2000® Index (Bloomberg symbol: "RTY")
<b>Automatic Call</b>	The notes will be called automatically on any Observation Date if the closing level of the Market Measure is equal to or greater than the Call Level
<b>Call Level</b>	100% of the Starting Value
<b>Observation Dates</b>	Approximately one year, two years, three years and four years from the pricing date
<b>Call Amounts</b>	[\$10.50 to \$10.60] if called on the first Observation Date, [\$11.00 to \$11.20] if called on the second Observation Date, [\$11.50 to \$11.80] if called on the third Observation Date and [\$12.00 to \$12.40] if called on the final Observation Date, each to be determined on the pricing date
<b>Payout Profile at Maturity</b>	<ul style="list-style-type: none"> <li>• If the Market Measure is flat or increases up to the Step Up Value, a return equal to the Step Up Payment</li> <li>• If the Market Measure increases above the Step Up Value, a return equal to the percentage increase in the Market Measure</li> <li>• 1-to-1 downside exposure to decreases in the Market Measure beyond a 15% decline, with up to 85% of the principal amount at risk</li> </ul>
<b>Step Up Value</b>	135% of the Starting Value
<b>Step Up Payment</b>	\$3.50 per unit, a 35% return over the principal amount
<b>Threshold Value</b>	85% of the Starting Value
<b>Investment Considerations</b>	This investment is designed for investors who anticipate that the Market Measure will not decrease over the term of the notes and are willing to take downside risk below a threshold and forgo interim interest payments, and are willing to have their notes called prior to maturity.
